





Armed Habitual Criminal Unlawful Use of a Weapon- Firearm (Automatic) 2400 block of Clarence Ave. – 3/05/2024 – 7:40p.m.

Officers met with a female victim who walked-in to the police station to file a report of a domestic battery that had just occurred at her residence on the 2400 block of Clarence Ave. The victim positively identified the male offender through a photo provided by the police. On 3/07/2024, Berwyn Tactical Detectives observed the offender's vehicle parked on the 2400 block of Clarence Ave. occupied by the offender (driver's seat) and one (1) male subject in the passenger seat. Detectives observed the driver exit the vehicle at which time they placed him in custody without incident. Said subject was found to have a small bag containing green plant-like substance (suspect cannabis) which was later weighed at a packaged weight of 11.4 grams. Detectives then observed the subject in the front passenger seat was reaching down towards the foot well area. Said subject then exited the vehicle as ordered by police. Upon said subject exiting the vehicle, detectives observed in plain view protruding from underneath the front passenger seat a loaded firearm equipped with a fully automatic switch and an attached extended magazine. Detectives recovered the firearm and placed the second male subject into custody without incident. Both subjects were transported to the Berwyn Police Department for processing. Upon further investigation, detectives determined that the recovered firearm belonged to the male subject who was in the driver's seat. The second subject (passenger) was subsequently released without charges. The first male subject (driver) was charged with: one (1) count Class X Felony-Armed Habitual Criminal, one (1) count Class X Felony- Unlawful Use of a Weapon-Firearm (Automatic), one (1) count Class A Misdemeanor- Domestic Battery. Case closed by arrest.


Burglary/Burglary from Motor Vehicle – 3/07/2024 2200 block of Gunderson Ave. – 5:05a.m.


Officers responded to the 2200 block of Gunderson Ave. for a delayed report of a burglary. Responding officers met with a male victim who related he discovered one of the windows on their garage was open. The victim further advised that the inside of their vehicle, which was parked inside the garage, was in disarray and their driver's license, state I.D., and FOID card were missing. The victim further related that multiple power tools, which belonged to the property manager, were now missing from the garage. While on scene, another tenant of said building, informed officers that some of her belongings were also missing from the garage. This investigation is ongoing.

Burglary from Motor Vehicle – 3/08/2024 1300 block of Highland – 3:22a.m.

While on patrol, an officer observed a Black Male subject rummaging through the rear passenger compartment of a vehicle. The officer exited his squad car at which time the offender fled Eastbound on 13th Street on foot. The officer pursued the offender on foot as the offender proceeded to flee Northbound on Harvey Ave. and then Westbound by hopping fences and cutting through yards. The offender ultimately escaped, however, he dropped his cell phone on the ground which was recovered by officers. Officers located the owner of the vehicle who reported multiple power tools missing from his vehicle. Officers determined that entry was made into the victim's vehicle by breaking out the rear passenger side window. This investigation is ongoing.




SIGNIFICANT INCIDENTS IN 6TH WARD





