

#### SIGNIFICANT INCIDENTS IN 1<sup>ST</sup> WARD

#### FOR WEEK OF 3/13/2023

Battery — 3/13/2023 Junior's Bar (7011 W. Ogden) — 9:28p.m.

Officers responded to a report of a disturbance at Junior's Bar. Responding officers met with the victim who stated that he was punched in the face. The offender was no longer on scene when officers arrived. BFD responded and treated the victim for a minor injury to the face. The victim signed a complaint refusal.

Fight/Brawl — 3/18/2023 Windsor Café (6834 W. Windsor) — 12:44a.m.

Officers were dispatched to Windsor Café for the report of 2 (two) subjects fighting inside the bar. Upon arrival, it was learned that the two subjects involved in the fight were pushed out the front door by other patrons and subsequently locked out. A check of the area for either subject was met with negative results.

Battery — 3/18/2023 Godson's Bar (6910 W. Windsor) — 1:33a.m.

Officers responded to a report of a battery inside Godson's bar. Upon arrival, officers discovered a male subject bleeding from the nose area. It was learned that the offender (male subject) left the scene prior to police arrival. The victim signed a medical refusal.

## Accident Involving Railroad — 3/16/2023 Ridgeland/Stanley — 9:53a.m.


Officers responded to a vehicle crash located on the BNSF tracks at Ridgeland Ave. Upon arrival, responding officers observed a vehicle obstructing the tracks with heavy front end damage. The driver of the vehicle was on scene and signed a medical refusal.

It was learned that the driver was traveling Northbound and went around the down gate and was struck by a Metra train traveling Westbound. The incident was turned over to the Metra Police for further investigation. The driver was issued citations by Berwyn Police accordingly.

#### Disturbance/Battery — 3/18/2023 Metro Towing (3100 block of Ridgeland) — 1:33p.m.

Officers were dispatched to Metro Towing in reference to a disturbance. Upon arrival, officers observed several subjects surrounding the owner, who appeared in distress. The owner stated he allowed a subject to recover an "ID card" from his vehicle which was towed due to an accident. Shortly after, the owner related he observed several subjects unloading numerous objects from the vehicle at which time the owner attempted to stop the subjects. A physical altercation ensued where a male and female subject struck the owner multiple times. The owner had no visible signs of injury and signed a refusal for emergency medical treatment. The owner (victim) did not want to pursue this matter any further and agreed to sign a complaint refusal.

## Criminal Damage to Property — 3/19/2023 Ridgeland/32<sup>nd</sup> Street — 2:50a.m.

Berwyn Dispatch received 1 (one) call of 6-8 shots fired in the area of 32<sup>nd</sup> Street/Ridgeland Ave. Responding officers discovered a gray colored sedan that had numerous windows broken out. Both front and rear driver side door windows as well as the front windshield were damaged with an unknown object. A check of the area revealed no spent casings and the damage did not appear consistent with being shot out. A check of the surrounding areas for any other evidence of shots fired was met with negative results.

## Catalytic Converter Theft/Aggravated Fleeing & Eluding 2100 block of Highland — 3/17/2023 — 4:40a.m.

Officer responded to the 2100 block of Highland for a report of a Catalytic Converter theft. Upon arrival, officers met with the victim who related that he had observed unknown person(s) underneath his SUV. The victim further related that the unknown person(s) got into a gray colored vehicle and fled. Officers confirmed that the Catalytic Converter was in fact stolen from said SUV.


While searching the area, officers observed a gray colored vehicle, matching the description provided by the victim, at 61st Ct/Vacin Fairway (Cicero). The officer observed 4 (four) male subjects standing outside of another vehicle which was nearby the offending vehicle. Upon observing the officer, the subjects ran back to their vehicle and fled. A brief vehicle pursuit began and a check of the license plate revealed the vehicle was reported stolen out of Chicago. After said pursuit was terminated, the officer returned to (61st Ct//Vacin Fairway) and discovered a saw underneath the vehicle. Cicero PD was contacted and recovered the saw. This investigation is ongoing.

### Aggravated Fleeing & Eluding — 3/13/2023 & 3/22/2023 Roosevelt/Ridgeland — 2:35a.m.

On 3/13/2023, officers observed a red colored tow truck and a black colored Dodge Challenger traveling together Westbound on 13<sup>th</sup> Street from Lombard Ave. at a high rate of speed. Shortly after, officers observed a black colored tow truck also traveling Westbound on 13<sup>th</sup> Street at a high rate of speed. Neither one of the tow trucks had any required markings on them. Berwyn Police Officers located all three of the vehicles together in the Fuel Stop Gas Station lot at Roosevelt Rd/Ridgeland Ave. As the first responding unit pulled into the lot, the Dodge Challenger fled Southbound on Ridgeland Ave. The red colored tow truck fled Eastbound on Roosevelt. Officers attempted to conduct a traffic stop on both tow trucks, however, both tow trucks fled. Both trucks were pursued and then terminated in Oak Park and Chicago. The Dodge Challenger and red colored tow truck did not have valid registration. The black colored tow truck is registered out of Cicero and was entered into LEADS as felonious.

On 3/22/2023, Berwyn Tactical Officers and Detectives located the owner of the black colored tow truck outside of his residence in Cicero. After a short foot pursuit, the male subject was taken into custody and transported to the Berwyn Police Department for processing. The male subject was subsequently charged with 1 (one) felony count of Aggravated Fleeing and Eluding. Case closed by arrest.






#### SIGNIFICANT INCIDENTS IN 5<sup>TH</sup> WARD

Aggravated Unlawful Use of a Weapon — 3/15/2023 Highland/21<sup>st</sup> Street — 4:13p.m.

Officers attempted a traffic stop at Highland/21<sup>st</sup> Street after observing a vehicle commit several traffic violations. When the officer made contact with the driver (sole occupant of the vehicle), the driver advised the officer that he had firearm in the backseat of the vehicle. Officers asked the driver to step out of the vehicle to which he complied. Officers located a loaded firearm under the front passenger seat. The driver had a valid FOID card but did not have a CCL. The driver was subsequently taken into custody and charged with 1 (one) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.


#### Battery — 3/13/2023 Old Time's Sake (6824 W. Cermak) — 5:20p.m.

Officers responded to a report of a Battery at Old Time's Sake. Responding officers met with the victim who stated that he was punched in the face for no reason. The victim refused medical treatment and signed a complaint refusal. The offender was advised that management did not want him in the establishment again.

## Aggravated Unlawful Use of a Weapon — 3/18/2023 16th Street/Euclid — 2:34a.m.

Officers conducted a routine traffic stop at 16<sup>th</sup> Street/Euclid. Upon making contact with the driver, the officer detected the strong smell of Cannabis emanating from inside the vehicle. Both the driver and passenger were asked to step out of the vehicle. Officers then conducted a search of the immediate area of the driver's seat which revealed a loaded firearm inside of the glove compartment. The driver has a valid FOID but does not have a CCL. The driver was subsequently taken into custody without incident and transported to the Berwyn Police Department where he was subsequently charged with 1 (one) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

#### Residential Burglary — 3/12/2023 1800 block of Wenonah — 6:40p.m.

Officers responded to a call of a residential burglary on the 1800 block of Wenonah. Responding officers met with the victims who related that 2 (two) White Male subjects wearing surgical masks & plaid jackets, knocked on the front door of the residence and stated they needed to check the water supply to the house. Both subjects displayed Com Ed I.D. cards to the victims. 1 (one) of the subjects spoke to the couple (victims) while the other subject went into the house. After the subjects left, the couple noticed a closet door forced open and approximately \$225 missing and room ransacked. This investigation is ongoing.

#### Criminal Trespass — 3/17/2023 El Nuevo Vallarta (6801 W. Cermak) — 10:53p.m.

Officers responded to El Nuevo Vallarta in reference to an unwanted subject. Upon arrival, officers met with the bar manager who advised that the male subject was previously removed from the establishment and advised that he was not wanted on the property. Officers subsequently paced the subject into custody and transported him to the police station where he was subsequently charged with Criminal Trespass to Real Property. Case closed by arrest.

#### Fight/Brawl — 3/18/2023 Guadalajara Bar (6814 W. Cermak) — 6:27p.m.

Officers responded to Guadalajara Bar for a call of 7-8 male subjects physically fighting. Upon arrival, officers learned that the brawl spilled outside in the Vacin fairway and then onto Oak Park Avenue (just North of Cermak Road). Officers quickly separated the brawl and only minor injuries were sustained by the involved parties. BFD was summoned to the scene for a medical evaluation of the involved parties. The officers determined the involved parties were mutual combatants and refusals were signed by everyone on scene. Officers then ensured all involved parties left the scene peacefully.

## Aggravated Unlawful Use of a Weapon — 3/19/2023 Walgreens (7113 W. Cermak) — 1:10a.m.

Officers responded to Walgreen's (Cermak Plaza) in reference to an unwanted/intoxicated subject sleeping in a chair by the camera department. Walgreens staff advised that they attempted to wake the subject unsuccessfully. BFD ambulance was summoned for the subject. BFD ambulance arrived on scene at which time they were able to wake the subject who was highly intoxicated and unable to care for himself. Officers on scene observed the handle of a gun in the subject's left jacket pocket. The gun was recovered without incident and a name check revealed the subject had a valid FOID card but no CCL. The subject was subsequently placed into custody and transported to Mac Neal Hospital for further evaluation. The subject was charged with 1 (one) count of felony Aggravated Unlawful Use of a Weapon. Case closed by arrest.


## Theft of City Property — 3/16/2023 1200 block of Home Ave. — 7:45a.m.

While a Berwyn Community Service Officer was traveling down the 1200 block of Home Ave. they discovered that a vehicle with a Barnacle (*The Barnacle is a pane of plastic that when placed will cover a windshield, thus immobilizing the vehicle – similar to the standard vehicle boot*) was missing. Officers utilized the GPS feature on the Barnacle and learned the vehicle was parked inside of the owner's garage. After obtaining a search warrant, Berwyn Police returned to said garage and recovered the vehicle which was subsequently towed and impound by Metro Towing.

## Aggravated Battery — 3/18/2023 1400 block of Ridgeland — 11:01p.m.

Officers responded to the 1400 block of Ridgeland in reference to a subject shot in the face with a paintball gun. Upon arrival, officers discovered a male subject lying on the ground, unconscious, with green paint on his face and a second male subject who was hit in the leg by a paintball and uninjured. BFD arrived on scene and the first male subject was placed in the back of the ambulance. While in the ambulance, the victim woke up and was unaware of what had happened. The victim was transported to Mac Neal Hospital for further evaluation of his injuries. This investigation is ongoing.
