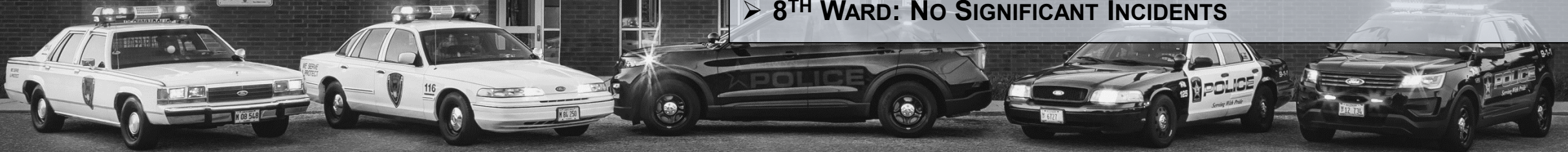

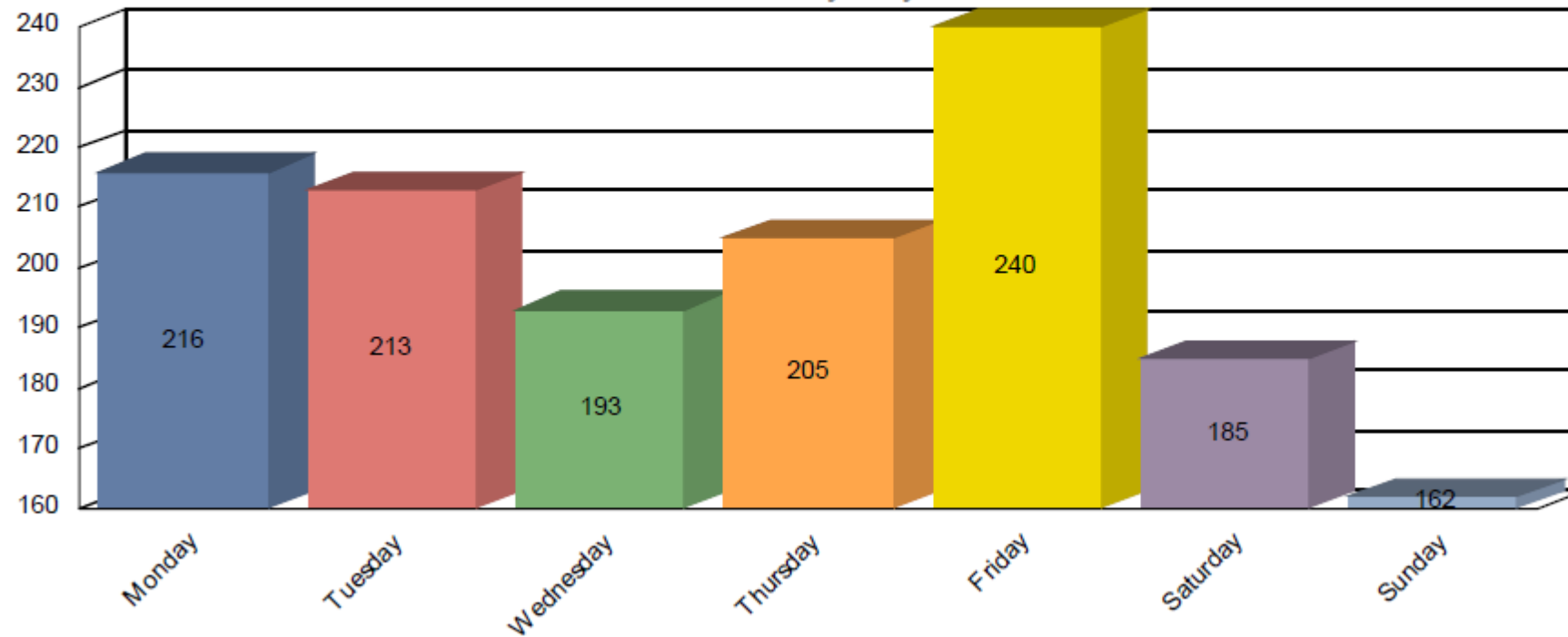

Total Items For Service

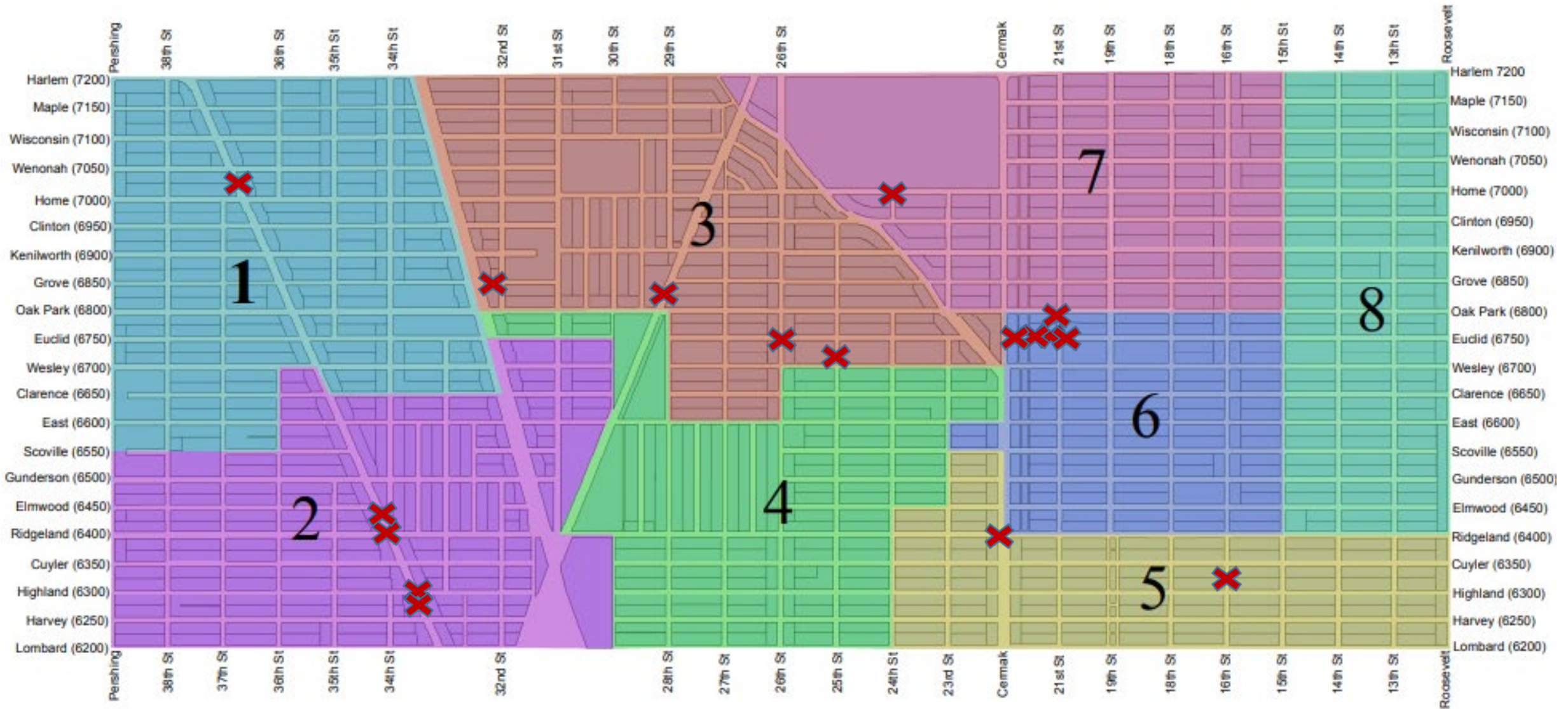

SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 3/20/2023

Battery — 3/25/2023

Junior's Bar (7011 W. Ogden Ave.) — 2:24a.m.

Officers responded to Juniors Bar in reference to a fight. While en route, Berwyn Dispatch advised that the fight was between two female patrons of the bar and that security had detained the offender. Upon officer arrival it was learned that the offender had left prior to police arrival. The victim was still on scene and related they would be willing to sign complaints. This investigation is ongoing.

SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 3/20/2023

Recovered Stolen Auto — 3/21/2023 Ogden/Ridgeland — 12:30a.m.

Berwyn Police received a hit on FLOCK for a stolen U-Haul Van traveling Eastbound on Ogden Ave. Officers located and conducted a traffic stop on said vehicle at Ogden/Ridgeland. The driver, female subject, was the sole occupant of the vehicle. It was learned that the subject was the original offender of the stolen auto. The vehicle was towed by Metro and the female offender was turned over to South Elgin PD for their case.

Aggravated Unlawful Use of a Weapon — 3/24/2023 Ogden/Ridgeland — 9:48a.m.

Berwyn Police conducted a traffic stop on a suspicious vehicle, traveling without valid registration. Upon further investigation, it was learned the driver had no valid driver's license and was subsequently taken into custody. An inventory search of the vehicle revealed a firearm hidden underneath the driver's seat. The driver did not possess a valid FOID or CCL. The offender was transported to the Berwyn Police Department and charged with 1 (one) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

Disturbance/Fight — 3/25/2023 Michael Anthony's Restaurant (6434 W. Ogden Ave) — 11:39p.m.

Officers responded to Michael Anthony's for a report of a disturbance with mention of an alleged gun called in by staff. Upon arrival, several people were seen running from the scene. Officers were met by numerous patrons all who were uncooperative. Officers checked the area for any victims and were met with negative results. Inside the tavern area officers observed obvious signs of a disturbance. Witnesses advised officers that the fight started in or near the men's bathroom between 2 (two) male subjects and that at some point during the disturbance there was someone who had a gun. The staff advised they did not wish to sign any complaints but did want to clear the establishment so they could close for the night.

SIGNIFICANT INCIDENTS IN 2ND WARD

Aggravated Battery — 3/26/2023

Berwyn Food & Liquors (6338 W. Ogden) — 2:42a.m.

Officers reported to Berwyn Food and Liquors for a report of a gunshot victim. Upon arrival, officers did not locate any victims on scene or in the area. The owner stated 2 (two) groups of people were involved in a verbal argument that appeared to be gang related. 1 (one) of the subjects displayed a gun and fired shots from outside into the store and then subjects from inside the store returned fire. Officers recovered approximately 28-30 shell casings from the scene. At approximately 7:00a.m. Mt. Sinai Hospital notified BPD of a gunshot victim in their ER. This incident has been turned over to the Detective Bureau for further investigation.

Aggravated Battery/Fleeing & Eluding — 3/24/2023 **Wesley/25th Street — 3:42a.m.**

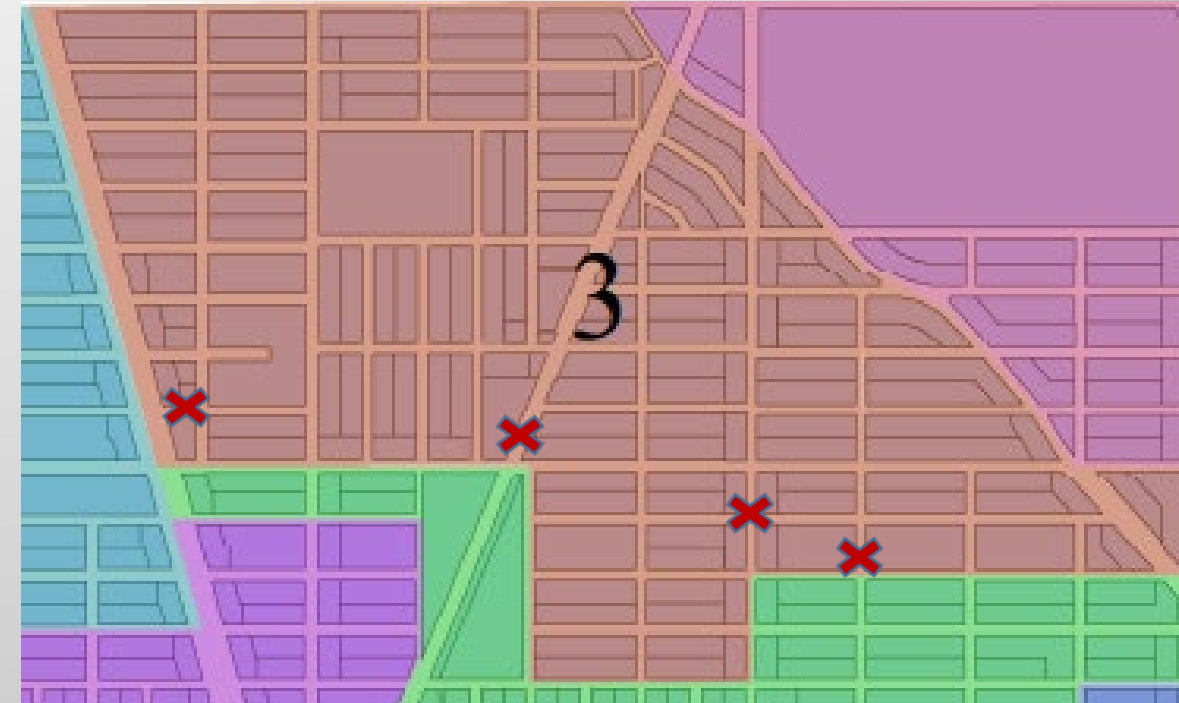
Officers attempted to conduct a traffic stop at which time the vehicle fled. During a brief pursuit, officers observed the offending vehicle to commit several more traffic violations. The officer self-terminated the pursuit at that time. A short time later Berwyn Police observed said vehicle traveling Northbound on Harlem at 15th Street, but did not pursue. Berwyn Officers subsequently put out an ISPERN message with the offending vehicle's information. Said vehicle was stopped, and the driver detained, by the Bloomingdale Police Department. Due to the vehicle being stopped less than an hour after the initial incident in Berwyn, Berwyn Officers traveled to Bloomingdale, IL for a "show-up". During said "show-up" both the vehicle and driver, Thomas Rivera, were positively identified by officers. During an inventory search of the vehicle Officers located a blank prescription pill bottle and clear plastic baggie containing three (3) pills suspect Ecstasy and a small amount of suspect Cannabis. The vehicle was towed/impounded by Metro. The driver was taken into custody without incident and transported back to the Berwyn Police Department where he was subsequently charged with 1 (one) Felony count of Aggravated Fleeing & Eluding. Case closed by arrest.

Criminal Damage to Property — 3/24/2023 **Donna's Gaming (6721 W. 26th Street) — 7:01a.m.**

Berwyn Dispatch received a call of a possible burglary at Donna's Gaming. Responding officers pointed off the building and made entry to conduct a search inside the building. It did not appear entry was made to the building. Officers noted there was damage (broken glass) to both entry doors. This investigation is ongoing.

Overcrowding (Unfounded) — 3/26/2023

Tipsy's Tap Bar (6802 W. 26th Street) — 1:47a.m.

Berwyn Dispatch received a report of a large crowd in front of Topsy' Tap and that they may be overcrowded. Upon officer arrival, officers observed only 1 (one) security employee outside who was turning 2 (two) subjects away advising them that Topsy's was closing. Security was advised of the complaint. Officers checked inside the establishment and did not find it to be overcrowded.

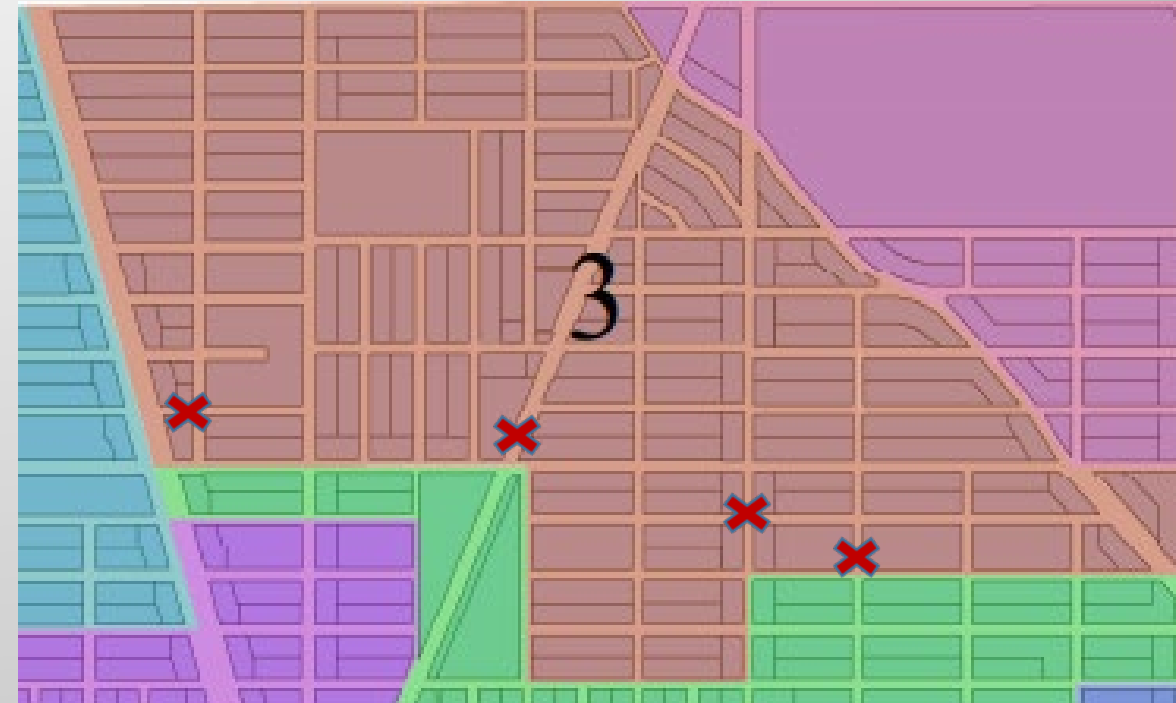
Disturbance/Robbery — 3/26/2023

The Garage (3202 Grove Ave) — 2:23a.m.

Officers responded to a report of a disturbance at The Garage. Upon arrival, several victims advised police that their purses had been stolen. Officers located and conducted a stop on the offending vehicle shortly after it fled the scene. Officers recovered the stolen purses. 6 (six) subjects (male & female) were taken into custody and transported to the station for further investigation. The subjects were arrested and charged accordingly.

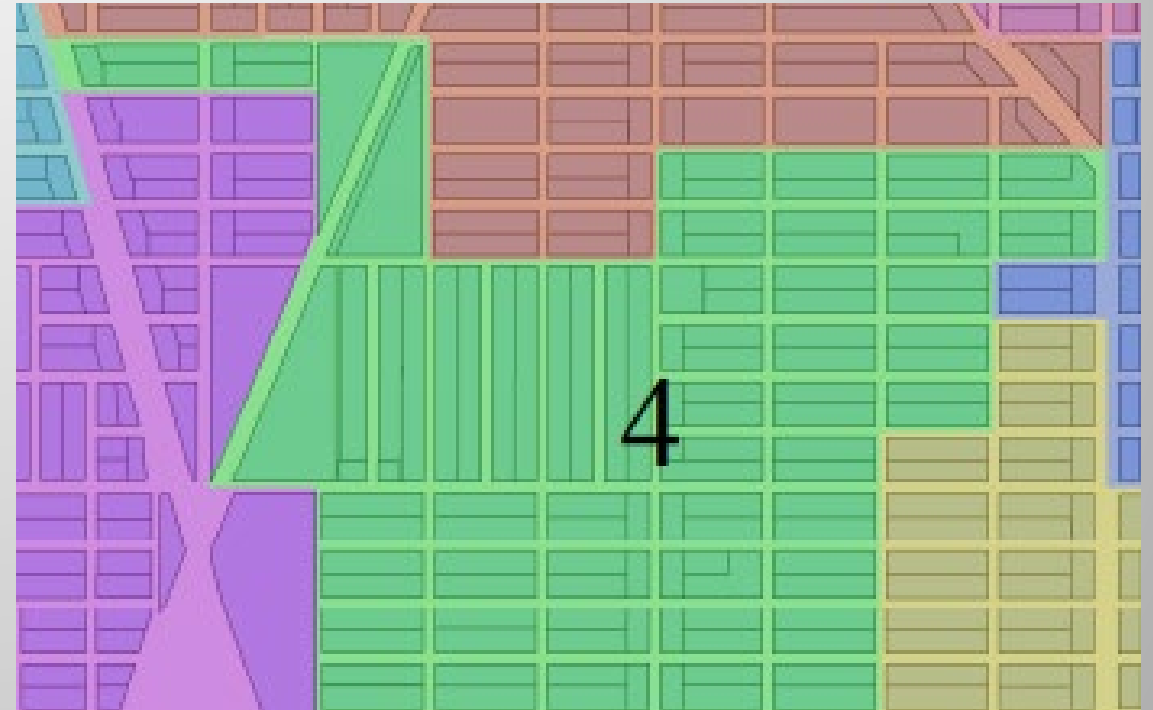

Disturbance/Overcrowding — 3/26/2023

Tapp Room (6330 W. 16th Street) — 1:02a.m.

While officers were conducting a routine patrol of the area, they observed a crowd of approximately 30 subjects standing in and around the entrance of the Tapp Room. Additional units were summoned to the scene and a Tavern Check was conducted. The occupancy of the tavern was known by officers to be 49 and a count of patrons revealed that the actual count of patrons at that time was more than 3 (three) times that number. Patrons were subsequently advised that the bar was being closed by police and everyone needed to leave. Officers cleared the establishment without incident.

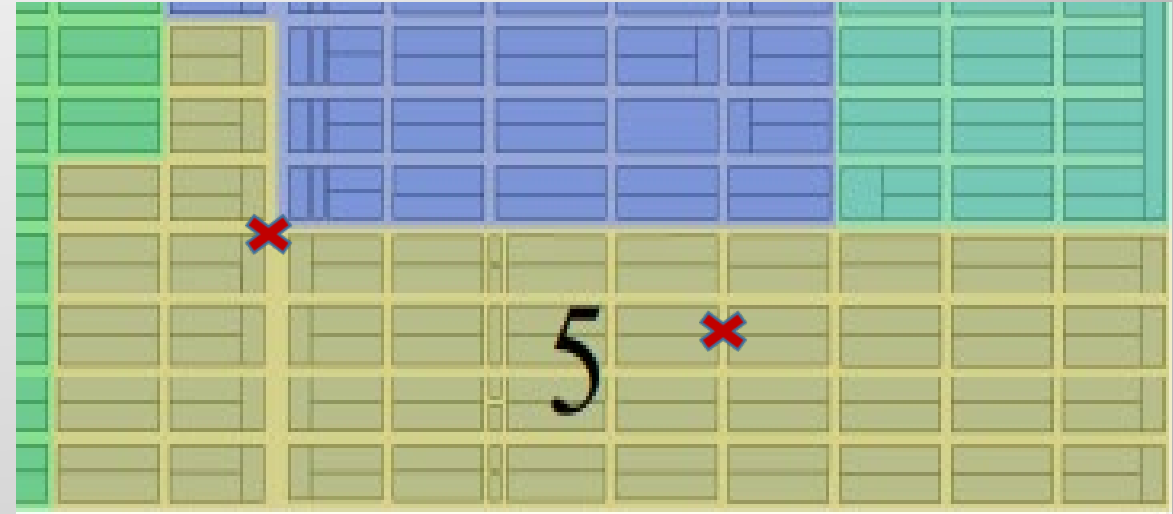
Mob Action/Drag Racing — 3/26/2023

Cermak/Ridgeland — 2:50a.m.

Numerous surrounding communities were dealing with groups of cars drag racing and conducting street take overs. Cicero PD had one of their cars surrounded by the offenders. Remnants of this group passed through Berwyn in various locations. Numerous cars blocked Cermak/Ridgeland and performed various acts of defiance (donuts and burn outs) with their vehicles. Many of the offending vehicles did not have valid license plates or had their license plates covered up. The Berwyn Police Department is currently working with multiple jurisdictions on this incident and it should be considered an open investigation.

SIGNIFICANT INCIDENTS IN 6TH WARD

FOR WEEK OF 3/20/2023

Recovered Stolen Auto (Hyundai) — 3/23/2023 **2100 block of Euclid — 6:23a.m.**

Officers observed a suspicious vehicle parked on the 2100 block of Euclid. The vehicle was unoccupied with the windows down. Officers on scene made contact with the vehicle owner and learned the vehicle had been stolen sometime during the night in Deerfield, IL. The vehicle was subsequently towed by Metro for owner pickup. This investigation is ongoing.

Recovered Stolen Auto (Kia) — 3/23/2023 **Euclid/Vacin Fairway — 8:45a.m.**

Chicago Police Department located a possible stolen vehicle belonging to a Berwyn resident. Berwyn Officers met with the vehicle owner, who related she parked her vehicle (Kia) in the alley of the 2100 block of Euclid Ave. at approximately 2:40a.m. that same day. The victim was advised that CPD recovered the vehicle. This investigation is ongoing.

Stolen Auto (Hyundai) — 3/23/2023 **2100 block of Oak Park Ave. — 8:49a.m.**

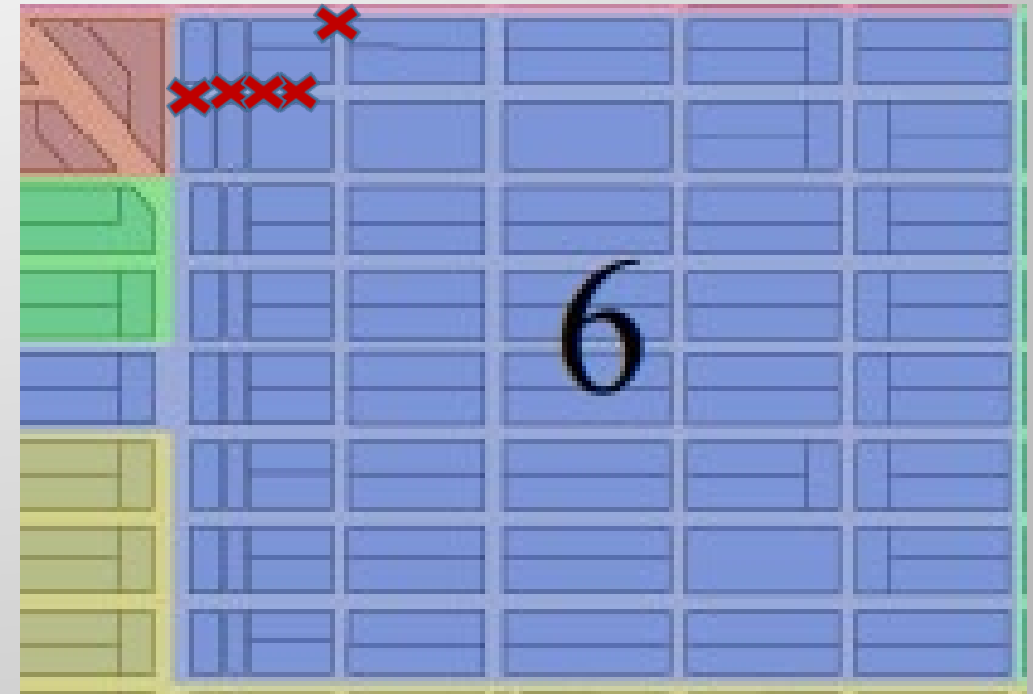
Officers responded to the 2100 block of Oak Park Ave. for a report of a stolen vehicle. Responding officers met with the reporting party who stated he parked his vehicle (Hyundai) at 6:30p.m. on 3/22/2023 and discovered it missing this morning. The vehicle was entered into LEADS as stolen. This investigation is ongoing.

Recovered Stolen Auto (Kia) — 3/23/2023 **Euclid/Vacin Fairway — 9:12a.m.**

Officers observed a damaged vehicle (broken Window) parked on the 2100 block of Euclid. Upon further investigation, it was learned the vehicle was abandoned/ possibly stolen. The vehicle was recovered and towed to Metro for safekeeping. This investigation is ongoing.

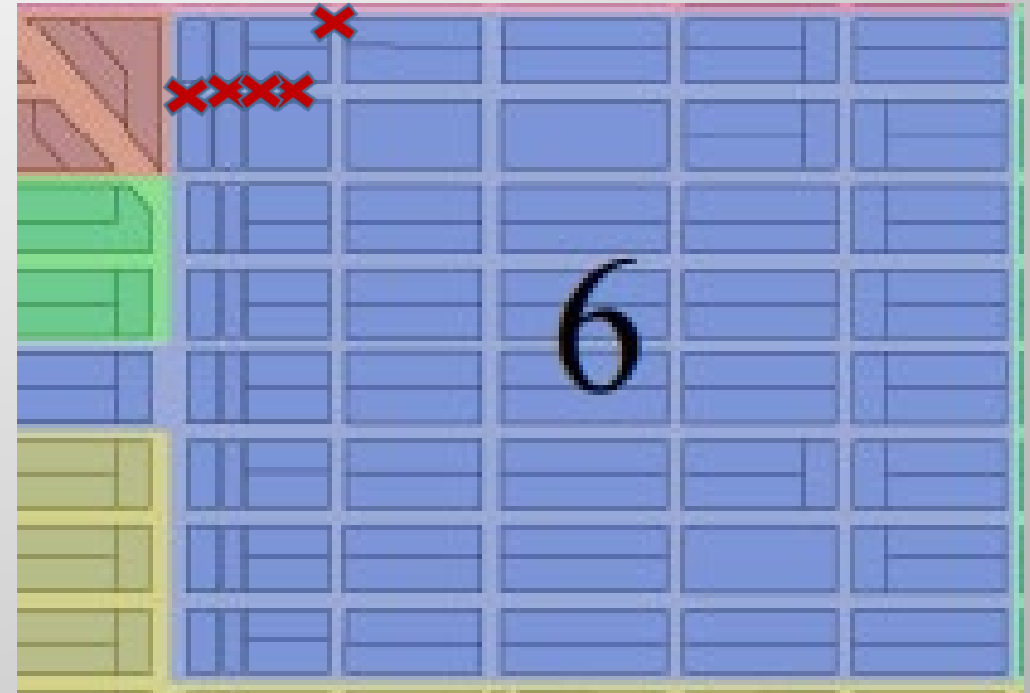
Recovered Stolen Auto (Kia) — 3/23/2023
