




SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 3/31/2025

Aggravated Unlawful Use of a Weapon/ Aggravated Assault with a Firearm/Possession of a Controlled Substance – 4/04/2025 Jalos Sports Bar & Grill (6334 Ogden Ave.) – 8:03p.m.

Officers were dispatched to Jalos Sports Bar & Grill in regards to a male subject threatening Security with a firearm. Responding officers conducted a traffic stop on the offender's vehicle as they were attempting to flee the scene. Both occupants of the vehicle were detained and the male driver was positively identified as the offender. A search of the offender revealed one (1) pocket knife, multiple projectiles, and one (1) plastic bag containing 1.8g of a white powdery substance (suspect Cocaine). Officers also recovered two (2) handguns from the offender's vehicle. Both occupants were taken into custody, transported to the Berwyn Police Department, and charged accordingly. Case closed by arrest.





SIGNIFICANT INCIDENTS IN 3RD WARD

FOR WEEK OF 3/31/2025

First Degree Murder/Attempt Murder – 4/05/2025 3200 block of Clinton Ave. – 1:08 p.m.

Berwyn Police Officers responded to the 3200 block of Clinton Ave. for a report of multiple shots fired. Upon arrival, responding officers located two (2) victims who both suffered multiple gunshot wounds. Both victims were transported to a local area hospital where one of the victims succumbed to their injuries and the other victim was in critical condition. After conducting a preliminary investigation, the Berwyn Police Department identified a male suspect who was located in Hillside, IL. At approximately 3:40 PM, the suspect was placed in custody and transported to the Berwyn Police Department for further investigation. Officers ascertained that the incident stemmed from a domestic dispute.

Following an extensive investigation of this tragic domestic incident, the following charges were approved on 4/07/2025 for the male offender: one (1) felony count of First Degree Murder and one (1) felony count of Attempt First Degree Murder. Case closed by arrest.


Home Invasion – 4/05/2025 6300 block of Roosevelt Rd. – 8:23 a.m.

Officers responded to 6300 block of Roosevelt Rd. for a report of a disturbance. Responding Officers met with the victims who related that an unknown Female Black subject entered their unlocked apartment without permission and struck a female subject in the face; at which time she (offender) fled out the door and into the alley. The female victim and a male witness positively identified the offender walking Southbound on the 1200 block of Cuyler Ave. The offender was subsequently taken into custody and transported to the Berwyn Police Department for further investigation. The victims later advised officers that they no longer wished to sign complaints. The offender was released without charges. Case closed.

Criminal Trespass – 4/06/2025 Jardin Restaurant (6431 W. Cermak Rd.) – 1:52 a.m.

Officers responded to Jardin Restaurant for a report of a disturbance near the front entrance between security staff and a female patron. Responding officers met with the security staff who advised that the intoxicated female subject was asked to leave the establishment but refused to comply. Said female subject also refused to comply to the officers' orders to leave and refused to identify herself. Said subject was taken into custody, transported to the Berwyn Police Department, and subsequently charged accordingly. Case closed by arrest.






SIGNIFICANT INCIDENTS IN 6TH WARD

Officers were dispatched to La Lupita for a physical altercation that occurred inside the upstairs bar area. Upon arrival, responding officers met with two (2) victims (one male and one female) who advised the physical altercation stemmed from a verbal argument with two (2) unknown male patrons. One (1) of the male offenders was still on scene and was taken into custody. Said offender was transported to the Berwyn Police Department and subsequently charged with one (1) misdemeanor count of Battery. Case closed by arrest.






