






Reckless Discharge of a Firearm – 4/06/2024







Burglary – 4/01/2024
Extra Space Storage (1301 S. Harlem Ave.) – 1:21p.m.

Officers responded to Extra Space Storage for a report of multiple storage units that were burglarized. Responding officers met with the establishment’s manager who stated in addition to the units he reported burglarized on 3/31/2024 he located an additional seven (7) units that had been burglarized. The manager further related that he believed the burglaries occurred sometime between 5:30p.m. on 3/30/2024 and 9:00a.m. on 4/01/2024. All victims were contacted by the manager and advised to contact the Berwyn Police Department to file individual reports. This investigation is ongoing.


Aggravated Fleeing & Eluding – 4/05/2024

Culver's Parking Lot (6943 W. Roosevelt Rd.) – 9:12p.m.

Officers were alerted by a FLOCK hit at Oak Park Ave./Roosevelt Rd. on felonious vehicle wanted out of Berwyn for Burglary. Officers also learned that said vehicle was recently involved in multiple other Burglaries in River Forest and Chicago, and involved in an Aggravated Fleeing and Eluding from Forest Park earlier that day. Officers initially observed the vehicle traveling Eastbound on 13th Street from Clarence Ave. Said vehicle ultimately pulled into the parking lot of Culvers. Additional units arrived on scene and officers then activated lights and sirens in an attempt to conduct a traffic stop. Multiple officers gave commands for the occupants to put their hands up at which time the driver began reversing the vehicle. The vehicle reversed and struck a marked BPD squad car as well as additional civilian vehicles before it ultimately fled Westbound on Roosevelt Rd. Officers gave chase from a distance as the vehicle eventually entered Eastbound I-290 and was involved in what appeared to be a single vehicle crash where it rolled over. Both occupants fled from the vehicle onto the L-tracks where they were placed into custody without further incident. Officers recovered one (1) loaded handgun as well as numerous items from the offending vehicle including: one (1) hammer, two (2) screw drivers, a US postal bag and a USPS ID card for the registered owner of the vehicle. Neither of the occupants were the registered owner of the vehicle. Officers learned that the recovered USPS arrow key was previously reported stolen on 01/31/2023. Offender #1 was subsequently charged with one (1) felony count of Aggravated Fleeing and Eluding and one (1) misdemeanor count of Resisting a Police Officer. Offender #2 was subsequently charged with one (1) misdemeanor count of Resisting a Police Officer. Case closed by arrest.






