






SIGNIFICANT INCIDENTS IN 2ND WARD




SIGNIFICANT INCIDENTS IN 3RD WARD

Fight/Disturbance/Battery (Juvenile Incident) – 4/12/2024 Riverside Dr./Home Ave. – 3:17p.m.

Officers responded to the area of Riverside Dr./Home Ave. for a report of a group of teenagers fighting. Upon officer arrival, the group had already begun to disperse and there was no active fight. While on scene, officers observed a male juvenile subject drop his backpack in the middle of the road while walking with clenched fists towards another male juvenile subject across the street. Officers then observed said juvenile strike the victim in the face. Officers then pursued the offender for a short distance on foot before ultimately taking him into custody without incident. The male juvenile was transported to the Berwyn Police Department and subsequently charged accordingly. Case closed by arrest.









SIGNIFICANT INCIDENTS IN 6th Ward

Battery – 4/12/2024 6500 block of Cermak Rd. – 12:19p.m.

Officers responded to the 6500 block of Cermak Rd. for a delayed report of a battery. Responding officers met with the female victim who related on 4/10/2024 at approximately 7:00p.m.-7:30p.m. while she was exiting the front door of a business, an unknown male subject riding a bicycle (possibly motorized) grabbed her buttocks as he rode past. The offender was described as wearing all black with a hood and face mask. This investigation is ongoing.

Battery – 4/11/2024 Ross Dress For Less (7065 W. Cermak Rd.) Parking Lot – 10:37p.m.

Officers responded to Cermak Plaza for a report of a battery. Responding officers met with the female victim who related while walking to her vehicle she observed an unknown male subject riding a bicycle towards her. When the victim arrived to the trunk of her car, said male subject struck her on the buttocks with his hand and fled the scene on his bicycle Eastbound through the parking lot. The offender was described as a male teenager, about 5'03" and 160lbs. wearing a black face mask, green camouflage sweater, and riding a black in color "BMX style" bicycle. This investigation is ongoing.

Aggravated Battery to a Police Officer/Aggravated Fleeing and Eluding/Resisting a Police Officer Home Ave./Cermak Rd. – 4/13/2024 – 2:03a.m.

While on patrol, officers observed a vehicle turn Southbound onto Home Ave. from Cermak going the wrong way down a one-way street. Officers attempted to conduct a traffic stop on said vehicle, however it proceeded to flee. A brief pursuit ensued and the vehicle ultimately drove over the Intercontinental track embankment and crashed on the other side. The driver immediately fled on foot. Officers located the driver a short distance away and attempted to take him into custody at which time the male offender actively resisted and fought with the officers. Officers were eventually able to take him into custody. A second subject also fled the vehicle. Berwyn officers, with the assistance of Stickney PD K9 Unit, conducted a check of the area for the second offender which yielded negative results. The male driver was subsequently charged with one (1) felony count of Aggravated Battery to a Police Officer, one (1) felony count of Resisting a Police Officer. Case closed by arrest.

Berwyn Dispatch received a call from an employee of Advanced Auto Parts relating he was just robbed at gun point. Responding officers met with the victim (employee) who described the offender as a Male Black, 19-20 years of age, approximately 6'2" wearing a blue in color hoodie and jeans. The victim further related that the offender displayed a black in color handgun with an extended magazine and took \$730 from the register. The offender then fled Westbound on Cermak Rd. on foot. Officers conducted a check of the area for the offender which yielded negative results. This investigation is ongoing.






SIGNIFICANT INCIDENTS IN 8th Ward
