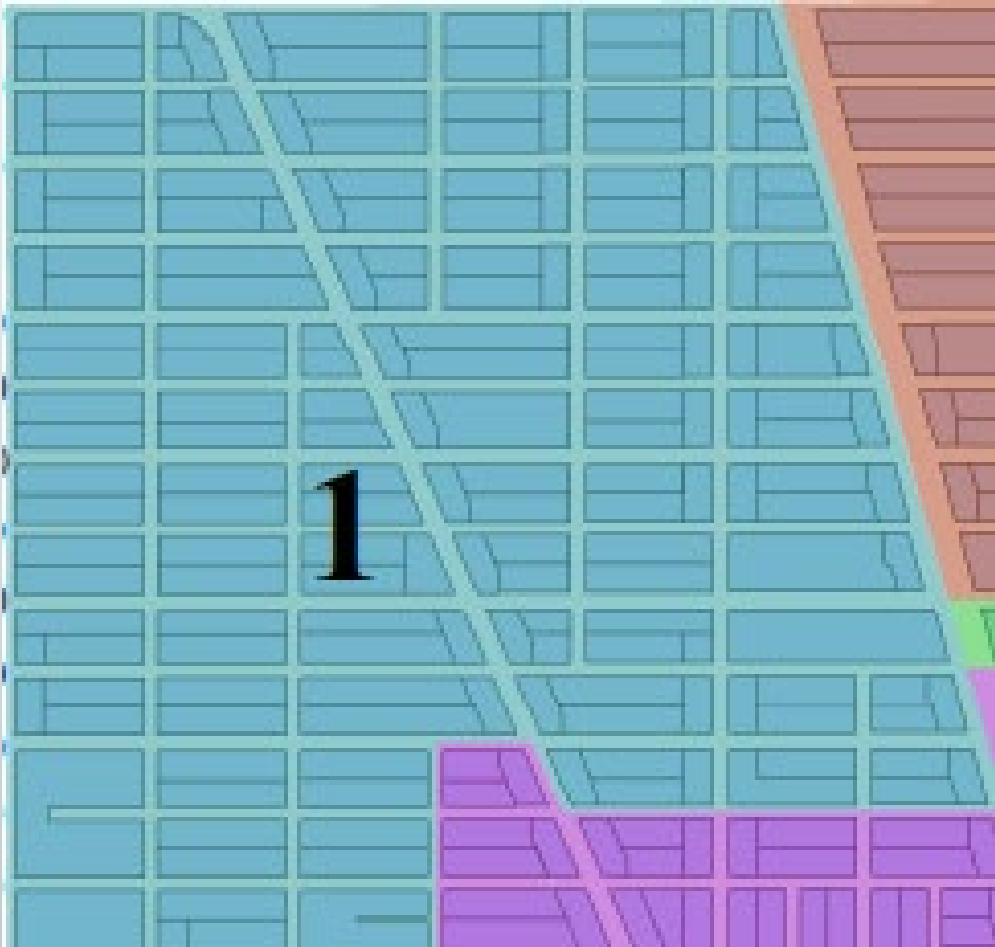

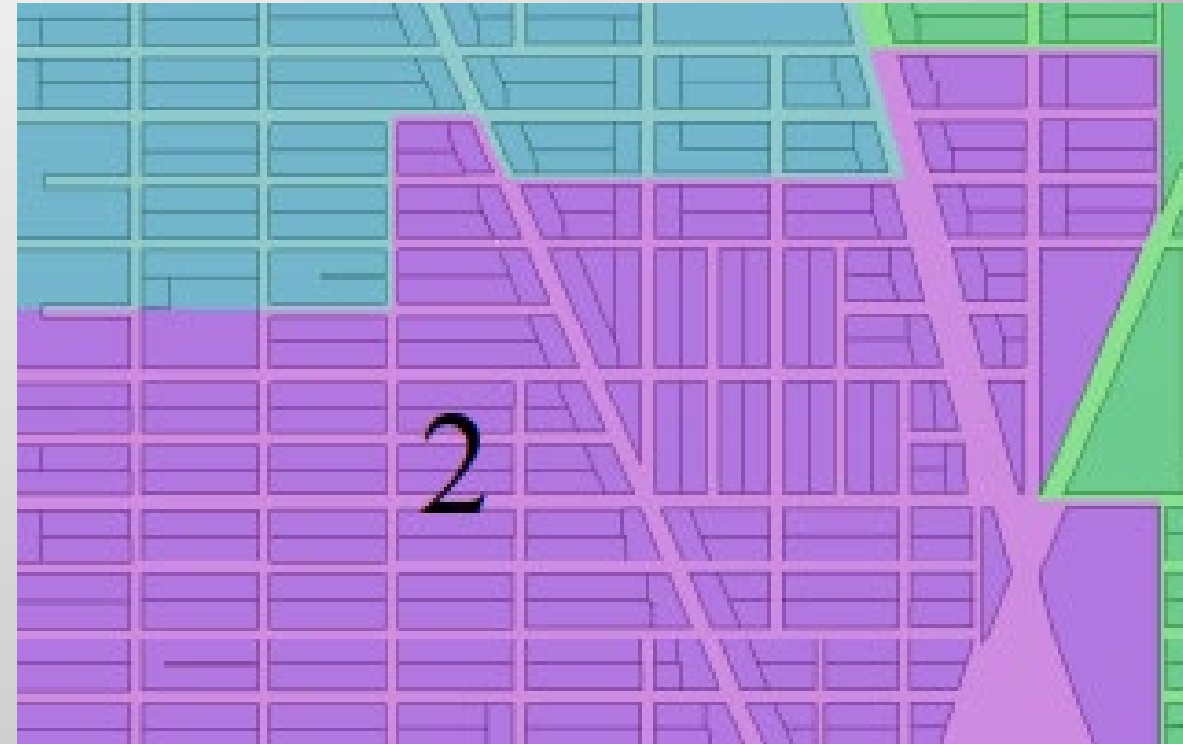

Berwyn Police Officers were dispatched to the 2400 block of Des Plaines Ave., North Riverside, IL where North Riverside Police Officers reported being on scene with both parties that were just involved in a hit-and-run that occurred in Berwyn. Responding officers met with the female victim who related she observed the male subject strike her vehicle on the 6800 block of 26th Street and then proceeded to drive away. The victim further related that she followed the offender to North Riverside. The offender was placed into custody without incident and transported to the Berwyn Police Department for further investigation. Officers recovered one (1) rifle from the front passenger seat of the offender's vehicle. A check of the offender's name revealed his FOID card was suspended. The offender was subsequently charged accordingly. Case closed by arrest.

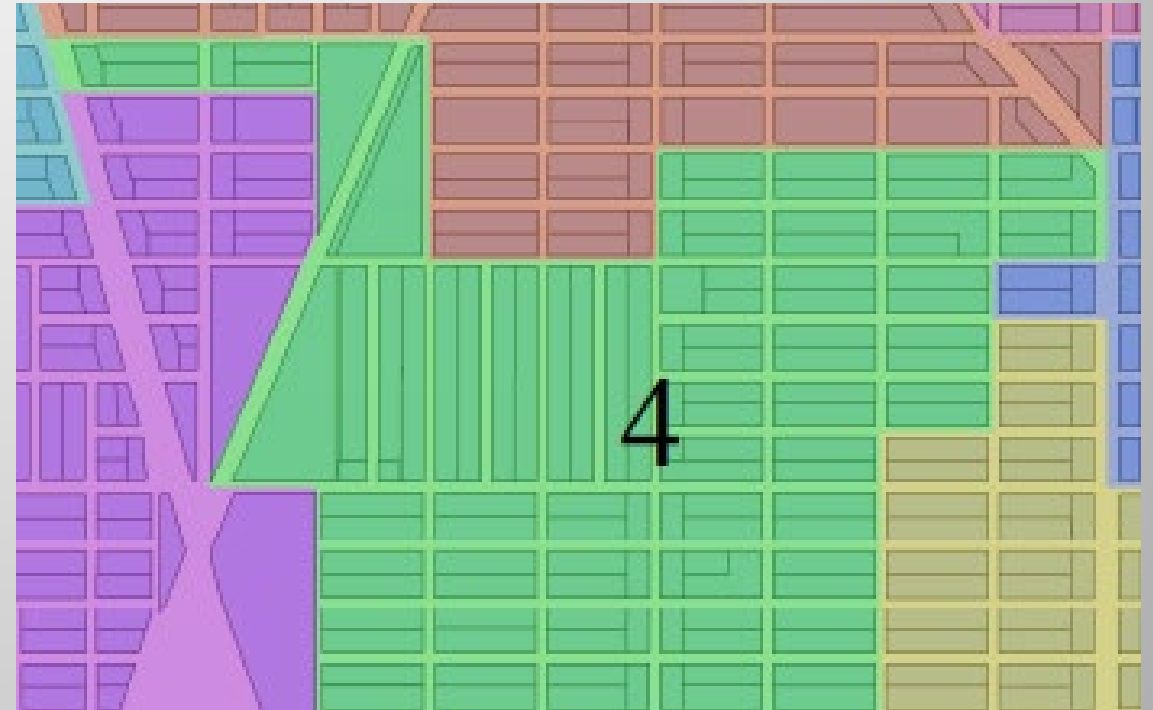

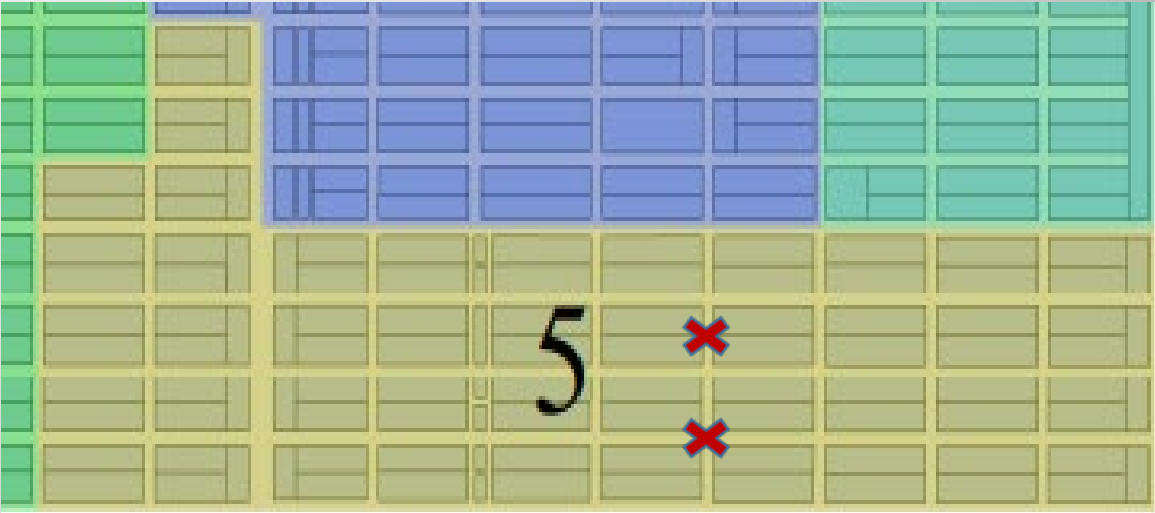
Officers conducted a traffic stop near 16th St./Harvey Ave. During the traffic stop, officers asked all four (4) occupants to step out of the vehicle. All of the occupants became irate and refused to exit the vehicle for approximately 20 minutes. Additional subjects arrived on scene and identified themselves as family members of the occupants. Said subjects became aggressive with officers and attempted to gain entry into the curbed vehicle. Ultimately, all four (4) subjects were removed from the vehicle, placed into custody, and transported to the Berwyn Police Department. Officers recovered one (1) loaded handgun and 5.3g of Cannabis from inside the vehicle. All subjects were charged accordingly. Case closed by arrest.
