



SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 4/24/2023

Unwanted Subject/Disorderly Conduct — 4/29/2023 Windsor Café (6834 W. Windsor) — 12:48a.m.

Officers responded to a call from an employee at Windsor Café reporting a person in the business that has caused problems in the past and is not wanted there. Upon arrival, officers learned that the male subject had left the business prior to their arrival. A check of the immediate area revealed said male subject in the alley behind the business. Officers observed the subject to be highly intoxicated and unable to care for himself. The subject was subsequently transported to BPD and issued an LO citation for Disorderly Conduct-Public Intoxication in a Public Space. Case closed by arrest.

Battery/Brawl — 4/30/2023 Junior's Bar (7011 W. Ogden) — 1:16a.m.

Units responded to a call from the bartender at Junior's Bar reporting a fight between approximately ten (10) subjects in the establishment. Upon arrival, there was no active fight and two (2) battery victims were located outside, in front of the bar. The male battery victim was highly intoxicated and refused to cooperate. The female victim advised that the male victim was her brother. The female victim stated that she was in the bathroom with her brother's girlfriend and when she opened the door to exit she was punched in the face by an unknown male subject. Her brother then stepped in to protect her and was also punched in the face causing his nose to bleed. A melee began and security stepped in to break it up. The victim was unable to identity the male offenders. The female victim further related that she did not wish to sign any complaints and refused to cooperate any further with the police.




SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 4/24/2023

Vehicular Hijacking — 4/24/2023 3500 block of Highland — 10:09a.m.

Berwyn Police responded to the 3500 block of Highland for a report of a Vehicular Hijacking that had just occurred. The victim is an Uber driver who related he was dispatched to pick up a fare at 3528 Highland (Note: address does not exist) The victim further related that upon arriving, four (4) Male Black subjects (Young Adults/Possibly Juveniles) approached and entered the victim's vehicle (occupying both the front and back seat). The victim (Uber Driver) briefly exited his vehicle to place an item in the trunk and during this time the offenders (passengers) stole his vehicle. The offenders were last seen traveling Westbound on 36th Street from Highland. The victim's cell phone was later recovered on the street at 36th Street/Cuyler. This investigation is ongoing.





SIGNIFICANT INCIDENTS IN 3RD WARD

FOR WEEK OF 4/24/2023

Aggravated Assault x2 Aggravated Resisting/Obstructing Arrest — 4/27/2023 Proksa Park (3001 W. Wisconsin Ave.) — 6:03p.m.

Berwyn Police responded to a report of a suspicious subject near the washrooms. The responding officer approached the male subject on the park bench and conducted a field interview. Said male subject immediately displayed aggressive behavior. Assistance from additional units was requested. The male subject brandished a metal pole approximately 4 feet long and started swinging it in the direction of the officers. The offender repeatedly disobeyed the officers' commands. One of the responding officers subsequently deployed his taser, which was not effective, and then followed up with a second taser deployment which was effective. The offender was taken into custody. BFD was requested to transport the subject to Mac Neal Hospital for medical evaluation under prisoner watch. The offender was released a short time later and transported to the Berwyn Police Department for processing. The offender was subsequently charged with two (2) felony counts of Aggravated Assault and one (1) felony count of Aggravated Resisting/Obstructing Arrest. Case closed by arrest.

Stolen Motor Vehicle — 4/30/2023 Outta Space Bar (6840 W. 32nd Street) — 12:02a.m.

Officers responded to a report of a stolen motor vehicle. The victim further related that his vehicle (Hyundai) was stolen from the area of 32nd Street/Grove while he was at Outta Space Bar. Officers located broken glass on the ground where the car was last parked. The vehicle was entered into LEADS as stolen.

At approximately 3:30a.m. Cicero PD advised that they located the vehicle in their town and it was towed to their tow yard. Vehicle owner advised. This investigation is ongoing.





Catalytic Converter Theft — 4/24/2023 16th Street/Euclid — 9:00a.m.

Victim reported he parked his vehicle at 8:00p.m. on 4/23/2023 and when he returned the next morning at 9:00a.m. on 4/24/2023 he discovered the Catalytic Converter had been removed from his vehicle. This investigation is ongoing.







SIGNIFICANT INCIDENTS IN 7TH WARD

FOR WEEK OF 4/24/2023

Recovered Stolen Vehicle — 4/29/2023 2100 block of Grove Ave. — 1:19a.m.

Berwyn Police were flagged down by a citizen with concerns about a vehicle parked in the roadway at 21st Street/Grove. Units located a white in color Hyundai parked at the intersection partially in the street. A check through LEADS showed the vehicle registered out of Chicago. Upon checking the vehicle, officers observed a broken rear window and damage to the steering column consistent with a stolen vehicle that had not been reported yet. Berwyn Dispatch was asked to contact Chicago PD to make contact with the registered owner. CPD made contact and confirmed the vehicle was stolen out of Chicago. The registered owner was advised that the vehicle was towed to Metro Towing for safe keeping. This incident was turned over to CPD for further investigation.

Aggravated Assault with a Firearm — 4/29/2023 Guadalajara (6814 W. Cermak) — 8:46p.m.

Officers responded to Guadalajara for a call of a man who pointed a handgun at a security guard. The security guard stated a Male Hispanic subject (long black hair, red hat, gray sweat shirt) pointed a handgun at him out of the driver's side window of a black in color SUV. The offender then sped off from the area and was last seen traveling Northbound on Oak Park Avenue. Officers learned that the incident stemmed from a disturbance in the vacin (behind Guadalajara) after the offender couldn't get his pickup truck around a vehicle the security guard was standing next to. The security guard stated he wishes to pursue complaints and can identify the offender. (Note: No shots were fired during this incident and there were no reported injuries.) This investigation is ongoing.

SIGNIFICANT INCIDENTS IN 7TH WARD

FOR WEEK OF 4/24/2023

Aggravated Discharge of a Firearm — 4/30/2023 Guadalajara (6814 W. Cermak) — 1:41a.m.

Officers responded to a call of shots fired from the Vacin Fairway area behind Guadalajara Bar. The caller advised Berwyn Dispatch that he heard three (3) shots fired. Responding Officers met with Guadalajara security staff members who advised they located two (2) casings in the alley of the 2100 block of Oak Park Ave. Officers relocated to that area and a 3rd casing was found. Guadalajara security further advised a black in color sedan occupied by four (4) subjects was involved in the incident which left the area in an unknown direction. This investigation is ongoing.



Catalytic Converter Theft — 4/24/2023 East Ave/15th Street — 6:42a.m.

Officers responded to a report of a theft from a motor vehicle from the area of East Ave/15th Street. Upon arrival, responding officers met with the reporting party who related while at home, he observed a grey in color vehicle with an unknown dealer registration park in the middle of the street. The witness further related they observed a Male Black subject driving said vehicle and a second Male Black subject in the front passenger seat. The passenger exited the vehicle and proceeded to remove the Catalytic Converter from a silver in color Honda Pilot that was parked on 15th Street. After retrieving said catalytic converter, the passenger returned to their vehicle and fled the seen Eastbound on 15th Street. This investigation is ongoing.

Shots Fired/Unlawful Possession of a Firearm — 4/24/2023 15th Street/Oak Park — 1:38a.m.

While on routine patrol in the area of 1400 block of Wesley Ave, an officer reported hearing multiple gunshots coming from the West of his location. Units responded to the area and began checking for any victims or evidence. While checking the area. Berwyn Dispatch received a call from a subject who reported that while at DiNicco's Pizza on Roosevelt Rd he overheard a male subject state he was shot at. Said male subject was last seen by the witness retrieving something from a parked black in color sedan before leaving DiNicco's parking lot with an unknown female subject in a different vehicle. The witness pointed out the vehicle to officers on scene. Officers observed a spent casing on the front driver's side floorboard as well as what appeard to be blood on the back seat of the vehicle. Access was made into the vehicle for the purpose of checking the trunk for any victims. Once the trunk was found clear of any victims, the vehicle was closed and towed to the Berwyn Police Station pending further investigation. While checking the area, officers located three (3) spent 9mm casings at 15th Street/Oak Park Ave. which were photographed and recovered. A concerned neighbor on the 1400 block of Oak Park Ave. made contact with officers on scene and advised he heard three (3) shots followed by at least one (1) vehicle drive away Northbound from 15th Street/Oak Park Ave. No further description of the vehicle(s) or subject(s) involved was given. No reported victims. Pursuant to an investigation, a male subject was taken into custody and subsequently charged for Unlawful Possession of Ammunition without a FOID. Case closed by arrest.
