





Criminal Trespass to Vehicle — 6/05/2023 3400 block of Harvey — 2:49a.m.

Berwyn dispatch received a report of three (3) Male Black subjects, wearing masks and hoodies, checking vehicle door handles on the 3400 block of Harvey. Responding officers met with the victim who stated one of the subjects entered his vehicle. The subjects fled the scene prior to police arrival. Officers located three (3) vehicles that had been entered by the offenders. Only one (1) of the three victims (vehicle owners) wishes to sign a complaint. This investigation is ongoing.

Aggravated Vehicular Hijacking/Aggravated Robbery — 6/05/2023 3500 block of Lombard — 3:58a.m.

Officers responded to a report of a vehicular hijacking on the 3500 block of Lombard. The victim stated he was in his garage, and in the process of entering his vehicle, when he was confronted by three (3) Male Black subjects. The victim further described the offenders as approximately 18 years of age, wearing masks and hoodies. The offender(s) struck the victim in the face, took money from his pockets, and then fled the scene in the victim's vehicle. The vehicle was entered into LEADS as stolen. At approximately 7a.m. that day, the victim notified Berwyn Police that he located his vehicle parked on the 3700 block of Harvey. The vehicle was returned to the owner. The investigation was subsequently closed due to the recovery of the vehicle and the owner's refusal to sign a complaint.






Burglary from Motor Vehicle — 6/06/2023 1400 block of Harvey — 5:16a.m.


Victim stated his vehicle was burglarized overnight on the 1400 block of Harvey. Responding officers determined forced entry was made to the victim's garage where the vehicle was parked. The victim related that approximately \$10,00 worth of tools were missing from his vehicle. This investigation is ongoing.

Reckless Discharge of a Firearm/Unlawful Use of a Weapon 1300 block of Highland — 6/08/2023 — 10:45p.m.

Units responded to a call of a shot fired by the downstairs neighbor. Upon arrival, units made contact with a subject in the backyard of the residence. Responding officers met with the reporting party who shared surveillance with officers that captured said shot being fired. Upon reviewing the video, officers confirmed that the subject in the backyard was the offender. The subject was subsequently taken into custody. Officers conducted a check of the area which revealed a handgun just North of the residence. The offender admitted to police that he fired one shot in the air that night. The offender does not have a valid FOID or CCL. The offender was charged with one (1) felony count of Reckless Discharge of a Firearm and two (2) felony counts of Unlawful Use of a Weapon. Case closed by arrest.

Aggravated Unlawful Use of a Weapon (Juvenile) — 6/09/2023 Lombard/19th Street — 5:32p.m.

Officers responded to a call of shots fired. The initial caller stated he heard a gunshot and shortly after observed a Male Black subject with dreadlocks running from the area while holding a handgun. Officers were further advised that a second Male Black subject was involved and wore a navy blue sweatshirt and sweatpants. Officers conducted a check of the area for subjects matching the reported descriptions. Officers observed the two males and attempted to make contact. Both subjects immediately fled on foot. Officers detained one of the subjects and later identified him as a 16 year old Juvenile. Officers did not locate the second subject at that time. A search of the area yielded two loaded handguns. A victim to the original shooting was not located nor was a shell casing found. The Juvenile was taken into custody and turned over to Youth Investigations. The Juvenile subject was subsequently charged with Aggravated Unlawful Use of a Weapon and transported to the Juvenile detention facility. Case closed by arrest.







