



#### SIGNIFICANT INCIDENTS IN 1ST WARD

#### FOR WEEK OF 6/19/2023

Disturbance — 6/25/2023 Windsor Café (6834 Windsor) — 9:30p.m.

Officers responded to a report of a disturbance at Windsor Café. Upon arrival, officers were informed that the offender (Male Hispanic subject with face tattoos) left the scene prior to police arrival. Bar staff related that the offender was throwing chairs inside of the establishment. One witness further related that the offender became aggressive and threw a construction horse at the front window but did not cause any damage. This investigation is ongoing.






#### SIGNIFICANT INCIDENTS IN 2<sup>ND</sup> WARD

Officers responded to a report of a burglary to a motor vehicle. Responding officers met with the victim who reported he heard his vehicle's audible alarm going off. The victim further related that he then went outside to the vehicle and observed the rear window to be shattered and entry made to the vehicle. The victim stated his power tools were stolen. Officers conducted a check of the area which was met with negative results for any offender(s) or missing property. This investigation is ongoing.

Aggravated Discharge of a Firearm — 6/24/2023 The Garage (3202 Grove Ave.) — 12:02a.m.

Units responded to The Garage in reference to a fight/disturbance. Upon arrival, all parties involved in the fight appeared to have fled the scene. Witnesses related that there was a group of individuals outside the business arguing near the parking lot and gunfire erupted. Officers canvassed the area and found multiple shell casings the street as well as several vehicles in the parking lot that were damaged from gunfire. The search was met with negative results for any victims. This investigation is ongoing.


Stolen Auto — 6/21/2023 1800 block of Cuyler — 5:17a.m.

Victim reported his vehicle stolen. The victim stated that he last saw his vehicle at 8:00p.m. on 6/20/23 and discovered it missing at 5:10a.m. on 6/21/2023. Officers did not observe any broken glass in the area where said vehicle was previously parked. This investigation is ongoing.

House Fires — 6/24/2023 2200 block of Harvey — 5:36p.m.

Berwyn Police Officers responded to a report of a house fire on the 2200 block of Harvey. Responding Officers Acosta and Swiecionis were the first to arrive on scene at which time they observed a home fully engulfed in flames. A concerned neighbor notified officers that an elderly female was still inside of the affected residence. Due to the severity of the fire and the importance of saving time, Officers Acosta and Swiecionis made forced entry into the home and located the 85 year old female subject in the front room. Officers successfully removed the female from the house fire without incident. The elderly female victim, did not suffer any injuries or smoke inhalation. Officers noted that approximately one minute after they rescued the female from the front room of her home, that same room became fully engulfed in flames. Additional police officers responded to the tragic scene and immediately began knocking on the surrounding residences and evacuated as many occupants as possible. The fire grew at a rapid rate and spread to three neighboring homes. The Berwyn Fire Department arrived on scene, let out their lines, protected the exposed residences, and were ultimately able to extinguish the fires. Additional assistance was received from neighboring Fire Departments. During the course of the fire, the front lawn of one of the homes became engulfed in flames and damaged a vehicle that was parked nearby. Several residents were displaced from their homes due to the fire. All occupants of the four homes escaped without injury. The Red Cross arrived on scene to immediately begin working on providing temporary placement for all of the victims. The cause of the fire is still unknown and is pending an investigation.


# Attempted Stolen Auto (Kia) (Juvenile) — 6/21/2023 1600 block of Gunderson — 8:16p.m.

Berwyn Dispatch received a call of four (4) Male Black subjects attempting to steal a white in color Kia. As responding officers approached the area, the offenders fled on foot. A foot pursuit ensued and all four (4) subjects were detained within a several block radius. Burglary tools were located in the stolen vehicle along with several locations within the flight of the offenders. All four subjects were taken into custody and transported to the station. Following an investigation by Juvenile Detectives, all four (4) juvenile subjects were charged with one (1) felony count each of the following: Attempt Burglary (with damage); Possession of Burglary Tools. Case closed by arrest.

### Criminal Trespass/Warrant (x3) — 6/25/2023 2100 block of Oak Park Ave. — 2:31a.m.

Berwyn Dispatch received a call from a female subject who related she came home and found an unknown male subject, passed out in her apartment. Responding officers arrived and found the subject on the floor of the apartment passed out, heavily intoxicated. The subject was taken into custody and transported to the Berwyn Police Department where it was learned he had three (3) active warrants from surrounding municipalities. The subject was subsequently charged accordingly. Case closed by arrest.


Attempted Stolen Auto (Hyundai) — 6/21/2023 1200 block of Scoville — 10:40p.m.
