





Officers placed the offender in custody without incident and transported him to the Berwyn Police Department where he was charged accordingly. Case closed by arrest.

The offenders then re-entered said vehicle driven by a fourth Male Black subject and fled the scene prior to officer arrival. There were no reported injuries. Note: the victim advised officers that the incident occurred approximately twenty (20) minutes prior to calling 9-1-1. This investigation is ongoing.




