





Officers met with witnesses on scene who advised seeing a white in color vehicle with blue tinted headlights flee the area after the shots were fired. Shortly after, Riverside PD advised they conducted a traffic stop on a vehicle matching the given description. Riverside PD futher advised that they observed spent shell casings and one (1) firearm in plain view inside the vehicle. Two (2) subjects were subsequently detained by Riverside PD and transported to Berwyn PD for further investigation. 
#### Armed Robbery – 8/25/2025 Jardin Restaurant (6431 Cermak Rd.) – 12:06a.m. (Delayed Report)


Shots Fired – 8/26/2025 1600 block of Lombard Ave. – 1:01a.m.




#### Attempt Robbery – 8/26/2025 Walgreens (7113 Cermak Rd.) – 5:43p.m. (Delayed Report)
