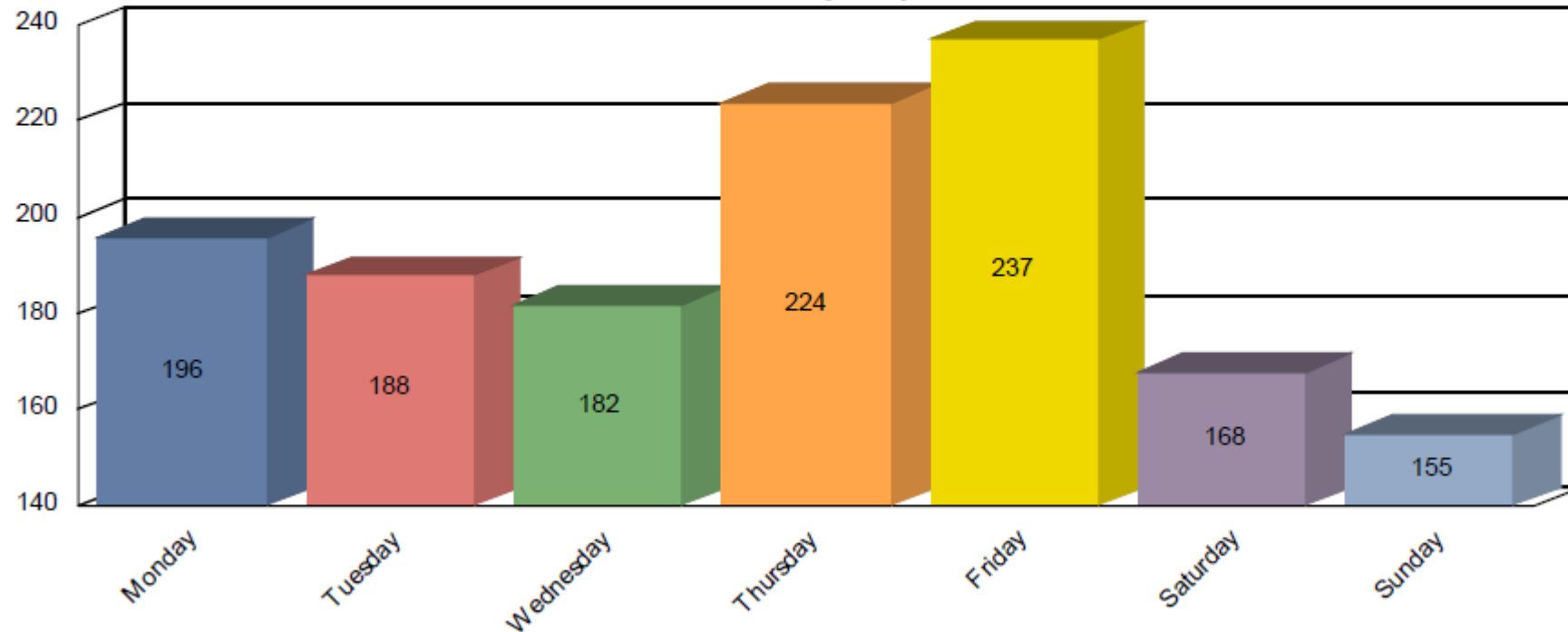

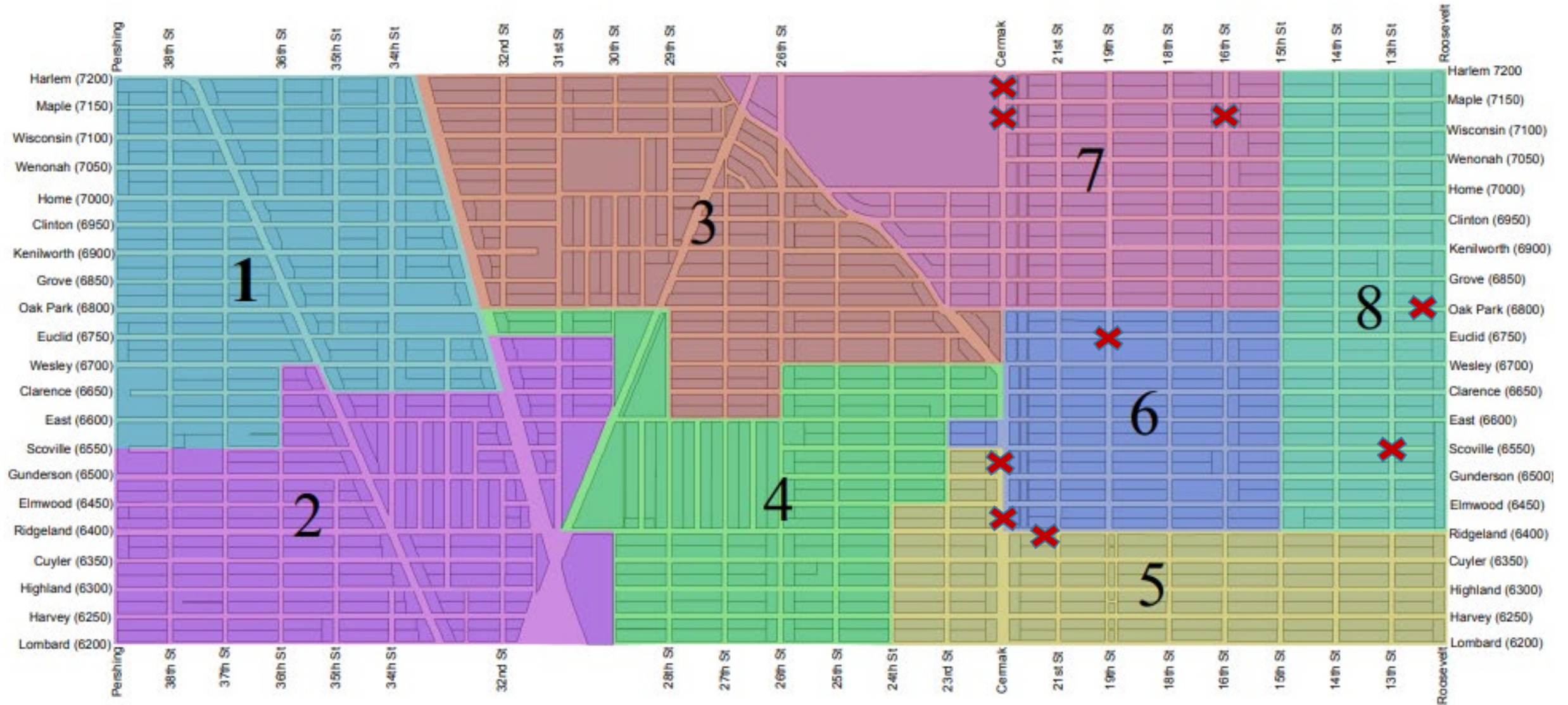

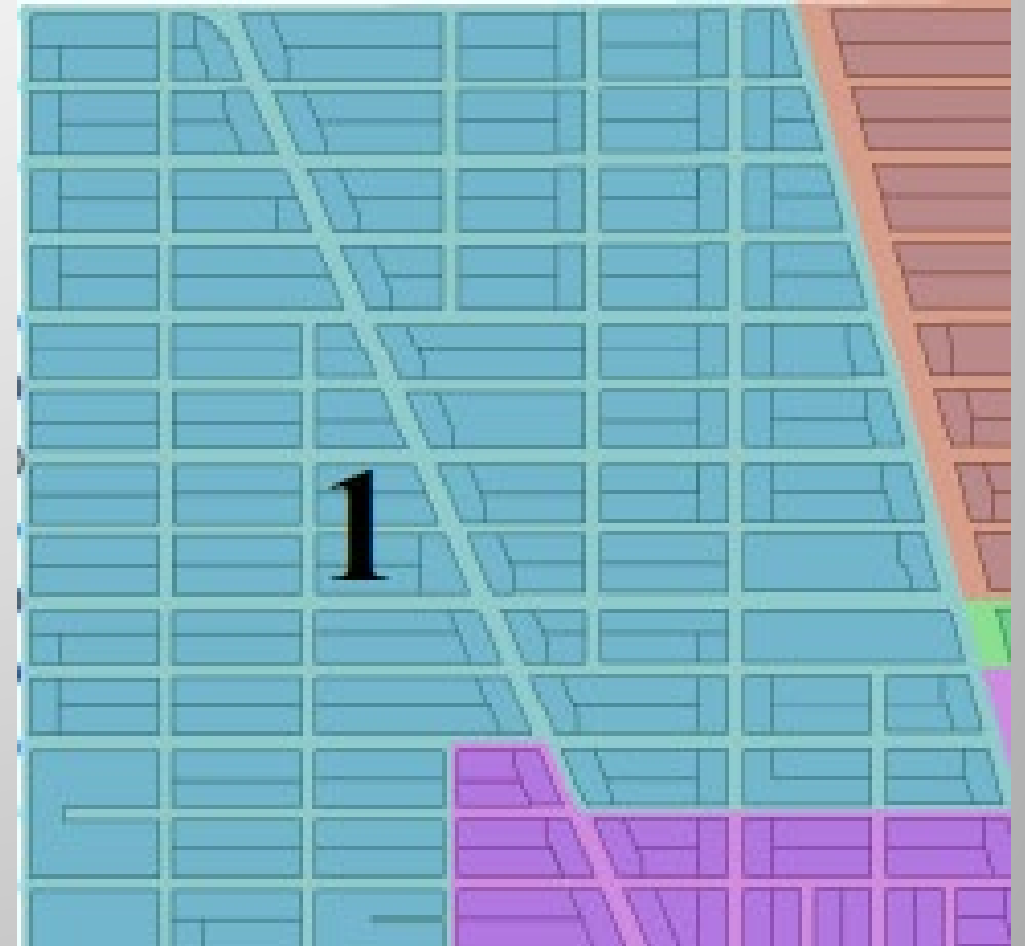

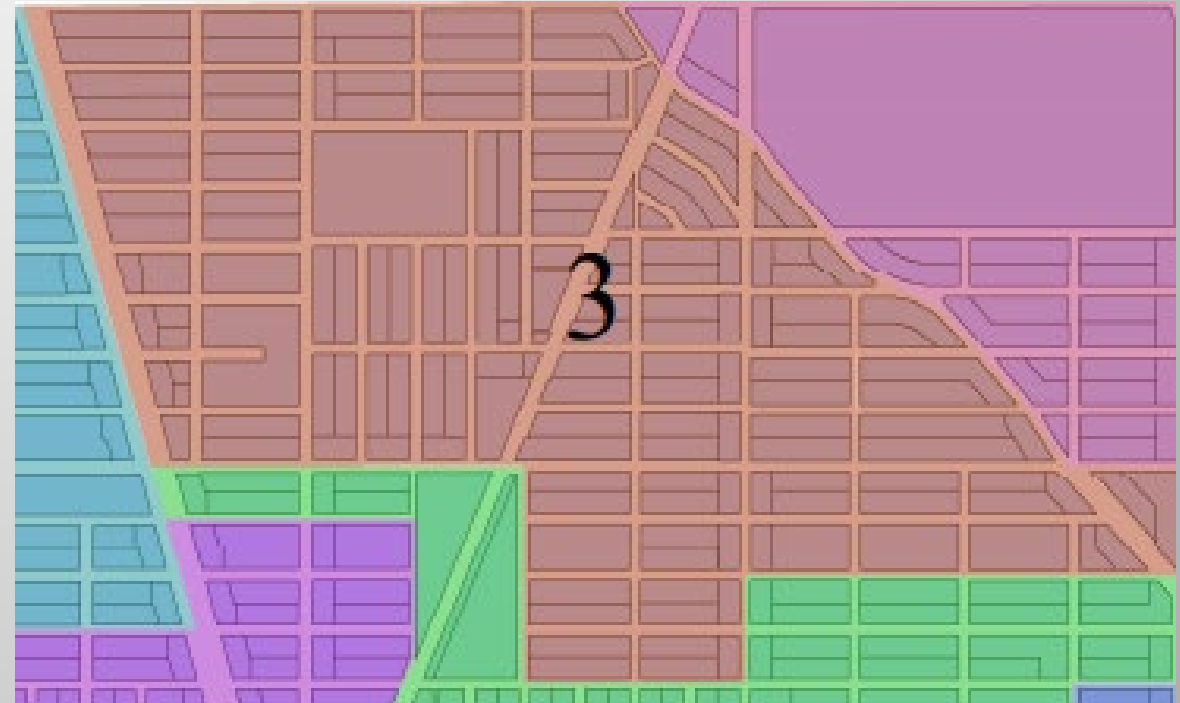

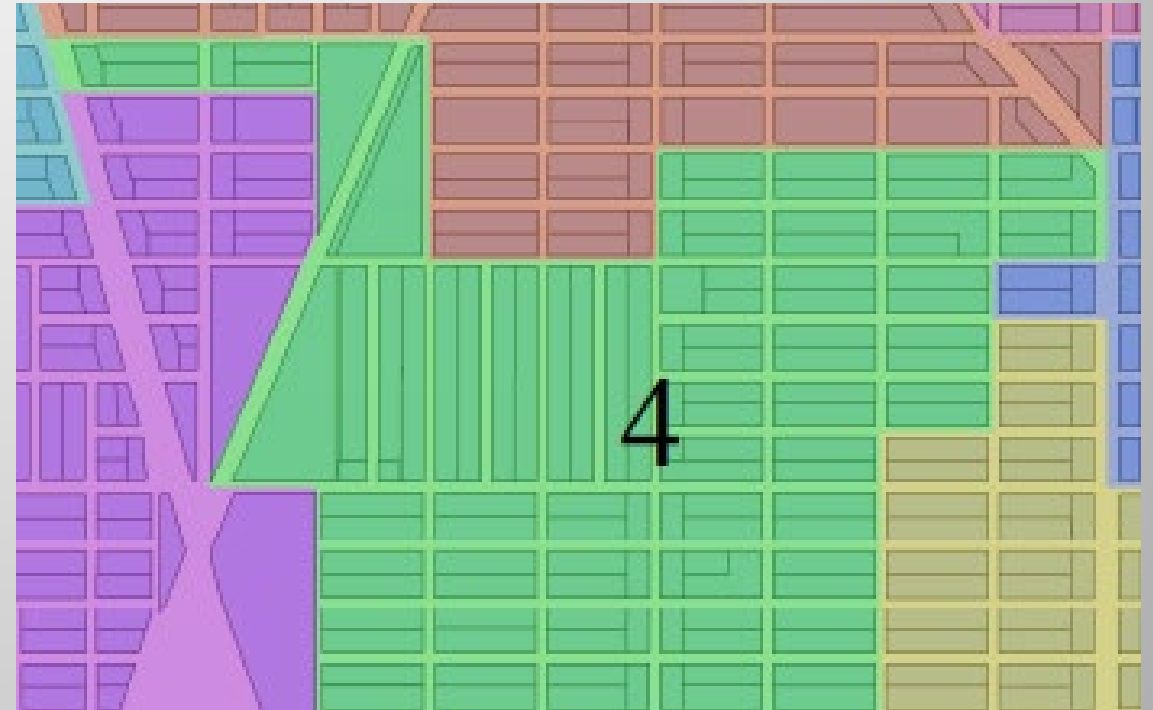

**Criminal Trespass to Motor Vehicle/Criminal Damage to Property/Resisting and Obstructing Arrest — 10/24/2023
2100 block of Ridgeland — 1:03a.m.**

While units were on scene for a Theft incident on the 6400 block of Cermak Rd, Berwyn Dispatch received a call of a car that had just been broken into by a male subject displaying a knife. Responding officers met with the victim who related her vehicle was parked on the street when an unknown male subject broke the windows in an effort to gain entry into the vehicle. The offender, who was still on scene, was subsequently taken into custody. Officers recovered the offender's knife on the ground as pointed out by the victim. Upon further investigation, it was determined that the offender was the same subject wanted for the Theft incident that had just occurred on Cermak. The offender was taken into custody and transported to the Berwyn Police Department. Officers recovered a plastic baggie containing a white chunky and powdery substance (suspect Cocaine) from the offender's property. Officers also discovered that said offender had four (4) existing warrants. The offender was subsequently charged accordingly. Case closed by arrest.

SIGNIFICANT INCIDENTS IN 6TH WARD

Theft — 10/24/2023

Old Time's Sake (6428 W. Cermak Rd) — 12:41a.m.

Units responded to Old Time's Sake for reports of a theft and a man with a knife. Upon arrival, it was learned that a male subject stole the victim's phone from the bar after the victim went home. The victim returned to the bar to retrieve his phone and a witness advised him that the male subject outside in front of the bar took his phone. The victim exited the bar and requested his phone back. The male subject then displayed a knife towards the victim and asked him if he wanted "this" (inferring to the knife) or a bullet that the offender placed in the victim's hand. The offender immediately left the scene on foot. The victim did not report any injuries. While still on scene with the victim, Berwyn Dispatch received a call of a suspicious person on the 2100 block of Ridgeland. Responding officers located said subject who matched the description given by the victim on scene at Old Time's Sake. The offender was subsequently taken into custody and transported to the Berwyn Police Department where he was subsequently charged with one misdemeanor (1) count of Theft. Case closed by arrest.

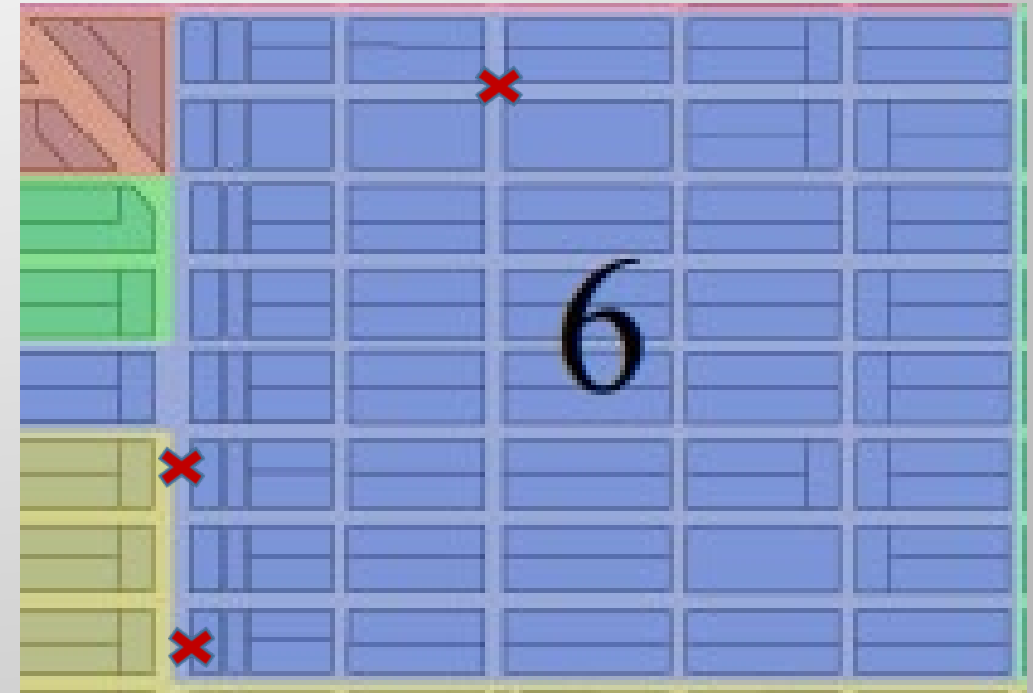
Robbery — 10/27/2023

1900 block of Euclid — 12:38a.m.

Units responded to the 1900 block of Euclid for a report of a female victim who stated she had just been robbed while walking her dog in the alley. Responding officers met with the victim who related she was approached by an unknown Male Hispanic subject on a bicycle, wearing a mask, glasses, and a black in color jacket with black pants. The victim further related that the subject flashed gang signs, implied he had a weapon, and took the victim's cell phone from her person prior to fleeing the scene on his bicycle. This investigation is ongoing.

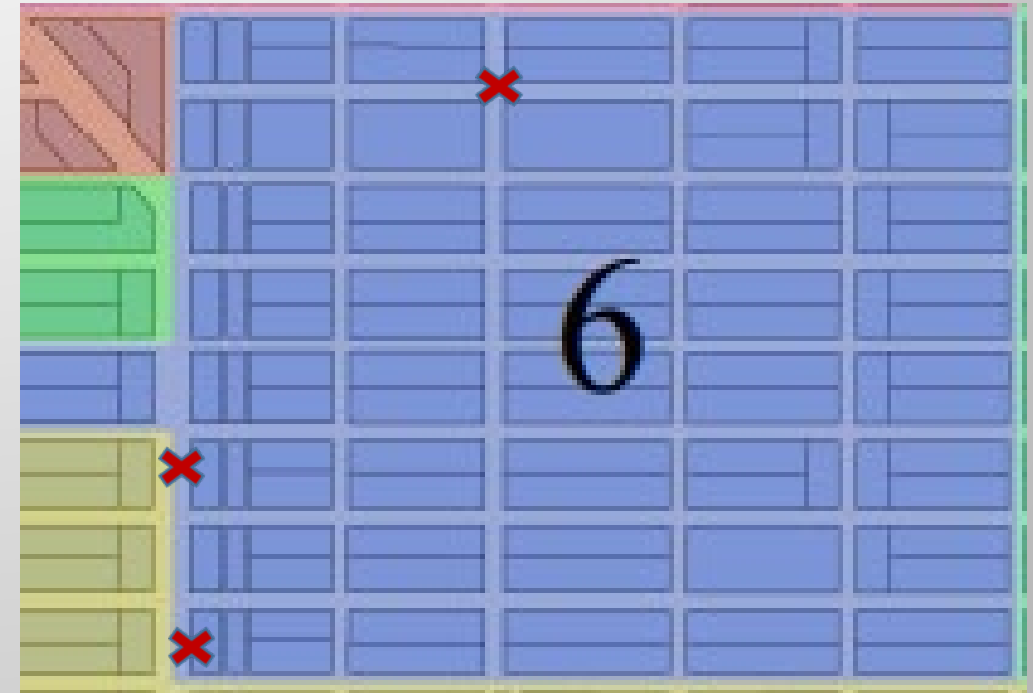
Robbery — 10/28/2023

Las Islas Bar & Grill (6516 W. Cermak Rd.) — 5:30p.m.

Officers responded to Las Islas Bar & Grill for a call of a robbery. Responding officers made contact with the victim who stated he was involved in a verbal altercation with two (2) male subjects who were known to him. The victim further related that the altercation escalated and the offender struck him multiple times and took his cell phone. The offenders left the scene prior to officer arrival. Pursuant to an investigation the subject was taken into custody on 10/31/2023 and subsequently charged. Case closed by arrest.

Attempted Robbery — 10/24/2023

Starbucks (7124 W. Cermak Rd.) — 5:54p.m.

Officers responded to a report of an Attempted Robbery that had just occurred in the Starbucks parking lot. The victim stated that he was walking to his vehicle when an unknown Male Black subject with short black hair, light beard, wearing a black shirt and blue jeans attempted to snatch his keys from him. The offender was unsuccessful and the victim ran back into Starbucks. Officers canvassed the area and were met with negative results for the offender. This investigation is ongoing.

Criminal Damage to Property/Fight (Juvenile Incident) — 10/27/2023

McDonald's (7181 W. Cermak Rd.) — 3:36p.m.

Officers responded to the McDonald's (Harlem/Cermak) for a call of approximately forty (40) juveniles who were fighting inside the restaurant and broke tables. Upon arrival, officers broke up the fight and identified the offenders responsible for breaking tables. One of the juveniles fled the scene on foot. After a short foot pursuit through Cermak Plaza, officers took said subject into custody. Two (2) additional juveniles were taken into custody and all were transported to the police department where they were charged accordingly. Case closed by arrest.

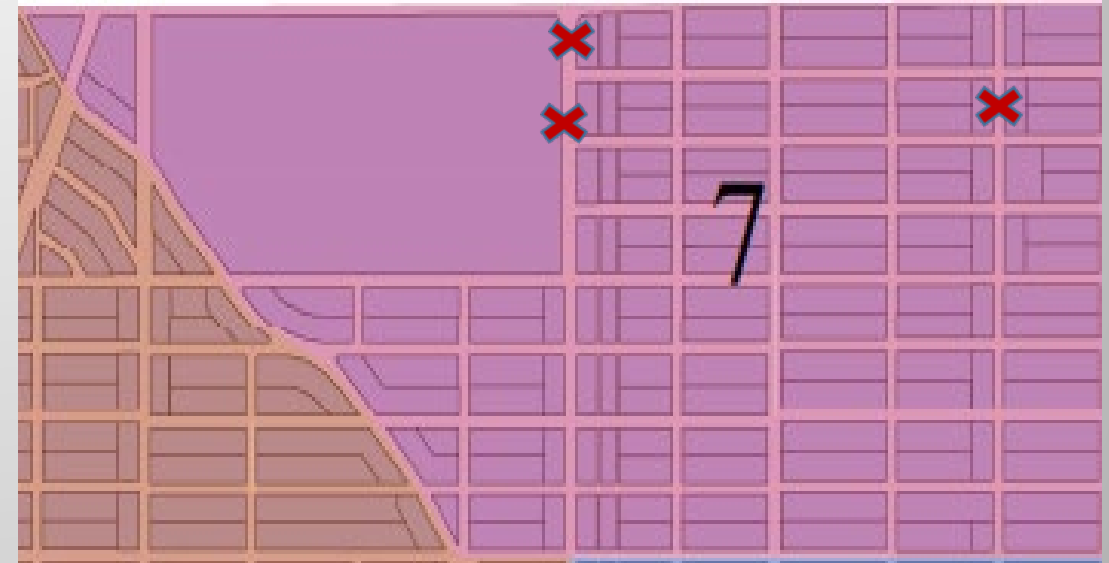
Unwanted Subject/In-State Warrants (Retail Theft (x2) and Escape/Violate Electronic Monitoring) — 10/24/2023

Officers responded to the 7100 block of 16th Street for a report of an unwanted male subject who had been told to leave the property on multiple occasions. Responding officers made contact with the subject who related to the officers that he believed he had an outstanding warrant. The subject was taken into custody without incident and charged accordingly. Case closed by arrest.

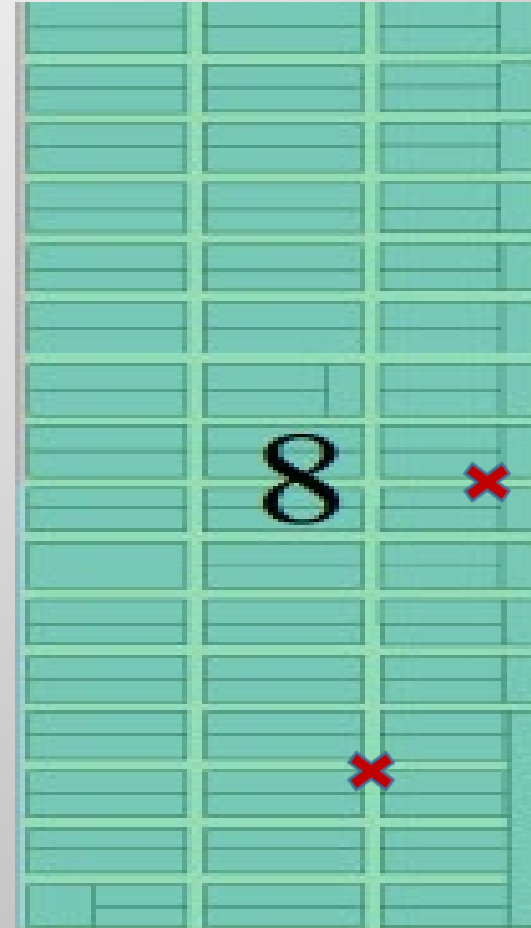
Criminal Damage to Property — 10/24/2023 **1200 block of Oak Park Ave. — 5:15a.m.**

Officers responded to the 1200 block of Oak Park Ave. for a report of an attempted Catalytic Converter Theft. Responding officers met with the victim who related that an unknown subject attempted to steal the Catalytic Converter off of his vehicle. The victim further advised that he heard a “sawing” noise at which time he observed the offender underneath his vehicle. The victim chased the offender off before he was able to completely saw off the Catalytic Converter. The offender was described as a male subject dressed in all black clothing. The offender was last seen entering the passenger side of a black in color sedan which fled Northbound on the 1200 block of Oak Park Ave. Officers observed a fresh saw cut underneath the vehicle. No parts were missing from the vehicle. This investigation is ongoing.

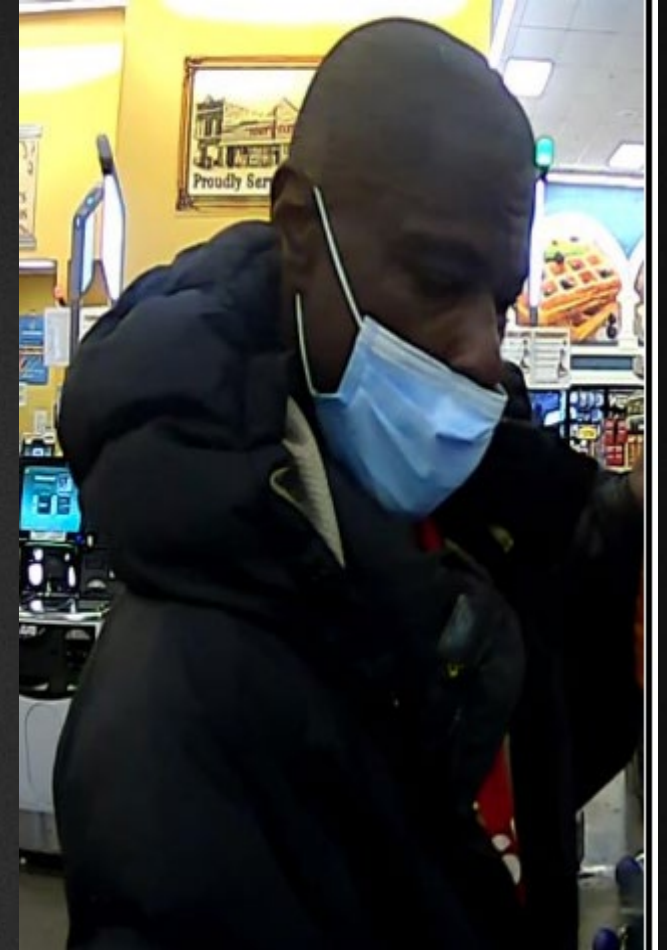

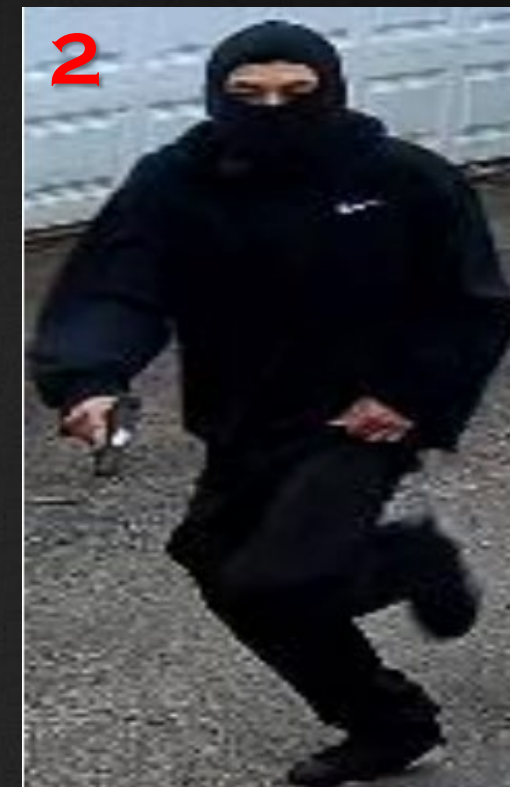

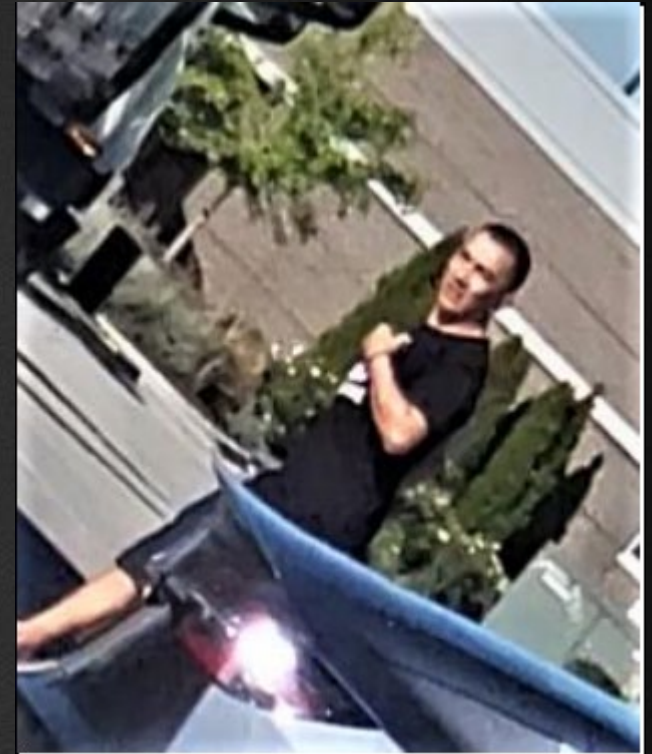
