



SIGNIFICANT INCIDENTS IN 3RD WARD

One (1) female and the sole male subject were taken into custody without incident and transported to the Berwyn Police Department. Both subjects were charged accordingly. Case closed by arrest.







SIGNIFICANT INCIDENTS IN 4TH WARD

Aggravated Unlawful Use of a Weapon — 11/03/2023 2500 block of Gunderson — 9:09p.m.

Officers conducted a traffic stop on the 2500 block of Gunderson. Upon making contact with the driver, the officers observed an open alcoholic beverage in the front cup holder. Officers asked the driver to step out of the vehicle and if he had any weapons on his person. The male subject (driver) advised police that there was one (1) handgun next to the driver's seat. (Note: the male subject has a valid FOID but no CCL). Officers recovered the handgun and ammunition. A search of the vehicle also revealed a plastic bag containing a green plant like substance (suspect Cannabis-17g) and a glass jar containing a green plant like substance (suspect Cannabis-11g). The male subject was taken into custody and transported to the Berwyn Police Department where he was charged accordingly. Case closed by arrest.









Armed Robbery — 11/02/2023 Ram Liquors (6515 W. Cermak Rd.) — 8:45p.m.

Units responded to a report of an armed robbery at Ram Liquors in which three (3) Male Black subjects, all armed with handguns, entered the business and demanded cash from the register and personal belongings from all victims. The victims' related that one (1) of the offenders fired one (1) shot off to the side in an effort to scare the victims. There were no reported injuries. Officers located one (1) shell casing on scene. Responding officers met with witnesses who related they observed the three (3) offenders flee the store and run Eastbound on Cermak to the end of the block where they entered a white in color SUV which was parked on Cermak prior to the incident.(Note: officers conducted a search of the license plate information provided by witnesses and discovered the vehicle had been reported stolen).

Approximately 2 hours later, Berwyn Police Officers learned that Forest Park PD had the offending white in color SUV and its occupants in custody for incidents that had just occurred in Forest Park. Berwyn officers traveled to Forest Park PD where they interviewed the offenders who confessed to committing the armed robbery at Ram Liquors earlier that evening. Two (2) male subjects were each subsequently charged with one (1) felony count of Armed Robbery. Case closed by arrest.






SIGNIFICANT INCIDENTS IN 5th Ward

Attempted Catalytic Converter Theft/Aggravated Assault 1500 block of Harvey — 11/04/2023 — 4:19a.m.

Berwyn Dispatch received a call reporting an attempted Catalytic Converter theft on the 1500 block of Harvey. Responding officers met with the victim who related they observed three (3) Male Black subjects (wearing all black clothing and ski masks) underneath his vehicle with a power tool, attempting to remove the Catalytic Converter. The victim further related that he ran outside to his vehicle and began yelling at the offenders at which time he observed two (2) of the offenders display handguns. The subjects fled in a dark in color sedan. This investigation is ongoing.







Officers responded to Laundry World in regards to a stolen auto. Upon arrival, officers met with the female victim, who related she was a patron at the facility when she dropped the keys to her vehicle on the floor. The victim further related that she observed an unknown male subject pick up the keys and proceed outside to the parking lot where they located the victim's vehicle. The offender entered the victim's vehicle and fled the scene Westbound on Cermak Rd. The vehicle was entered into LEADS as stolen. Within the hour of the incident, officers located the vehicle unoccupied at Cermak/Harlem Ave. in the rear of Cermak Plaza. The vehicle was removed from LEADS and the owner was notified. This investigation is ongoing.



Aggravated Battery to a Police Officer (x2) — 11/04/2023Roosevelt Rd/ Home Ave. — 1:52a.m.

While on patrol, an officer observed an SUV traveling Eastbound on Roosevelt Rd. (from Home Ave.) at a high rate of speed, endangering the safety of the public. The officer conducted a traffic stop on the vehicle and arrested the female driver for driving while under the influence. The subject was transported to the Berwyn Police Department for processing where she became uncooperative with the officers. The subject spat on two (2) officers and kicked one in the stomach. The subject was subsequently charged with two (2) felony counts of Aggravated Battery to a Police Officer, Reckless Driving, and DUI. Case closed by arrest.

Armed Robbery — 11/04/2023 Shell Gas Station (6405 W. Roosevelt Rd.) — 6:24p.m.

Officers responded to a call of an armed robbery that occurred approximately 40 minutes prior at the Shell Gas Station (Roosevelt/Ridgeland). The victim related he purchased items from inside the gas station and returned to his parked vehicle on Ridgeland. While sitting in his vehicle, the victim stated two (2) Male Black subjects approached vehicle, opened both the driver and passenger doors and robbed victim of his cash. The offenders then fled Westbound on bicycles through the Roosevelt alley. This investigation is ongoing.
