





Robbery — 12/08/2023 Walgreens (6800 W. Ogden Ave.)— 8:32p.m.

Officers responded to a report of a robbery at Walgreens. Officers met with the victim (store clerk) who related that a male subject went behind the registers and demanded money from the cashiers. 

Unlawful Use of a Weapon — 12/09/2023 1500 block of Cuyler — 1:51a.m.

Officers responded to the 1500 block of Cuyler for a report of a suspicious person inside of a parked vehicle who may be in possession of a firearm. Upon arrival, officers made contact with the male subject in his vehicle who related he is from out of state and was sleeping in his vehicle. Said subject admitted to having a firearm in his vehicle. The subject did not have a valid FOID or CCL. Officers placed the subject in custody and he was subsequently charged accordingly. Case closed by arrest.






SIGNIFICANT INCIDENTS IN 6TH WARD

FOR WEEK OF 12/04/2023

Manufacture/Delivery- Heroin — 12/08/2023 Chase Bank (6532 W. Cermak Rd.) — 3:49p.m.

Units responded to Chase Bank for a report of a male subject with a gun causing a disturbance. Upon arrival, officers met with the victim who related that the incident stemmed from a road rage incident over a handicap parking spot. The victim further related that while she was waiting to park, a Male White subject approached her vehicle from the passenger side door and begin swearing and threatening her. Said male stated he was going to shoot her and reached his arm inside the victim's vehicle and tried to strike her but she moved out of the way. The offender then re-entered his vehicle and fled Westbound on Cermak. Officers conducted a search of the area and located the offending vehicle in the Buffalo Wild Wings parking lot (7130 W. Cermak). Upon making contact with the driver (male subject), officers observed in plain view, a plastic sandwich bag filled with numerous smaller bags filled with a gray powdery substance (suspect heroin) sticking out of the subject's hoodie pocket. The suspect heroin was retrieved from the subject's pocket and the subject was detained. Officers also observed a large amount of cash fall to the ground from said subject's person as he was removed from the vehicle. It should be noted that officers also spoke with a second male subject on scene who related he was meeting there to purchase heroin from the other male subject (driver). Officers conducted a show up at which time the victim gave a positive identification to the driver (male subject) as the offender and he was subsequently taken into custody. The offender was then transported to the Berwyn Police Department and charged accordingly. Case closed by arrest.


Armed Robbery — 12/08/2023 1500 block of Maple Ave. — 2:22a.m.

Units responded to the 1500 block of Maple Ave. in regards to an armed robbery that had just occurred. Responding officers met with the victim who related that he heard suspicious noises and when he went outside he observed at least three (3) male subjects burglarizing his work van. The victim further related that he then shouted at the offenders at which time, one of the males pointed a handgun at the victim who in turn ran back into his residence and called 911. Numerous power tools were reported missing from the victim's vehicle. Officers observed the driver side window was broken. This investigation is ongoing.

Armed Robbery — 12/08/2023 6800 block of Cermak Rd. — 2:51a.m.

Units responded to the 6800 block of Cermak Rd. in regards to an armed robbery that had just occurred. Upon arrival, officers met with the victim who related he observed unknown subjects breaking into his work van via his surveillance camera, at which time the victim and his wife exited their apartment and confronted the subjects. Two (2) of the offenders then pointed handguns at the victims, at which time the victims then returned into their apartment and called 911. Entry was made into the victims work van by breaking out the front and rear passenger side windows. Approximately twelve (12) power drills were reported stolen. This investigation is ongoing.






SIGNIFICANT INCIDENTS IN 7TH WARD

Aggravated Assault — 12/09/2023 Longhorn Steakhouse (7115 W. Cermak Rd.) — 11:16p.m.

Units responded to Longhorn Steakhouse in regards to a customer that had battered two (2) employees. Upon arrival, units ascertained that the incident stemmed from the offender's complaint regarding an online order. The victims (restaurant staff) related that the offender became upset about an issue with her order and struck them several times. The offender then exited the restaurant, re-entered her car, and drove her vehicle up over the curb in the direction of where three (3) employees were standing. The offender fled the scene prior to officer arrival. This investigation is ongoing.


Robbery — 12/05/2023 In and Out Liquor Store (6601 W. Roosevelt Rd.)— 12:00p.m.

Officers responded to In and Out Liquor Store for a report of a robbery that had just occurred. Responding officers met with the victim (store clerk) who related that an unknown male subject entered the store, jumped over the counter, and struck the clerk in the face with a closed fist. The offender took approximately \$800 from the cash registers before he fled the scene Westbound through the Roosevelt Rd. alley. The offender is described as: Male, Black, medium build, wearing a black hoody, black pants, black Nike shoes with white trim, black ski mask and winter gloves. Pursuant to an investigation, the offender was linked to two (2) additional Robbery incidents in Berwyn and taken into custody on 12/06/2023 without incident. The offender was subsequently charged accordingly. Case closed by arrest.

Burglary — 12/09/2023 1400 block of Gunderson — 4:09a.m.

Berwyn dispatch received a call of a burglary to a garage in progress on the 1400 block of Gunderson. Responding officers met with the victim who described the offenders as two (2) Male Hispanics wearing ski masks. The victim related that the the offenders entered his garage through an open service door and took miscellaneous tools from within the garage. The victim further related that the offenders fled the scene in a dark in color sedan prior to police arrival. This investigation is ongoing.
