





#### Robbery — 12/27/2023 Harlem Ave/34<sup>th</sup> Street – 6:01p.m.



The offender was transported to the Berwyn Police Department and subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon and three (3) misdemeanor counts of Aggravated Assault. Case closed by arrest.







