



SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 2/20/2023

Aggravated Battery to Elderly Person x2/Aggravated Battery to Police Officer/Aggravated Robbery 3500 block of Home Ave. — 2/22/2023 — 7:17p.m.

Officers were dispatched to the 3500 block of Home Ave. for a call that initially came out as a disturbance. Upon arrival, responding officers observed the elderly female victim with contusions and cuts on her right eye and nose. The victim related that while she was driving Northbound on the 3600 block of Wisconsin, she realized she was being followed closely by an unknown black in color BMW. The victim stated that she drove around the block several times and noticed that the same black BMW continued to follow her closely. Said BMW then struck/rear ended the victim's vehicle on Home Avenue, coming out of the South 35th Street alley. The victim related that she pulled over at which time, the offending vehicle drove up on to the sidewalk and lawn of and then drove back onto the street parking directly in front of the victim's vehicle. The driver (unknown Black Female, approximately 5'4" tall, thin-medium build, short hair) exited the vehicle and approached the victim. The victim further related that the unknown female subject then struck her in the face with a closed fist, called her "white privileged," and then struck her in the face with a closed fist a second time.

Officers also met with the victim's husband who related that he exited their home, and observed his wife being battered by the unknown female subject. The victim's husband further related that he took a photo of the offender's license plate, at which point, the offender then struck him in the back of the head and the rest of his body with an unknown hard blunt object. At some point during the battery, the offender took the male victim's phone and returned to her vehicle. The offender was last seen fleeing Northbound on Home Avenue from 35th Street.

Pursuant to an investigation, the offender was located by Berwyn Police Officers and taken into custody without incident on 2/24/2023. The offender admitted to both the battery and the robbery and told detectives she confused the identity of the victim(s) with someone else. The offender was subsequently charged with 2 (two) felony counts of Aggravated Battery to Elderly Person, 1 (one) felony count of Aggravated Battery to Police Officer, 1 (one) felony count of Aggravated Robbery. Case closed by arrest.







Officers responded to Guadalajara Bar for a call of a battery. Responding officers met with the male victim who was visibly battered (injuries to his face). The victim stated that he was jumped in the bathroom of the bar and that the offenders took his money. No offenders were on scene when officers arrived. The victim stated that while he was using the men's bathroom he dropped approximately \$120 on the floor. The victim further related that while he was attempting to recover his money the offenders attacked him and took his money. BFD arrived on scene and attended to the victim who ultimately signed a medical refusal with BFD. This investigation is ongoing.




