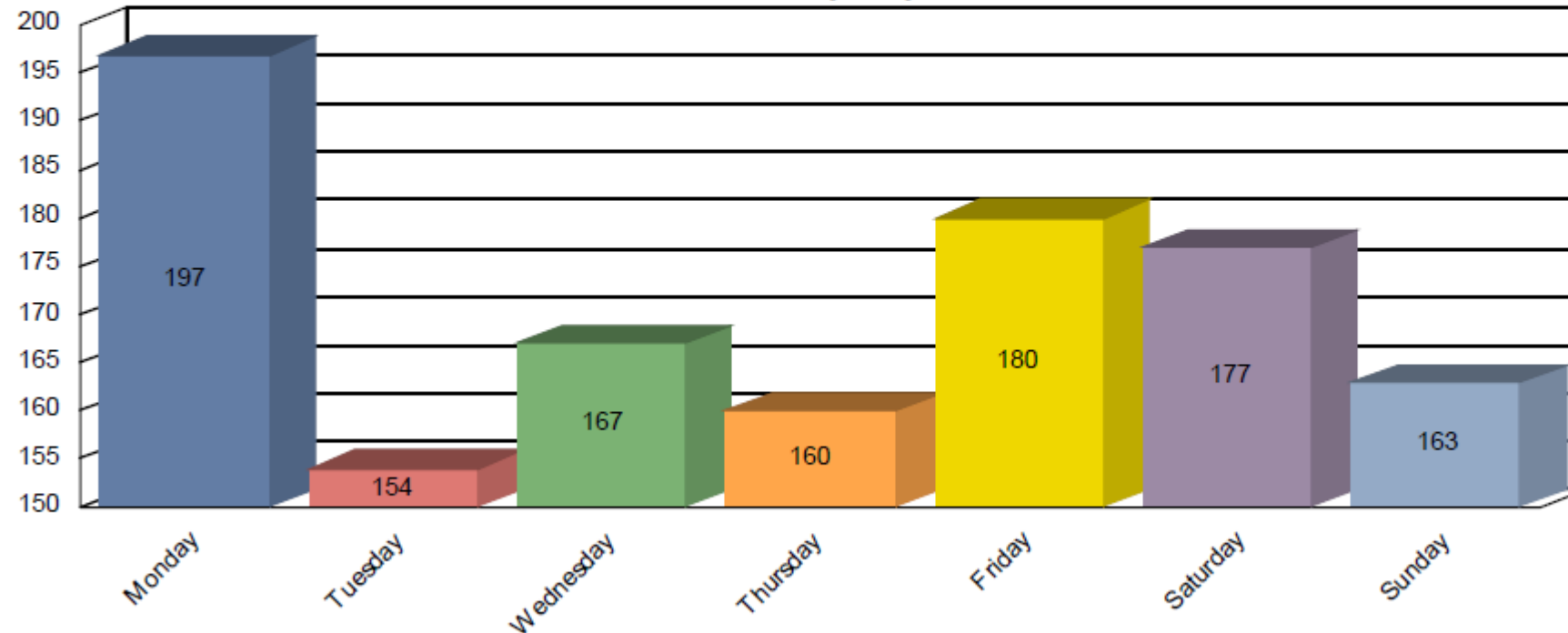

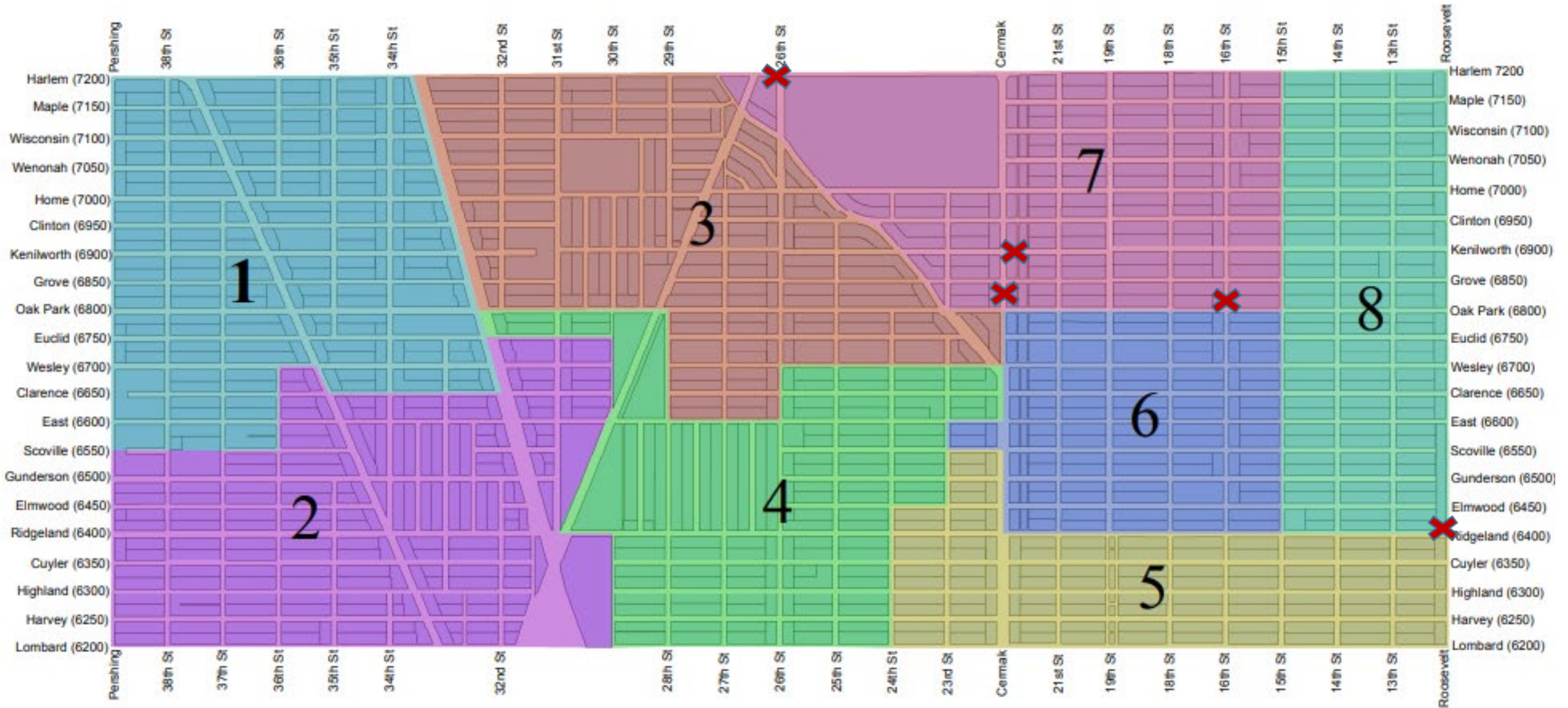

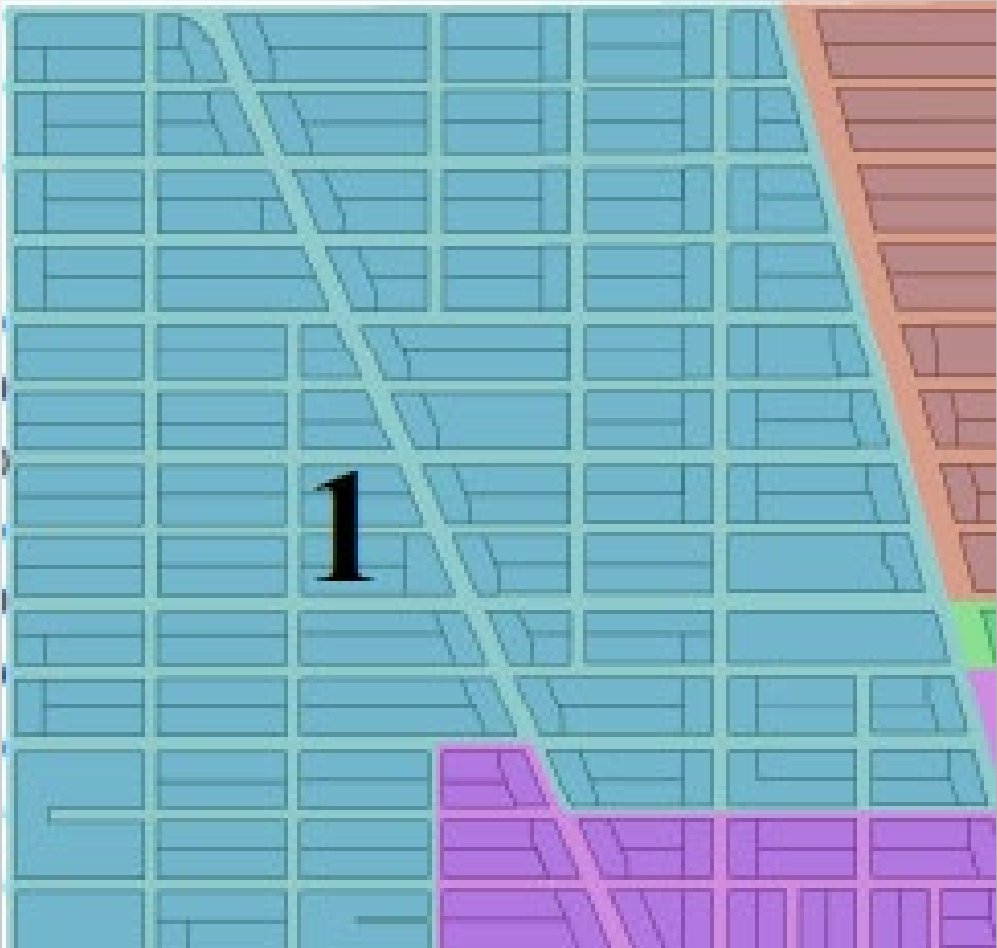

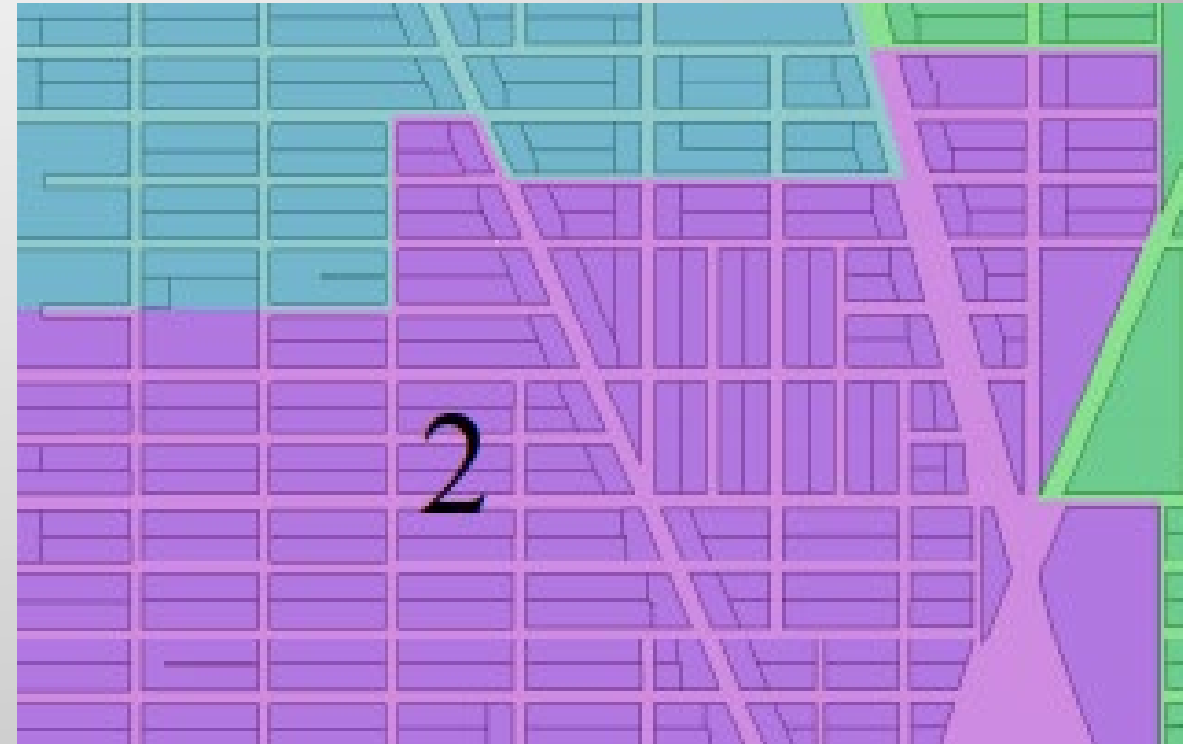

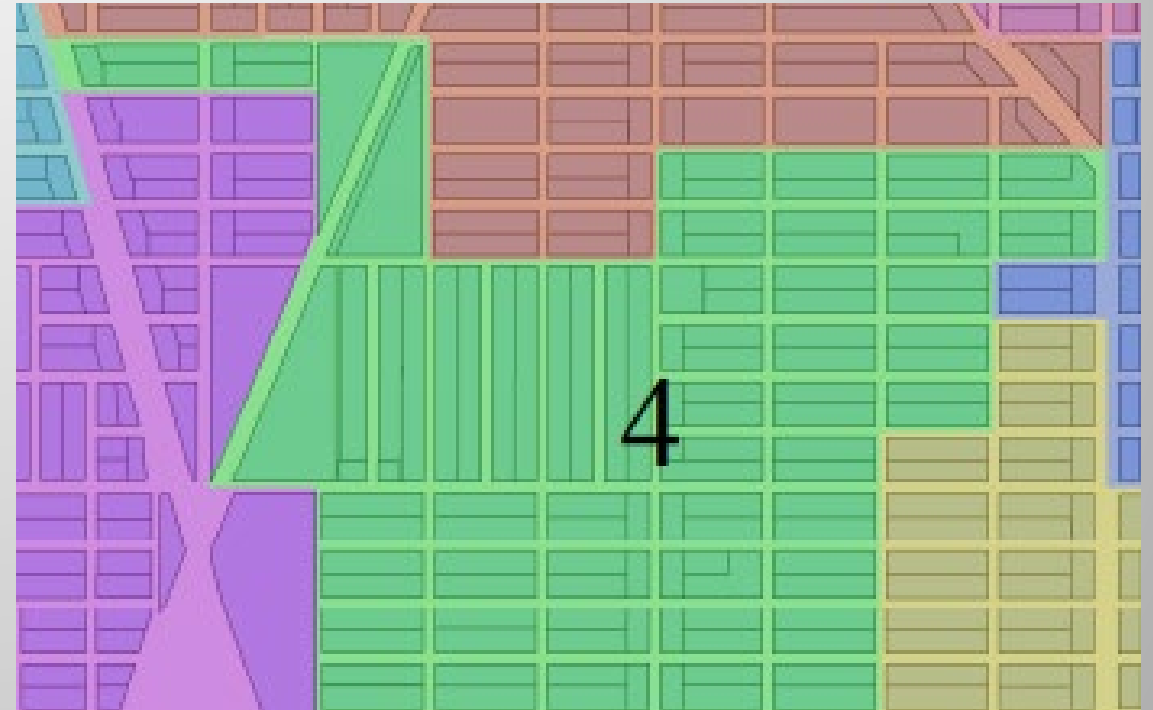

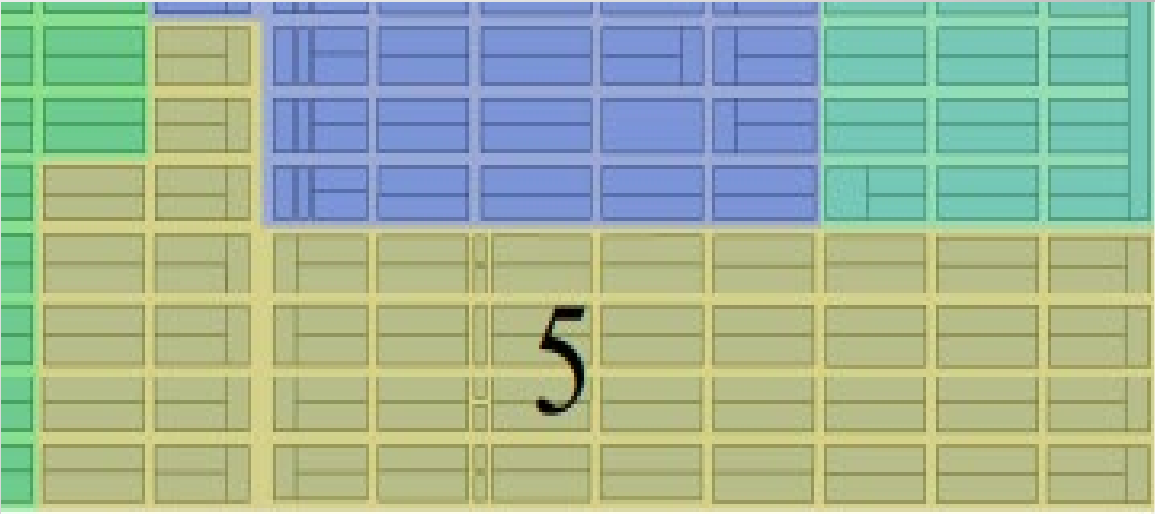

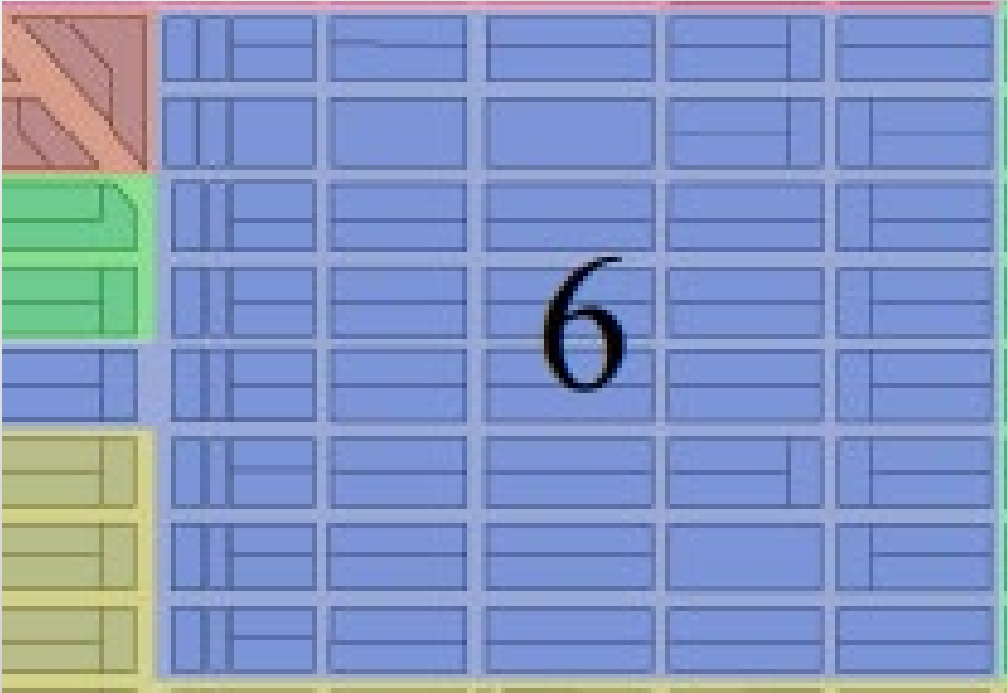

Aggravated Unlawful Use of a Weapon — 2/29/2024 **26th Street/Harlem Ave. – 5:19p.m.**

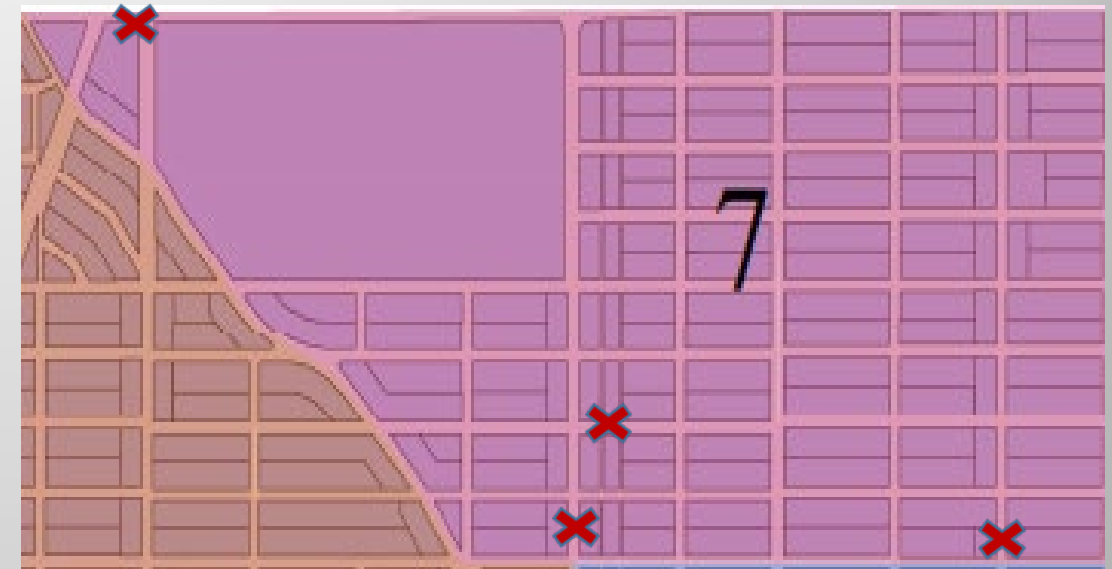
Officers conducted a traffic stop in the area of 26th Street/Harlem Ave. Officers made contact with the male driver of the vehicle and observed two (2) juvenile occupants in the backseat. Officers learned that the driver did not possess a valid driver's license. The driver advised officers that he had a firearm in the driver's side door pocket. Officers confirmed that the subject had a valid FOID but no CCL. Officers conducted a namecheck inquiry which revealed a non-extraditable warrant out of Champaign County, IL. Officers recovered a fully loaded firearm and one (1) additional magazine loaded to full capacity from inside the vehicle. The subject was placed into custody without incident and transported to the Berwyn Police Department for processing. Juvenile Detectives took both juveniles into temporary protective custody before they were ultimately released to the care of an adult family member. The offender was subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

Fight/Disturbance — 3/02/2024 **16th Street Liquors (6808 W. 16th Street) – 1:28a.m.**

Officers responded to a call of a fight inside 16th Street Liquors involving approximately five (5) Male Hispanics. Upon arrival, responding officers did not observe any physical altercation nor did any person(s) on scene have any injuries consistent with being in a physical altercation. Officers made contact with the bar's security staff and owner who related that a fight amongst patrons did occur, however, the subjects fled the scene prior to police arrival.

Criminal Trespass — 3/02/2024

Guadalajara Bar (6814 W. Cermak Rd.) – 2:53a.m.

While patrolling the area, officers were flagged down by an employee of Guadalajara Bar for an unwanted subject in the establishment. Officers were further advised by the bar owner that there was a female subject who was refusing to leave after being told numerous times to do so. Officers located the subject in the front vestibule. Officers made several attempts to talk with the subject, however, she refused to comply and leave the establishment. The owner stated they wished to sign a complaint for Criminal Trespass. Said subject was then placed into custody and transported to the Berwyn Police Department where they were subsequently charged accordingly. Case closed by arrest.

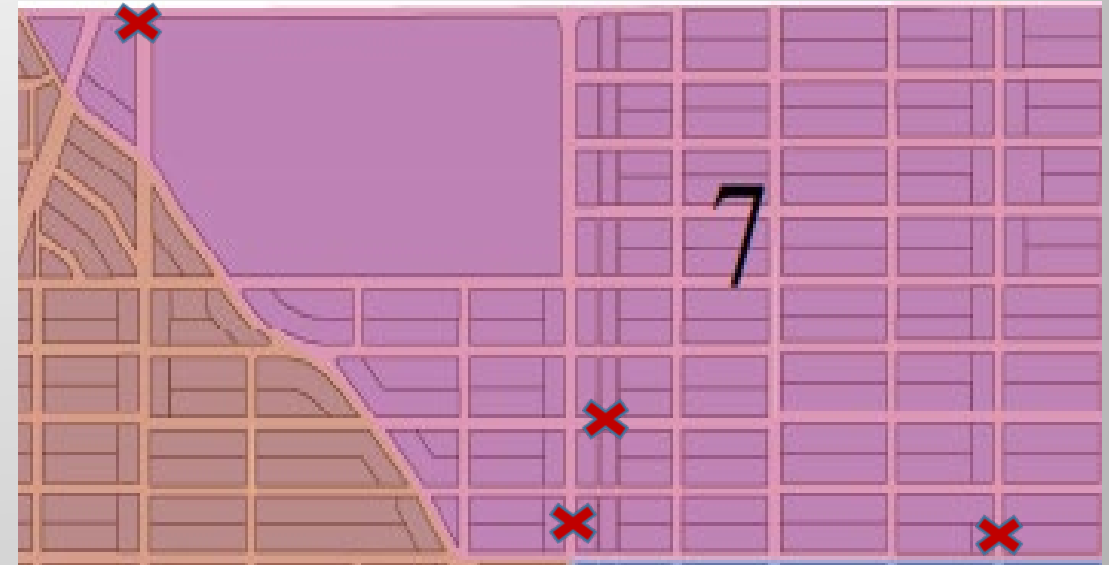
Aggravated Battery/Robbery/Child Endangerment (Juvenile Incident) — 3/03/2024

Kenilworth Ave./Cermak Rd. – 2:47p.m.

Officers responded to the Kenilworth Ave./Cermak Rd. alley near the vacin for a report of a battery to a female juvenile subject called in by a third party witness. Responding officers made contact with the victim who related she and her child were walking near the Kenilworth Ave./Cermak Rd. alley when two (2) female subjects and one (1) male subject approached them and began to physically attack the victim and took her backpack. The reporting witness related that they were driving by when they saw the incident taking place and they pulled over to assist the juvenile victim and her child. BFD was summoned to the scene for treatment and evaluation of minor injuries. This incident was turned over to the Juvenile Detective unit for further investigation.

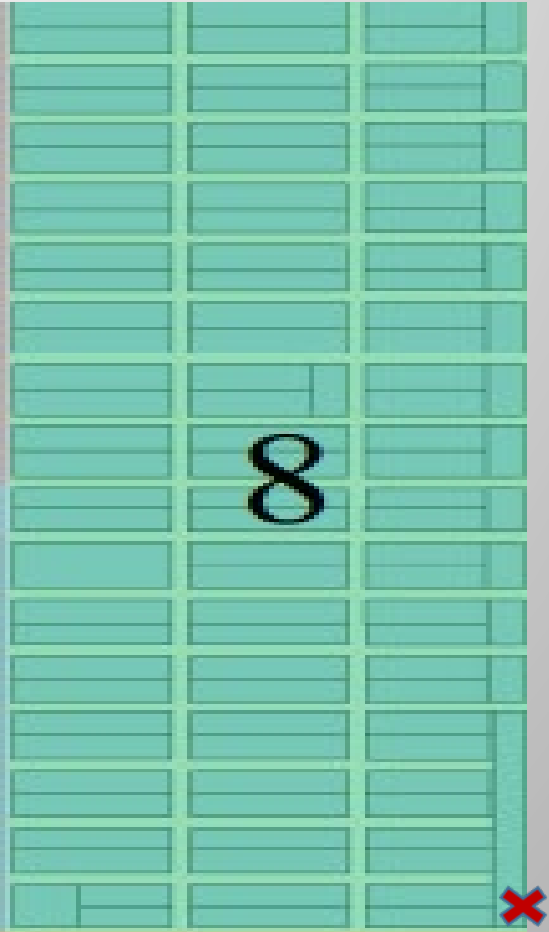
SIGNIFICANT INCIDENTS IN 8TH WARD

Armed Robbery — 2/27/2024
Shell Gas Station (6405 W. Roosevelt Rd.) – 6:11p.m.

Officers responded to a report of an armed robbery at the Shell Gas Station (Roosevelt/Ridgeland) called in by the alarm company. Upon arrival, responding officers learned that two (2) Male Whites entered the gas station and one of the offenders went behind the counter and displayed a knife to the clerk while the other offender grabbed an unknown amount of cigarette packs from the shelf. Both offenders fled the store on foot and were last seen heading Westbound on Roosevelt Rd. Officers conducted a check of the area which yielded negative results for the offenders. There were no injuries reported. This investigation is ongoing.

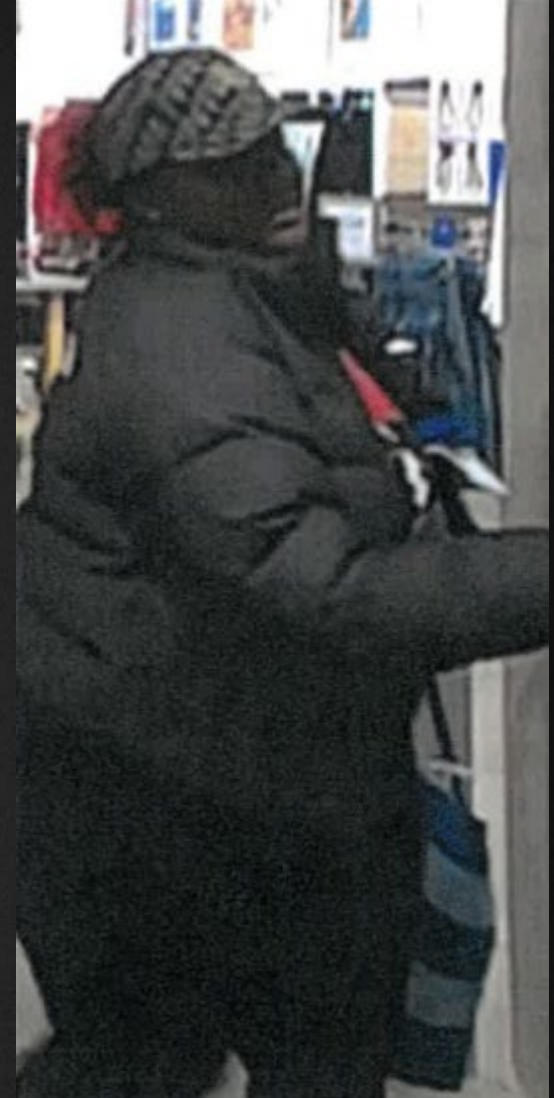
