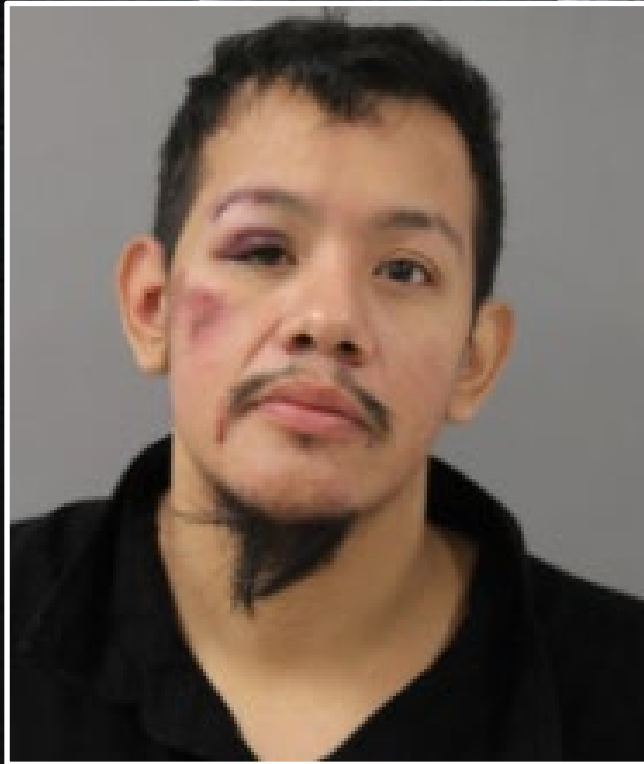

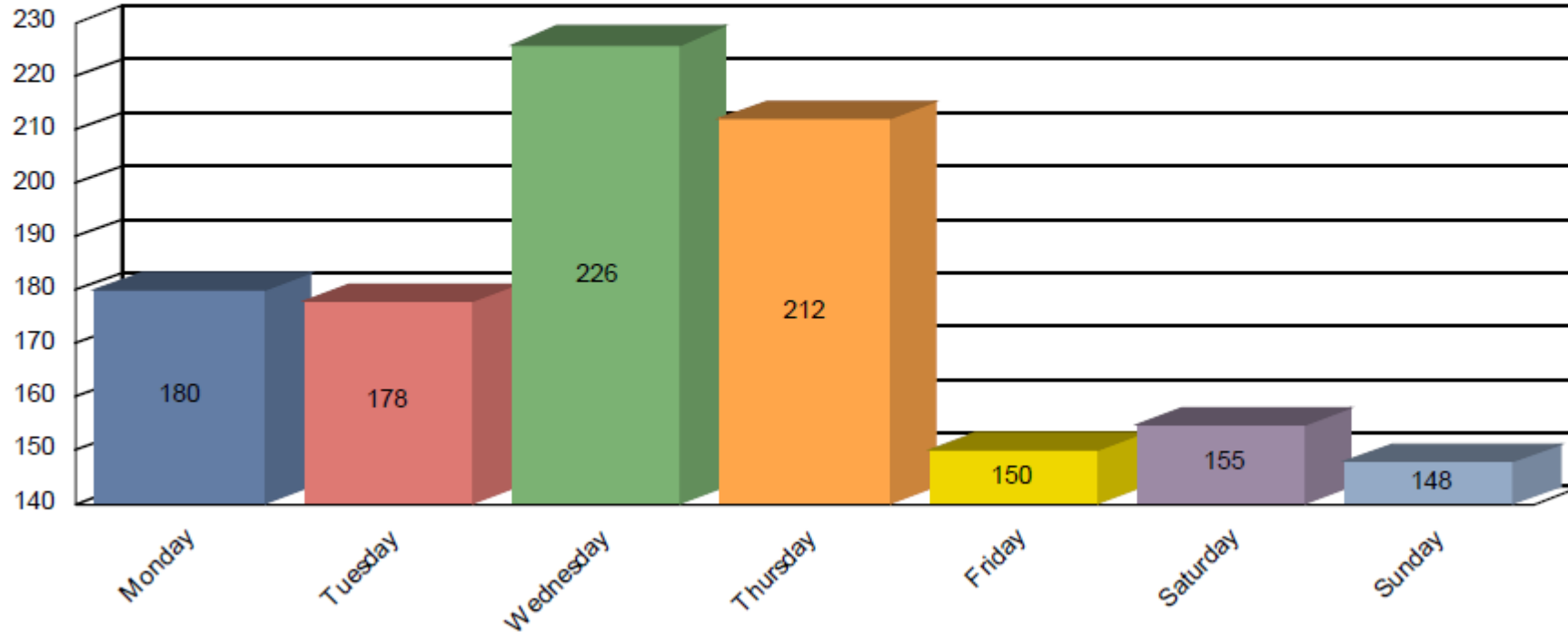

## Total Items For Service

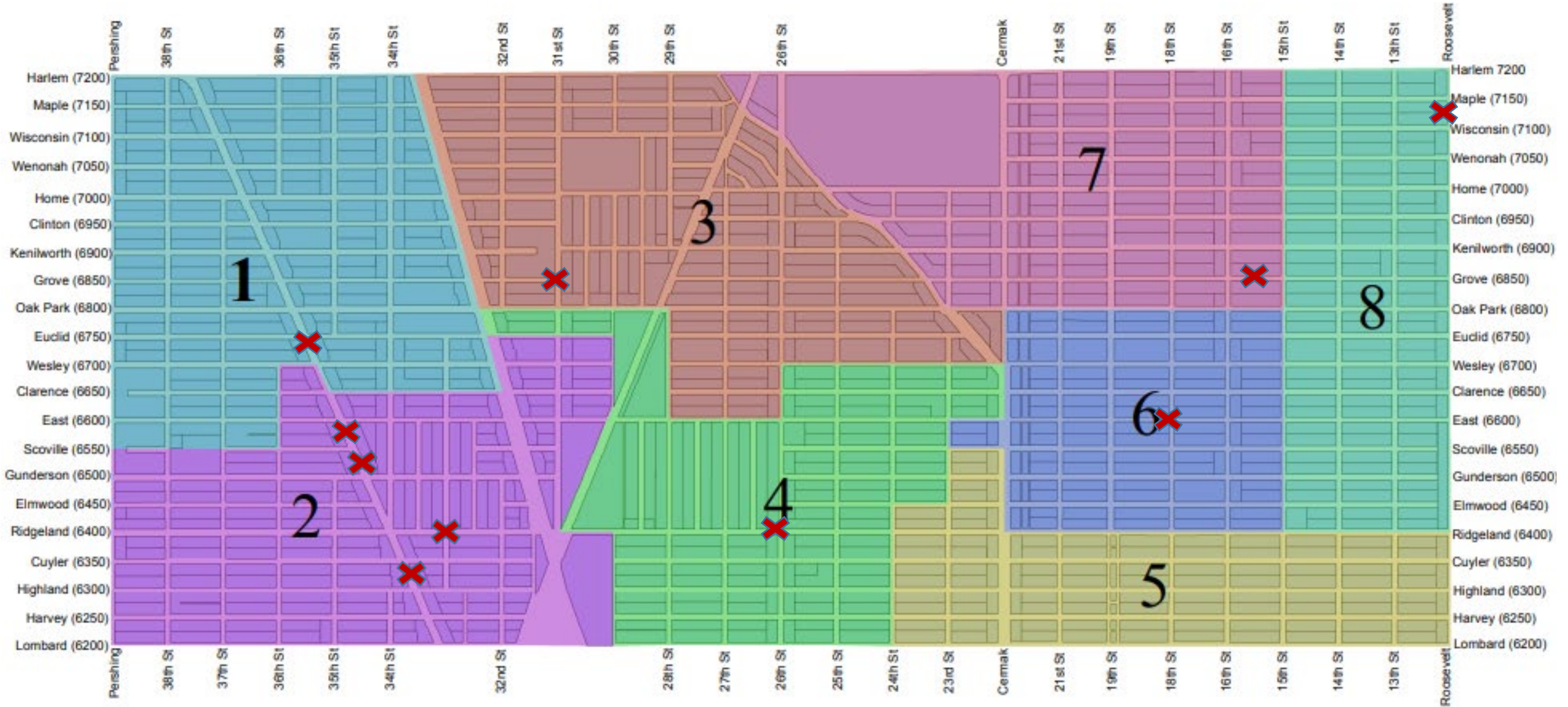

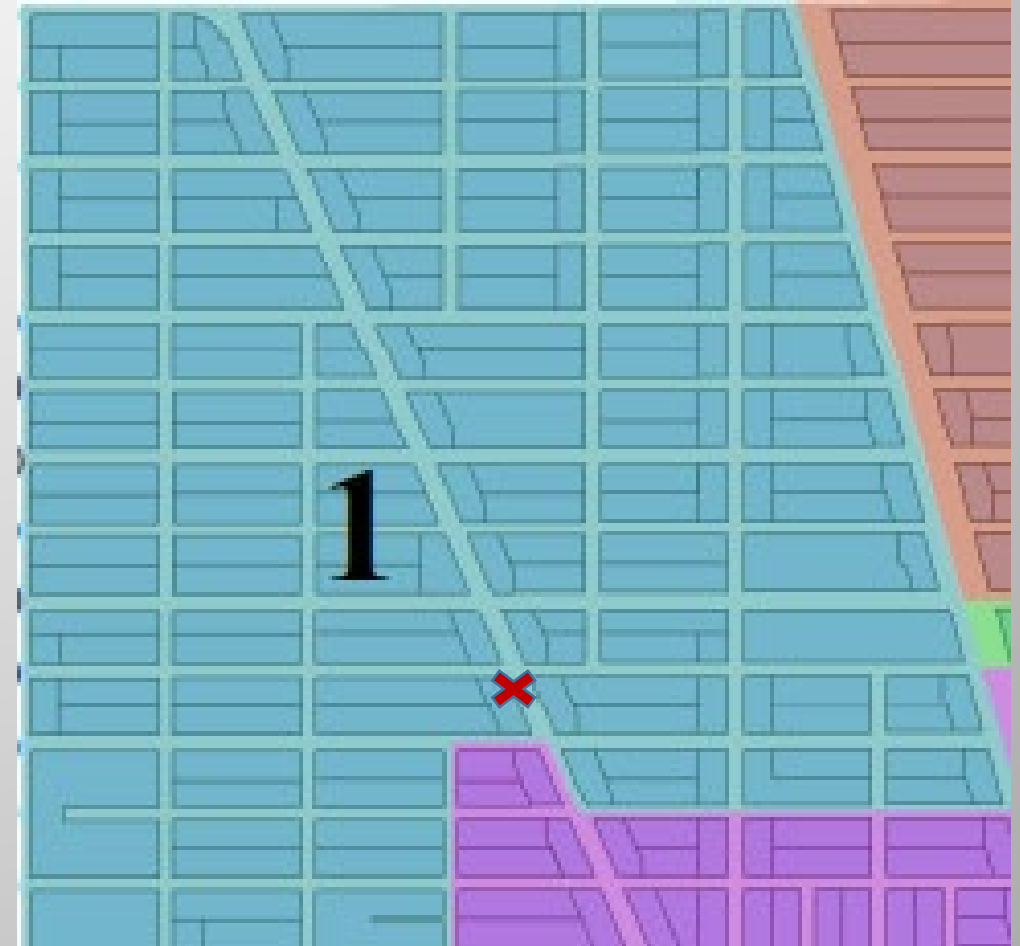

## **Armed Robbery 12/07/2021 — 8:10 p.m. Auto Zone (6700 W. Ogden)**

Units responded to Auto Zone (6700 W. Ogden) regarding an armed robbery. Upon arrival it was learned that two male black subjects, one wearing a black hoody and a mask and the other wearing a gray hoody an mask exited a white vehicle which pulled into the parking lot, entered the store produced hand guns and stole between \$200 and \$300. The subjects exited the store, entered the white vehicle, and fled in an unknown direction.

## **Man With A Gun 12/08/2021 — 2:30 p.m. Ron's Auto Body (6507 W. Ogden)**

Units responded to Ron's Auto Body (6507 W. Ogden Avenue) for a man with a gun. Upon arrival officers learned that when an employee exited the alley door they observed a male black subject, 5'11", slender build, wearing a gray hooded, black hat and black surgical mask, armed with a handgun. Upon seeing the employee the subject ran and entered the passenger side of a silver vehicle, which then fled eastbound through the alley towards Gunderson. Complainant related the subject with the gun never said a word to him nor did he point the gun at him.

## **Shots Fired 12/08/2021 — 10:48 p.m. 3300 block of Ridgeland**

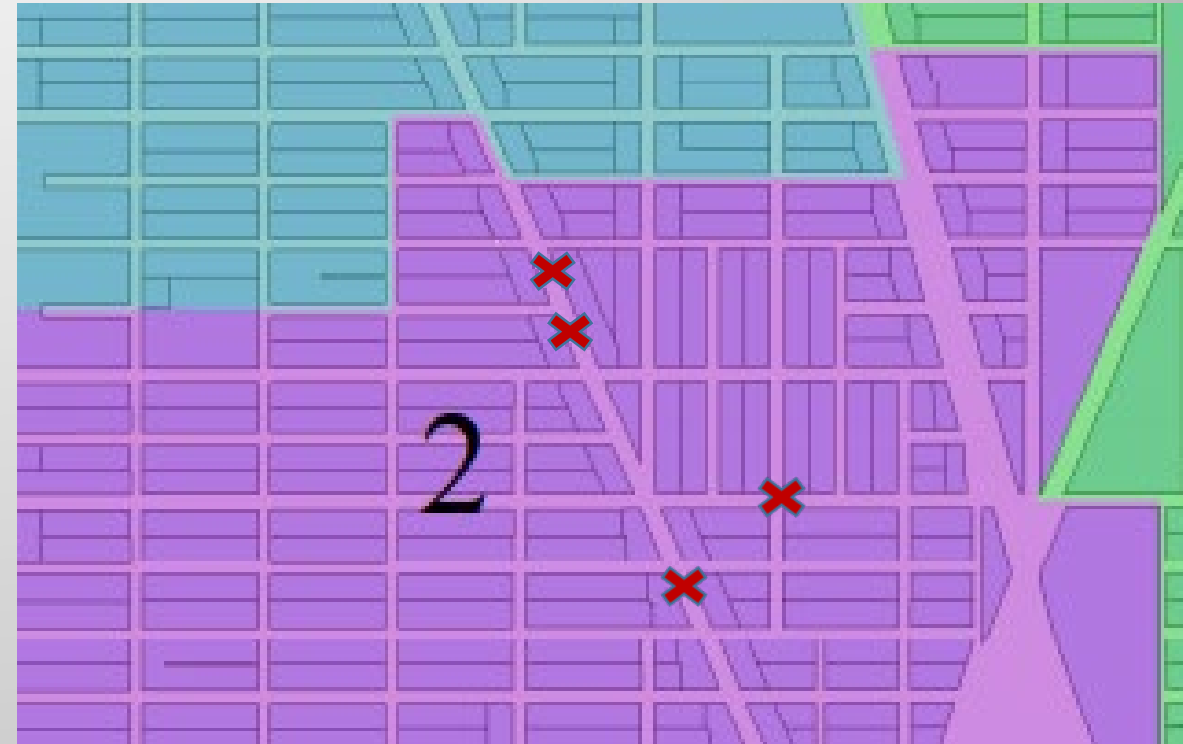
Dispatch received two calls of shots fired in the area of 33<sup>rd</sup> street/Ridgeland. Upon checking the area, (5) 9mm shell casings were discovered by officers in the alley of the 3300 block of Ridgeland. No Property Damage or injuries found.

## **Commercial Alarm 12/08/2021 — 3:08 a.m. 6539 W Ogden (Ziegler Auto)**

Units were dispatched to Ziegler Auto (6539 W Ogden) in reference to a commercial alarm being called in by the alarm company. Upon arrival officers met with the business security guard on duty who advised that he checks the doors of the business every hour. During his 2:00a.m. hr check all doors of the building were secure. At 3:00 a.m. he found the pedestrian door located on the south east corner of the building leading to the service bays unlocked and the door opened setting off the alarm. An interior check was made with nobody located within. The door was re secured and the security guard contacted the manager who was in route to reset the alarm. All units cleared

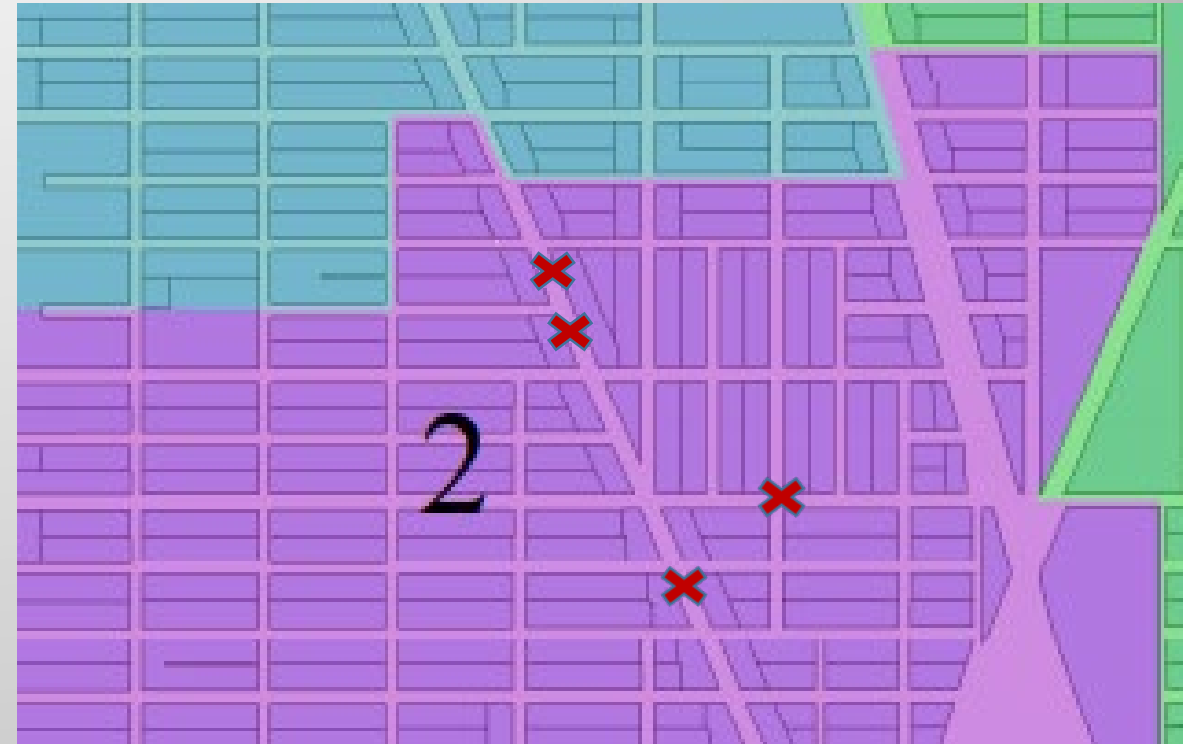
## **Gunshot Victim 12/09/2021 — 2:30 p.m. Nicco's Bar & Grill (6300 W. Ogden)**

Officers responded to Nicco's Bar and Grill (6300 W. Ogden) for a transfer call from Cicero for a person shot inside the establishment. Prior to the arrival of the officers, BPD Dispatch was notified that a male gunshot victim walked into MacNeal Hospital and told staff he had been shot around Nicco's. The male victim told officers he was inside Nicco's and became involved in an altercation. Prior to the fight escalating further, security staff kicked out all of the involved parties. The victim then got into his vehicle and left south on Highland from Ogden.

Prior to being sedated at the hospital the victim stated he was not sure what street he was on when he was shot but he was in his van and he knows the male who shot him.

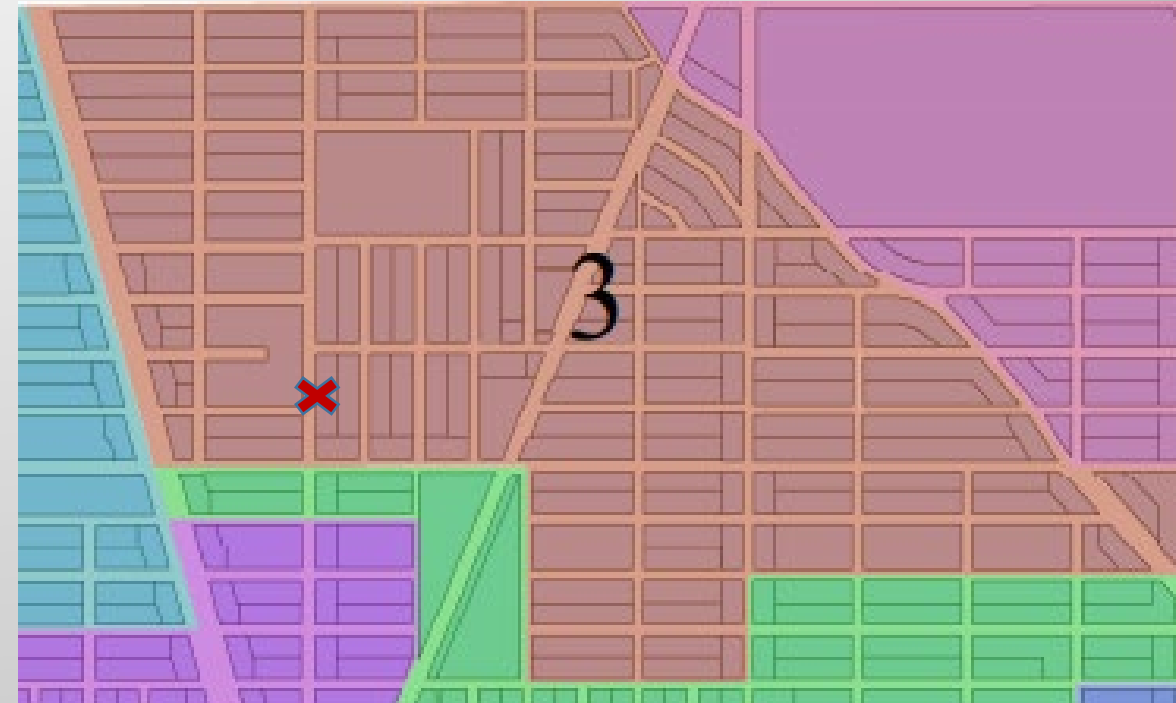

Units received a call from MacNeal hospital of a walk in gunshot victim. Units arrived at the hospital and received information that the shooting occurred in the area of 31st Street/Grove. The victim was shot once in the top of the left shoulder and exited out of his upper back. A shell casing was located in the alley of the 3100 block of Grove. The victim was able to transport himself to MacNeal and there were no reported calls of shots fired in the area.

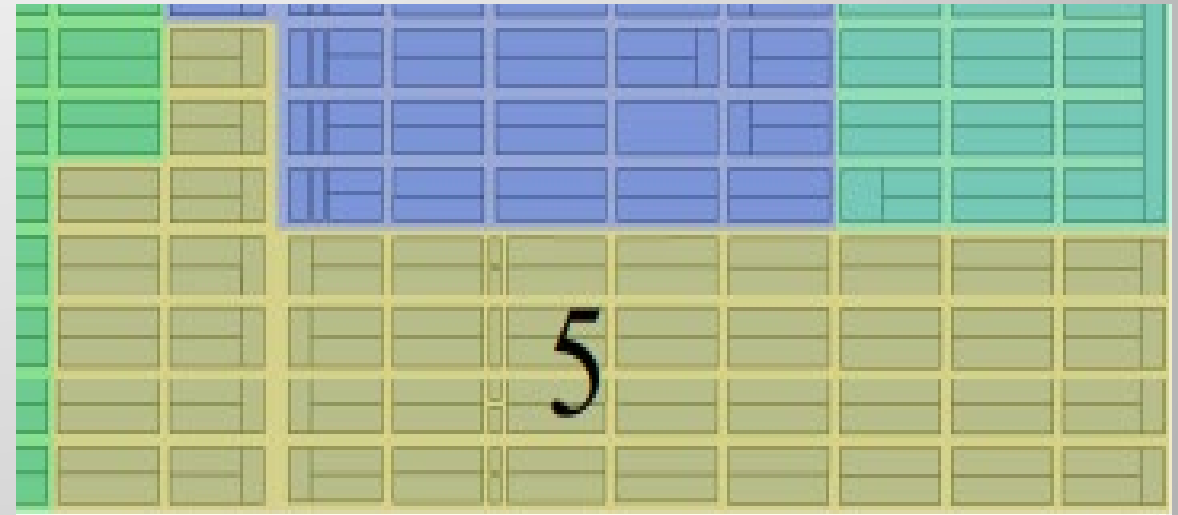

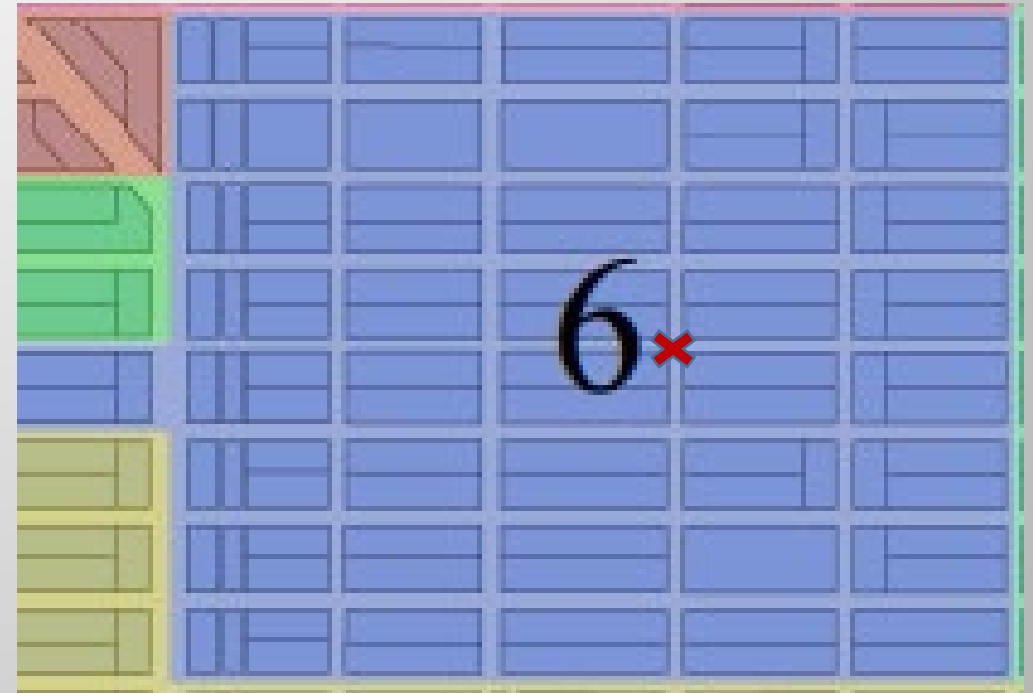

Upon arrival complainant related that she was involved in an auto accident in Chicago with a subject who lives on the 1500 block of Grove and provided false insurance information. She related that when she went to speak with him about it the male subject became agitated and allegedly displayed a gun. She then related that she wasn't sure if it was a gun but had a dark object in his hand. Officers spoke with the male subject who had no weapon. Both parties advised.

Later in the evening the female subject returned and threatened to kill the male subject and his brother, who was also present at the time of the accident. The female fled the scene prior to the arrival of the police.

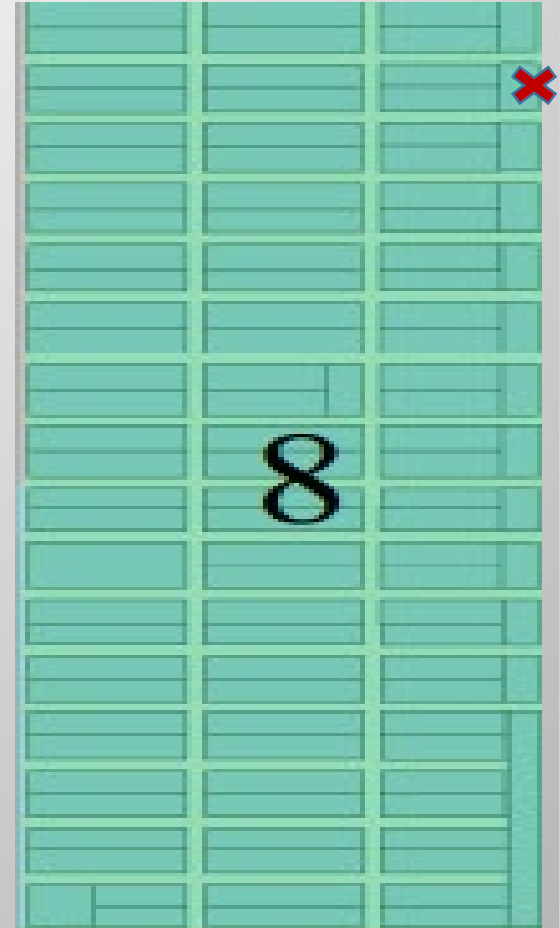

## **Resisting/Obstructing a Police Officer 12/10/2021 Lucky's Bar (7123 Roosevelt) — 11:17 p.m.**

Officers responded to Lucky's Bar (7123 Roosevelt) for a call of an unwanted male. When officers arrived on scene the male subject was walking out of the bar followed by the bouncer. Officers recognized the subject as matching the description of the male subject involved in an aggravated domestic battery / attempted murder earlier that day. While the subject was getting kicked out of Lucky's Bar he attempted to physically attack the bouncer in front of responding officers. The subject ignored multiple commands from the responding officers, attempted to push past the officers to attack the bouncer, and swung his arms around in an attempt to defeat the arrest. The responding officers performed an emergency takedown on the offender in order to better gain the leverage necessary to take him into custody. The subject sustained a cut above his right eye and a scrape on the right cheek. BFD was summoned to the scene and he went to MacNeal Hospital for medical evaluation. Two use of force packets were completed for review. The subject was released from the hospital and placed into a cell awaiting the investigation.

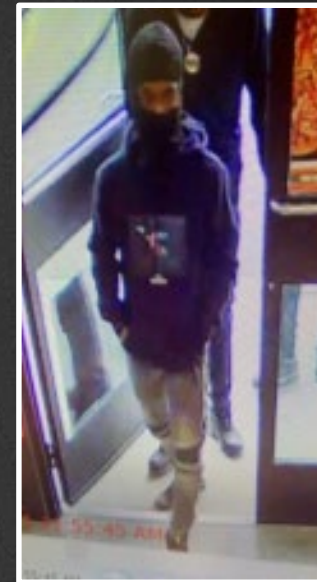
