





#### Reckless Discharge of Firearm — 1/17/2022 Berwyn Liquors (6338 W. Ogden) — 6:36 p.m.

While on patrol, a police officer heard one (1) gunshot and then observed a male subject fire a second shot in a Southwesterly direction at someone. The officer radioed that he had a view of shots fired and that he has a subject detained at gun point. Upon arrival of additional responding units, the subject, who was an employee at Berwyn Liquors, had been detained and a weapon was recovered. Units canvassed southbound on Ridgeland Avenue for a victim or a blood trail which would indicate that someone had been shot, however they were met with negative results.

Upon the arrival of the store manager, surveillance video was viewed which revealed that a male black subject had appeared to commit a retail theft and that the employee jumped over the counter to confront the subject. Subsequently the offender and employee exited the store at which point the employee discharged a firearm at the offender. At this time, the detectives are attempting to secure additional surveillance footage from the surrounding area. The employee is currently in custody and on hold for the detectives.





#### SIGNIFICANT INCIDENTS IN 2<sup>ND</sup> WARD

Home Invasion — 1/17/2022 3000 block of Wesley — 2:52 a.m.

The victim reported that a male subject wearing dark clothing (no further description) pried open the outside rear door then forced entry to the first floor residence. The homeowner further related that they went to investigate after hearing a loud bang, and discovered the unknown subject. The homeowner related that they yelled at subject and the subject then fled out the rear door, proceeded West down the gangway then South through the Wesley/Euclid alley. Units were able to follow a set of footprints that came from the residence's gangway and appeared to be in a running stride due to the length between the strides. The prints were tracked all the way to the crosswalk of the Northwest corner of 31st Street/Euclid. A search of the area for the offender was conducted but met with negative results.

#### Burglary Investigation/Resisting Arrest — 1/18/2022 Calliber Collision (6305 W. Ogden) — 8:56 a.m.

Concerned caller reported a man on his front porch that he observed through his Ring Doorbell. Athe caller provided a description to officers where the subject was subsequently located. While conducting a field interview, the store manager at Caliber Collision advised that the male subject stole a tool from their shop. Police officers attempted to place handcuffs on the offender, however, he resisted arrest. The offender was taken to the ground where he was placed into custody. No injuries reported to officers. Minor injury reported by offender (medical refusal signed). Use of force packet to be completed. Burglary investigation turned over to the Detective Bureau.









Officers responded to the 3200 block of Harlem for a call of a male subject walking through the gangways in the area and trying to open multiple doors. Upon arrival, the officers observed a male subject exiting a door from a residence (rear unit) which is a vacant. The officers also observed the subject carrying a bag with copper piping. The officers attempted to speak with the male subject but he fled the area on foot. After a brief foot pursuit the officers placed him into custody without further incident. On the offender's person two pipe cutting tools were located and the bag of copper piping was also recovered. The offender gave a recorded interview to the assisting detectives admitting to the burglary and charges were approved.





Berwyn Police pulled over a vehicle for a traffic violation which resulted in the recovery of a firearm and three subjects taken into custody for investigation.












#### Reckless Discharge of Firearm — 1/17/2022 16th Street/Oak Park — 3:02p.m.

Units responded to 16<sup>th</sup> Street/Oak Park Avenue regarding numerous calls of shots fired. Upon arrival it was learned that a male black subject, thin build, dressed in a dark colored or black jacket, black winter hat, black face mask had been involved in a verbal altercation with a subject in a white Audi and that the male black subject produced a gun and fired two shots at the Audi as it drove away from the gas station at 16th Street/Oak Park. The offender then fled (on foot) Southbound on Oak Park and then Westbound through the yards in the middle of the block. Officers in the area located the white Audi parked on the 1600 block of Grove with two (2) bullet holes. The owner of the vehicle was uncooperative with the police officers, however, he related that he would speak with detectives regarding this incident.

#### Armed Robbery — 1/20/2022 1600 block of Kenilworth — 6:47 p.m.

Units responded to the 1600 block of Kenilworth regarding an armed robbery. Female victim stated that she exited her vehicle at which time she was accosted by a male black subject, dressed in all black, with a mask and armed with a pistol. The subject pointed a black gun at her sternum and demanded her money. The subject then pushed her against her car, grabbed her purse and fled Northbound towards 16th Street. The victim related that she believes that she can identify the offender. Victim was checked out by paramedics and signed a medical refusal. Detectives on scene, area canvassed for further witnesses and surveillance cameras. Area was checked for offender however met with negative results.



Officers responded to Guadalajara Grill for a call of 10 people fighting with security. Upon arrival, the fight was over and everyone was separated. Police Officers observed facial injuries to two subjects. Two ambulances were summoned to the scene and the subjects were transported to MacNeal Hospital for medical treatment. Both subjects stated they were sucker punched by Guadalajara security although both stated they could not identify who struck them. Guadalajara security and staff advised officers that the group of friends with the two subjects were disorderly and after being asked to leave the establishment they began pushing security staff and the melee ensued. Both subjects stated they want to pursue complaints.

#### Fight/Brawl/Riot — 1/23/2022 El Nuevo Vallarta (6801 Cermak) — 10:53 p.m.

Call of a large fight inside El Nuevo Vallarta – units arrived on scene and determined that the fight was between patrons yelling gang slogans at the bar security as they were attempting to remove the subjects. 
