









SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 8/01/2022

Unlawful Discharge of Firearm — 8/07/2022 7100 block of Windsor — 6:57a.m.

Victim reported that he returned home after being away for several days and discovered a 9mm projectile on the floor of his apartment. Police believe the projectile may have entered through the frame of a window. Evidence Technician arrived on scene for photographs and the item was recovered. The exact date and time of this incident is unknown due to the victim being away.

SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 8/01/2022

Possession of Stolen Property — 8/04/2022 Ogden/Ridgeland — 12:16a.m.

Units responded to Ogden/Ridgeland for the report of a male subject lying in the grass. Responding units located the subject who appeared to be under the influence of an unknown drug. BFD ambulance was summoned to the scene. While waiting for the ambulance officers found that the subject was in possession of a ladies wallet. Approximately 1 minute later officers were approached by a female subject who advised that her wallet was taken out of her vehicle while it was parked nearby. The female identified herself and it was learned that the wallet in the male subject's possession belonged to her. A check of the male subject's backpack revealed numerous other items that may be proceeds from additional vehicle burglaries. The backpack and contents were inventoried. A name check of the male subject revealed an active warrant out of Chicago. The subject was transported to a local area hospital for treatment and placed into custody. Once released from the hospital, the subject was transported to the Berwyn Police Department where subsequent to an investigation Felony charges were approved for Possession of a Controlled Substance, Possession of Burglary Tools, and Burglary From Motor Vehicle. Case closed by arrest.

Unlawful Use of Weapon — 7/31/2022 **18th Street/Gunderson — 11:27p.m.**


Units were dispatched for a call of shots fired. Upon arrival, officers observed damage to a parked vehicle that had also been forced into other parked vehicles. Upon speaking with witnesses, officers learned two vehicles were chasing and an occupant of one of the vehicles may have fired a shot. While on scene, Berwyn Dispatch advised that Illinois State Police had a vehicle at I-290/Central that may have been involved. A unit went to that area and spoke to the involved party who stated he was at 18th Street/Gunderson in his vehicle speaking with someone when the second vehicle approached, brandished a firearm and threatened him. The victim related that the second vehicle was occupied by a known subject and this was a domestic dispute. The subject further related that he then reversed to get away and struck parked vehicles. The subject stated that he then fled South on Gunderson and the other party chased until I-290/Central where the victim's vehicle broke down. ISP arrived on scene and then contacted Berwyn PD. A search of the area was conducted which resulted in one spent shell casing found near the intersection of 18th Street/Gunderson. No reported injuries. Victim did not wish to sign complaints and the case was subsequently closed.

Strong Armed Robbery — 8/04/2022 **18th Street/Gunderson — 12:12p.m.**

Male victim came in to the police station to report a robbery that occurred the previous night. The victim stated while walking in the alley, two male Hispanics wearing surgical masks approached him, implied they had guns on their waists, and demanded his belongings. The offenders took the victim's iPhone and wallet before fleeing the scene. This case is under investigation.


Armed Robbery — 8/05/2022

7-11 (6603 16th Street) — 11:27p.m.

Units were dispatched to the above location for a report of an armed robbery that just occurred. Upon arrival, the store clerks described the offenders as: two male Black subjects, approximately in their 20's, wearing all black clothing and face masks. The victims further related that the offenders entered the store, displayed a black in color handgun, and demanded money from the registers. The clerk complied and turned over an unknown amount of money to the offenders who then left the store in a vehicle Westbound from the location. No injuries were reported. A check of the area for the offenders was met with negative results. This incident is currently under investigation.

Aggravated Unlawful Use of Weapon — 8/04/2022 **16th Street/Maple — 1:53a.m.**


Berwyn Police conducted a traffic stop on a vehicle. Name check on the driver and sole occupant of the vehicle revealed he was *Driving While License Revoked (DWLR)*. Subject was asked to step out of the vehicle at which time he was found to have a loaded pistol holstered in the small of his back. A name check revealed the male subject did not have a valid FOID or CCL. A search of the vehicle revealed an open alcoholic based beverage in the cup holder and a green leafy substance in a black baggie in the trunk which was later determined to be 7 grams of Cannabis. The subject was placed into custody without incident, transported to the Berwyn Police Station, and subsequently charged.

Aggravated Discharge of Firearm — 8/06/2022 **Guadalajara 16th (6814 Cermak) — 2:19a.m.**

Units responded to the report of a large fight inside the bar. Upon arrival, units spoke with security who advised that 7-8 male subjects began fighting and the group was escorted out the back door where the two groups went separate ways. Witnesses related that the group was seen leaving in two vehicles. Prior to leaving the parking lot, one vehicle was observed swerving towards the other car/group of people standing outside of it. One subject standing by the second vehicle then pulled out a gun and fired one round into the air. All remaining subjects then entered the second vehicle which left the area East bound in the alley. Officers canvassed the area and located one spent shell casing. No reported injuries or damage.



Unlawful Use of Weapon/Attempted Aggravated Vehicular Hijacking — 8/03/2022 — 9:24p.m. 1200 block of Wesley

Officers responded to the 1200 block of Wesley for a call of a person with a gun. The victim advised responding officers that she parked her vehicle in front of their residence to drop off a family member. The victim further related that while parked in front of the residence, a black sedan with tinted windows parked near her vehicle. Two male black subjects exited the vehicle and one of them pointed a gun at the victim. The victim fled the area which therefore prevented the offenders from taking her vehicle or any other property. The victim related she did not believe she would be able to identify the offenders. Incident was turned over to the detective bureau for further investigation.
