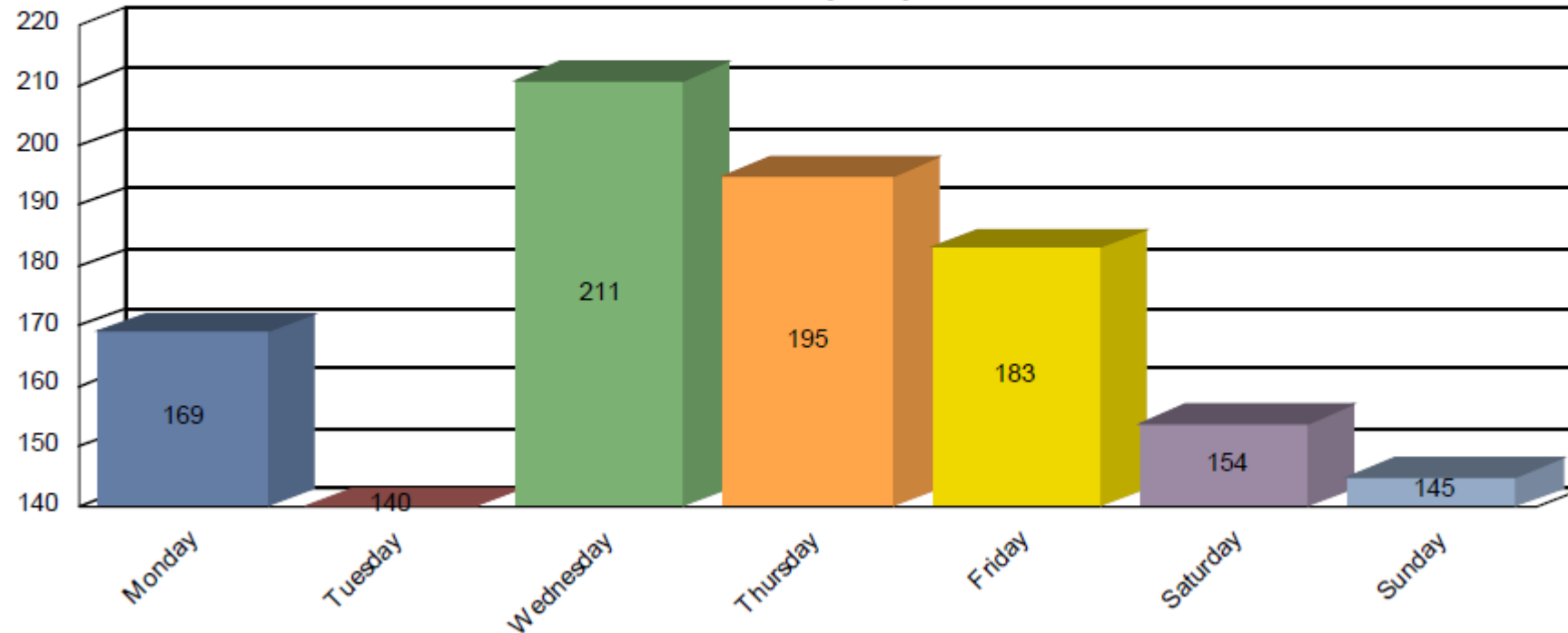

SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 1/30/2023

Burglary — 1/31/2023

Betty's Bistro (6969 W. Ogden) — 3:33a.m.

Units responded to Betty's Bistro for a commercial alarm. Upon arrival, responding officers discovered one of the front glass windows shattered and entry could be made into the business. Officers cleared the interior. The Area Manager arrived on scene and was able to access the business's surveillance video. Upon review of the video, officers learned that 2 (two) male subjects, each with a large crow bar in hand, shattered the front window and entered the businesses. The offenders attempted to pry open numerous gaming machines but were unsuccessful. The offenders left the business on foot headed Eastbound. This investigation is ongoing.

Armed Robbery(Juvenile) — 1/31/2023

3400 block of Oak Park Ave. — 8:25p.m.

A juvenile subject and their parent presented at the police station to file a report of Armed Robbery. Juvenile Detectives met with the victim who stated he went to a classmate's residence on the 3400 block of Oak Park Avenue. When the juvenile victim went inside the residence, multiple masked individuals approached him and robbed him of his Apple Air Pods and iPhone. One of the masked individuals pointed a gun at the victim. Following an investigation, Juvenile Detectives placed one juvenile offender in custody who was subsequently charged with Armed Robbery. Case closed by arrest.

Tavern Check — 2/04/2023

Windsor Café (6834 Windsor) — 3:32a.m.

While on patrol, officers observed patrons occupying the Windsor Café after hours. Officers subsequently conducted a check of the bar and learned that served alcohol was still present and being consumed by patrons. A Local Ordinance Citation was issued to the Bartender for Alcohol served after Hours.

SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 1/30/2023

Aggravated Vehicular Hijacking — 2/01/2023 **Ron's Auto Body Shop (6507 W. Ogden) — 3:17p.m.**

Officers responded to Ron's Auto Body for a report of a stolen vehicle. Upon arrival units located the stolen vehicle crashed and unoccupied behind Ron's Auto Body. The employees of the shop related 2 (two) Male Black subjects wearing all black entered the garage and got into said vehicle. One of the offenders pointed a gun at the employees. The offenders began backing the vehicle out of the garage when one of the employees, who was armed, fired at the vehicle causing the offenders to crash. The offenders subsequently exited the vehicle and fled Eastbound on foot. No reported injuries. This investigation is ongoing.

Disturbance/Warrant Service — 2/03/2023 **Nicco's Bar & Grill (6300 W. Ogden Ave.) — 9:39p.m.**

Officers were dispatched to Nicco's Bar & Grill in response to male subjects fighting in the parking lot. Upon arrival officers met with the caller/manager of the bar who related a Male Hispanic subject was inside the establishment highly intoxicated and being a nuisance to other patrons. The subject was escorted out of the establishment by security at which time the subject struck the security staff member in the face. Witnesses advised police that the offender was currently on House Arrest. Officers conducted a search of the area and located the offender at Ogden/Ridgeland. BFD was summoned to the scene to transport the subject to a local area hospital for treatment. Officers confirmed that said subject was the offender from Nicco's Bar & Grill and learned he had cut off his electronic monitoring device earlier that day at home. Reporting parties signed complaint refusals. Upon discharge from the hospital, the male subject was transported/turned over to Illinois Department of Corrections.

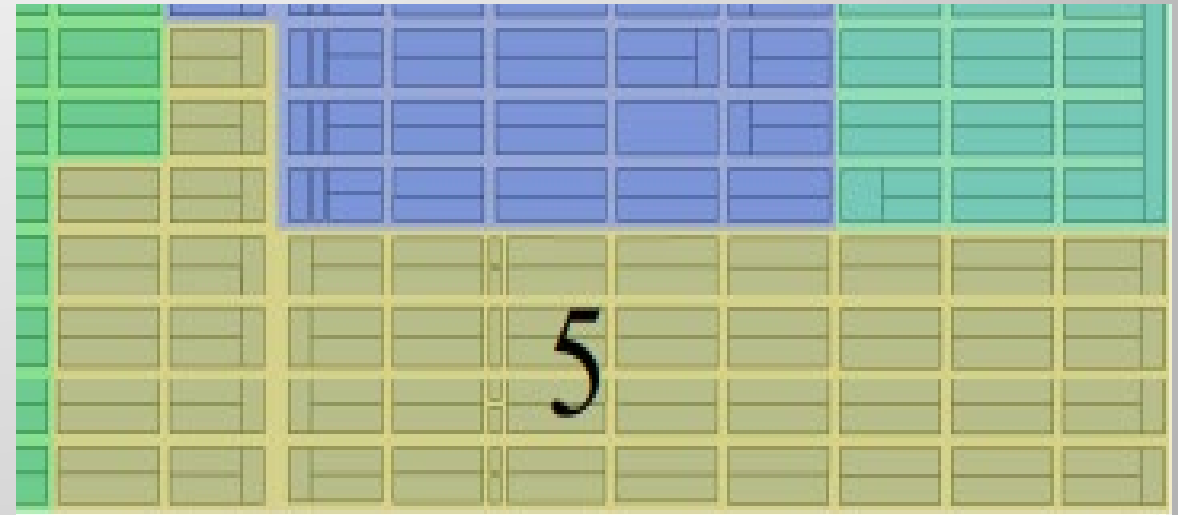

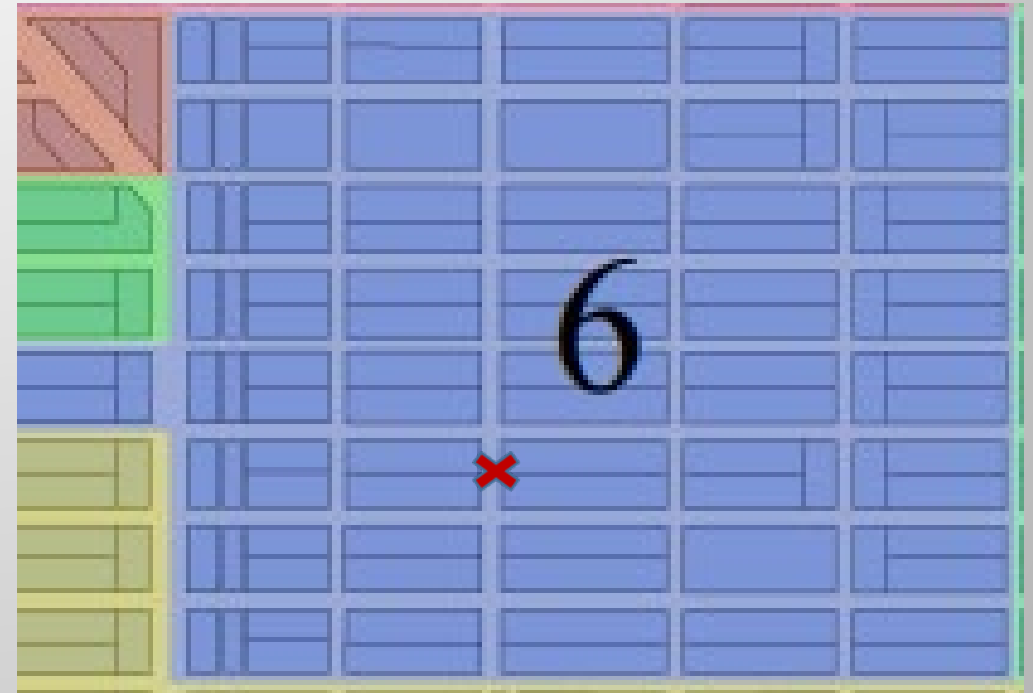
Aggravated Battery to Police Officer/Resisting Arrest — 2/05/2023 6500 W. 19th Street — 10:03p.m.

Officers responded to a domestic disturbance where they encountered a male subject who was intoxicated and highly confrontational on scene. The male subject continuously approached officers in a confrontational manner while pointing his i-Phone at them. Despite being continuously advised to cease his actions, he continued. An attempt to place the subject into custody was made at which point he resisted causing officers to fall down a short flight of stairs. The subject then spit blood at the arresting and assisting officers. An additional officer was kicked as he attempted to place leg shackles and reason with the arrestee.

The subject was placed into custody and transported to MacNeal Hospital for intoxication and medical examination. Upon hospital discharge, the subject was transported to the Berwyn Police Department where he was subsequently charged with 4 (four) felony counts of Aggravated Battery to Police Officers and 1(one) felony count of Resisting Arrest. Case closed by arrest.

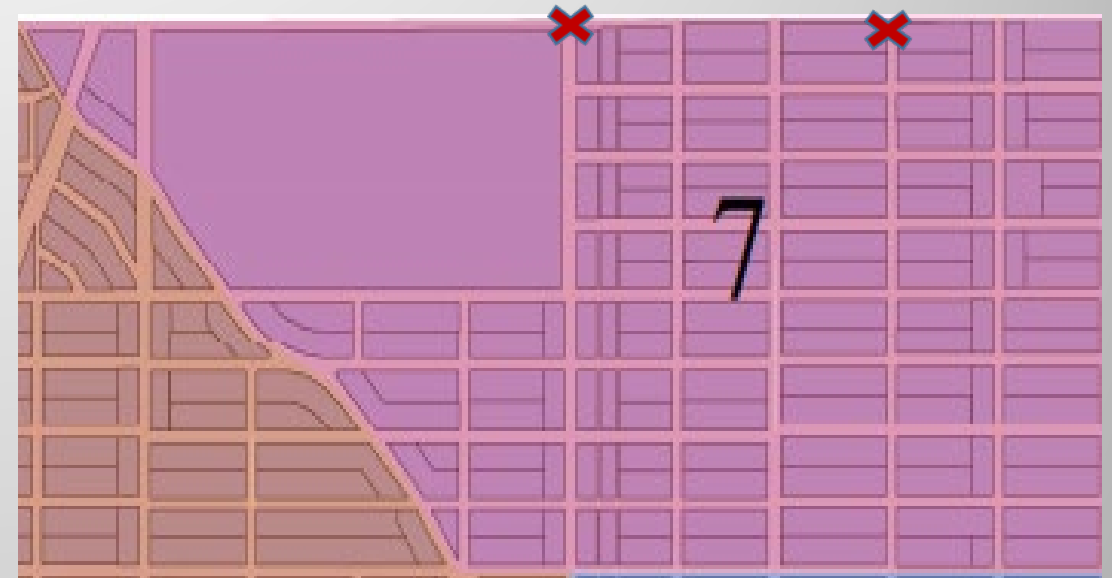

Aggravated Discharge of a Firearm — 2/01/2023 Cermak/Harlem — 3:47a.m.

Berwyn Dispatch received information from WESCOM regarding two vehicles shooting at each other while traveling at a high rate of speed Southbound Harlem Ave. from North Ave. Berwyn units in the area of Harlem Ave/Cermak Rd. observed 2 (two) vehicles Eastbound Cermak Rd and heard shots being fired from one of the vehicles. Both vehicles turned onto Northbound Harlem Ave. from Cermak Rd. at which time 3-4 additional shots were fired from one of the vehicles towards the other. A third vehicle that may have been involved fled Eastbound Cermak Rd. at a high rate of speed. Berwyn units pursued vehicle #2 Northbound on Harlem onto Eastbound I-290 losing sight of the vehicle at Cicero Ave and terminating the pursuit. Oak Park PD advised that they had one of the vehicles involved in a crash in their town with a live 9mm round located inside the vehicle. Northbound Harlem Ave was shut down at Cermak Rd and a canvas was conducted for spent casings. 2 (two) spent casings were located at on the 2100 block of Harlem Ave (one in the street and one on the sidewalk). Items were recovered and inventoried as evidence. This investigation is ongoing.
