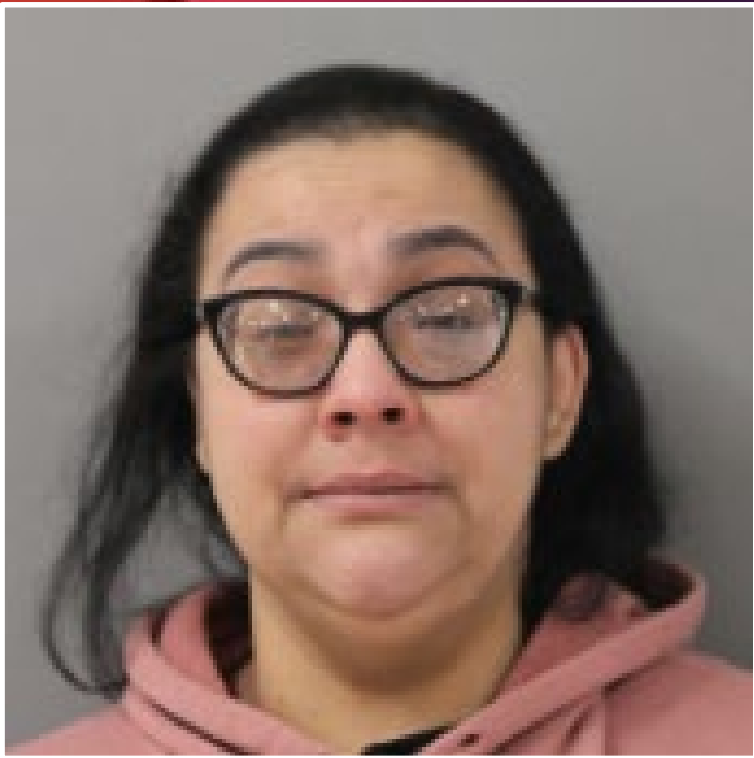

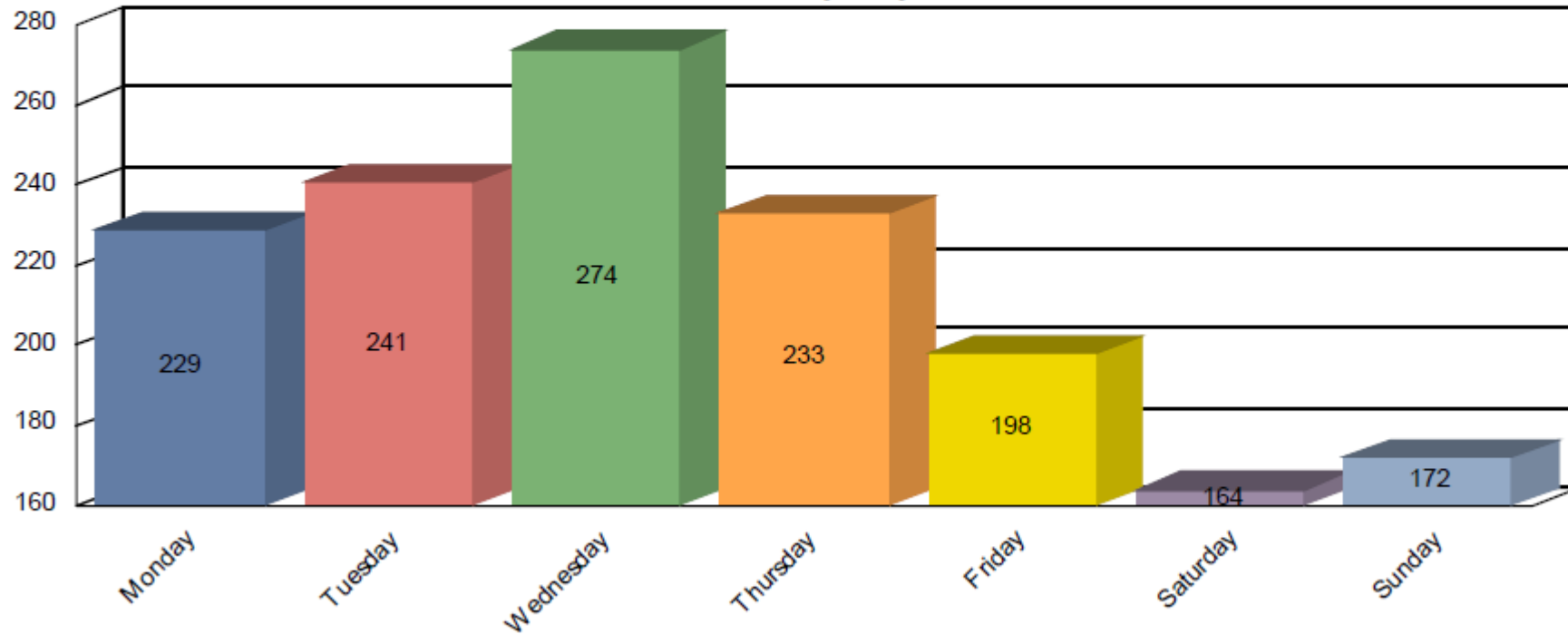

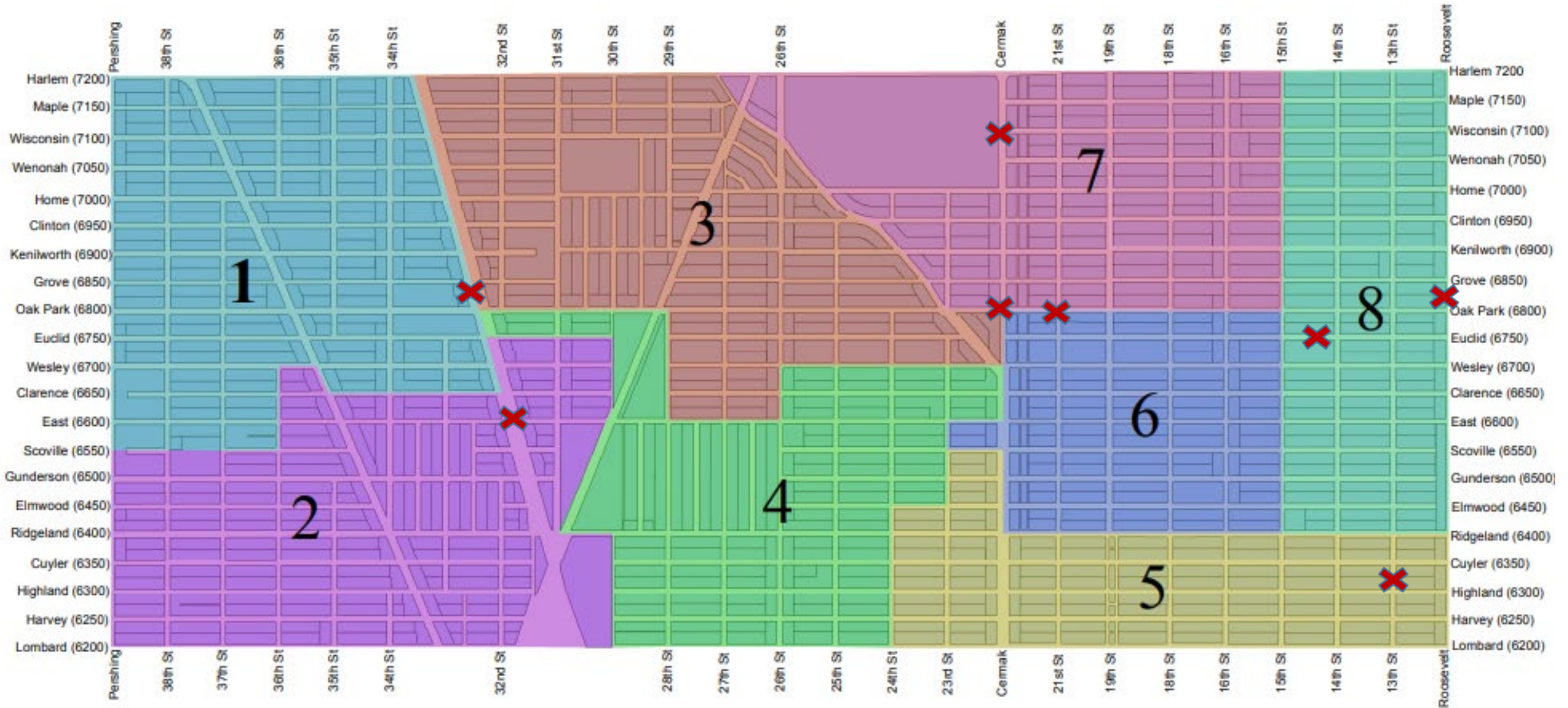
### Items For Service Distribution

# SIGNIFICANT INCIDENTS IN 1<sup>ST</sup> WARD

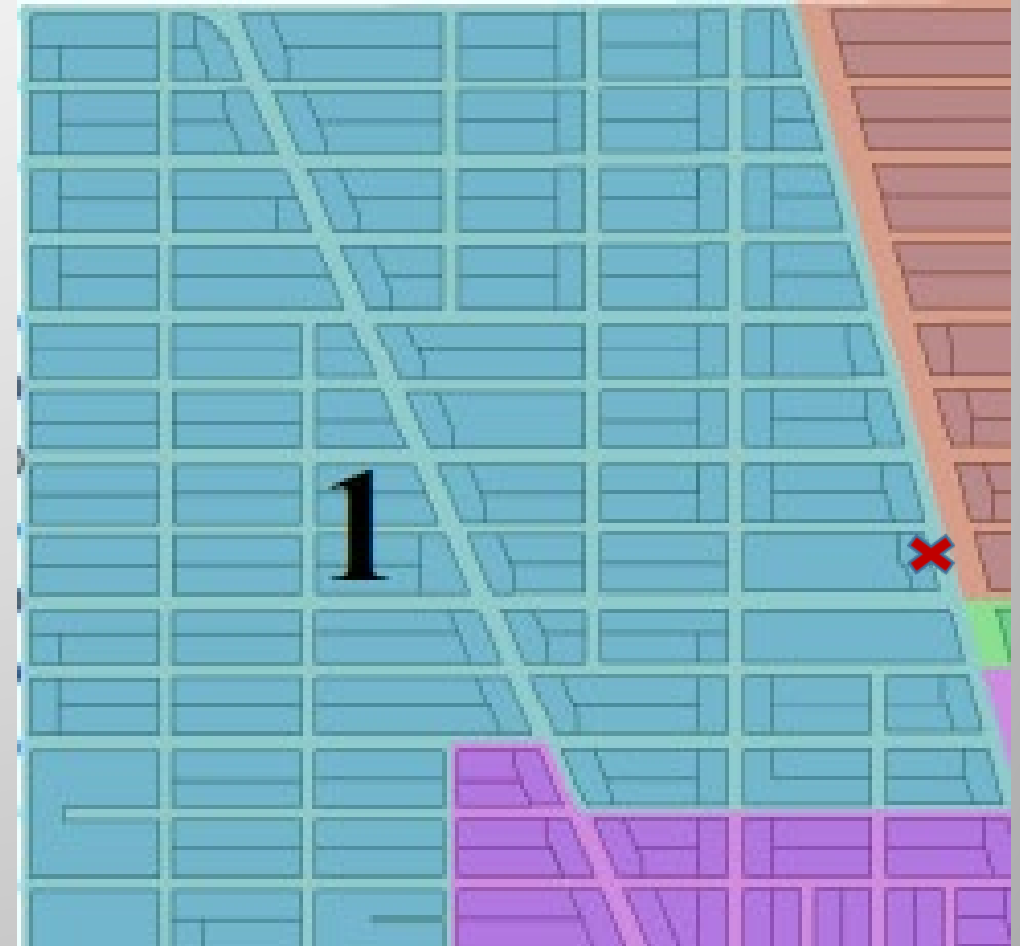

## **Aggravated Unlawful Use of a Weapon by a Felon Possession of a Controlled Substance — 2/28/2023 Windsor Café (6834 Windsor) — 8:33p.m.**

Officers responded to Windsor Café for a call of a person with a gun. Upon arrival, officers met with a witness who stated they saw a White Male subject waving a gun at two Hispanic Male subjects. It was first reported that the offender left the bar, however, while officers were on scene they observed a Male White subject stand up inside the bar with a handgun visible in the rear waistband of said subject. Officers detained said subject and eventually placed him under arrest and transported him to Berwyn PD for processing. Officers recovered a loaded firearm from the subject's waistband, 2 (two) folded dollar bills with Cocaine (2 grams), and 1 (one) plastic bag with Cannabis (1 gram). The subject was subsequently charged with 1 (one) felony count of Aggravated Unlawful Use of a Weapon and 1 (one) felony count of Possession of a Controlled Substance. Case closed by arrest.

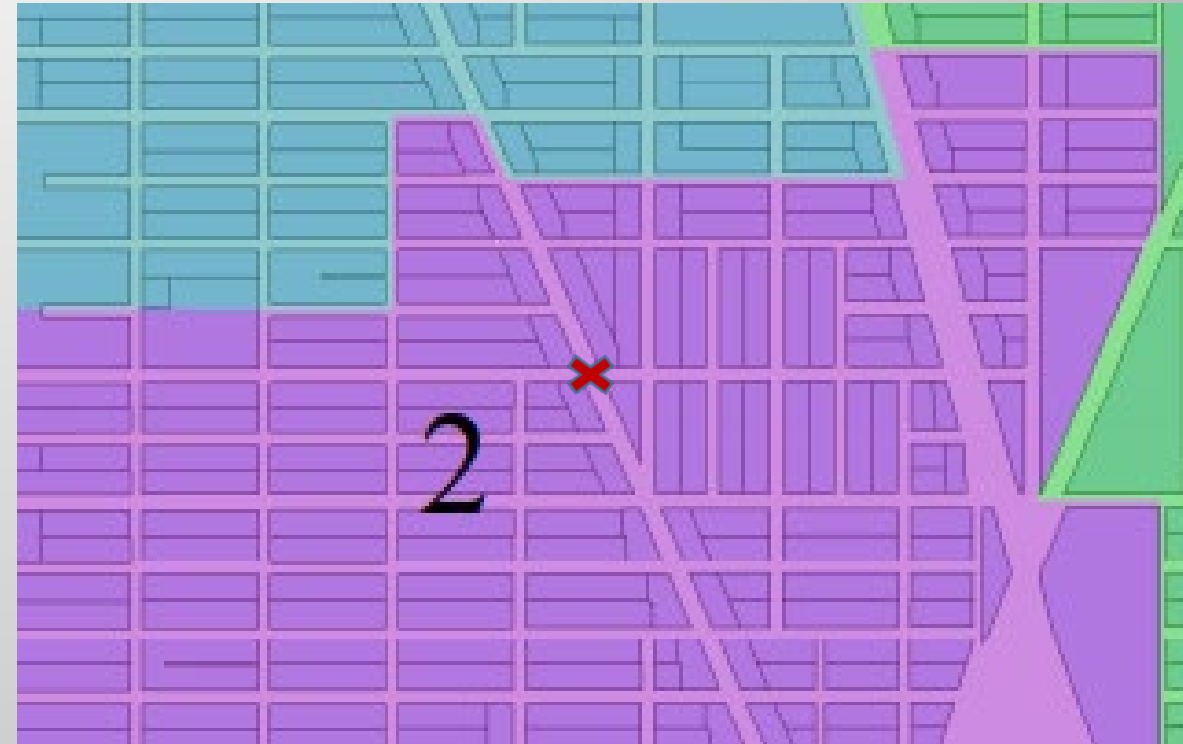

## Aggravated Fleeing & Eluding (Juvenile) — 3/03/2023 Ogden Ave/East Ave — 12:38a.m.

Berwyn Police Officers observed a vehicle traveling at a high rate of speed (72mph in the 30mph posted zone) Westbound on Ogden Ave at East Avenue. The officer attempted to stop the vehicle, however, the vehicle refused to stop. Said vehicle extinguished their lights and attempted to make a turn onto Wesley from Ogden Ave. The vehicle subsequently lost control and struck a traffic control sign on the corner of Wesley/Ogden Ave. Units converged on the vehicle which was occupied by 2 juveniles (1 Male, 1 Female). The Male Juvenile driver was taken into custody and transported to the station. The mother of the two juveniles was contacted and arrived on scene where she signed a medical refusal with BFD for both subjects. The driver was subsequently charged with Aggravated Fleeing & Eluding. Case closed by arrest.

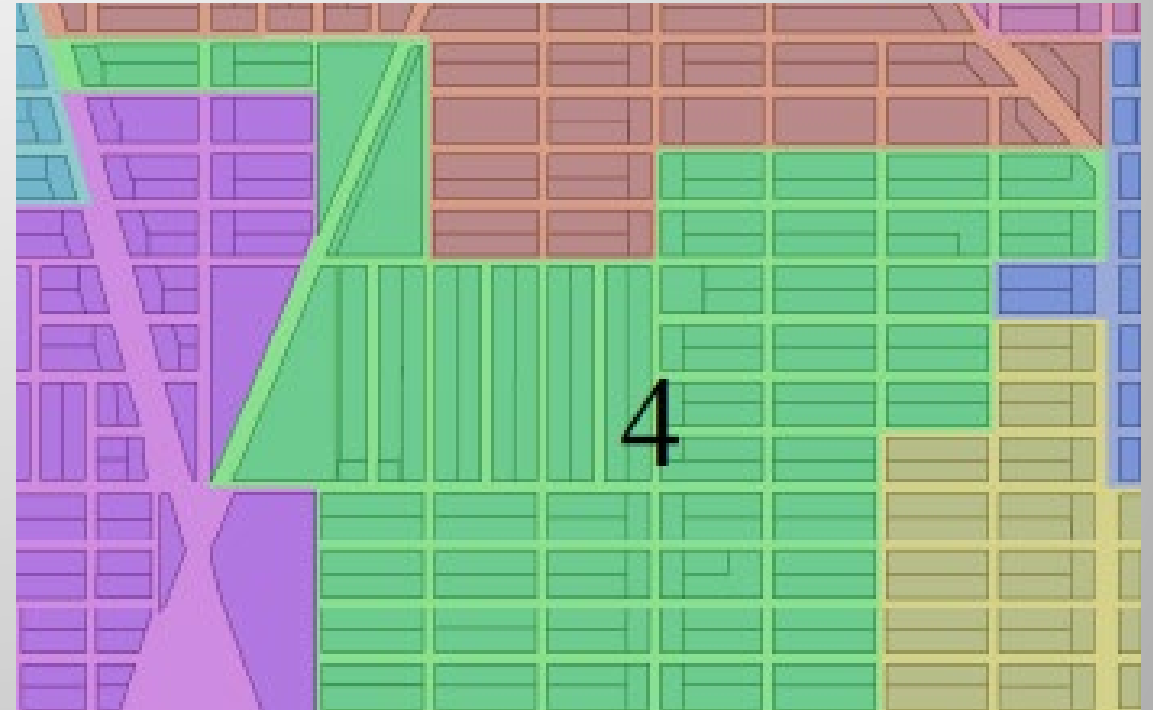

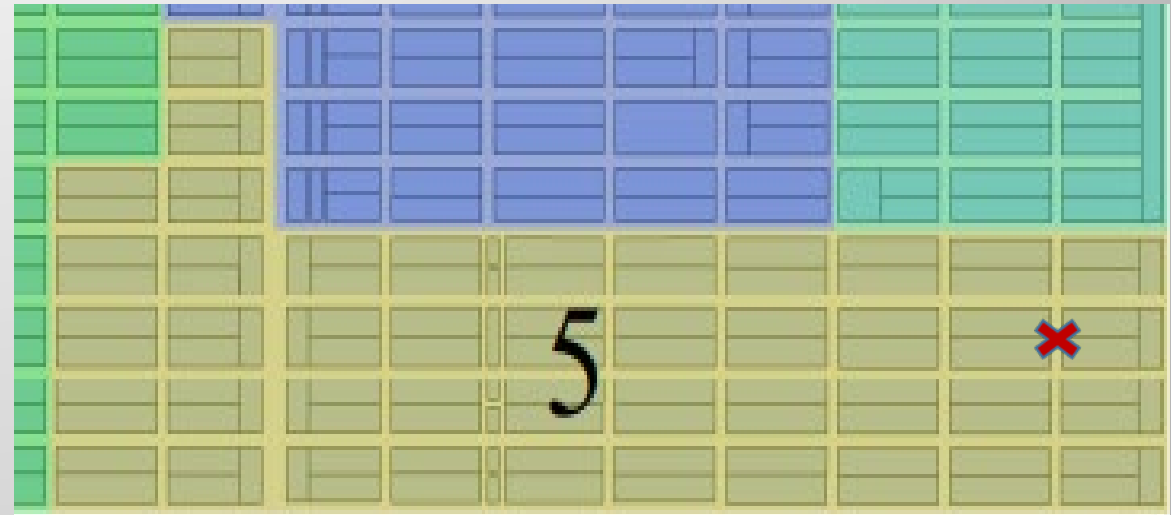

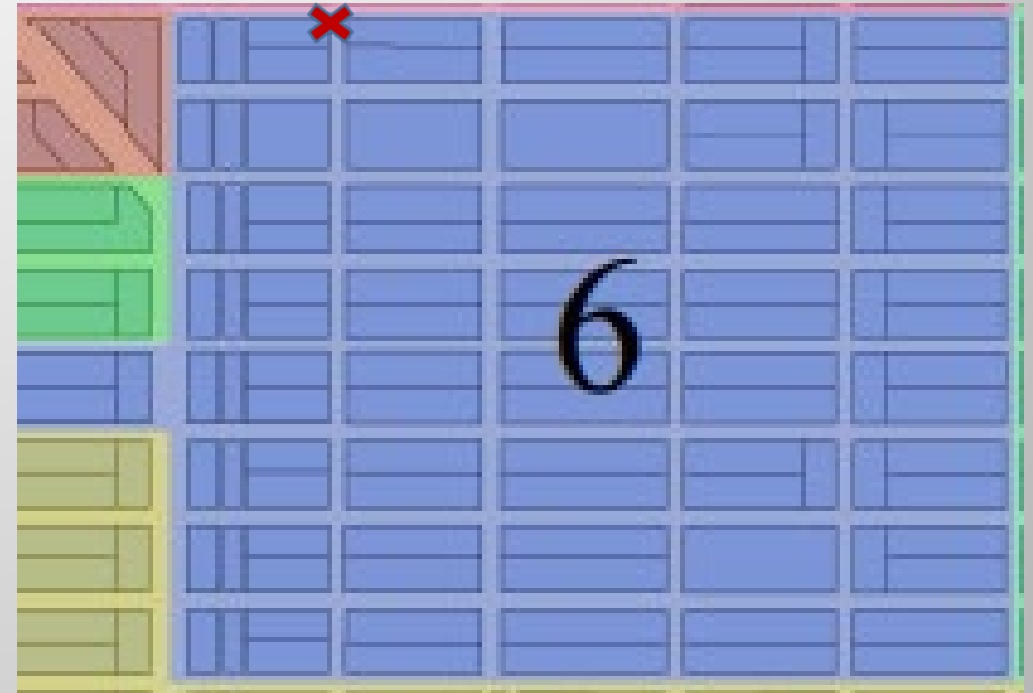

## Aggravated Unlawful Use of a Weapon — 2/28/2023 2100 block of Oak Park Ave. — 10:58a.m.

Officers responded to a call of a suspicious person at a residence on the 2100 block of Oak Park Ave. It was further reported that suspicious male was in the rear of said building on the third floor porch. The caller stated that she believed that the male had damaged the exterior front door of said address. Upon arrival, officers located a male subject exiting the third floor porch who matched the description. At this time a black in color semi-automatic handgun was recovered in an open and unsecured bag. The subject did not have a valid Foid or CCL. Said weapon was checked via LEADS and found to be stolen out of Crown Point Indiana. Officers placed the subject in custody without incident and transported him to the Berwyn Police Department. The subject was subsequently charged with 1 (one) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

# SIGNIFICANT INCIDENTS IN 7<sup>TH</sup> WARD

## Retail Theft/Warrant — 2/27/2023

### Walgreens (7113 W. Cermak) — 12:31a.m.

Officers responded to a call of a retail theft in progress at Walgreens (Cermak Plaza). Responding Officers were advised by Berwyn Dispatch that a Male Black subject with a thin build, wearing a black hooded sweatshirt with gold writing, had just stolen 3 (three) bottles of Jack Daniels alcohol and walked out of the store. Officers conducted a check of the area and located the offender in front of Lens Crafters carrying three bottles of Jack Daniels (now placed inside of a Tony's plastic bag). Officers detained the subject and a Walgreens employee was brought over for a show-up of the offender. A positive identification was made on scene and the Walgreens employees advised that they wished to pursue a criminal charge. The offender was transported to the Berwyn Police Department and the proceeds from the theft were turned back over to Walgreens.

While at the police station, officers learned that the offender had an active warrant. The warrant was confirmed by Cook County as a No Bond Warrant for Robbery. The offender was processed on the warrant and also charged with retail theft. Case closed by arrest.

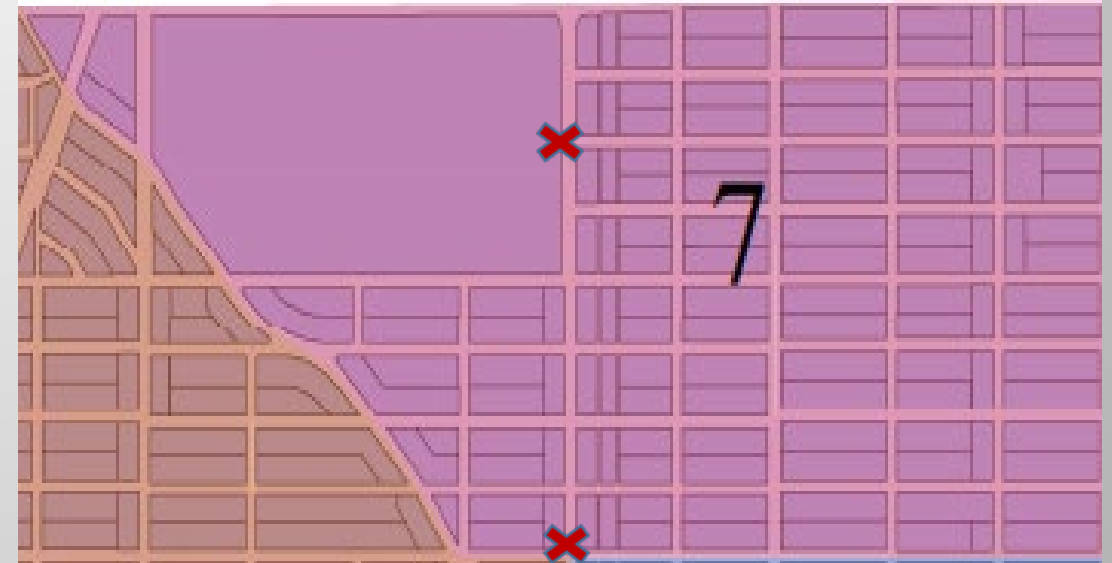
## Theft of Services — 3/03/2023

### El Nuevo Vallarta (6801 W. Cermak) — 9:41p.m.

Officers responded to El Nuevo Vallarta for a report of theft of services. Upon arrival, officers found that security was detaining a Male Hispanic subject. The offender and several of his friends ran up a bill of approximately \$650. All of his friends had left prior to him, one at a time. The offender was unable to pay the bill and management wished to sign complaints. The offender was taken into custody without incident and charged accordingly. Case closed by arrest.

## **Motor Vehicle Theft (Kia) — 3/05/2023** **1400 block of Euclid — 11:46a.m.**

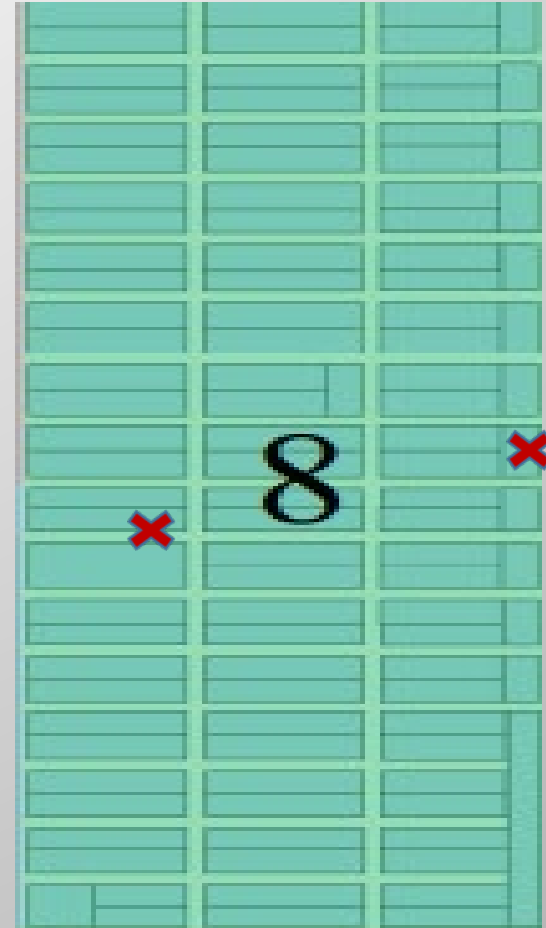

Officers observed broken glass on the ground where the vehicle was parked. The vehicle was entered into LEADS as stolen. On 3/06/2023 Chicago Police Department advised that said vehicle was located (no arrests made). This investigation is ongoing.

Officers responded to a check the well-being of a driver who was slumped over. An investigation was conducted and the driver was determined to be intoxicated. Officers observed an open bottle of alcohol in the vehicle. The subject was placed into custody. While officers were conducting a protective search of the subject, a firearm was discovered in his jacket pocket. The driver did not have a valid FOID or CCL. The offender was subsequently charged with 1 (one) felony count of Aggravated Unlawful Use of a Firearm and DUI. Case closed by arrest.

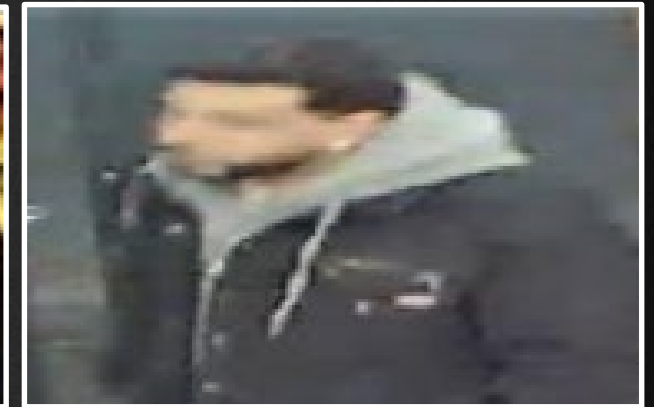
