
### SIGNIFICANT INCIDENTS IN 2<sup>ND</sup> WARD

#### FOR WEEK OF 4/03/2023

#### Reckless Homicide (Fatal Accident) — 4/08/2023 Caliber Collision (6305 W. Ogden) — 10:43p.m.

Officers responded to a report of a vehicle that crashed into the building at Caliber Collision (6305 W. Ogden Ave). BPD Traffic Unit and WESTAF were called out to investigate the crash. Officers spoke with the male driver who related that he was traveling Eastbound on Ogden Ave. and hit a pothole in the area of Cuyler Ave. which caused him to lost control of the vehicle. Prior to striking the building the vehicle took down a City light pole. During the investigation, it was determined that the vehicle was traveling Eastbound on Ogden at a high rate of speed (74mph in a 30mph zone) when it went air bound and then came back down to the pavement at which point the vehicle lost control and struck the building. The vehicle, Dodge Charger Hellcat, did not have a valid registration and was determined to be totaled. Officers discovered multiple license plates inside the vehicle and black colored electrical tape covering the VIN. Berwyn Police notified the building department and BFD. BFD inspected the structure and deemed it uninhabitable.

The male driver refused medical treatment and the female passenger suffered serious injuries to which she later succumb to while at the hospital. The driver was taken into custody without incident and transported to the Berwyn Police Department. The driver was issued multiple citations for traffic violations and was also charged with 1 (one) felony count of Concealing the Identity of a Vehicle and 1 (one) felony count of Reckless Homicide. Case closed by arrest.

### SIGNIFICANT INCIDENTS IN 4<sup>TH</sup> WARD

#### FOR WEEK OF 4/03/2023

Stolen Auto (Kia)/Possession of Stolen Motor Vehicle — 4/05/2023 2800 block of Ridgeland — 4:38p.m.

Officers responded to the 2800 block of Ridgeland for a call of a stolen auto (Kia). The victim related that she last saw her vehicle earlier that morning. Officers did not observe any broken glass on the street where the vehicle was parked. The vehicle was entered into LEADS as stolen.

The stolen vehicle was located the following day (4/06/23) in Oak Park when a report was received of its involvement in a traffic accident at Lombard/Park. Berwyn Police responded to the area of said accident for the vehicle that struck a pole and the driver (Male Black subject) fled on foot. Upon arrival to the area, officers observed a black in color Kia Soul with heavy front end damage that had struck a utility pole and also a fence. Berwyn Police noted that said vehicle was reported stolen out of Berwyn the previous day.

Shortly after recovering the vehicle, Berwyn Tactical Detectives located the offender in the area of 35<sup>th</sup> Street/Highland at 5:30p.m. While touring the area, Tactical Detectives observed a Male Black subject with dreads and a gray hooded sweatshirt running Southbound from 35<sup>th</sup> Street on Highland. Tactical Detectives attempted to perform a street stop on the individual, at which time he disobeyed and continued to flee on foot Westbound through several yards, and then Southbound on Cuyler. Pursuant to a short chase, Tactical Detectives detained the offender and placed him into custody without incident on the 3500 block of Cuyler. The offender was in possession of a USB cable and a large flathead screw driver, tools that are commonly used for stealing Kia's and Hyundai's. The offender was transported to the Berwyn Police Department and subsequently charged with 1 (one) felony count of Possession of a Motor Vehicle. Case closed by arrest.



#### Person with a Gun (Unfounded) (Juvenile) — 4/07/2023 6300 block of 26<sup>th</sup> Street — 11:59p.m.

Officers were dispatched to the 6300 block of 26<sup>th</sup> Street in response to a report of a person with a gun. Upon arrival, responding units located two subjects (Male and Female) in the alley. The male subject was highly intoxicated and an ambulance was requested to the scene. The male subject advised that he was 18 years old. His mother arrived on scene and provided his birthdate which confirmed he was actually a Juvenile. The male subject was transported to Mac Neal Hospital for further treatment. The male juvenile was issued a Local Ordinance citation for Under Age Consumption of Alcohol, which was turned over to the juvenile's mother at the hospital.

Note: Police determined the initial gun report to be unfounded.





### SIGNIFICANT INCIDENTS IN 5<sup>th</sup> Ward

### FOR WEEK OF 4/03/2023

#### Battery/Fight/Brawl — 4/08/2023 Canton 8 (6312 W. Cermak) — 2:42a.m.

Officers were dispatched to Canton 8 in reference to a third party caller who advised of a group of 8-10 subjects beating up on two other subjects. The original caller also advised that they observed some of the offenders with handguns. Upon arrival, the victims were located and an ambulance was requested for 2 battery victims. Attempts to obtain information from the victims was met with negative results. Officers spoke with witnesses who advised the incident stemmed from a verbal altercation inside the bar. Shortly after, when one group was leaving they were approached by 8-10 subjects who approached them and began physically fighting with the 2 male victims. After the victims were attacked the offenders fled in a white colored truck/SUV and were last seen traveling Eastbound in the Vacin Fairway towards Lombard Ave. This investigation is ongoing.

#### Car Club/Street Racers — 4/09/2023 Cermak/Ridgeland — 12:022a.m.

Berwyn Dispatch received information from Cicero PD that a group of street racers were heading into Berwyn near Cermak/Ridgeland. Chicago PD Helicopter (PH2) was following the vehicles as they entered Berwyn and the surrounding towns, transmitting information on ISPERN. Numerous vehicles raced through town without license plates. BPD units successfully kept the vehicles from taking over any intersections. BPD units dealt with the vehicles entering and exiting Berwyn for over 2  $\frac{1}{2}$  hours.




### SIGNIFICANT INCIDENTS IN 6<sup>th</sup> Ward

#### FOR WEEK OF 4/03/2023

### Attempt Stolen Auto (Hyuandai)/Criminal Damage to Property 1900 block of Elmwood — 4/06/2023 — 1:14a.m.

Officers responded to the 1900 block of Elmwood Ave. for a call of an attempted stolen auto. Responding officers observed the victim's vehicle (Hyundai) had a broken passenger side rear window and the steering column was damaged. A witness advised they observed 2 (two) Male Black subjects (one wearing a tan hoodie and the other wearing a red hoodie) exit the victim's vehicle and run Southbound on Elmwood Ave. from that location. One of the offenders dropped his cell phone next to the victim's vehicle. The offenders also left a phone charging cable that would have been used to start the car. The Evidence Technician on scene recovered the cell phone and charging cable. This investigation is ongoing.



#### Stolen Auto (Kia) — 4/05/2023 6800 block of 19<sup>th</sup> Street — 9:49a.m.

Berwyn resident presented at the Berwyn Police Department's front desk to report her vehicle (Kia) as stolen. The victim related that the vehicle was taken sometime between 5:30p.m. on 04/04/2023 and 6:45a.m. on 04/05/23 from the 6800 block of 19<sup>th</sup> Street. The victim further related that this is the second time her vehicle has been stolen since January 1<sup>st</sup>. The vehicle was entered into LEADS as stolen. The Chicago Police Department located said vehicle on 4/13/2023 and notified the owner. This investigation is ongoing.

#### Possession of a Controlled Substance/Unlawful Use of a Weapon by a Felon — 4/06/2023 Cermak/Home Ave. — 12:46a.m.

Officers conducted a traffic stop at Cermak/Home Ave. Upon making contact with the driver, police learned that the driver did not have a valid Drivers License and was subsequently taken into custody without incident. During an inventory search of the vehicle, officers located numerus pills, several live rounds of ammunition and other contraband. The passenger was on parole and had an active out-of-state warrant. The passenger was then also taken into custody but advised officers he needed medical treatment for a pre-existing injury. The passenger was transported to Mac Neal Hospital for treatment. The driver was transported to the Berwyn Police Department and subsequently charged accordingly. The passenger was charged with 1 (one) felony count of Unlawful Use of a Weapon by a Felon and 1 (one) felony count of Possession of a Controlled Substance. Case closed by arrest.






### SIGNIFICANT INCIDENTS IN 7<sup>TH</sup> WARD

#### FOR WEEK OF 4/03/2023

#### Battery/Disturbance — 4/08/2023 El Nuevo Vallarta (6801 W. Cermak) — 12:21a.m.

Officers responded to El Nuevo Vallarta in reference to a report of a disturbance between a female subject and a security guard at the location. Upon arrival, it was learned that a disturbance between two groups started in the bar and continued as they exited the establishment. A security guard was alerted to the fight in the parking lot and was able to separate the groups. A battery victim was located as well as the offender (female subject) on scene who was taken into custody without incident. While identifying the remaining subjects on scene that were involved in the disturbance, a female subject (identified by security as being involved) refused to identify herself. Said female subject was taken into custody for obstructing identification and was transported to the Berwyn Police Department. Two (2) male subjects from the same group, were intoxicated and attempting to start fights with other patrons as they were leaving the bar. Said subjects failed to obey numerous lawful orders given by officers on scene and were subsequently taken into custody for Disorderly Conduct/Public Intoxication and transported to the Berwyn Police Department. All three subjects were given Local Ordinance citations for public intoxication. Complaint signed for Battery by the victim and the offender was charged accordingly. Case closed by arrest.
