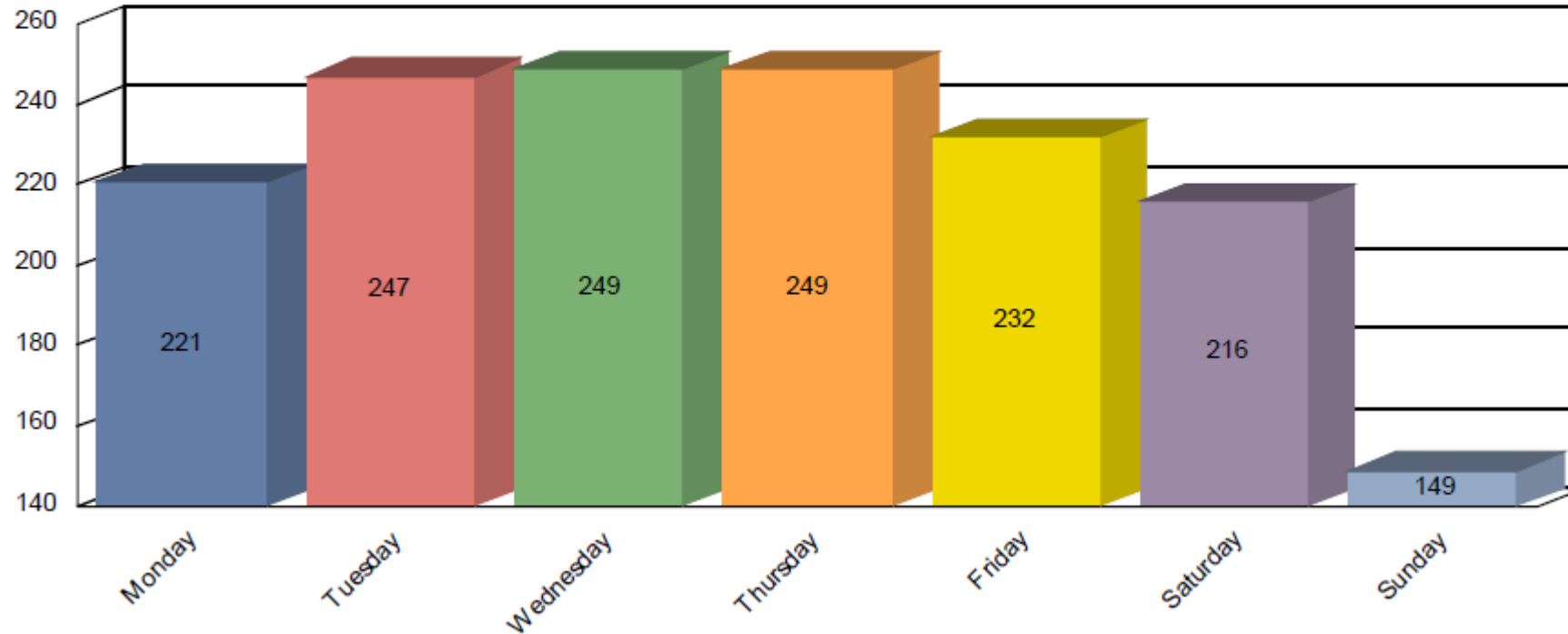

Total Items For Service

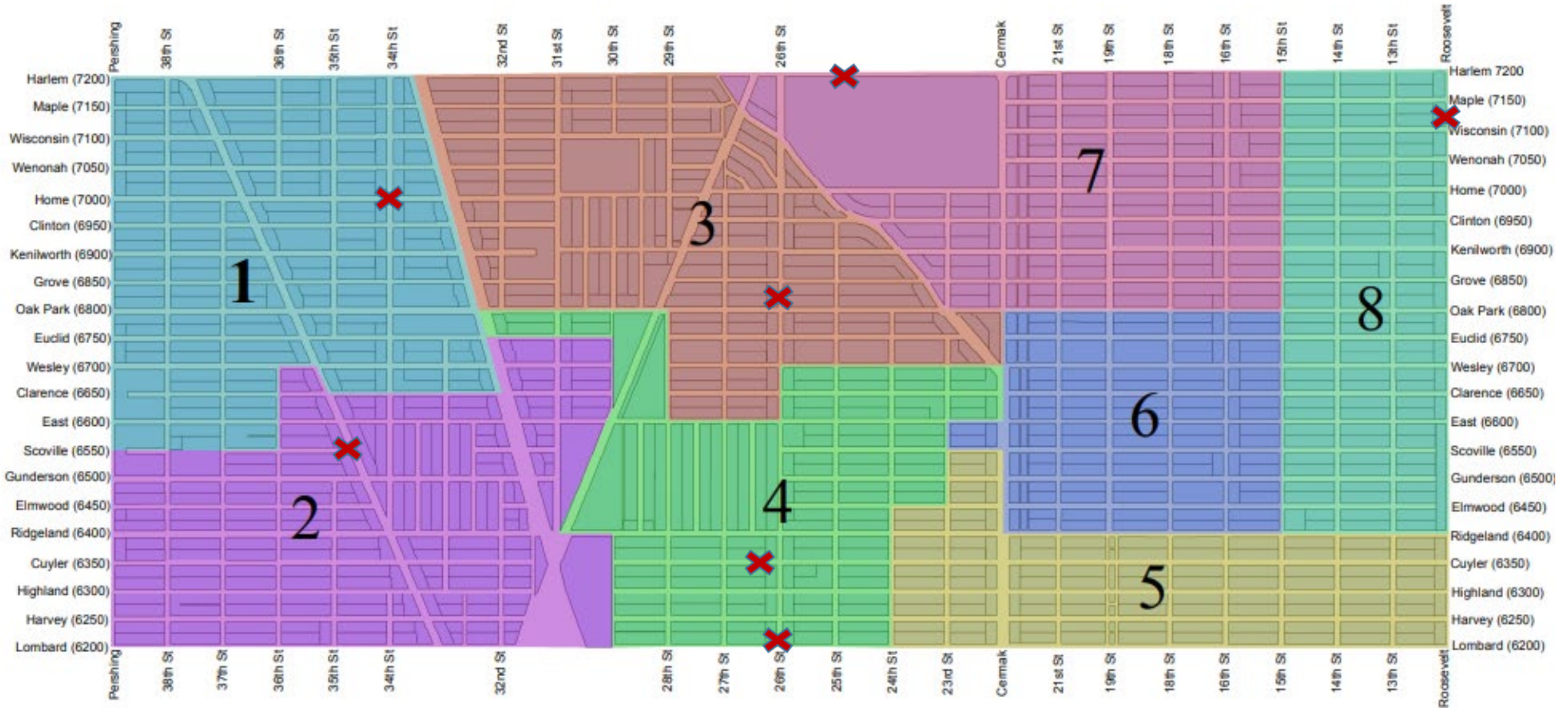

SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 4/10/2023

Aggravated Unlawful Use of a Weapon — 4/11/2023 **3400 block of Home Ave. — 4:53p.m.**

Berwyn Police conducted a traffic stop on the 3400 block of Home Ave. Upon making contact with the driver, officers learned that the driver did not have a valid driver's license. The driver was subsequently taken into custody. A search of the vehicle revealed a loaded firearm which was unlawfully concealed within a void in the front panel behind the air vent near the steering wheel. Neither the driver nor any of the occupants of the vehicle had a valid VOID or CCL. The driver was charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.



Ward 1



SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 4/10/2023

Aggravated Assault/Attempted Robbery/Failure to Register as Sex Offender Ogden/Scoville — 4/15/2023 — 10:46a.m.

Berwyn Police were flagged down by a male subject who related that that he, his girlfriend, and daughter (in stroller) were walking Westbound on the 6400 block of Ogden Ave. when four (4) male subjects wearing dark clothing approached him in a threatening manner and demanded to see what was inside his back pack. The victim further related that the male subjects yelled out gang jargon at him. The victims escaped (unharmd) on foot. While fleeing on foot, the victims spotted an officer on patrol and notified them of said incident. The victims, in a panic, continued to flee on foot and told the officer they needed to get home where it was safe.

A short while later, the male victim called Berwyn Dispatch and reported seeing the offenders on foot near East Ave/34th Street. During the call, the victim further related one of the offenders displayed a handgun during the attempted robbery incident. Officers conducted a canvass of the area and successfully located the offenders who were taken into custody without incident. Officers conducted a show-up at which time the victim positively identified all four (4) offenders. A search of the offenders resulted in negative results for any firearms. The victim initially advised officers that he wished to sign criminal complaints for the assault but later became uncooperative with the investigation and did not sign the complaint.

During the brief investigation it was learned that one of the male subjects in custody had failed to register as a Sex Offender and was subsequently charged with one (1) felony count of Failure to Register as a Sex Offender.

SIGNIFICANT INCIDENTS IN 3RD WARD

FOR WEEK OF 4/10/2023

Disturbance — 4/15/2023

Tipsy's Tap (6802 W. 26th Street) — 2:47a.m.

Officers responded to Tipsy's Tap for a report of a fight in the rear. Responding officers observed an shirtless Male Hispanic subject screaming and running after another unidentified Male Hispanic subject. In order to prevent the incident from escalating and to prevent a battery from occurring, the first male subject was detained. Said subject related to officers that his chain was stolen after he got into a fight outside of Tipsy's Tap. The subject further related that he did not wish to pursue any criminal charges or have this incident investigated. The subject was subsequently released without further incident.



Ward 3



SIGNIFICANT INCIDENTS IN 4TH WARD

FOR WEEK OF 4/10/2023

Unlawful Possession of Stolen Motor Vehicle/Attempted Burglary to Motor Vehicle (Juvenile)/ Criminal Trespass to Motor Vehicle 2600 block of Lombard — 4/13/2023 — 3:03p.m.

Officers responded to the 2600 block of Lombard Ave. for a report of a vehicle (Kia) blocking the roadway with a broken window and peeled steering column. Upon arrival, officers observed a Black in color Kia which Berwyn Dispatch confirmed to be stolen out of Chicago. Officers observed the rear passenger side window to be broken and the steering column damaged which is consistent with a recent trend of stealing Kia and Hyundai vehicles. Said vehicle was towed by Metro.

Officers reviewed surveillance video from the immediate area which revealed four (4) occupants in the vehicle who fled on foot after abandoning the vehicle on the 2600 block of Lombard. (Note: Officers discovered the vehicle was out of gas). Officers shared a description of the four (4) male subjects who were seen occupying said vehicle with the rest of the officers on the street.

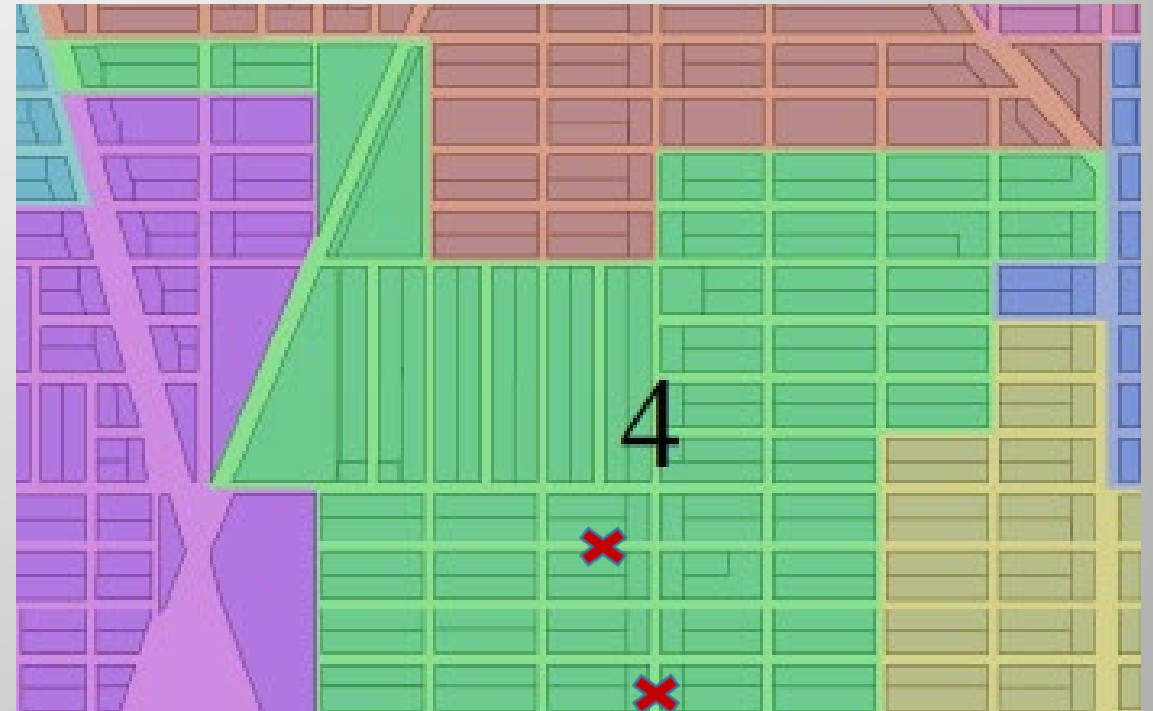
Shortly after, a report was made for the attempted theft of two (2) additional vehicles (Kia) in the area of 1900-2100 blocks of Scoville where the description of the offenders matched that of the previous incident on Lombard. Officers located said subjects and a short foot pursuit ensued. Three (3) subjects, 2 juvenile & 1 adult, were taken into custody and charged accordingly. (Note: 1 of the juveniles had an existing warrant) Case closed by arrest.

Shots Fired — 4/13/2023 2600 block of Cuyler— 9:36p.m.

Officers responded to the 2600 block of Cuyler for a report of shots fired. Upon arrival, responding officers met with a female subject who related that she and her boyfriend were shot at by unidentified offender(s), however, she was unwilling to furnish any additional information and did not wish for any Police nor Medical assistance. A canvass of the area revealed three (3) spent shell casings and negative results for any offenders. This investigation is ongoing.

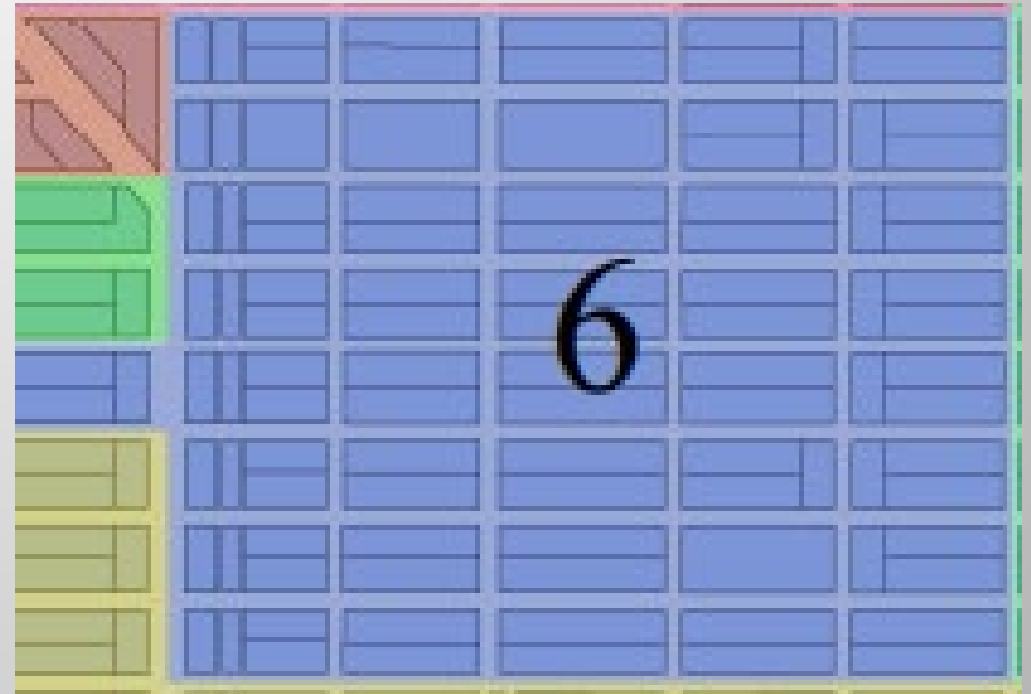

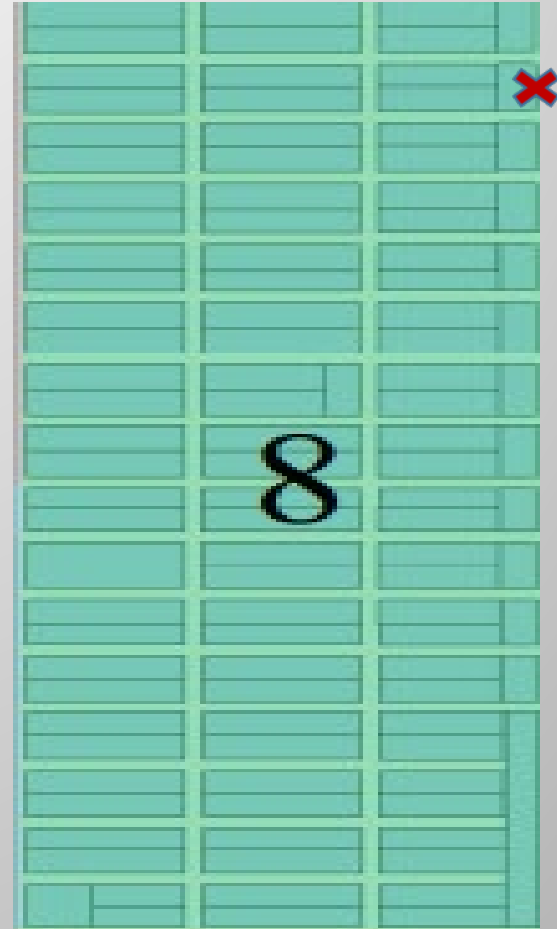
Battery — 4/16/2023
