




SIGNIFICANT INCIDENTS IN 3RD WARD


Suspicious Persons/Stolen Auto — 4/22/2023 1400 block of Highland — 1:47a.m.

Officers responded to a call regarding two male subjects wearing ski masks who switched the license plate on a red in color vehicle (Hyundai) placing a yellow Temporary Registration plate on it. Said vehicle was last seen traveling Southbound on Lombard Ave. The reporting party also related observing a license plate thrown from the vehicle near the 1400 block Harvey/Highland alley. The reporting party did not have any additional details regarding the vehicle's license plate or owner. Berwyn Police did not receive any reports of a stolen vehicle that matched the description of said vehicle. This incident has been documented and further investigation is pending any new details.

Battery — 4/23/2023 Canton 8 (6312 W. Cermak) — 1:25a.m.

Officers responded to a report of a fight inside Canton 8. Upon arrival, responding officers located a battery victim standing outside the front doors of the bar. The victim advised that while security was in the process of escorting a group of subjects from the bar, one of the subjects in the group bumped into the victim. The victim further related that the subjects from the group then proceeded to hit/push the victim. The victim sustained a shoulder injury from the incident and was transported by BFD to Mac Neal Hospital for further evaluation of the injury. The offenders fled out the back door prior to officer arrival. This investigation is to continue.






SIGNIFICANT INCIDENTS IN 5TH WARD

Reckless Discharge of a Firearm — 4/23/2023 Cermak Smokes (6327 W. Cermak Rd) — 11:07a.m.

Berwyn Police Evidence Technician arrived on scene for photographs and recovered one projectile (9mm). This investigation is ongoing.





Unlawful Possession of a Stolen Motor Vehicle/Aggravated Battery to a Peace Officer/Aggravated Fleeing and Eluding/Aggravated Unlawful Use of a Weapon/Possession of a Controlled Substance

1600 block of Harlem — 4/23/2023 — 1:25a.m

Officers observed a stolen vehicle (KIA) on the 1600 block of Harlem and attempted to stop said vehicle on the 1900 block of Harlem in the AutoZone parking lot in North Riverside. The driver of the vehicle intentionally drove head-on and struck one of the Berwyn Police squad cars on scene causing damage to the front bumper of squad.

The offender fled the scene traveling Northbound on Harlem and then East on Roosevelt, and ultimately coming to a stop at Oak Park Avenue after causing an accident. The offender then exited the stolen vehicle and fled on foot into Oak Park. Officers set up a perimeter and located the offender shortly after. Berwyn Police placed the offender into custody without incident and transported him to the Berwyn Police Department. A search of the vehicle revealed a loaded handgun under the driver's seat. The offender was subsequently charged accordingly. Case closed by arrest.






