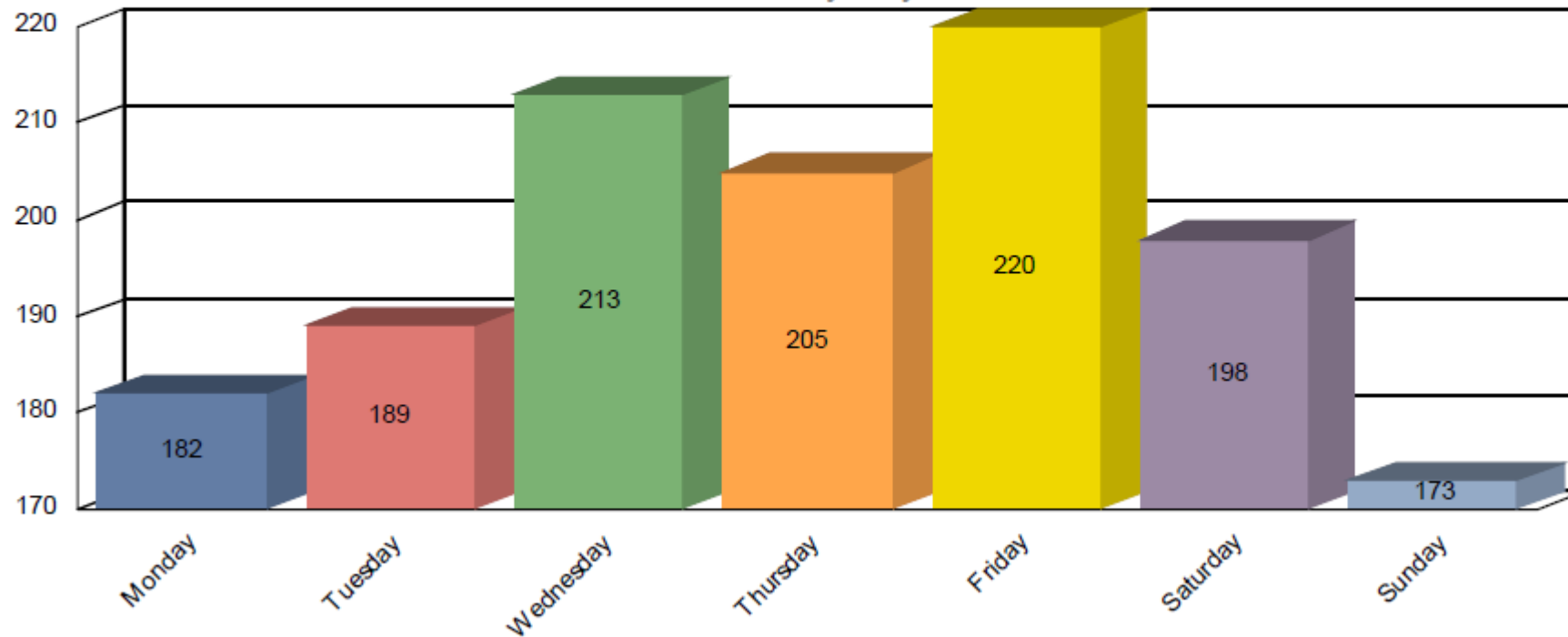

Total Items For Service

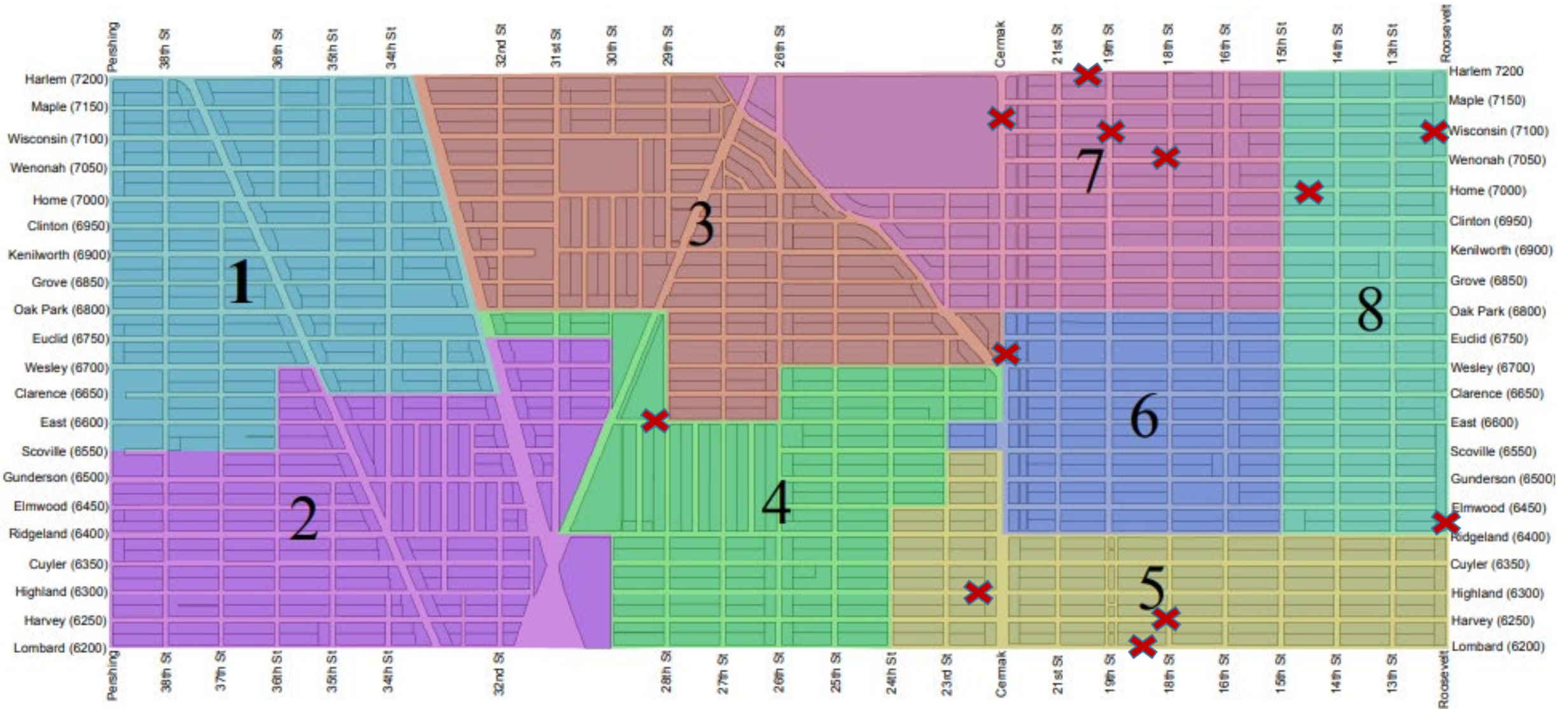

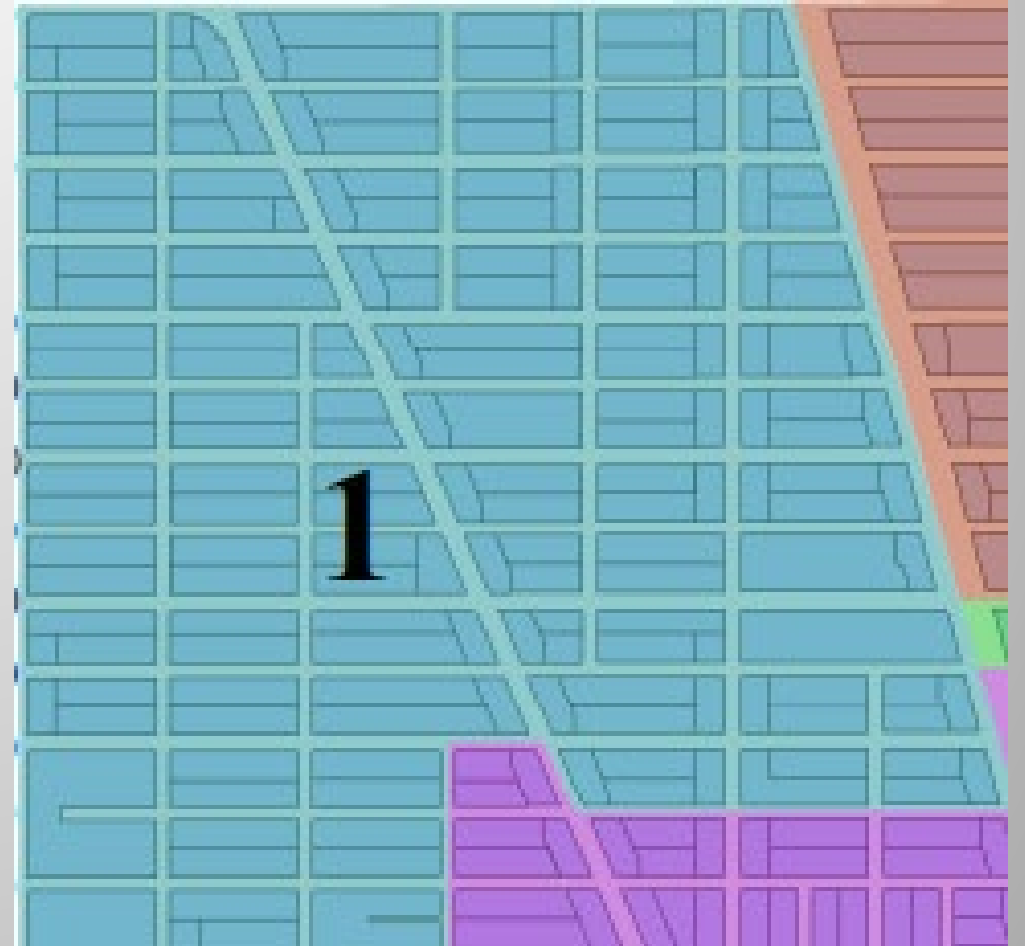

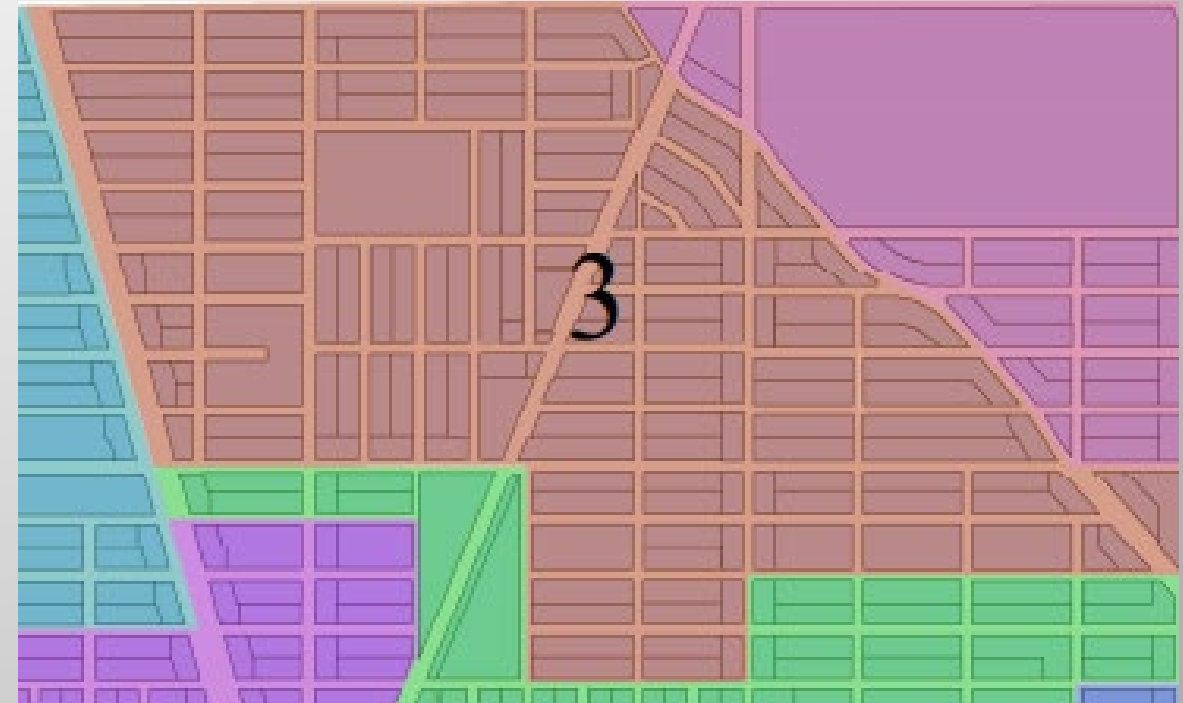

SIGNIFICANT INCIDENTS IN 4TH WARD

Disturbance — 7/20/2023

Baseball Alley (29th Street/East Ave) — 6:52p.m.

Officers responded to Baseball Alley for a report of a male subject acting erratically and brandishing knives. Officers canvassed the area and located the subject at the Berwyn Rec. Center (3100 S. East Ave.). Officers approached the subject and he immediately fled on foot Westbound on 31st Street. Officers detained the subject in the area of 31st Street/Wesley and found two (2) folding knives on his person. Officers observed the subject make irrational statements and display delusional behavior. BFD medics were summoned to the scene and subsequently transported this subject to Mac Neal Hospital for evaluation and treatment. There were no reported injuries or witnesses wishing to sign complaints.

SIGNIFICANT INCIDENTS IN 5TH WARD

Attempted Stolen Auto/Criminal Damage to Property — 7/18/2023 **1800 block of Lombard — 8:43a.m.**

Officers responded to a report of an attempted stolen auto. Responding officers met with the victim who related she parked her vehicle (Kia) the previous night and when she returned this morning she found the rear driver side window damaged and the steering column had been peeled. This investigation is ongoing.

Arson/Criminal Damage to Property — 7/20/2023 **18th Street/Harvey — 2:44a.m.**

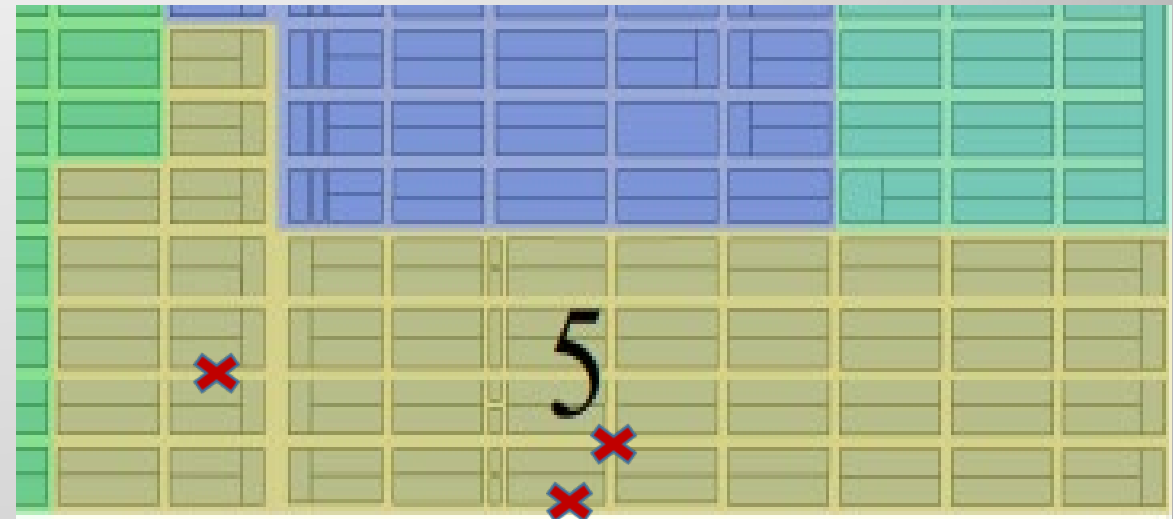
Officers responded to a call reporting a fire in the street in the area of 18th Street/Harvey. BFD was on scene and advised responding officers that there was a small fire on the windshield of a vehicle and a second fire on a beer can in the street. Both fires were extinguished and there were no reported injuries. This investigation is ongoing.

Aggravated Unlawful Use of a Weapon **Possession of a Stolen Firearm (Juvenile)** **2200 block of Highland — 7/20/2023 — 7:47p.m.**

Berwyn Dispatch received a call of a black in color sedan and several male subjects chasing another male subject in the 2200 block of Highland/Harvey alley. Responding officers located and stopped said vehicle involved and learned the driver did not have a valid driver's license. A search of the vehicle revealed a loaded handgun with an extended magazine and large amount of Cannabis. Three (3) juvenile subjects were taken into custody and turned over to Youth Investigations. Following an investigation, detectives learned that the victim's bicycle was also stolen by the offenders. Juvenile #1 was charged with one (1) felony count of Aggravated Unlawful Use of a Weapon and one (1) felony count of Possession of a Stolen Firearm. Juvenile #2 was charged with one (1) misdemeanor count of Unlawful Possession of Firearm Ammunition. Juvenile #3 was charged with one (1) misdemeanor count of Theft. Case closed by arrest.

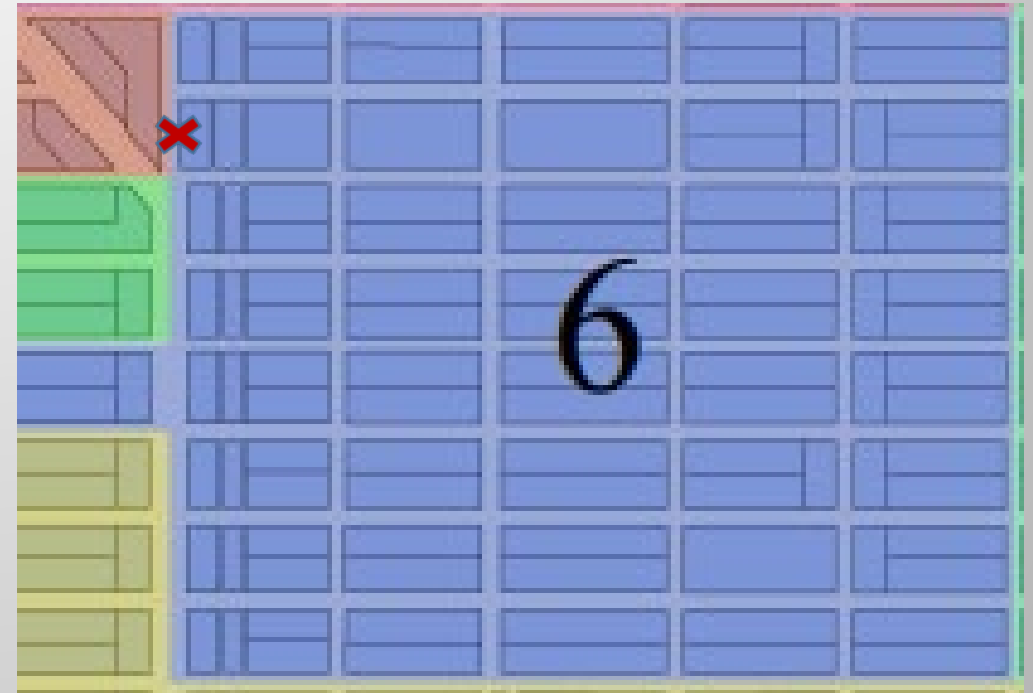

Criminal Damage to Property/Battery — 7/22/2023 **La Aduana Bar (6736 W. Cermak) — 2:38a.m.**

Units responded to La Aduana for a report of a female subject who had just broken the glass on the front door of the establishment. The offender was still on scene upon officer arrival. Responding officers learned that the offender damaged the front door and battered the owner. Officers placed the offender in custody and transported her to the Berwyn Police Department where she was subsequently charged accordingly. Case closed by arrest.

Attempted Stolen Auto/Criminal Damage to Property — 7/18/2023 19th Street/Wisconsin — 12:32 a.m.

While on patrol, officers observed the rear driver side window damaged on a white in color vehicle (Hyundai). Responding officer made contact with vehicle owner who relocated said vehicle to their garage. This investigation is ongoing.

Attempted Stolen Auto/Criminal Damage to Property — 7/18/2023 1800 block of Wenonah — 1:27a.m.

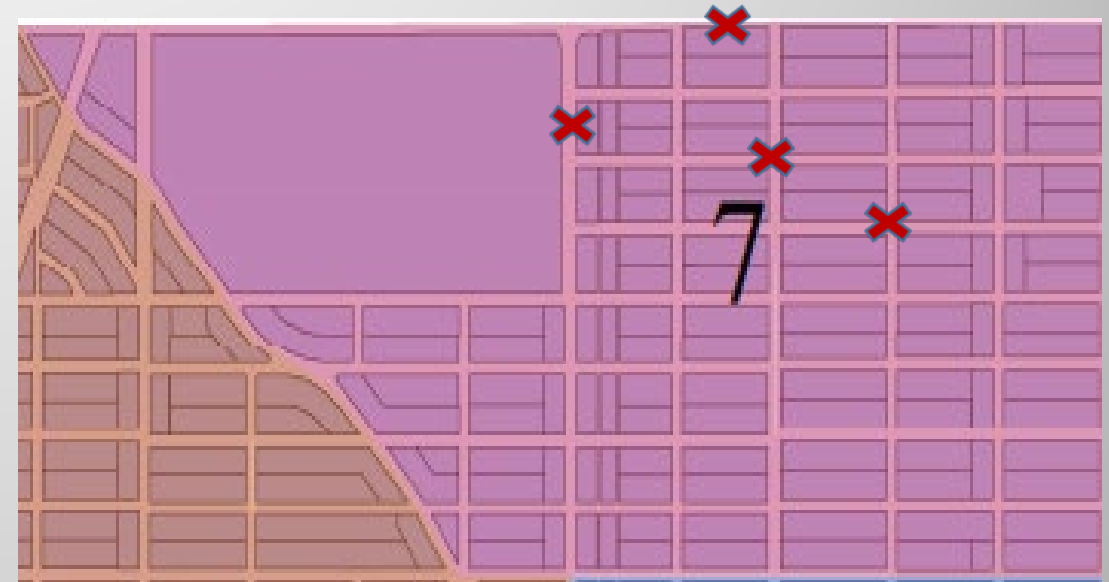
While on patrol, officers observed the rear driver side window damaged and the steering column had been peeled on a black in color vehicle (Kia). Responding officer made contact with vehicle owner. This investigation is ongoing.

Aggravated Unlawful Use of a Weapon — 7/20/2023 Buffalo Wild Wings (7130 W. Cermak) — 11:51p.m.

Units responded to Buffalo Wild Wings for the report of two (2) subjects with a gun. Upon arrival, officers located the subjects matching the description in front of the restaurant. The male subject was found to have a handgun in the back of his waist band. The male subject did not have a valid FOID or CCL. Officers did not locate a weapon on the female subject. Witnesses advised police that at the time of the call, the female subject handed the handgun to the male subject who then placed it in his waist band. The female subject had a valid FOID but no CCL. Both subjects were detained pending further investigation and review of video surveillance. Both subjects were subsequently taken into custody and each were charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

Officers responded to a report of a stolen auto. Officers observed broken glass on the ground in the area where the victim stated the vehicle was stolen from. The vehicle entered into LEADS as stolen. Said vehicle was located by Chicago PD on 7/19/23 and the vehicle owner was notified.

Berwyn Police received notification from Oak Park PD regarding a recovered stolen vehicle (Kia) bearing IL registration out of Berwyn. The vehicle was taken back to Berwyn PD for processing and contact was made with the vehicle owner who wished to pursue charges. This investigation is ongoing.

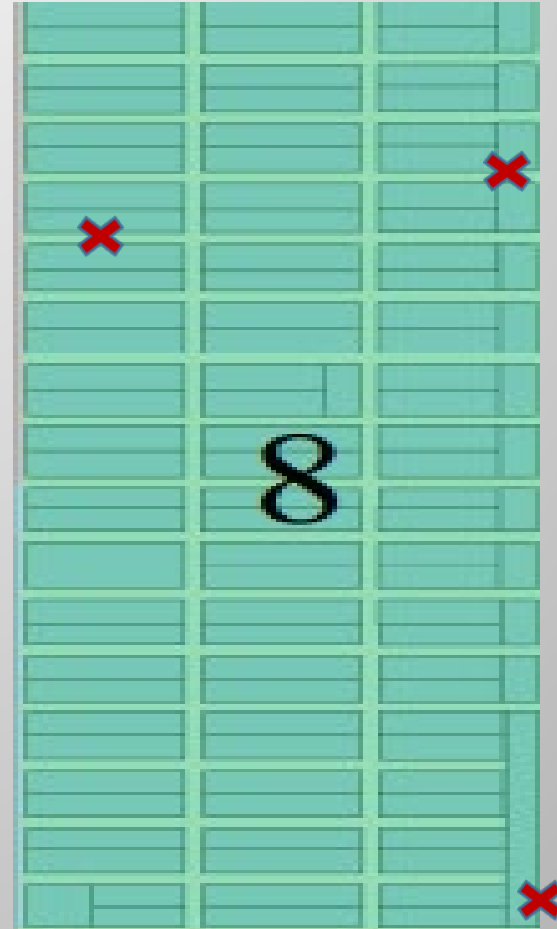
Criminal Damage to Property — 7/19/2023
