



SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 7/24/2023

Aggravated Unlawful Use of a Weapon — 7/26/2023 6800 block of Ogden Ave. — 12:29p.m.

Berwyn dispatch received a call in regards to a man with a gun and an Electronic Monitoring ankle bracelet. Upon arrival, officers located said subject who was subsequently identified by the reporting witness. Officers confirmed that the male subject was on Electronic Monitoring and a handgun was located in his front pocket. Officers placed the subject in custody and transported him to the Berwyn Police Department where he was subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

Armed Habitual Criminal — 7/30/2023 3400 block of Harlem — 12:57a.m.

Officers conducted a traffic stop on a white in color rental vehicle with out of state license plates. Upon making contact with the driver, the officer could smell Cannabis emanating from the vehicle. The driver admitted to having Cannabis in the vehicle (which officers later confirmed to weigh 26 grams). The male subject (driver) gave the officer consent to search the vehicle at which time the officer located and recovered a loaded pistol within the vehicle. The officer also learned that the subject is currently on parole for a weapon charge and subsequently placed the subject in custody. The offender was charged with one (1) felony count of Armed Habitual Criminal. Case closed by arrest.

Armed Robbery — 7/30/2023 Mobil Gas Station (6856 W. Ogden Ave.) — 9:51p.m.

Units responded to a report of an Armed Robbery that occurred outside the Mobil Gas Station. Responding Officers met with the victims, two (2) male subjects, who related that they were sitting inside their vehicle at the gas pump when a Male subject wearing a hoodie and a mask approached their vehicle, opened the driver's door, pointed a handgun at the driver's head and demanded all of their belongings. The victims further related that they complied and the offender fled on foot prior to officers arrival. There were no reported injuries or shots fired during this incident. This investigation is ongoing.

Criminal Trespass to Vehicles — 7/25/2023 2500 block of Wesley — 12:56a.m.

Officers responded to the 2500 block of Wesley for a report of subjects checking and opening parked vehicle doors. Responding Officers located two (2) offenders, one (1) of which (adult) was currently inside a vehicle that did not belong to him. The other offender was his brother, a male juvenile. Officers conducted a check of the area which revealed several more vehicles that had been burglarized. Witnesses positively identified both offenders on scene. Both offenders were taken into custody and transported to the Berwyn Police Department. Both offenders were subsequently charged accordingly. Case closed by arrest.

Aggravated Assault — 7/25/2023 Oak Park Ave/Stanley — 4:21p.m.

Officers responded to a report of a disturbance at Oak Park Ave/Stanley Ave. where a male subject approached the caller and threatened him with a knife. Responding Officers located the offender and took him into custody. Officers located a knife on the offender's person. There were no reported injuries. The offender was transported to the Berwyn Police Department and subsequently charged with Aggravated Assault. Case closed by arrest.





SIGNIFICANT INCIDENTS IN 4TH WARD

Criminal Damage to Property — 7/29/2023 Fill Up Station (2627 Ridgeland)— 6:39p.m.

Officers responded to the Fill Up Station for a report of property damage caused by fireworks. Responding Officers met with the property owner who related they heard a loud boom and upon checking the area outside he discovered damage to his garage roof. Upon review of video surveillance, officers learned that several unknown male subjects in the alley threw a firework that detonated on the roof of the garage. Furthermore, officers also learned from the surveillance video that the same unknown subjects spray painted graffiti on said garage. Offenders fled the scene prior to officer arrival. This investigation is ongoing.

Aggravated Unlawful Use of a Weapon — 7/30/2023 2800 block of Highland— 12:28a.m.

Officers attempted to conduct a traffic stop at 26th Street/East Ave. on a black in color vehicle, however, the vehicle fled from the police. The vehicle was curbed in the 2800 block alley of Cuyler/Highland Ave. While officers were speaking with the driver of the vehicle, they observed in plain view a magazine for a pistol, lying on the floorboard inside the vehicle. The driver related to police that he had a handgun in the vehicle. Officers confirmed that the driver had a valid FOID but did not have a CCL. The driver was subsequently taken into custody and the loaded handgun was recovered from the vehicle. The subject was transported to the Berwyn Police Department and subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.


Stolen Auto (Hyundai) — 7/25/2023 6300 block of 13th Street — 7:24a.m.

Berwyn Dispatch received a call of shots fired in the area of the 1200 block of Highland/Cuyler alley. The caller stated she heard numerous, rapid gunfire stemming from the alley and observed a vehicle flee the area. Responding units canvassed the area and located fourteen (14) spent, 9mm, shell casings in the alley. A canvass of the area did not yield any victims or property damage. This investigation is ongoing.

Recovered Stolen Autos — 7/24/2023 1500 block of Wesley — 5:52p.m.

Officers received information that a vehicle stolen out of Chicago was located by its owner who used an Apple Air Tag tracking device to track this vehicle to a garage on the 1500 block of Wesley Ave. Berwyn Police responded to the area of 15th Street/ Wesley Ave. and observed the offenders attempt to drop off another stolen vehicle. Officers attempted to stop said subjects but the subjects fled in the stolen vehicle and the pursuit was terminated. Further investigation revealed the reporting party's vehicle in the garage (with the Apple Air Tag) and another stolen vehicle inside the garage. Both vehicles were recovered and the respective owners were notified. Officers attempted to make contact with someone at said residence but were met with negative results. This investigation is ongoing.


Aggravated Unlawful Use of a Weapon — 7/26/2023 Scoville/Cermak — 3:49p.m.

Officers conducted a traffic stop on a vehicle occupied by a female subject (driver) and male subject (passenger). Upon making contact with the driver, officers learned that the female subject had an active warrant out of Cook County and was subsequently placed in custody. Officers then asked the male subject to step out of the vehicle to which he complied but informed officers his handgun was inside of the glove compartment. Officers recovered a handgun from the glove compartment as well as a loaded magazine from under the driver's seat. The male subject was subsequently taken into custody. Both subjects were transported to the Berwyn Police Department and charged accordingly. Case closed by arrest.


Burglary from Motor Vehicle — 7/26/2023 1800 block of Grove — 12:09a.m.


Criminal Damage to Property/Attempted Stolen Auto (Kia) 2100 block of Harlem — 7/29/2023 — 7:00a.m.


Aggravated Assault — 7/29/2023 Roosevelt/Kenilworth — 3:38p.m.


