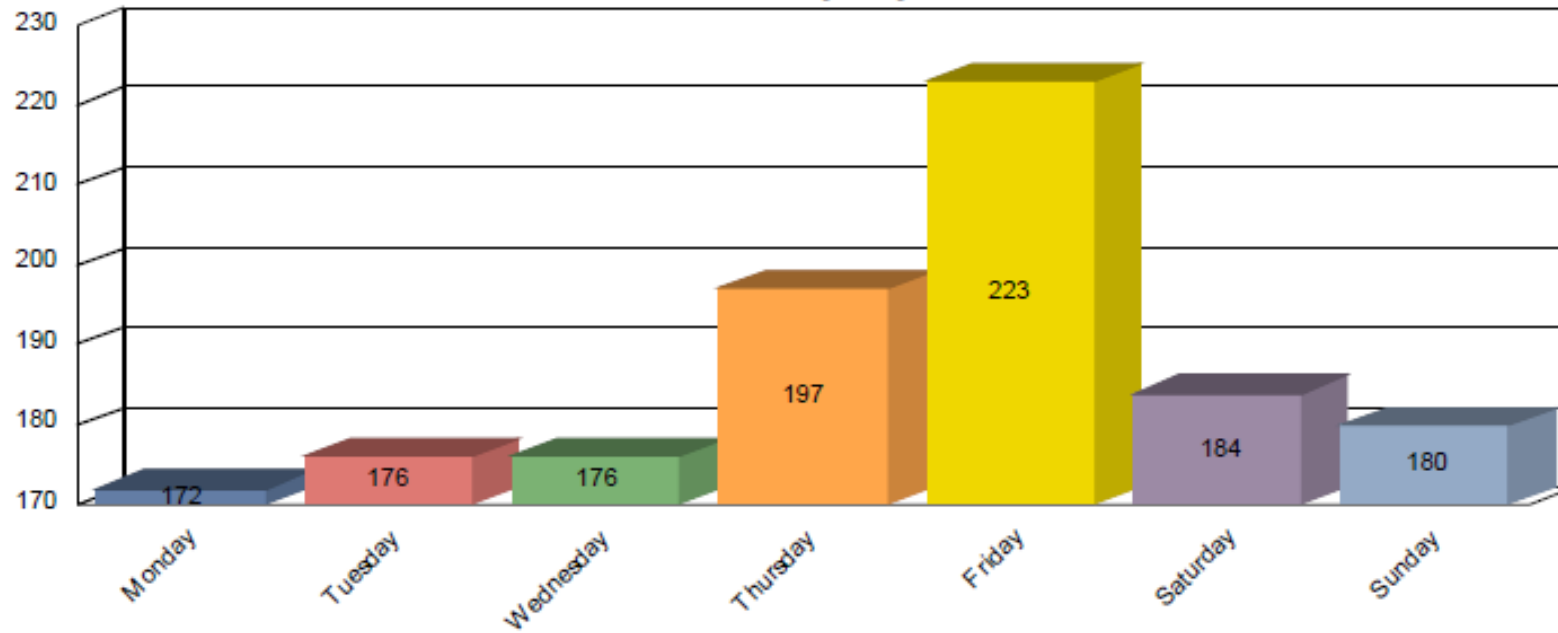

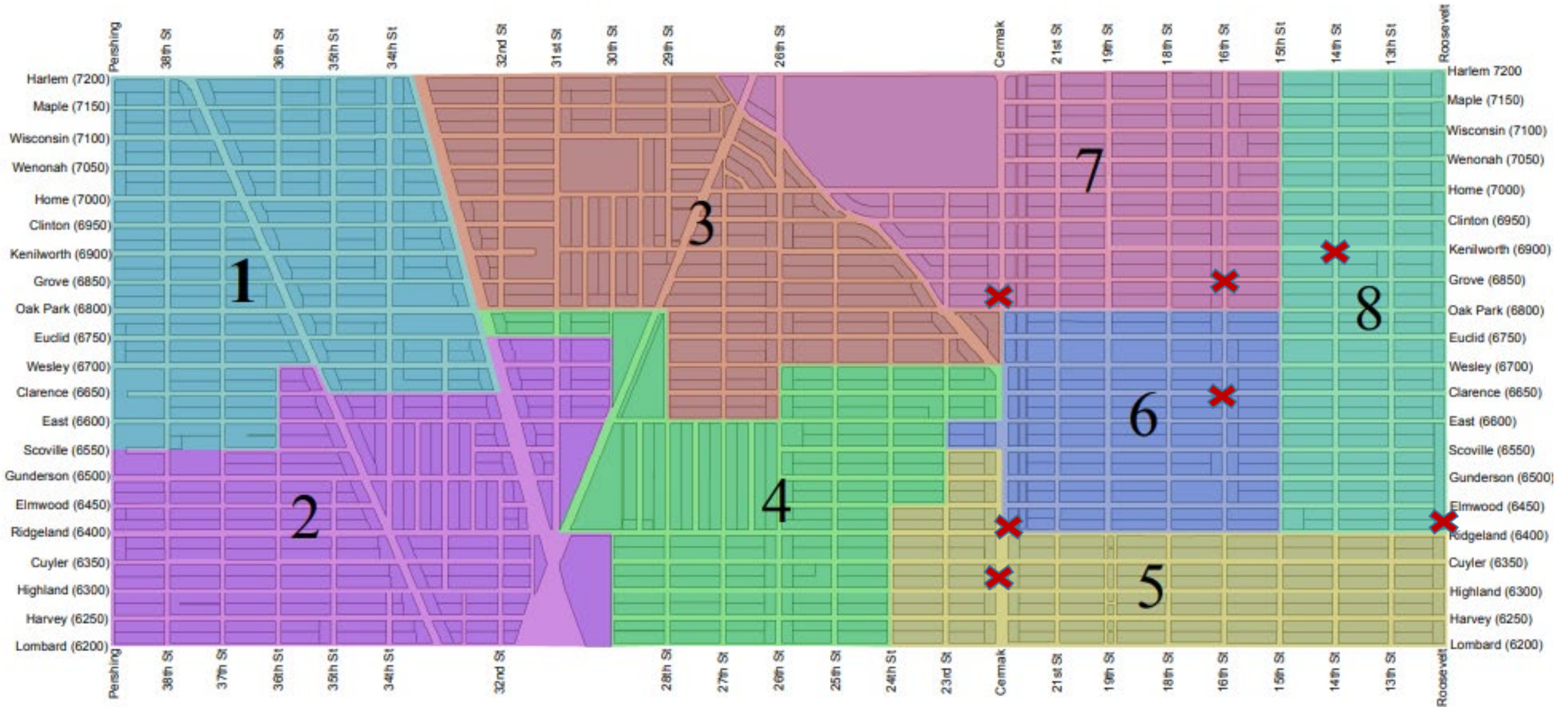
### Items For Service Distribution

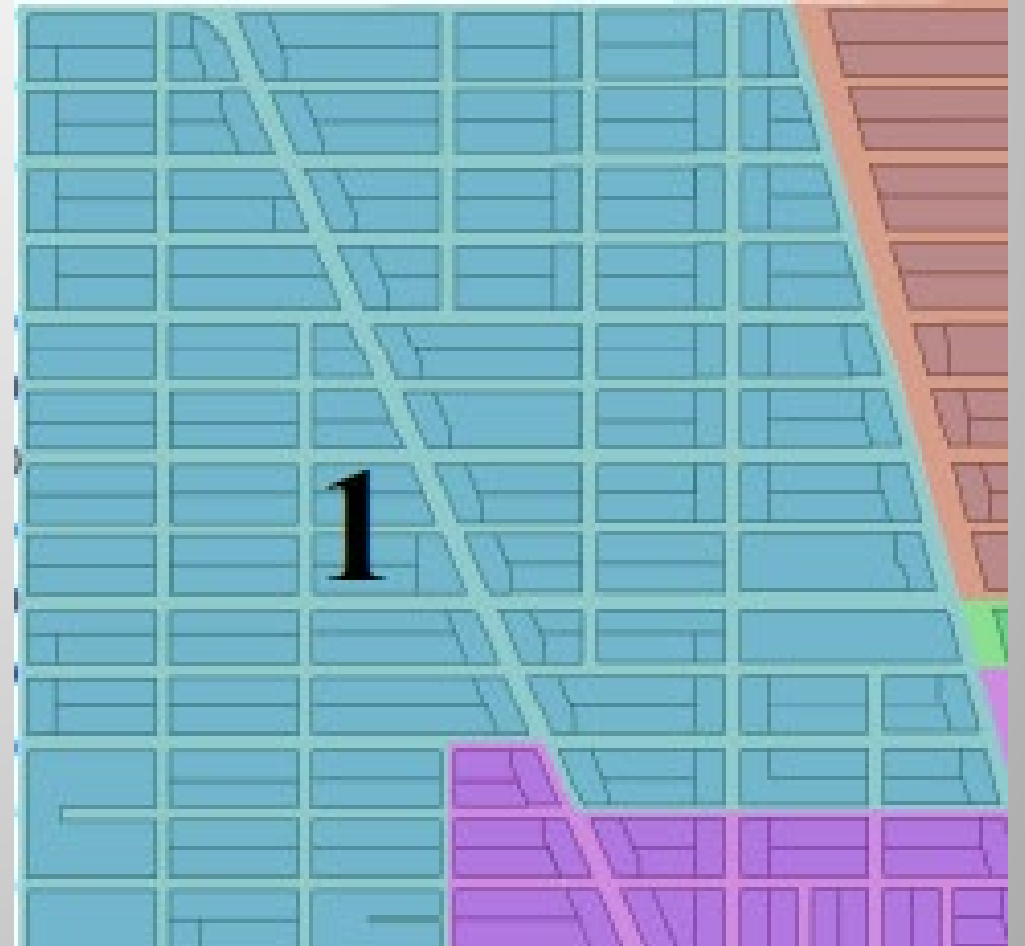

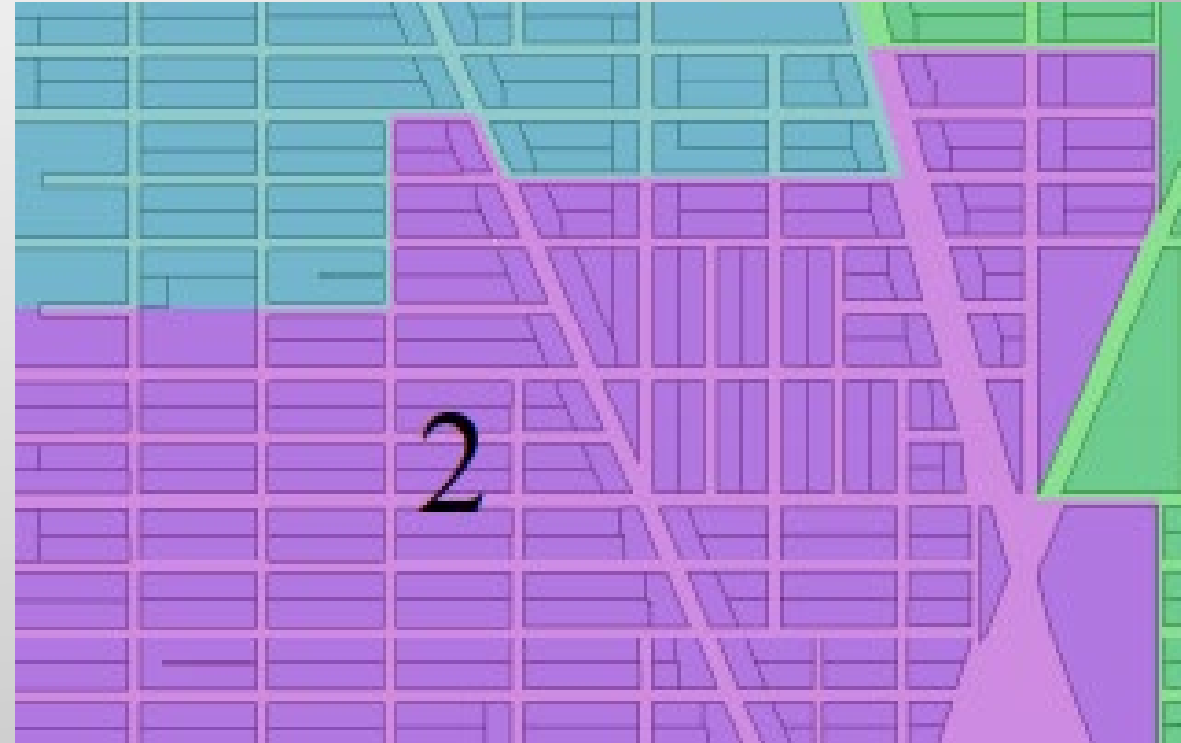

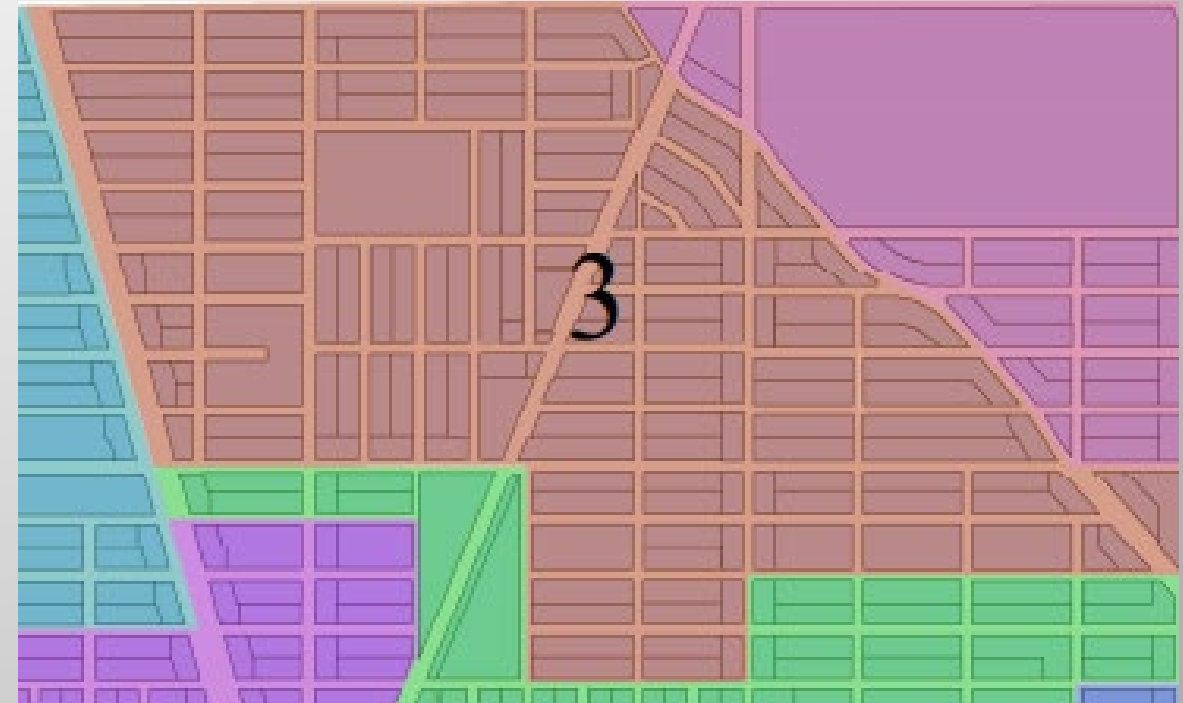

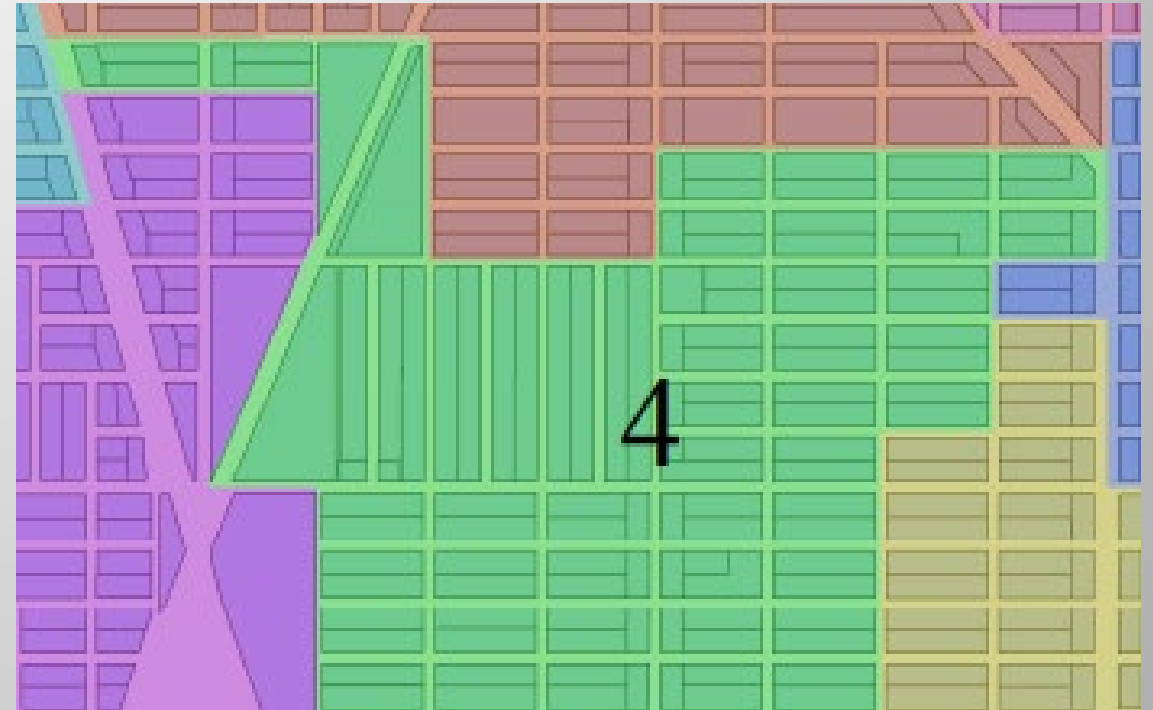

## Recovered Stolen Auto — 8/08/2023 6300 block of Cermak — 8:52a.m.

Maywood PD contacted Berwyn PD in regards to a stolen vehicle that was pinging to the 6300 block of Cermak. Berwyn units located the vehicle in question, awkwardly parked with the passenger windows rolled down, on the 2200 block of Cuyler. Said vehicle (Kia) was stolen out of Maywood and involved in an Aggravated Assault against a Maywood Police Officer. Berwyn Police removed the vehicle from LEADS. The vehicle was towed to Metro Tow Yard for safe keeping.

## **Aggravated Vehicular Hijacking — 8/11/2023** **1500 block of Elmwood — 9:57p.m.**

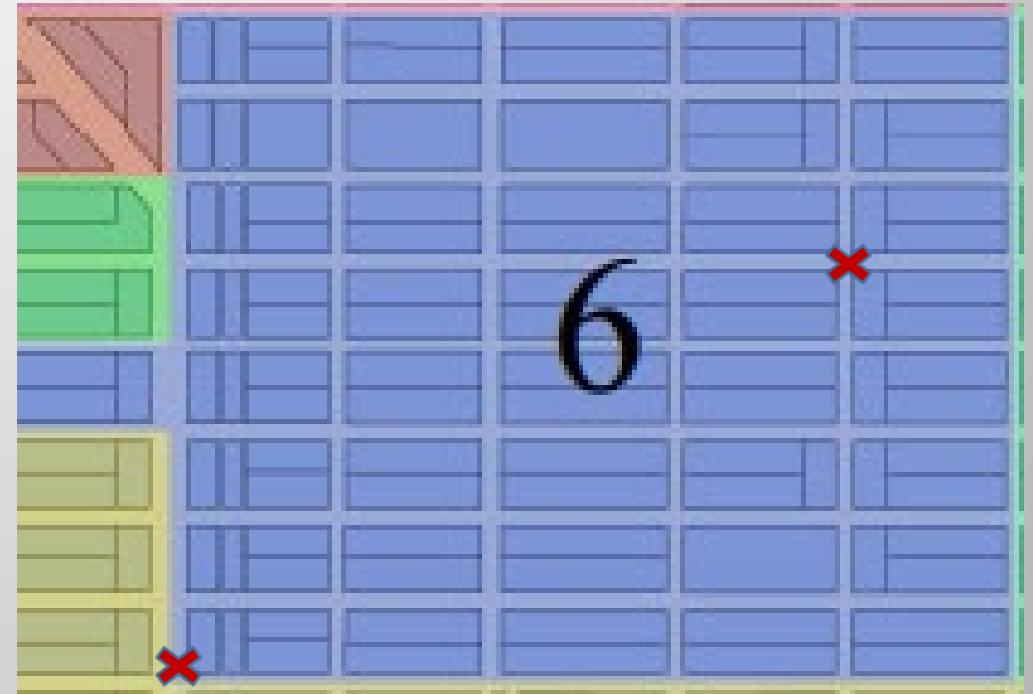
Officers responded to the 1500 block of Elmwood Ave. for a report of an Aggravated Vehicular Hijacking that just took place. Responding officers met with the victim who related he was an Uber Driver who was dispatched to the 1500 block of Elmwood to pick up a rider. The victim related that when he arrived on the 1500 block of Elmwood a female subject entered his vehicle but requested to change the location of her destination. The victim stated he did not have his vehicle in park and at that time accidentally struck a nearby parked car. The victim then pulled over to check on the status of the struck vehicle at which time a male subject, who claimed to be the owner of the struck vehicle, displayed a handgun and demanded money from the Uber driver. When the Uber Driver did not comply, the female passenger then exited the vehicle and demanded the Uber Driver's phone and keys. The offenders then stole the Uber Driver's phone and fled the scene in the Uber vehicle. The vehicle was entered in LEADS as stolen and an ISPERN message was sent. This investigation is ongoing.

## **Aggravated Unlawful Use of a Weapon — 8/13/2023** **16<sup>th</sup> Street/Clarence — 1:06a.m.**

Officers conducted a traffic stop at 16<sup>th</sup> Street/Clarence Ave. The driver (sole occupant) made a spontaneous statement to the officer that he had a firearm located between the front driver seat and the center console. The driver did not have a valid FOID or CCL. The driver was taken into custody without incident and subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

# SIGNIFICANT INCIDENTS IN 7<sup>TH</sup> WARD

## **Aggravated Unlawful Use of a Weapon (x2) — 8/09/2023** **16<sup>th</sup> Street/Grove Ave. — 12:46a.m.**

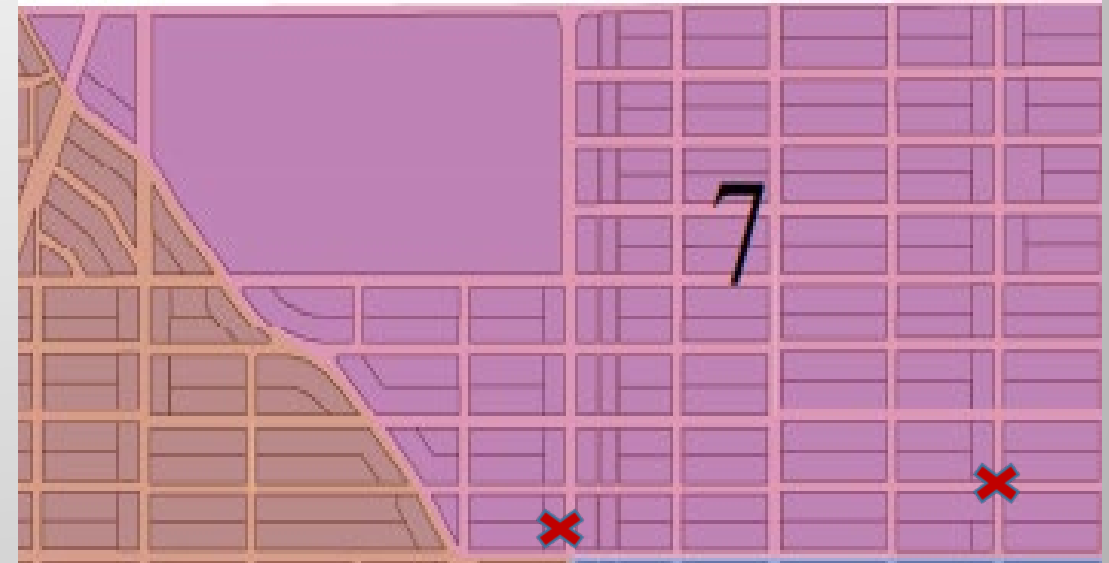
Officers conducted a traffic stop at 16<sup>th</sup> Street/Grove Ave. The traffic stop led to the recovery of two (2) loaded firearms. All five (5) occupants of the vehicle were detained pending further investigation. Officers confirmed that the driver of the vehicle had a valid FOID but no CCL (Note: None of the other occupants had a valid FOID or CCL). Officers learned that one of the female occupants had a fully extraditable warrant out of Texas. Officers verified all warrant paperwork for said female subject and turned her over to the Cook County Sheriff's Police Fugitive Warrants Division. The driver was taken into custody and charged with two (2) felony counts of Aggravated Unlawful Use of a Weapon and one (1) misdemeanor count of Obstructing. One of the male subjects was taken into custody and charged with one (1) misdemeanor count of Obstructing. Case closed by arrest.

## **Battery — 8/13/2023** **El Nuevo Vallarta (6801 W. Cermak Rd.) — 2:21a.m.**

While on patrol, Berwyn Auxiliary Officers observed a disturbance in the parking lot of El Nuevo Vallarta. Units responded and ascertained that an intoxicated female subject was escorted out of the business after she battered another patron (male subject). Said female subject then battered the security officer. The male victim (patron) did not wish to sign a complaint. The Security Officer's injuries were photographed and he signed complaints. The female subject was taken into custody and subsequently charged with one (1) misdemeanor count of Battery and one (1) misdemeanor count of Resisting a Police Officer. Case closed by arrest.

## **Recovered Stolen Auto — 8/08/2023** **1300 block of Kenilworth — 9:29a.m.**

Officers responded to the 1300 block of Kenilworth for a report of a possible recovered stolen auto. Upon arrival, officers met with the reporting party who was also the owner of said vehicle. The owner related to officers that her vehicle (Hyundai) had been stolen out of Schiller Park and she was searching the area of 14<sup>th</sup> Street/Kenilworth when she located her vehicle. Berwyn Police contact Schiller Park PD who approved the vehicle being turned over to the owner on scene.

## **Criminal Trespass to Vehicle — 8/12/2023** **Roosevelt/Ridgeland — 1:37p.m.**

Berwyn Units canvassed Roosevelt Road in regards to a FLOCK hit on a vehicle stolen out of Chicago. Officers located said vehicle at Roosevelt/Ridgeland. Responding officers subsequently conducted a traffic stop of said vehicle and placed the driver in custody without incident. Berwyn Officers contacted the Assistant State's Attorney for Felony Review, however, the ASA rejected felony charges. The offender was subsequently charged with one (1) misdemeanor count of Criminal Trespass to Vehicle. Case closed by arrest.
