



SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 8/28/2023

Aggravated Battery — 9/02/2023 Mac Neal Hospital (3249 S. Oak Park Ave.) — 1:01a.m.

Berwyn Police responded to Mac Neal Hospital ER for a report of a walk-in gunshot victim who initially claimed to have been shot in the area of 18th Street/Wisconsin Ave. The male victim was uncooperative with officers and gave conflicting stories when he later related the incident may have occurred on the 1300 block of Elmwood. Officers canvassed both locations and were met with negative results for any signs of a crime scene. This investigation is ongoing.


Aggravated Unlawful Use of a Weapon — 8/30/2023 6700 block of Stanley Ave. — 8:35p.m.

Officers responded to a call of an unwanted subject/man with a gun. The victim advised Berwyn Dispatch that the unknown male subject pointed a firearm at the victim, placed it back into his waistband, and then left the location. Dispatch broadcasted a description of the offender and said offender was subsequently located by Berwyn Police in the area of 31st Street/Oak Park Ave. Upon further investigation, officers learned that a verbal altercation ensued inside a residence amongst friends during which time a male subject displayed a firearm at two subjects and then fled the scene on foot prior to police arrival. The offender related to police that he dropped his firearm and voluntarily showed the officers where said firearm was located. Officers recovered the firearm from the area of 31st Street/Euclid Ave. The offender was subsequently taken into custody and transported to the Berwyn Police Department. The offender was subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

Armed Robbery — 9/02/2023 6300 block of Ogden Ave. (alley) — 11:02a.m.

Officers responded to the 6300 block of Ogden Ave. (alley) for a report of an armed robbery. Responding officers met with the victim who stated that he was walking Westbound in the 6300 block of Ogden alley on the South side of Ogden when two (2) Male Black subjects approached him, pointed a handgun toward his head, and demanded his cell phone and wallet. The victim further described one of the offenders as having dread locks and wearing a yellow baseball hat and the other subject was wearing a black color shirt, blue pants, and a black baseball hat. The victim advised that both offenders fled Southbound down the Ridgeland/Cuyler alley on foot. This investigation is ongoing.








Stolen Auto — 8/30/2023 2200 block of Gunderson — 7:30a.m.


Stolen Auto — 8/31/2023 18th Street/East Ave. — 7:35a.m.

Officers responded to the area of 18th Street/East Ave. for a report of a stolen vehicle. The victim related they parked their vehicle at approximately 1:00a.m. on 8/31/23 and later discovered it missing at 7:00a.m. on 8/31/23. This investigation is ongoing.

Stolen Auto — 9/02/2023 18th Street/Clarence — 4:23p.m.

Berwyn Dispatch received a call from a witness reporting they just observed the theft of their neighbor's vehicle take place. Responding officers met with the witness who related she observed a Female Black subject, approximately 18-20 years old, wearing all black clothing exit the driver's seat of an SUV and walk over to the parked vehicle which the witness believed belonged to her neighbor. The female subject proceeded to make entry into said parked car and fled Westbound on 18th Street. The reporting party further related they then observed a Male Black subject, approximately 18-20 years old, wearing a red in color hoodie move over to the driver's seat of their SUV and follow the female subject in the other vehicle Westbound on 18th Street. Officers made contact with the vehicle's owner who related they wished to sign complaints if the offenders are apprehended. The victim's vehicle was entered into LEADS as stolen. This investigation is ongoing.





SIGNIFICANT INCIDENTS IN 7TH WARD

FOR WEEK OF 8/28/2023

Armed Robbery — 8/28/2023 Office Depot (7001 W. Cermak Rd.) — 12:47a.m.

Units responded to the rear of Office Depot in regards to an armed robbery. Responding officers met with the three (3) victims (2 adults and 1 juvenile) who related they were walking Westbound on Cermak Road when 5-6 Male Black subjects, all armed with handguns, exited a grey in color sedan with dark tinted windows and took property from the three (3) victims. The offenders were further described to all be wearing hoodies and masks. The offenders immediately returned to their vehicle and fled the scene. There were no reports of injuries or shots fired during the incident. Taken in the robbery was a backpack containing cash, a Nikon digital camera and 2 Sony digital cameras; and two (2) iPhones. Officers conducted a canvass of the area which revealed two (2) digital cameras discarded in the rear of Mattress Firm (7112 W. Cermak Rd.) This investigation is ongoing.

Fight/Brawl (Juveniles) — 8/30/2023 Mraz Park (23rd Street/Grove Ave.) — 3:26p.m.

Units responded to Mraz Park for reports of a large group of juveniles gathering at the park with the intent to fight. Officers located and dispersed a crowd of approximately fifty (50) juveniles from Mraz Park without incident. Shortly after, said juveniles continued to travel Westbound on 23rd Street and a large brawl ensued between several of the juveniles at 23rd Street/Kenilworth. Additional units were requested on scene. Two (2) juvenile subjects were taken into custody and transported to the Berwyn Police Department where there were subsequently charged accordingly. Case closed by arrest.

Attempted Armed Robbery (Juvenile) — 9/02/2023 2100 block of Wisconsin Ave. — 12:21a.m.

Officers responded to the 2100 block of Wisconsin Ave. for a report of an attempted armed robbery. Responding officers met with the victim who related he was travelling on a bus and exited the bus at Cermak Rd/Harlem Ave. at which time he observed a Male Black subject (teenager) exit the bus with him and follow the victim along with a Female Black juvenile. The subjects then ran up alongside of the victim and the male subject pepper sprayed the victim and then struck the victim with his fist and attempted to take the victim's money. The victim advised officers that he placed money inside of his sock while on the bus. The victim further related that he was able to fight off the offender and the offender fled Southbound on foot down Wisconsin Avenue toward the Vacin fairway. Officers immediately conducted a search of the area at which time they were able to locate the offender at the McDonald's (Cermak/Harlem). The juvenile offender was positively identified by the victim and taken into custody. The juvenile was subsequently charged accordingly. Case closed by arrest.




