



Theft — 9/13/2023 2800 block of Highland — 5:02a.m.

Berwyn Dispatch received a call of a theft in progress. A witness related they observed two (2) Male Black subjects unloading boxes into a dark in color SUV from the BNSF yard on the 2800 block of Highland. Responding officers responded to the yard and observed the described vehicle fleeing from the scene into Cicero at a high rate of speed. Berwyn Police Officers did not pursue said vehicle. Officers secured the scene where it was observed the fence had been compromised and burglary tools along with proceeds from a box truck were left behind. BNSF police were contacted and the scene was turned over to them for further investigation.






SIGNIFICANT INCIDENTS IN 5TH WARD

Armed Robbery — 9/11/2023
Ram Liquors (6332 W. Cermak Rd.) — 10:54p.m.

Units responded to Ram Liquors in reference to an armed robbery that had just occurred. The victims related that two (2) Male Black subjects, both armed with handguns, entered the establishment and demanded the employees open the cash register. Taken was approximately \$3,500 and an unknown amount of liquor and cigarettes. The victims further related that the offenders fled the scene on foot prior to officer arrival. This investigation is ongoing.





Accident (Assist Other Agencies) — 9/12/2023 6900 block of Cermak Rd. — 8:32p.m.

Berwyn Police Officers were made aware that a Chicago PD pursuit of a vehicle was traveling into Berwyn. The occupants of said vehicle were believed to be involved in multiple robberies in Chicago and possibly surrounding suburbs. The pursuit of said vehicle continued Northbound onto Harlem Ave. from Ogden Ave. and then Eastbound on Cermak from Harlem Ave. The offending vehicle struck multiple vehicles near Cermak/Clinton before coming to a stop at Cermak/Kenilworth. Four (4) occupants of said vehicle were taken into custody and a weapon was recovered. The incident was turned over to Chicago PD for further investigation.

Aggravated Unlawful Use of a Weapon — 9/15/2023 2200 block of Grove Ave. — 1:19a.m.

Officers conducted a traffic stop on the 2200 block of Grove Ave. Upon making contact with the driver, the officer detected a strong smell of fresh cannabis emanating from inside the vehicle. The officer also observed an open bottle of alcohol on the floor as well as a green leafy substance (suspect cannabis). The driver related to the officer that there was Cannabis in the vehicle as well as a firearm in his pocket. The driver had a valid FOID but no CCL. The officer recovered a loaded firearm from the male subject's pocket and placed said subject in custody. A search of the vehicle revealed two (2) small plastic baggies of Cannabis weighing 12 grams each which were found under the seats. A bottle containing promethazine syrup was also recovered from the rear of the vehicle. The subject was transported to the Berwyn Police Department and subsequently charged with one (1) felony count of Aggravated Unlawful Use of Weapon. Case closed by arrest.


Aggravated Assault — 9/10/2023 Shelby's Slots (6601 W. Roosevelt Rd.) — 7:06p.m.

Officers responded to Shelby's Slots in regards to a woman who threatened an employee with a knife. Responding officers learned that there was a dispute and the female subject who refused to leave the gaming machine displayed a knife. The knife was recovered and the offender was taken into custody without incident. There were no injuries reported. The offender was subsequently charged accordingly. Case closed by arrest.

Unlawful Use of a Weapon- by a felon Possession of a Controlled Substance — 9/13/2023 Scoreboards Bar (7109 W. Roosevelt Rd.) — 1:11a.m.

Berwyn Dispatch received an emergency call from employees at Scoreboards stating security had a man with a gun detained in the parking lot. Responding officers met with security who stated an unknown male subject, wearing a hoodie and a mask, approached him at closing time. Security advised the subject that the establishment was closed at which time the subject displayed a handgun that he was carrying in his waistband. Officers recovered a loaded handgun as well as three (3) plastic baggies containing narcotics and took the subject into custody. The subject was transported to the Berwyn Police Department and subsequently charged with one (1) felony count of Unlawful Use of a Weapon-by a felon and one (1) felony count of Possession of a Controlled Substance. Case closed by arrest.


