



SIGNIFICANT INCIDENTS IN 2ND WARD




SIGNIFICANT INCIDENTS IN 4TH WARD

Burglary – 5/17/2024 Valle's Produce (6603 W. 26th Street) – 7:53a.m.

Officers responded to Valle's Produce for a report of a burglary that occurred sometime overnight. The reporting party (staff member) related that when they arrived at the business at 7:00a.m. that day, they found the lock had been broken on the glass front door and the video surveillance system had been disconnected. The staff member reported \$6,000 missing. This investigation is ongoing.







SIGNIFICANT INCIDENTS IN 5th Ward

FOR WEEK OF 5/13/2024

Strong Armed Robbery – 5/19/2024 Corazon Bar (6308 W. Cermak Rd.) – 1:44a.m.

Officers observed a large crowd exiting Corazon Bar and requested additional units on scene for assistance with crowd control. One (1) female subject related that she had been battered near the restrooms within the bar. The victim further related that approximately seven (7) unknown female subjects attacked her and took her cell phone, shoes, passport, and car keys. The victim was transported to a local hospital for treatment. Officers met with the bar owner who stated his security staff had escorted a few patrons outside of the bar earlier. While on scene, officers also found the bar to be non-compliant with its state license. The business was subsequently issued two local ordinance violations. This investigation is ongoing.




SIGNIFICANT INCIDENTS IN 6th Ward

Sex Offender Loitering in School Zone – 5/16/2024 16th Street/Gunderson – 5:01p.m.

Berwyn Tactical Officers observed a male subject walking Westbound on 16th Street from the Ridgeland Ave./Elmwood Ave. alley. Said male subject engaged in a verbal interaction with a juvenile female subject near 16th Street/Elmwood Ave. Officers observed said male subject stand in close proximity to the juvenile during the verbal interaction. Officers made contact with the juvenile female subject who stated that the male subject asked for her phone number as well as where she was going. The victim further related that the male subject made her feel uncomfortable. The male was then observed walking directly in front of Lincoln Middle School where he exchanged words with a male juvenile subject. A check of the subject's name revealed that he is a registered sex offender and in non-compliant status. Officers subsequently took the offender into custody and transported him to the Berwyn Police Department. The offender was charged with one (1) felony count of Sex Offender Loitering Within 500ft of a School. Case closed by arrest.


Stolen Auto – 5/13/2024 2100 block of Home Ave. – 2:53a.m.

Officers responded to the 2100 block of Home Ave. for a report of a stolen motor vehicle that had just occurred. Responding officers met with a witness who related they observed two (2) Male Black subjects inside a white in color sedan stop close to the victim's vehicle and then fled Northbound on Home Avenue. Officers observed broken glass on the pavement where the victim's vehicle was previously parked. The vehicle was entered into LEADS. On 5/14/2024 Berwyn Detectives discovered the victim's vehicle had been towed and impounded by Chicago PD. The vehicle was subsequently recovered by its owner. This investigation is ongoing.

Aggravated Unlawful Use of a Weapon (JUVENILE) – 5/15/2024 Cermak Rd./Clinton Ave. – 8:54p.m.

Berwyn Tactical Officers observed a Male Black subject running Northbound from Cermak Plaza across Cermak Rd. while holding the centerline of his waistband with his right hand, consistent with that of concealing an unholstered firearm. The officers exited the squad car to conduct an investigative street stop at which point the subject proceeded to flee on foot Southbound in the 2100 block of Home Ave. while holding the centerline of his waistband for several blocks. Officers then noticed the subject was running Southbound on Clinton Ave. with both hands free. Officers gave the subject verbal commands to stop to which he complied. Officers placed the subject into custody without further incident on the 2200 block of Clinton Ave.

Officers canvassed the area where the foot pursuit took place which revealed a handgun in the side driveway of a residence on the 2200 block of Clinton Ave. Officers recovered the loaded firearm and noted it had scrapes consistent with it being thrown to the ground. The subject was transported to the Berwyn Police Department for processing. The juvenile subject was subsequently petitioned with the following: one (1) count Reckless Conduct, one (1) count Obstructing a Peace Officer, and one (1) count Aggravated Unlawful Use of Firearm under the age of 21. Case closed by arrest.


