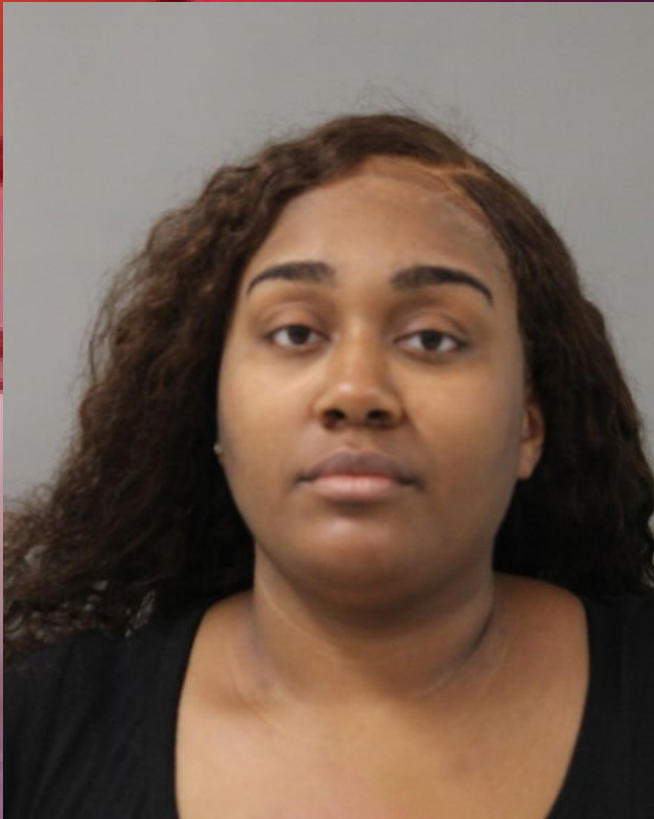

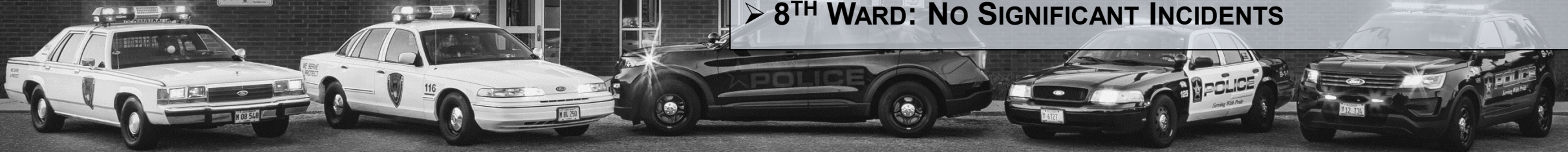

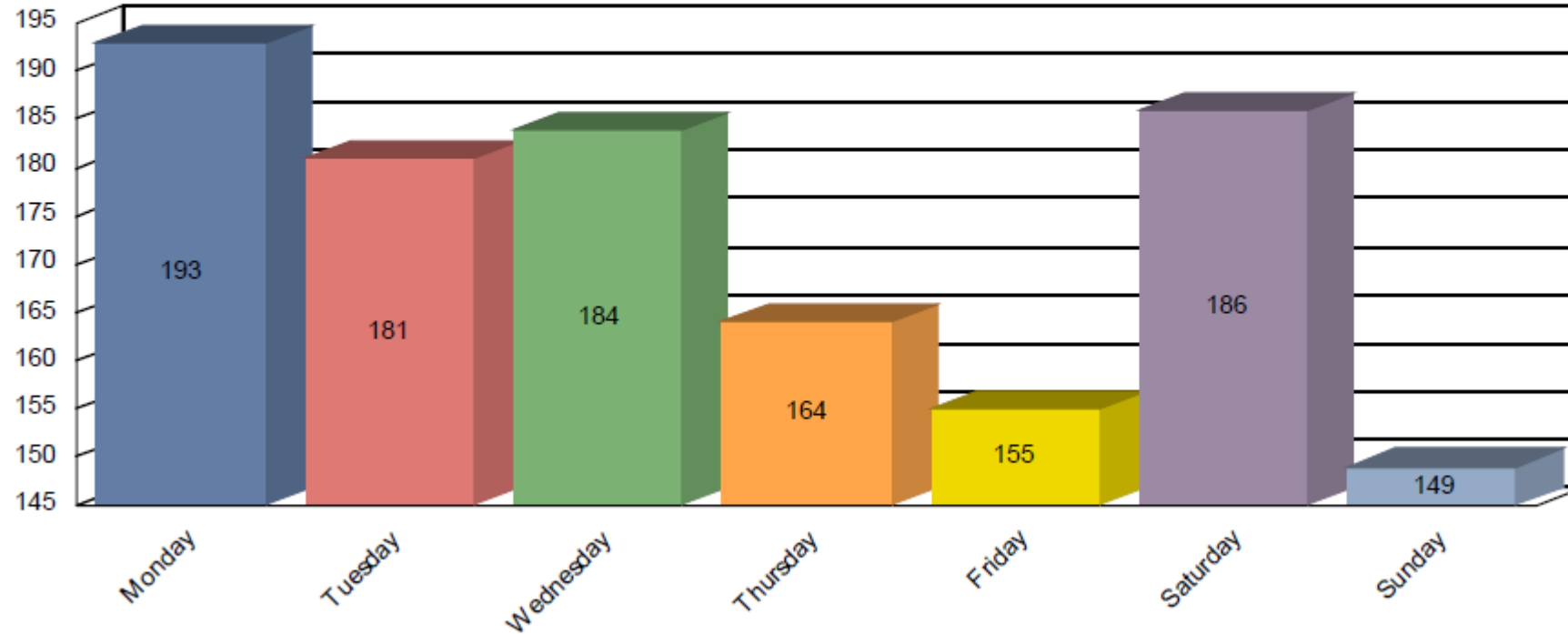

## Total Items For Service

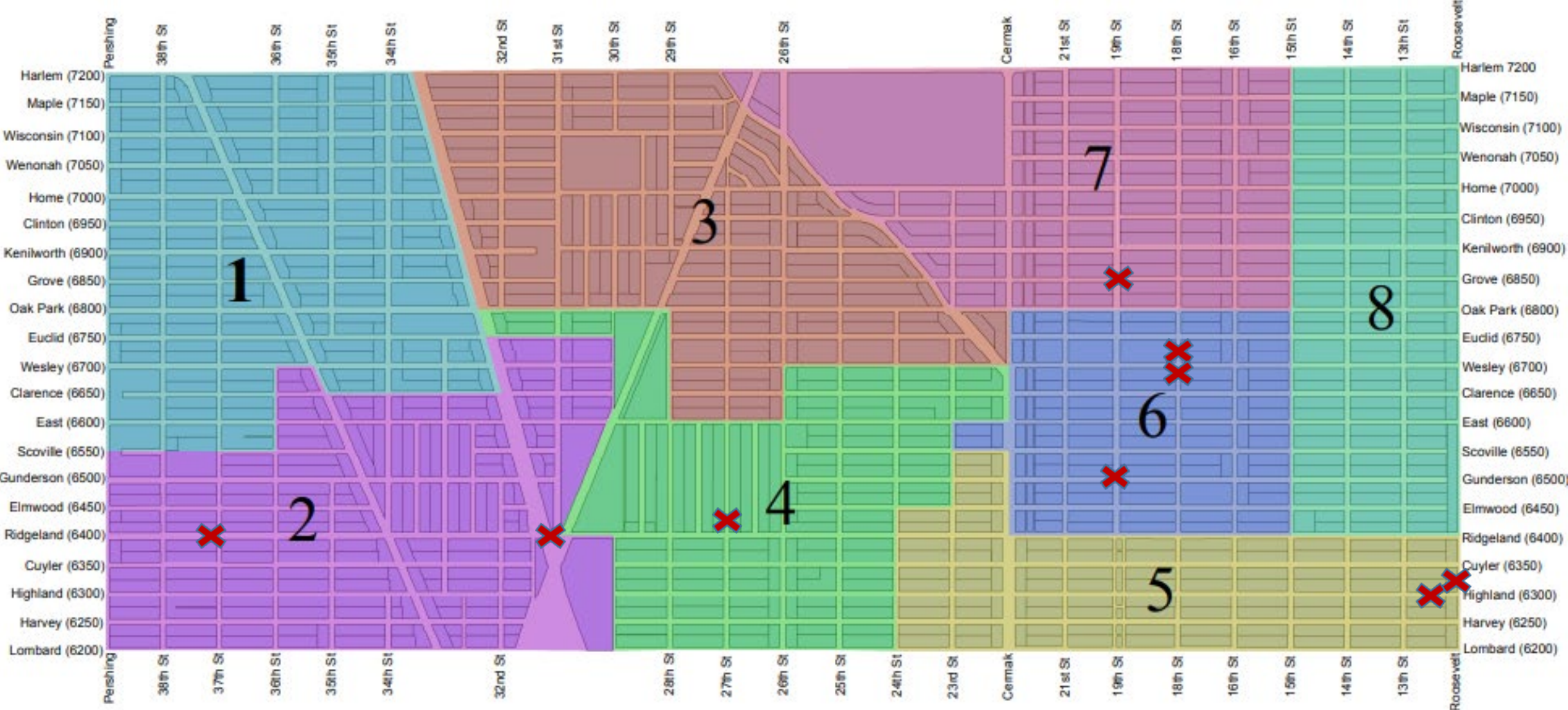

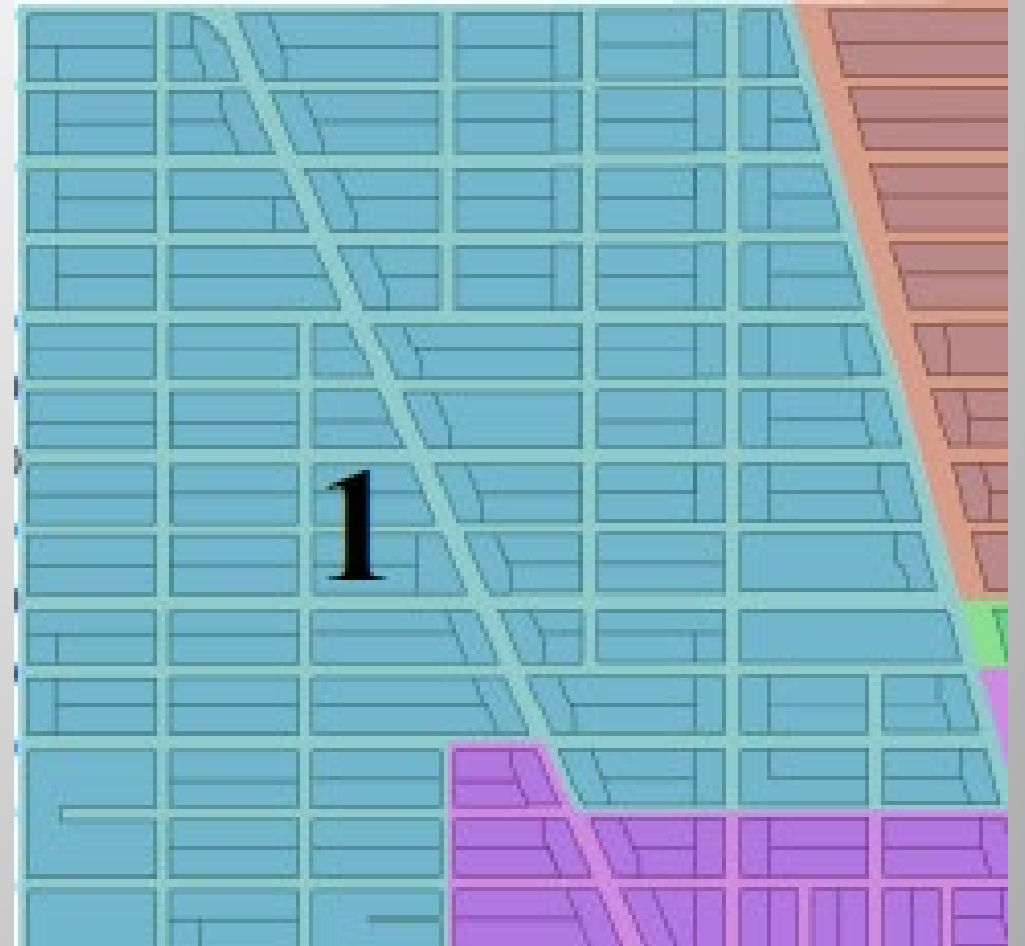

## **Stolen Motor Vehicle – 6/15/2024**

**3700 block of Ridgeland Ave. – 1:19a.m.**

Officers responded to the 3700 block of Ridgeland Ave. for a report of a stolen motor vehicle. Responding officers met with the victim (vehicle owner) who related a family member heard the vehicle start up at which point they looked outside and observed the vehicle exiting their driveway. The vehicle was last seen traveling Northbound on Ridgeland Ave. The owner further related that they have possession of the only key for the vehicle. This investigation is ongoing.

## **Aggravated Battery to a Police Officer (x3)**

**Unlawful Use of a Weapon – 6/12/2024**

**3100 block of Ridgeland Ave. – 10:42a.m.**

Units responded to the 3100 block of Ridgeland Ave. for a report of a female subject that was yelling outside and hitting an apartment door with a baseball bat. Upon arrival, officers observed a female subject hitting the door of an apartment with an aluminum baseball bat. Said subject ignored verbal commands by officers to drop the bat. The offender then walked towards the officers with the bat in her left hand and a canister of Pepper Spray in her right hand. While officers were attempting to detain the subject, the subject continued to resist officers and deployed the pepper spray subsequently causing exposure and irritation to all three (3) officers. Officers then took the offender into custody without further incident. Officers recovered an 8" kitchen knife from inside the offender's pant leg. The offender was transported to the Berwyn Police Department where she was subsequently charged with three (3) felony counts of Aggravated Battery to Police Officer and one (1) misdemeanor count of Unlawful use of a Weapon. Case closed by arrest.

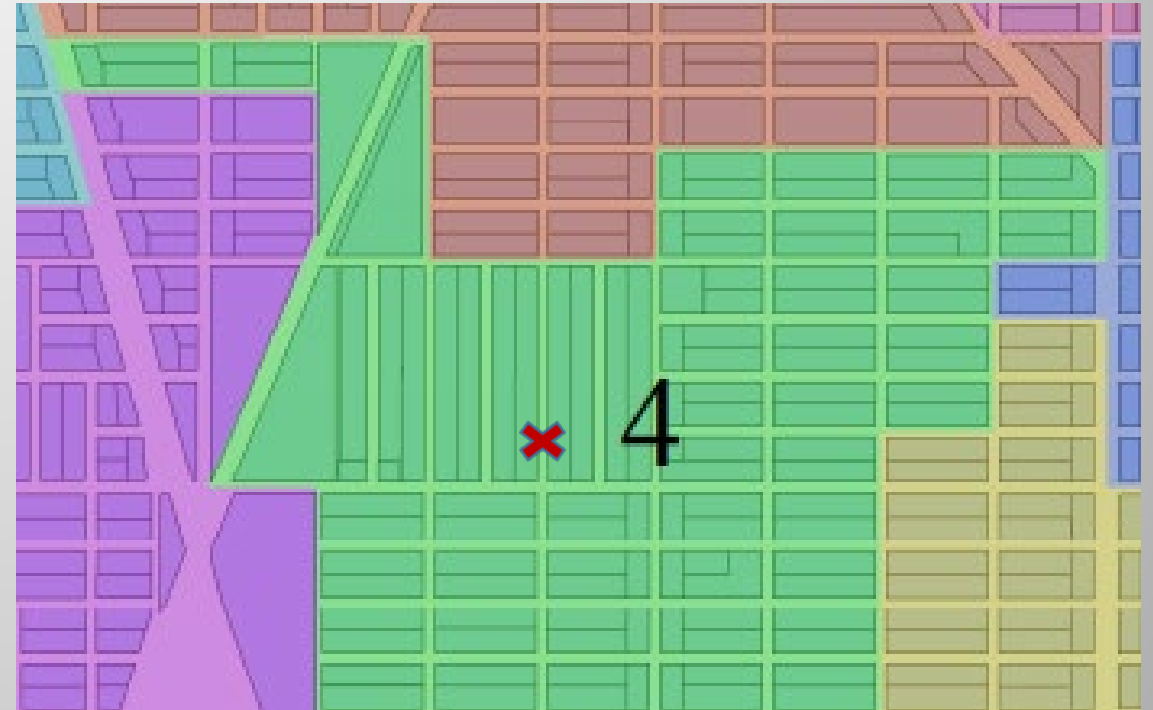

## Aggravated Unlawful Use of a Weapon – 6/14/2024 6400 block of 27<sup>th</sup> Street – 11:57p.m.

Officers conducted a traffic stop at Ridgeland Ave./27<sup>th</sup> Street. Upon making contact with the driver of the vehicle, officers detected the strong smell of fresh cannabis emanating from inside the vehicle. Officers observed in plain view a clear plastic baggie containing a green leafy plant substance (suspect cannabis) protruding from the driver's pants pocket. The driver then complied with the officers' request for him to step out of the vehicle. At this time, the driver advised officers there may be a firearm underneath the driver's seat. A LEADS check confirmed that the driver had a valid FOID but no CCL. Officers observed the handle of a firearm protruding from underneath the driver's seat. Officers recovered the loaded firearm and the bag of the green leafy plant substance (3g packaged weight cannabis). The subject was placed into custody and transported to the Berwyn Police Department where he was subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

## **Disturbance – 6/15/2024**

**Mike's Place (6319 W. Roosevelt Rd.) – 1:55a.m.**

Units responded to Mike's Place for multiple calls reporting a large disturbance involving approximately 40+ people in front of the business. Berwyn Dispatch related that a few of the callers related that one (1) of the male subjects had a firearm. Upon arrival, the group began to disperse. No cooperating witnesses remained on scene. Officers cleared the scene without further incident.

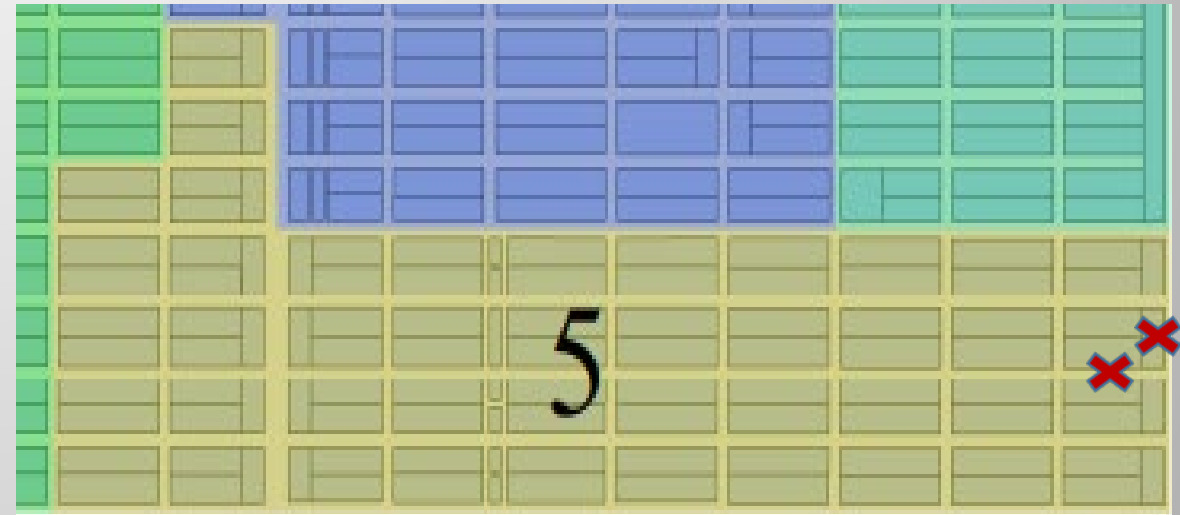
## **Residential Burglary – 6/11/2024**

**1200 block of Highland Ave. – 10:48p.m.**

Officers responded to the 1200 block of Highland Ave. for a report of a burglary. Responding officers met with the victims who related they left their home around 12:40p.m. and when they returned home at 10:40p.m. they discovered the front door of their house open and the back door's glass panel shattered. Officers cleared the home for any unwanted subjects. The victims reported their dining room and bedroom had been ransacked and approximately \$3,800 worth of jewelry and \$300 cash were missing. This investigation is ongoing.

## **Criminal Trespass to Real Property/Public Intoxication Pyrce Park (16<sup>th</sup> Street/Wesley Ave.) – 6/15/2024 – 1:44p.m.**

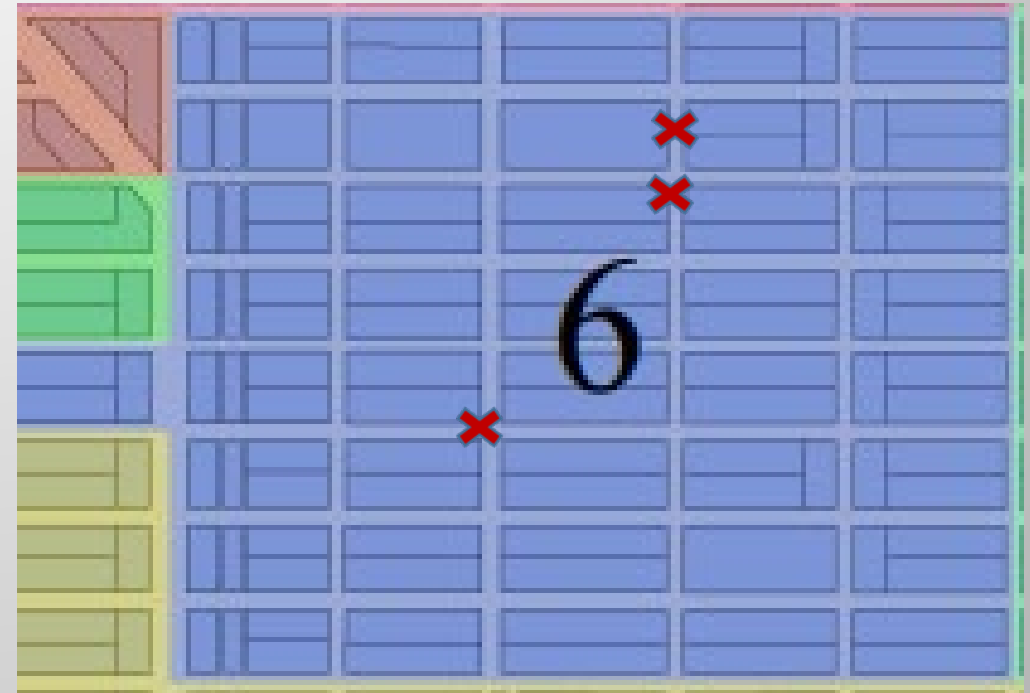
Units responded to Pyrce Park for a report of a disturbance. Upon arrival, responding officers met with several witnesses who related a male subject and female subject were highly intoxicated while in the water park area. It was reported that said male subject grabbed a juvenile female subject by the hand and attempted to bring her into the water park area. It was at this time that the juveniles mother stopped him. A parent of another child related that said male subject was dancing in a sexual manor while his pants were below his waist and buttocks were partially exposed. While on scene, officers learned that the same offenders had just been involved with a Battery incident in front of Strikers Lanes. Both adult subjects were taken into custody and transported to the Berwyn Police Department for further investigation.

## **Battery – 6/15/2024 Strikers Lanes (6728 W. 16<sup>th</sup> Street) – 2:14p.m.**

A Berwyn Police Officer was flagged down by an adult male subject who reported that his juvenile son was just choked by an unknown adult male subject exiting Strikers Lanes. The juvenile victim and his friend related they exited the bowling alley and began to walk Eastbound on 16<sup>th</sup> Street when an unknown male subject began choking him. The victim related that he fought back and was able to free himself from the offender. The victim then called his father who immediately arrived on scene. The victim advised the officer that they observed the offender and his girlfriend enter Pyrce Park. At that time, officers on scene at Pyrce Park for a disturbance incident were advised that they may be dealing with the same offenders for both incidents. The incidents were turned over to Juvenile Detectives for further investigation. The juvenile victim positively identified the male and female subjects in custody as the offenders from their Battery incident. The female offender was cited for Public Intoxication and released. The male offender was charged with one (1) misdemeanor count of Battery and also cited for Provocative Dancing, Public Intoxication, and Criminal Trespass to Real Property. Case closed by arrest.

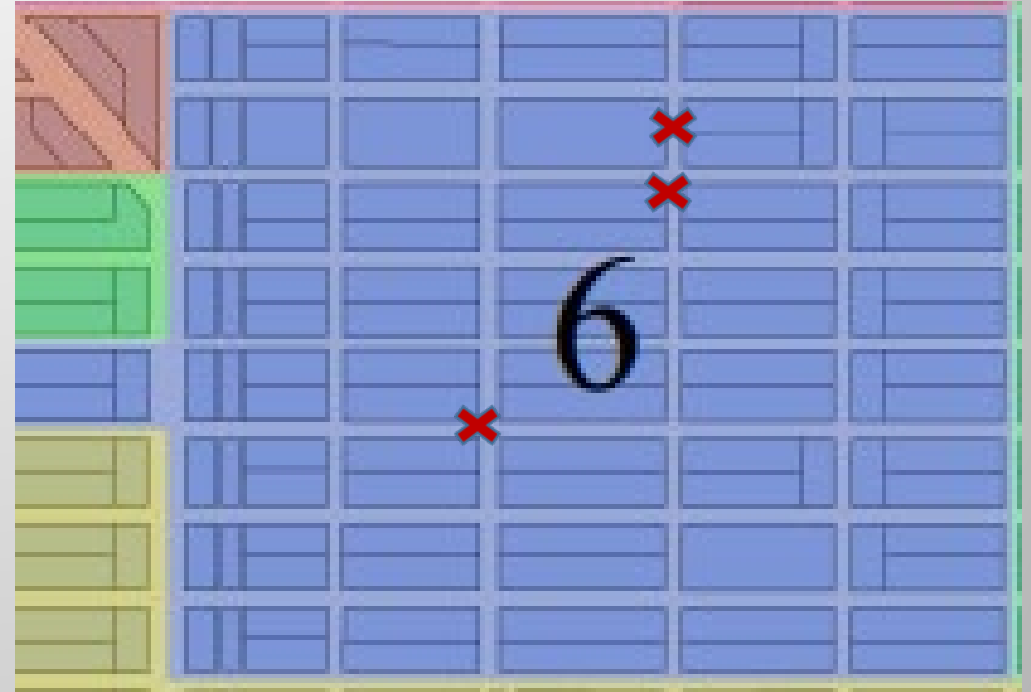

Officers responded to the 1900 block of Gunderson for a report of shots fired in the alley. Upon arrival, responding officers located a male subject in the alley where the shots were allegedly fired. Said subject was detained pending further investigation. A female subject on scene became aggressive with police officers and struck one of the officers in the forearm. Said female was taken into custody and transported to the Berwyn Police Department. Further investigation for the report of shots fired yielded negative results and officers determined it was unfounded. The male subject was subsequently released without charges. The female subject was charged with one (1) felony count of Aggravated Battery to a Police Officer. Case closed by arrest.
