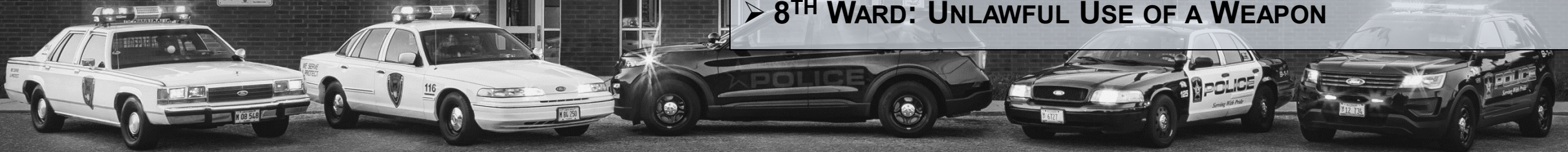

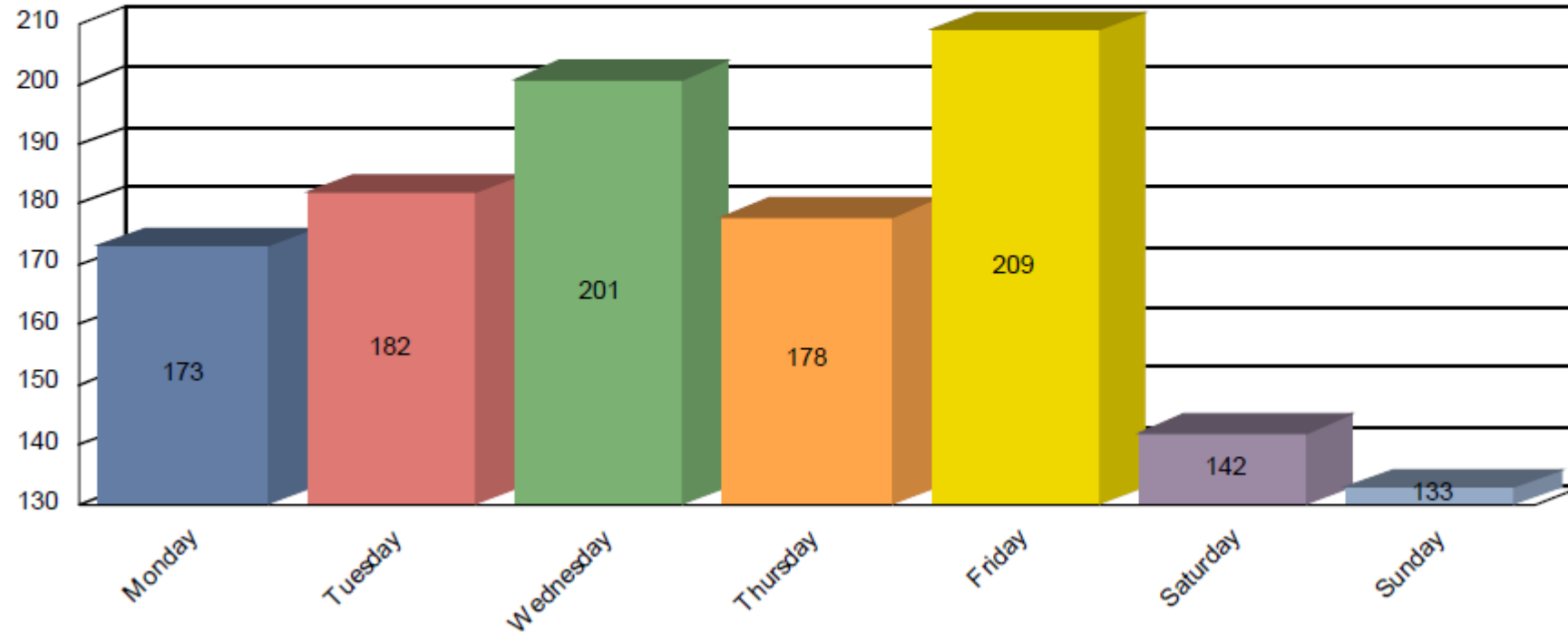

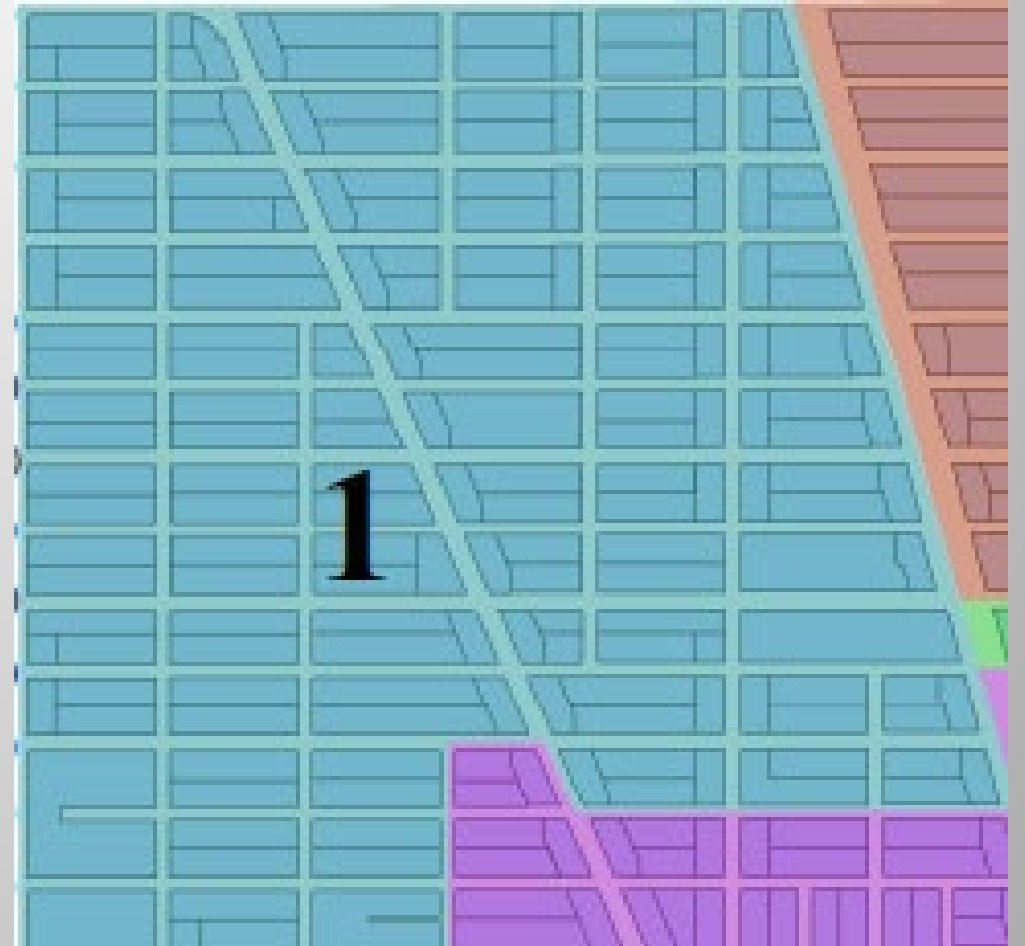

## **Attempted Aggravated Robbery/Burglary to Motor Vehicle/ Resisting a Peace Officer – 6/18/2024 6500 block of Ogden Ave. – 5:10p.m.**

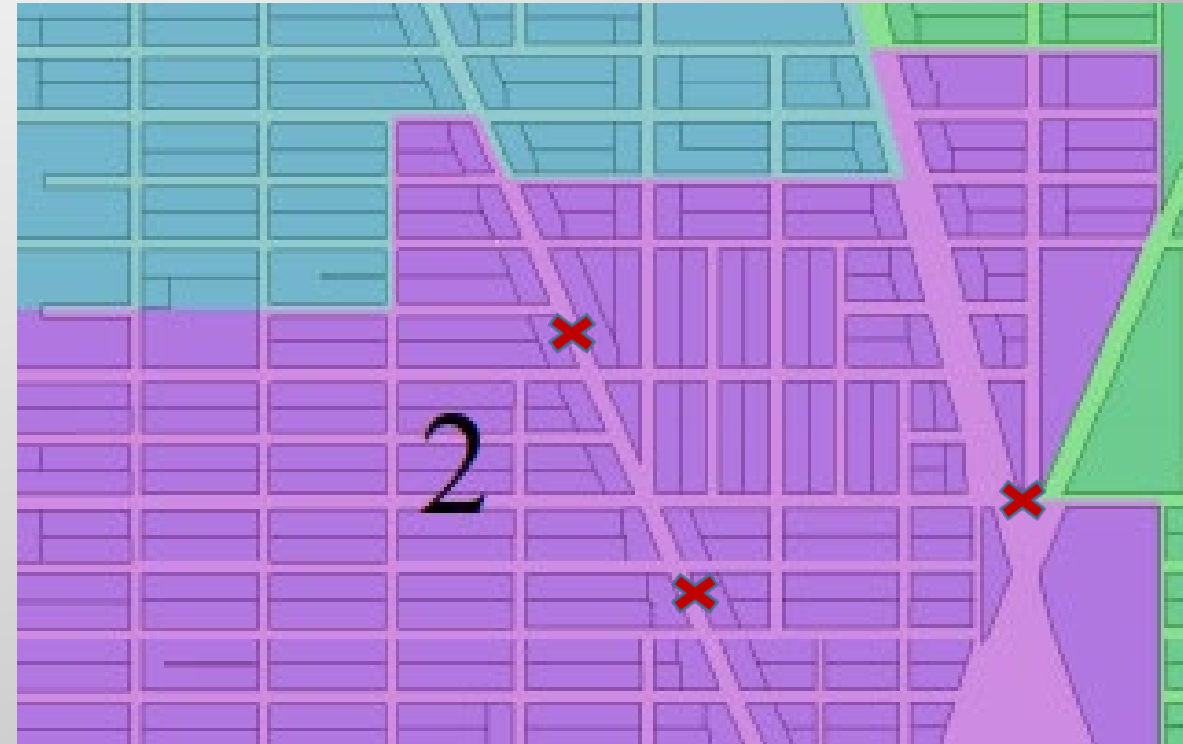
Units responded to the 6500 block of Ogden Ave. for multiple reports of a Male Black subject attempting to break into multiple vehicles near East Ave./Ogden Ave. Responding officers conducted a check of the area and located a male subject, matching the given description, carrying a bag. Said subject fled from the police on foot and a short foot pursuit ensued. Officers placed the offender in custody on the 3300 block of Harvey Ave. and transported him to the Berwyn Police Department. The offender was subsequently charged with one (1) felony count of Attempted Aggravated Robbery, one (1) felony count of Burglary to Motor Vehicle, and one (1) felony count of Resisting a Peace Officer. Case closed by arrest.

## **Stolen Motor Vehicle – 6/19/2024 Xander Auto Shop (3101 Ridgeland Ave.) – 12:13p.m.**

Officers responded to Xander Auto Shop for a report of a stolen motor vehicle. Responding officers met with the shop owner who related a Male Hispanic subject requested to use the restroom at which time he went to the area where the keys were located and took the keys to a vehicle. Said subject then entered the vehicle and fled Northbound on Ridgeland Ave. The offender was described as Male Hispanic, 5'6", 150lbs, black hair, brown eyes, with face and neck tattoos. Witnesses stated the offender was wearing a black baseball cap, white t-shirt, black jean shorts, and white shoes at the time of the incident. This investigation is ongoing.

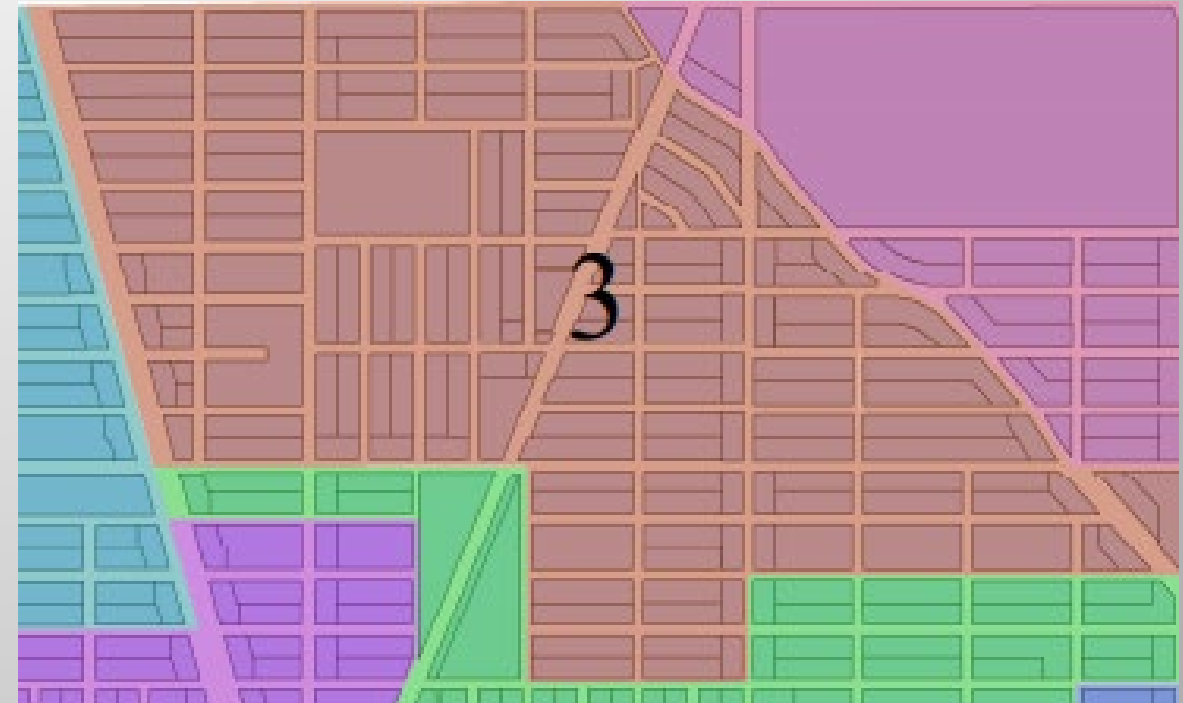

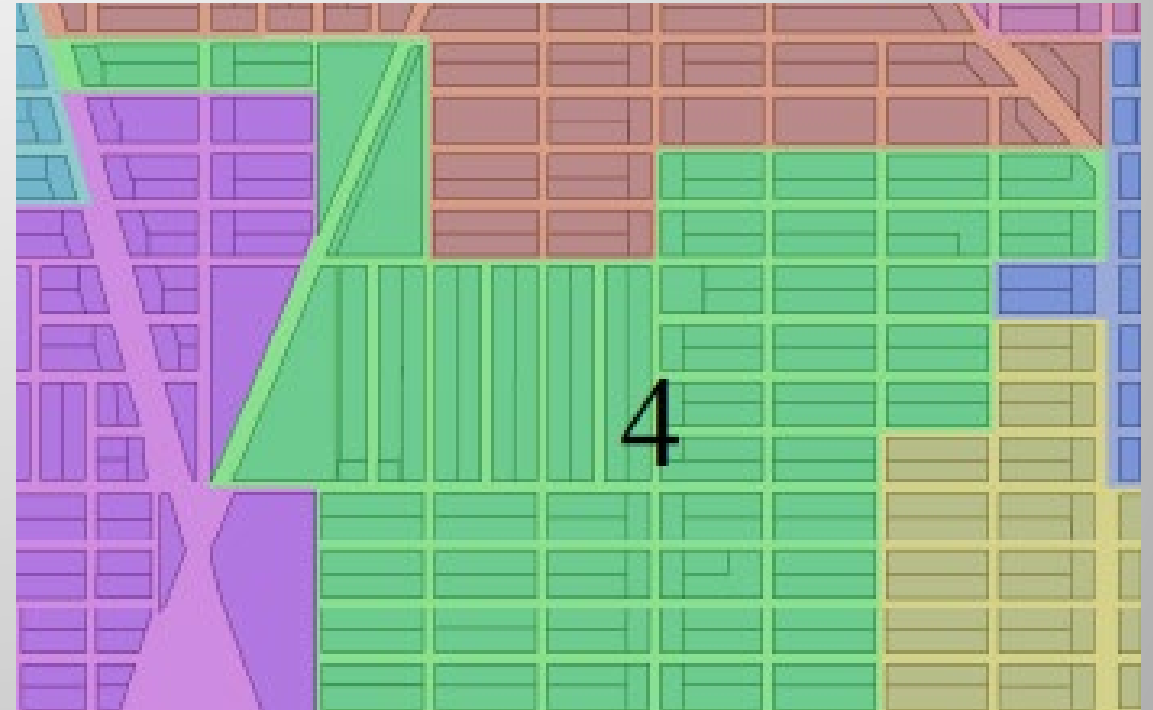

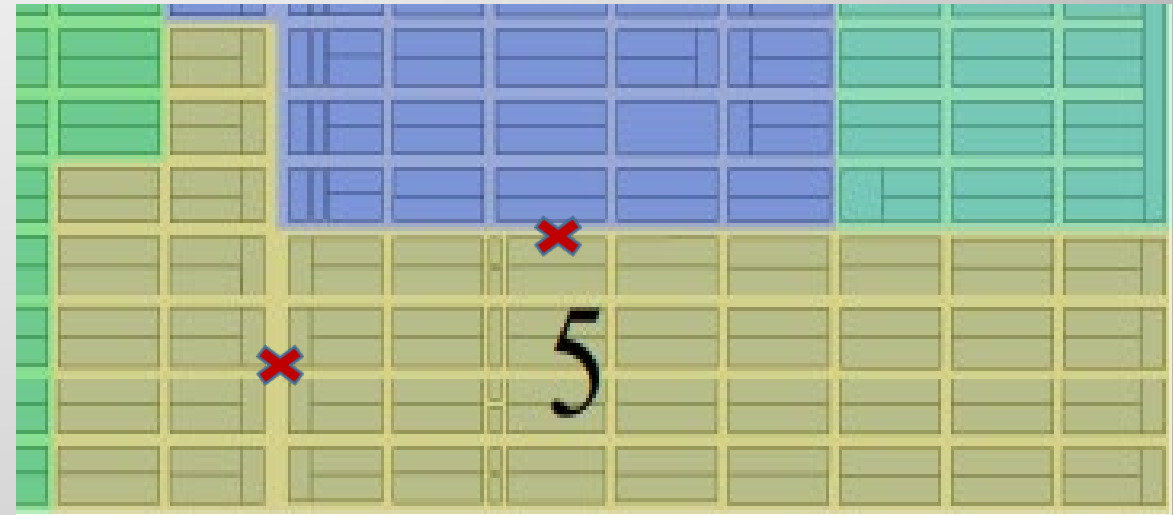

## Armed Robbery – 6/22/2024 Cermak Rd./Highland Ave. – 12:11a.m.

Officers were flagged down at Cermak Rd./Highland Ave. for an Armed Robbery that just occurred. The victim stated as he was walking to his vehicle he was approached from behind by an unknown Male Black subject wearing all black clothing, and a black ski mask. The victim further related that the offender put a knife to his back and demanded everything he had. The offender then struck the victim several times in the back, took his wallet, and then fled the scene on foot. The victim further related that his wallet contained \$1,500 cash, bank cards, and his Driver's License. This investigation is ongoing.

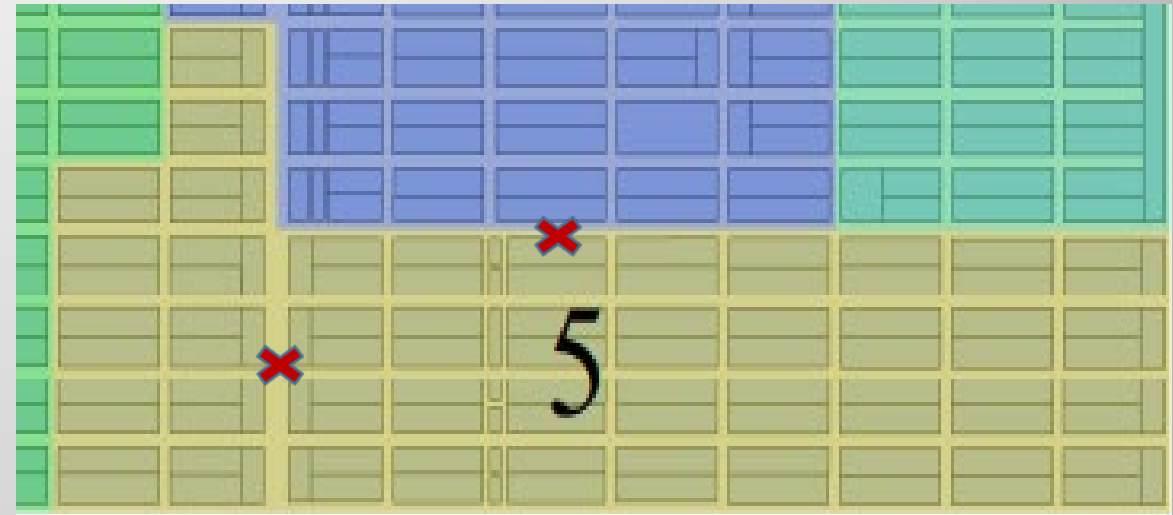

## **Aggravated Assault to a Police Officer/Criminal Damage to Government Property – 6/23/2024 1800 block of Ridgeland Ave. – 6:45p.m.**

Officers responded to the 1800 block of Ridgeland Ave./Cuyler Ave. alley for a report of a vehicle shot by a BB gun. Responding officers met with the victims who related a Male Hispanic subject brandished a firearm at the male victim and then fled into one of the residences on the 1800 block of Ridgeland Ave. The offender was last seen wearing black in color jogging pants, no shirt, and was approximately 5'6" with long hair. While speaking with the victims in the alley, a hard object grazed the arm of the male victim and then struck and dented the passenger-side of the police squad. Officers advised the victims to re-locate to a safer location. Officers observed the offender in the alley yelling profanities and threats towards the responding officers and victims. Additional units were summoned to the scene for assistance. The offender continued to throw several items at the victims and kept retreating into the rear door of his residence. Additional units arrived on scene and made contact with the offender who continued to be confrontational and profane towards the officers on scene. While officers attempted to continue to speak to the victims, the offender was observed pointing a possible firearm which was equipped with a green in color laser light. The victims were advised to enter their vehicle and flee the area. At this time, officers set up a perimeter around the residence and requested additional assistance. Officers made several attempts to make contact with the barricaded subject. At 8:35p.m. the offender finally opened the front door at which time he was taken into custody without further incident. The offender was charged with one (1) misdemeanor count of Aggravated Assault, one (1) felony count of Criminal Damage to Government Supported Property, and one (1) felony count of Aggravated Assault to a Police Officer. Case closed by arrest.

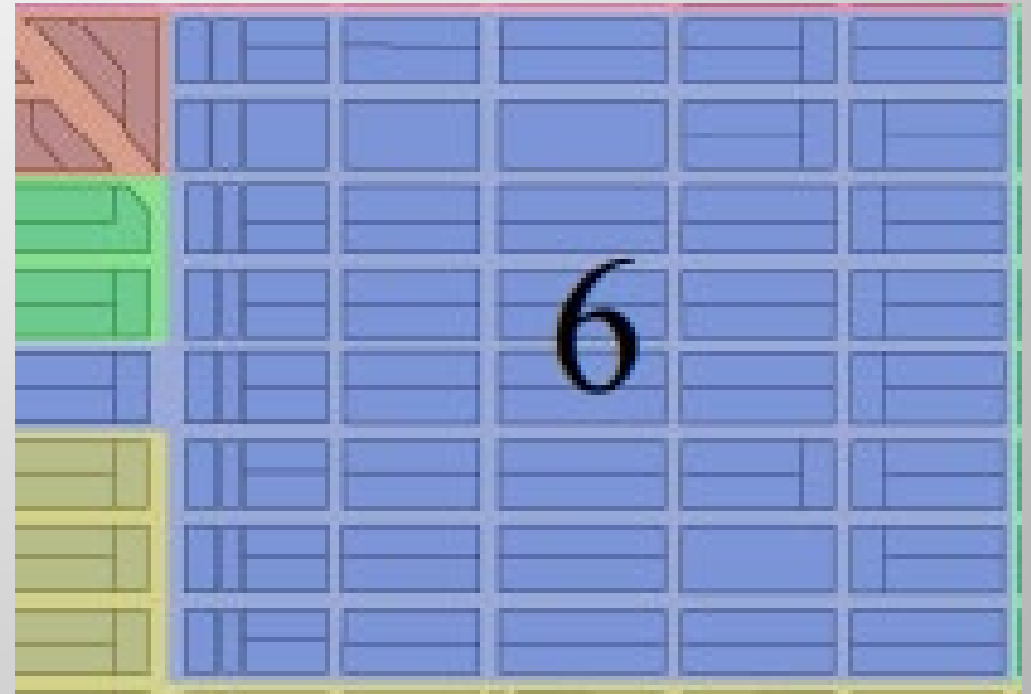

## Retail Theft/Warrants – 6/20/2024

### Advanced Auto Parts (6932 W. Cermak Rd.) – 11:43a.m.

Officers responded to Advanced Auto Parts for a report of a retail theft that had just occurred. The reporting party (store staff) further related to Berwyn Dispatch that the offender was a Male Black wearing a black hat, blue shirt, yellow/orange safety vest, and carrying one (1) black duffel bag and one (1) green duffel bag. Officers canvassed the area and located the subject in the area of Cermak Rd./Clarence Ave. Officers approached the offender at which time he fled down East Ave. and dropped two (2) duffel bags on the 6500 block of Cermak Rd. A foot pursuit ensued and the offender was ultimately apprehended and taken into custody at Cermak Rd./Scoville Ave. A show up was conducted and a positive I.D. was made. The offender experienced a medical episode and was subsequently transported to MacNeal Hospital for treatment. A search of the offender was conducted which revealed two (2) items on his person which were later identified as taken from Advanced Auto Parts. The items in the two (2) duffel bags were examined. The first duffel bag had items inside that were new and had tags from a different business. The second duffel bag had items and identifications that did not match the offender in custody. The offender was subsequently charged with one (1) misdemeanor count of Retail Theft. The offender was also processed and charged under three (3) outstanding warrants. The offender was transported to Cook County Fugitive Warrants for extradition. Case closed by arrest.

Officers responded to the 1300 block of Clarence Ave. for a report of a person with a gun. Upon arrival, responding officers met with the victim who related he was standing next to his car with a friend when a silver in color sedan occupied by four (4) Black Male subjects slowly passed by them. The victim further related that one (1) of the occupants shouted, "You got a problem?" and then drove off Northbound on Clarence Ave. The victim stated that a few minutes later the same vehicle returned and drove by again. The victim further related that this time, the rear passenger stuck his body out of the window, pointed a black in color firearm at them, and shouted "Your boy was mean mugging me" before fleeing Northbound on Clarence Ave. once again. No shots were fired. This investigation is ongoing.
