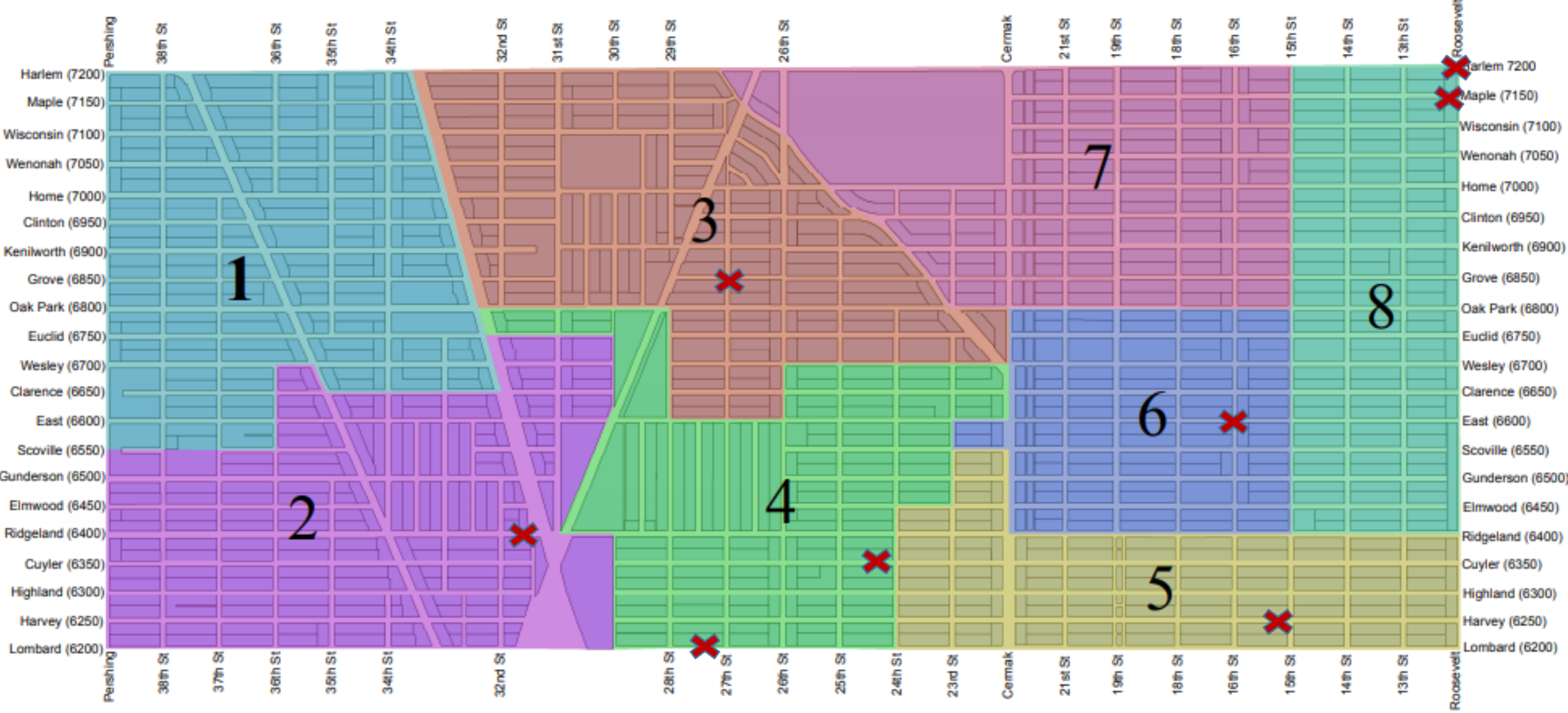

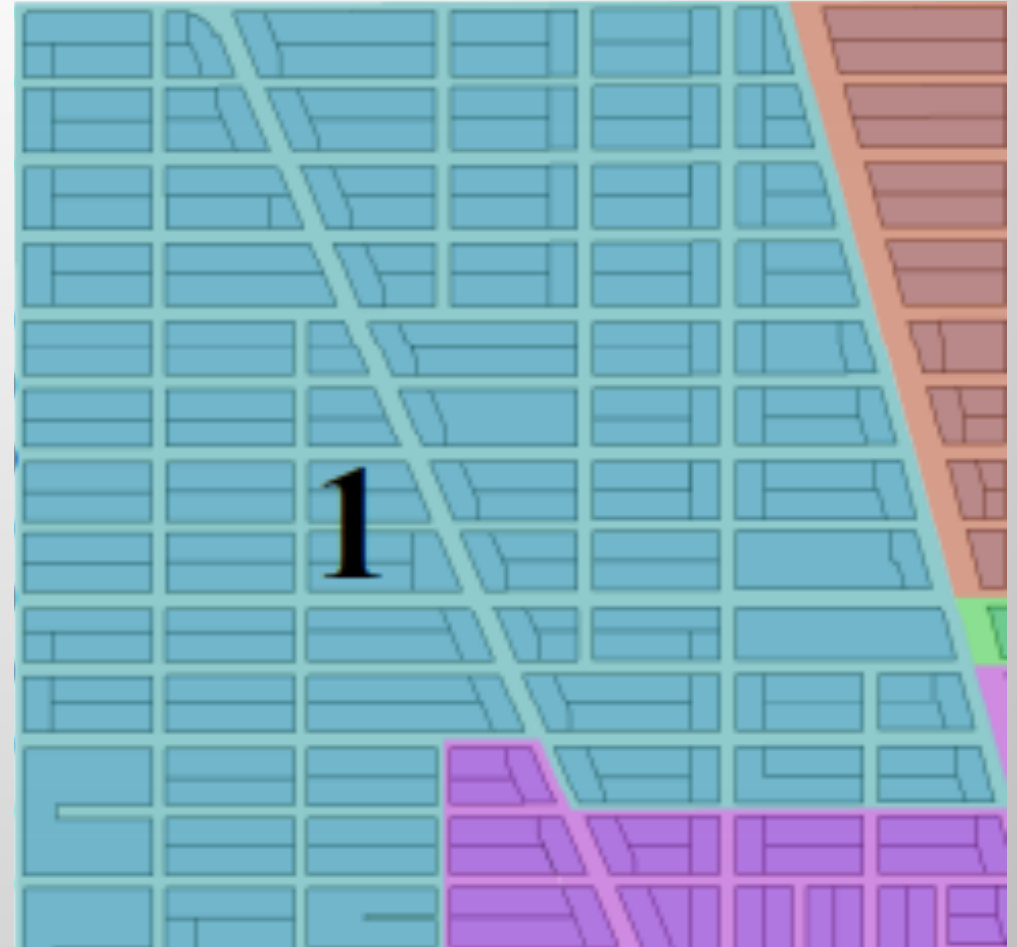

Aggravated Unlawful Use of a Weapon – 6/28/2024 Ridgeland Ave./Park Ave. – 1:54a.m.

Officers conducted a traffic stop on a vehicle at Ridgeland Ave./Park Ave. Upon making contact with the driver, the driver advised the officer that he had a handgun under the front passenger seat. The driver had a valid FOID but no CCL. The officer also learned that the vehicle's registration was expired. The male driver was subsequently taken into custody and transported to the Berwyn Police Department. Officers recovered a loaded firearm from underneath the front seat. The offender was charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

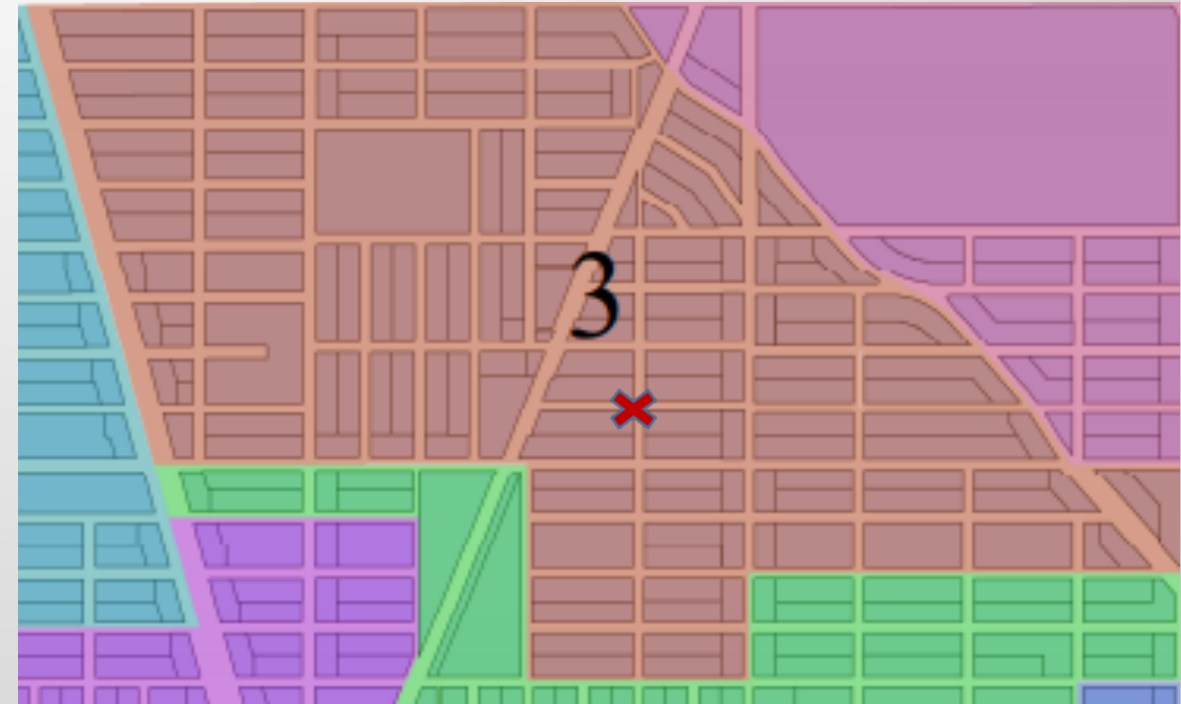

Berwyn Dispatch received two (2) calls reporting multiple shots fired on the 2700 block of Grove Ave. An extensive check of the area yielded negative results. Officers determined the calls to be unfounded.

SIGNIFICANT INCIDENTS IN 4TH WARD

Armed Robbery – 6/24/2024

2700 block of Lombard Ave. – 3:02p.m.

Officers responded to the 2700 block of Lombard Ave. for a report of an Armed Robbery that had just occurred. Responding officers met with the victim, who related he was delivering packages for Amazon and parked the Amazon delivery van on the 2700 block of Lombard. The victim further related that two (2) Black Males approached him and took packages from the truck as well as the victim's cell phone and other personal property. The victim stated that one (1) of the subjects displayed a handgun. The offenders then entered a white in color sedan, with a third person that acted as a lookout, and fled the scene Westbound on 28th Street from Lombard Ave. Both offenders were further described as 5'08"-5'10", 18-22y.o.a., wearing black in color hooded sweatshirts, and blue in color disposable face masks. This investigation is ongoing.

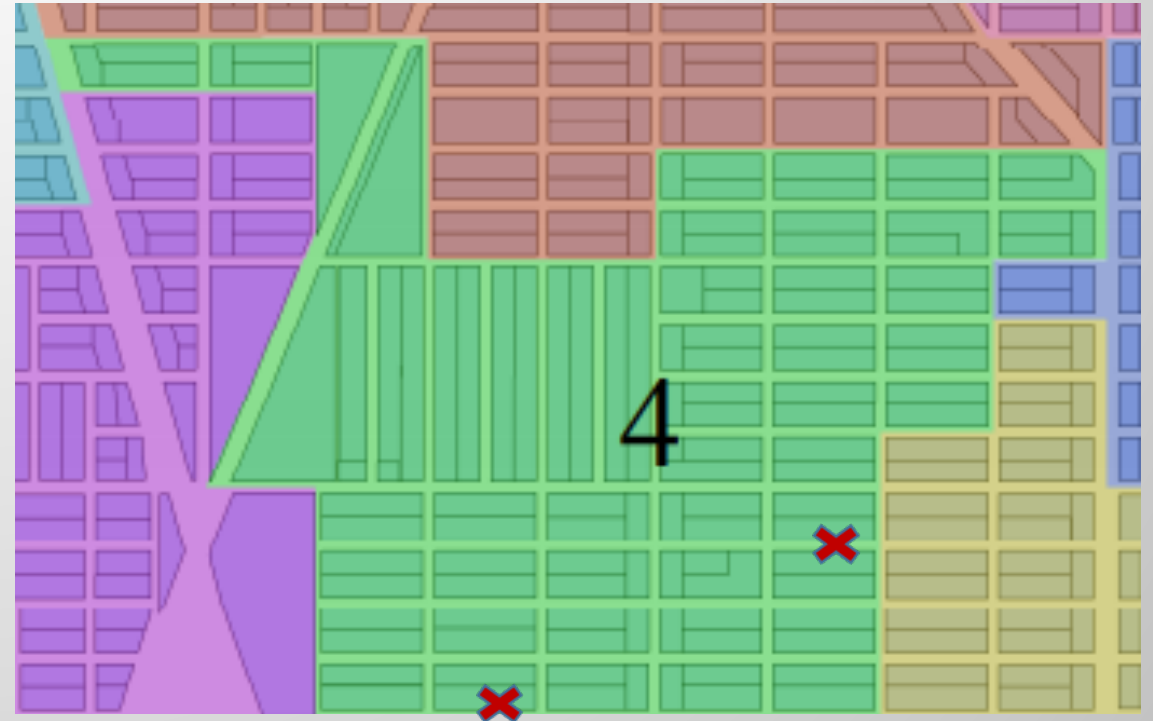
Possession of a Controlled Substance – 6/27/2024

2400 block of Cuyler Ave. – 8:50p.m.

Officers conducted a traffic stop on the 2400 block of Cuyler Ave. Upon making contact with the driver, officers learned that he did not have any form of identification on his person and subsequently asked him to step out of the vehicle. A protective search of the male driver revealed one (1) plastic bag containing a green plant-like substance suspect cannabis (2g with packing) and one (1) small plastic bag filled with a white powdery substance suspect cocaine (less than 1g with packaging) in the offender's pants. The offender was transported to the Berwyn Police Department and charged with one (1) felony count of Possession of a Controlled Substance. Case closed by arrest.

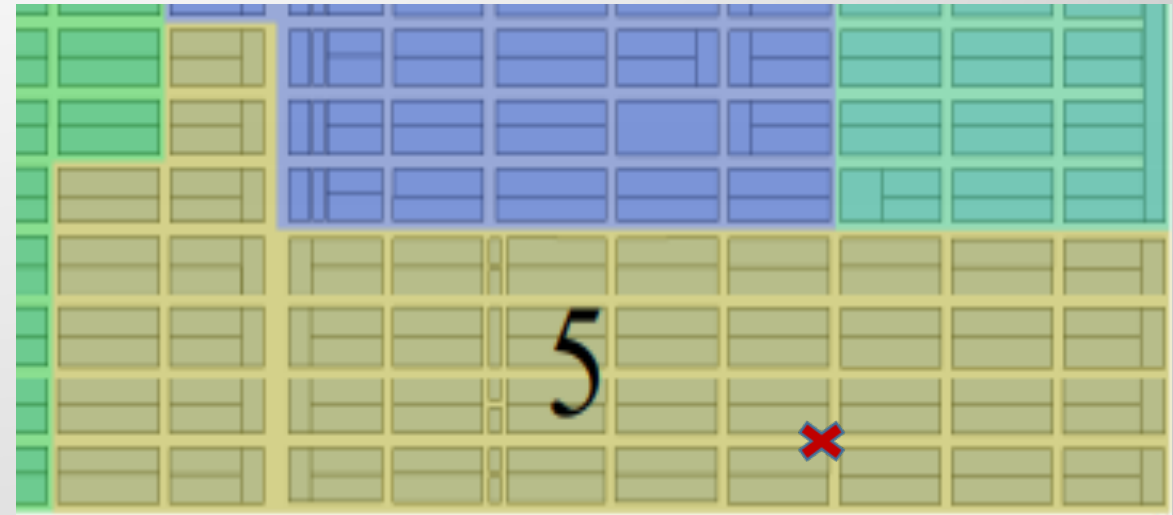

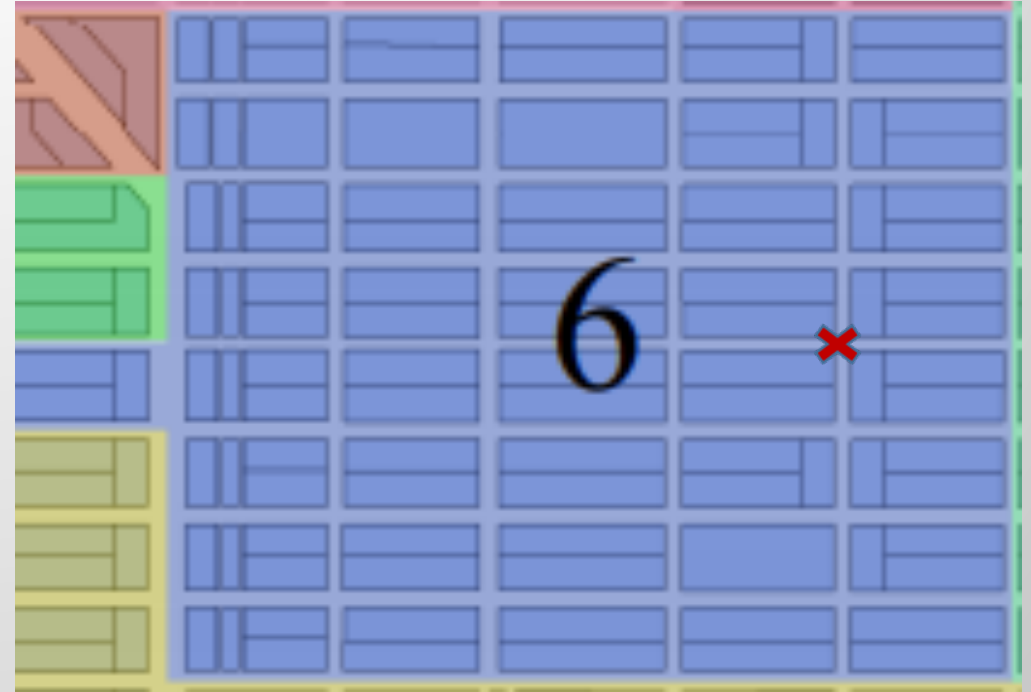
Stolen Motor Vehicle – 6/29/2024

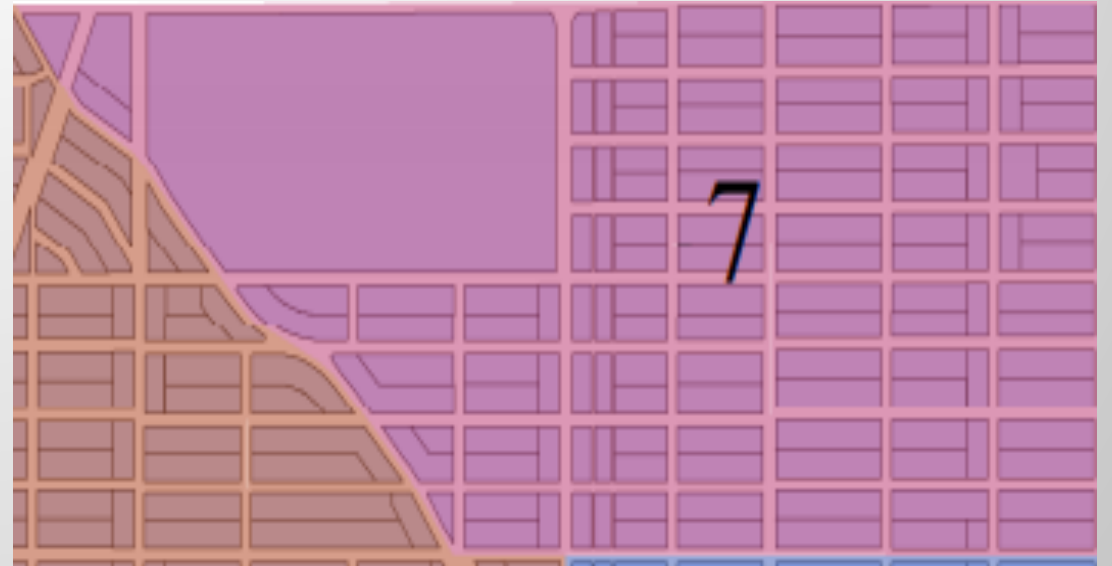

Attempted Robbery – 6/25/2024

Shell Gas Station (7143 Harlem Ave.) – 6:36p.m.

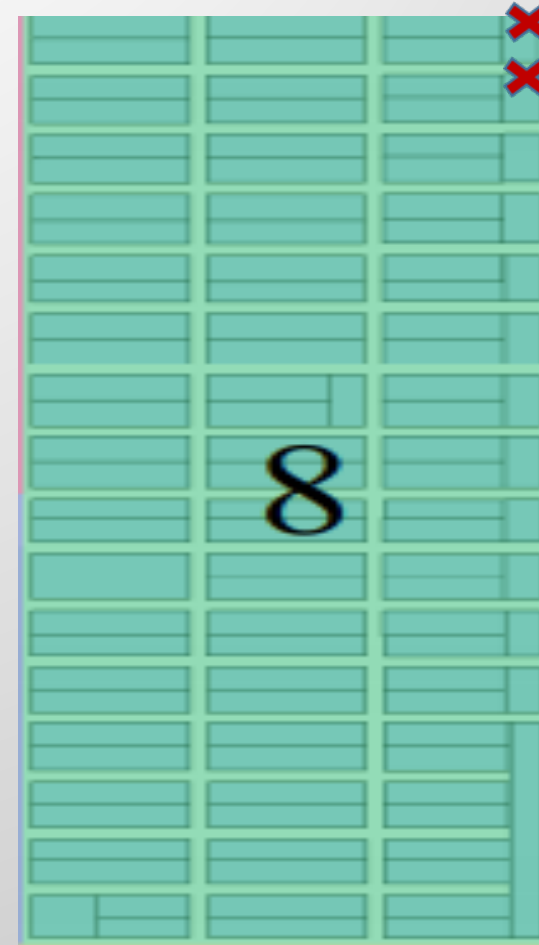
Officers were flagged down by several motorists who related a fight was in progress at the Shell Gas station. Upon arrival, officers made contact with the male and female victims (both juveniles). The victims related they were standing on the corner of Harlem Ave./Roosevelt Rd. waiting to cross Harlem Ave. when an unknown White Male subject approached the juveniles and asked them for money. The male juvenile advised that they did not have any money. The offender then grabbed the cellphone, which had a clear case holding cash attached, from the female victim's back pocket. The male juvenile struck the offender was able to stop him from taking the victim's belongings. The offender was still on scene at the time of police arrival and was subsequently taken into custody and transported to the Berwyn Police Department. The offender was charged with one (1) felony count of Attempted Robbery. Case closed by arrest.

Attempted Murder/Aggravated Unlawful Use of a Weapon/Aggravated Discharge of a Firearm – 6/25/2024 1200 block of Maple Ave. – 11:47p.m.

Berwyn Dispatch received one call of shots fired in the 1200 block of Maple Ave./Harlem Ave. alley. The caller advised that they heard a subject scream followed by approximately ten (10) gun shots. As responding officers were arriving on scene, Berwyn Dispatch advised that Forest Park PD units located the male victim. Berwyn officers reported to said location in Forest Park and made contact with the victim. Officers learned that the incident stemmed from a domestic dispute between the victim and his girlfriend on the 1200 block of Home Ave. A male family member of the girlfriend then followed the victim outside and fired multiple shots at the victim in the 1200 block of Maple Ave./Harlem Ave. alley. The offender then fled back to his residence on the 1200 block of Home Ave. on foot. Officers made contact with the offender at his residence and took him into custody without incident. On 6/26/2024 officers recovered a loaded firearm from the offender's residence while executing a search warrant. The offender was subsequently charged with one (1) felony count of Attempted Murder, one (1) felony count of Aggravated Unlawful Use of a Weapon, and one (1) felony count of Aggravated Discharge of a Firearm.
