



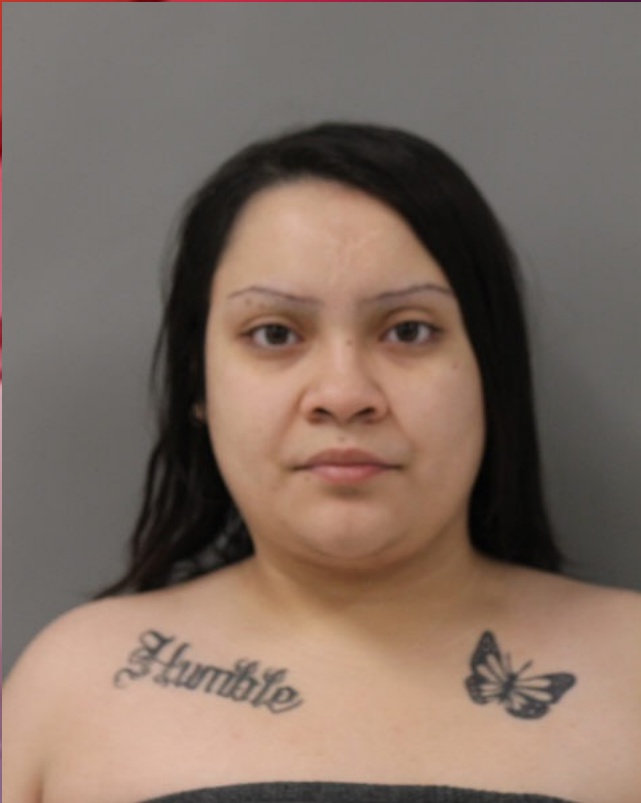

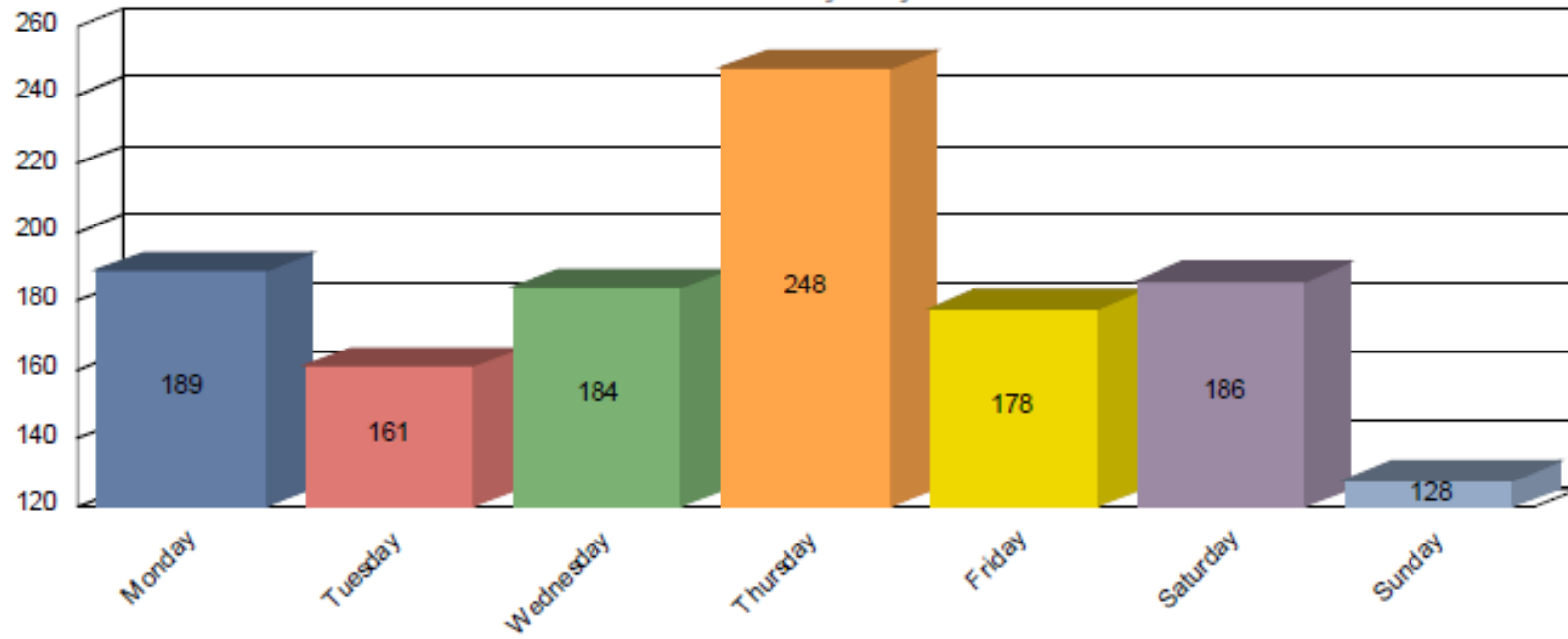

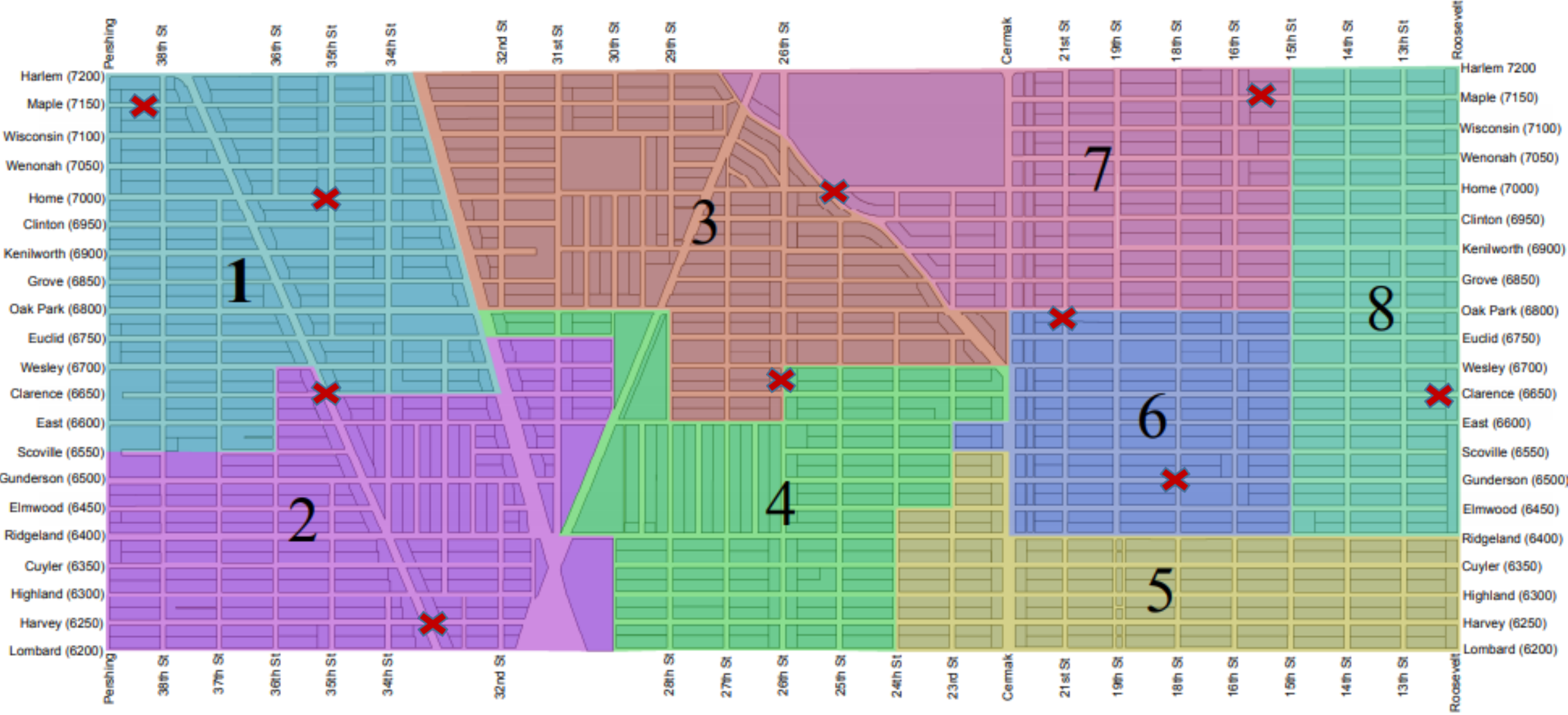

SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 7/01/2024

Unlawful Possession of a Controlled Substance/Possession with Intent to Deliver – 7/01/2024

3500 block of Home Ave. – 9:39a.m.

Officers responded to the 3500 block of Home Ave. for a report of a domestic battery in progress involving one (1) male subject and one (1) female subject. Upon arrival, responding officers placed the male subject in custody. Officers conducted a search of the offender and subsequently recovered several clear plastic bags containing a white powder powdery substance (suspect Cocaine) total weight 17.3 grams and a large amount of U.S. Currency on his person. The offender was then transported to the Berwyn Police Department where it was learned that he was currently on probation. The offender was subsequently charged with one (1) felony count of Unlawful Possession of a Controlled Substance, one (1) felony count of Possession with Intent to Deliver, and one (1) felony count of Domestic Battery. Case closed by arrest.

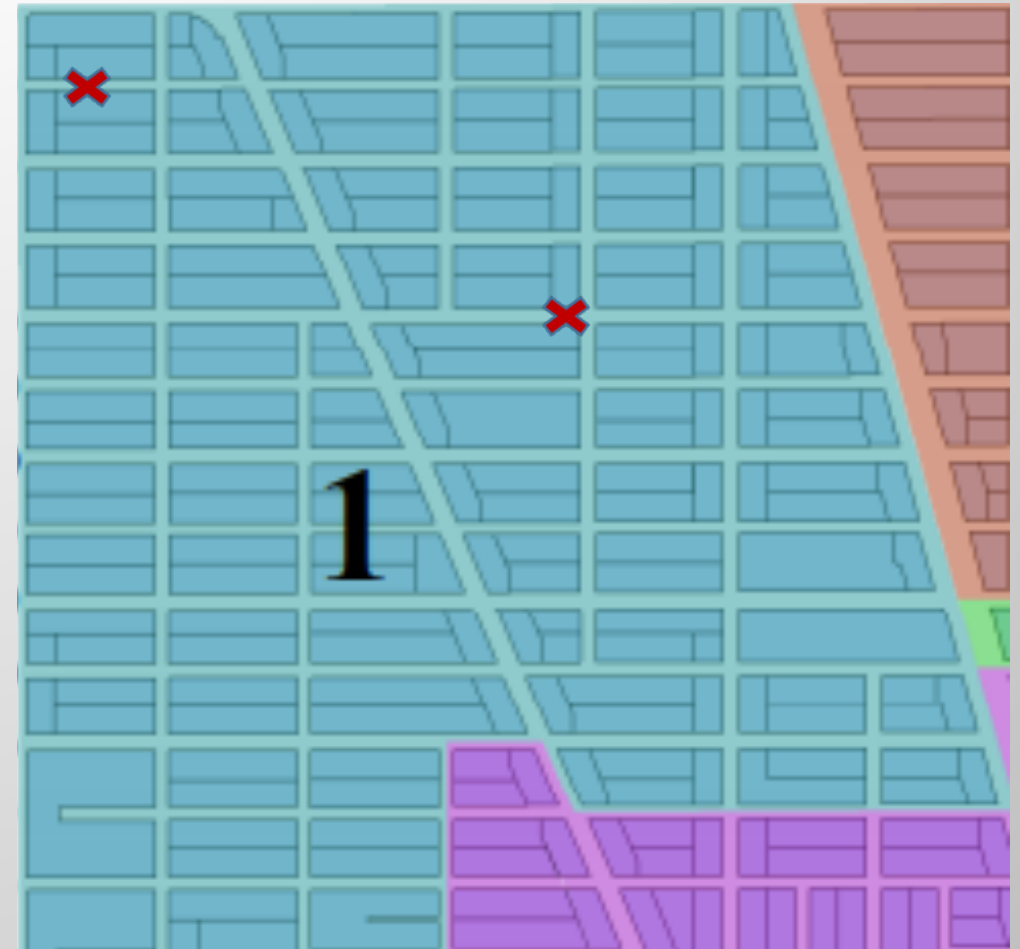
Stolen Motor Vehicle – 7/06/2024

Unlawful Use of a Weapon by a Felon – Firearm – 7/03/2024 Harvey/Ogden Ave. – 12:02a.m.

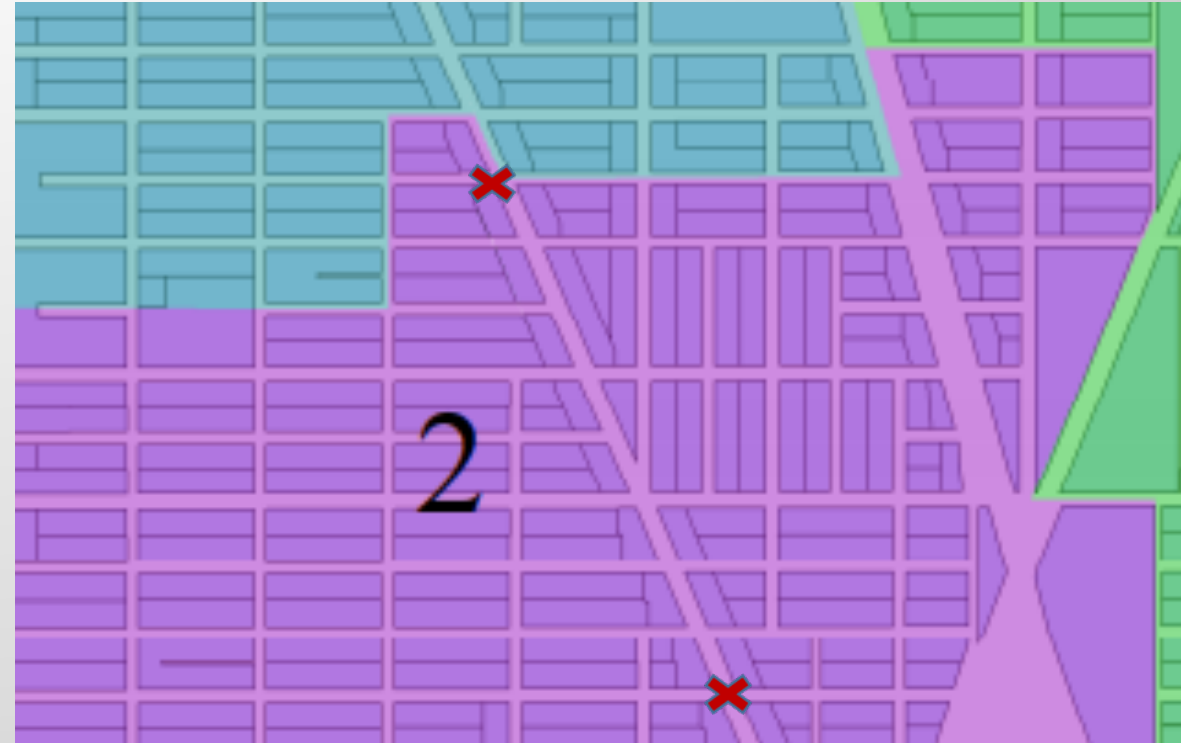
Officers conducted a traffic stop at Harvey/Ogden Ave. Upon making contact with the driver, officers observed open alcohol inside the vehicle. A search of the vehicle revealed a loaded uncased firearm between the driver's seat and the center console. The driver was found to have a denied FOID card and is a convicted felon. The subject was taken into custody and subsequently charged with one (1) felony count of Unlawful Use of a Weapon by a Felon. Case closed by arrest.

Aggravated Unlawful Use of a Weapon-Firearm (x2) – 7/07/2024 Clarence/Ogden Ave. – 2:46a.m.

Officers conducted a traffic stop at Clarence/Ogden Ave. The vehicle was occupied by one (1) male subject and one (1) female subject. Upon making contact with the driver (male), officers could smell a strong odor of an alcoholic beverage emitting from inside of the vehicle. The driver stated he did not possess a valid Driver's License. Both subjects were asked to step out of the vehicle. The driver then consented to a search of his vehicle. Officers conducted an inventory search of the vehicle and recovered an open alcoholic beverage as well as a loaded firearm. Neither of the subjects possessed a valid FOID or CCL. Both subjects were taken into custody and were each subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon- Firearm. Case closed by arrest.

Burglary to Motor Vehicle – 7/02/2024 **2500 block of Home Ave. – 5:44a.m.**

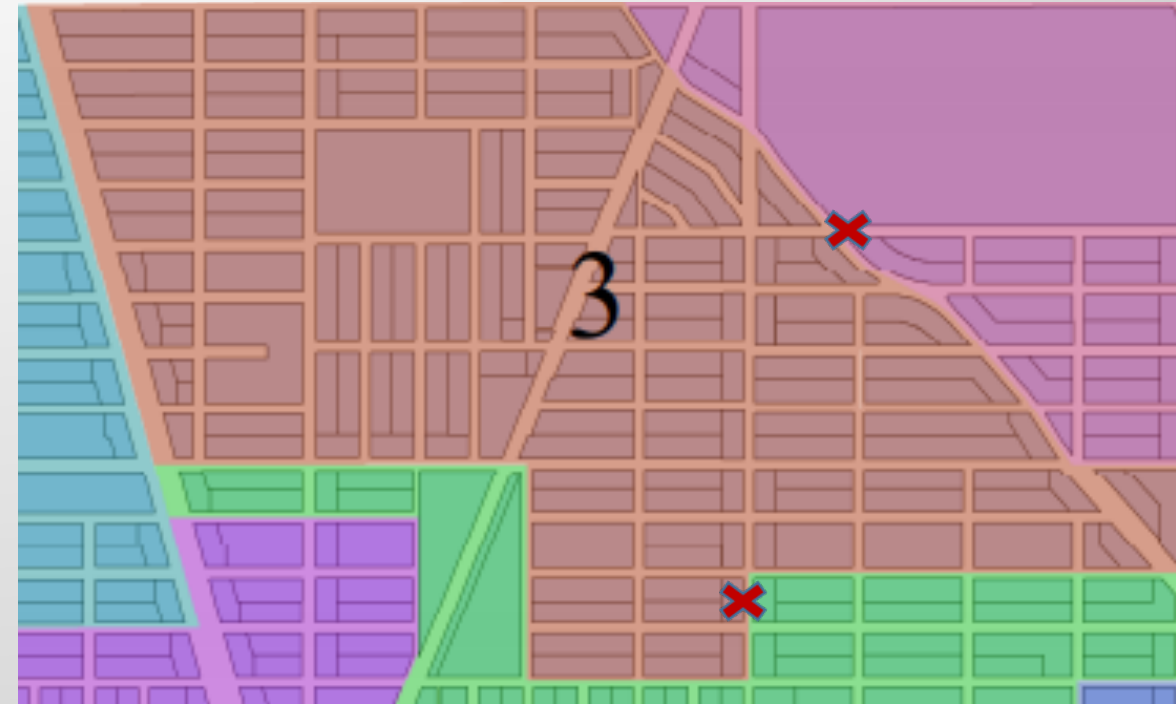

One neighbor related that at approximately 5:15a.m. he witnessed the offender inside of the victim's van before fleeing Northbound down Home Ave. in a dark colored sedan. This investigation is ongoing.

Commercial Burglary – 7/04/2024 **Jack's Rental (6638 W. 26th Street) – 3:47a.m.**

Units were dispatched to Jack's Rental for an activated burglar alarm. Upon arrival, units discovered shattered glass on the rear door where entry could be made. Contact was made with a key holder and an interior check of the business was made and checked clear. Taken was a plastic case containing a pipe crimper said to be valued at approximately \$4,500. This investigation is ongoing.

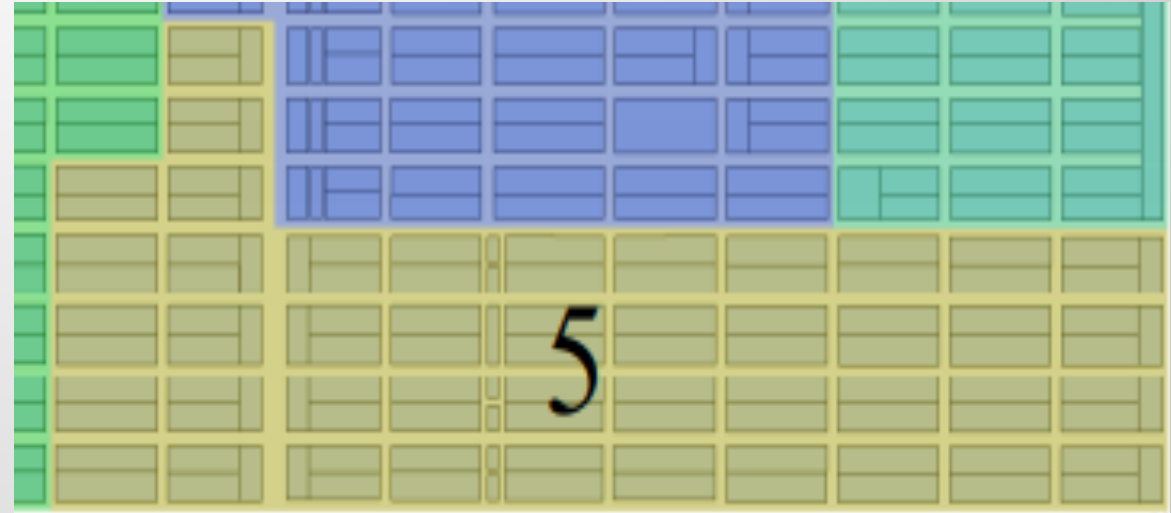
