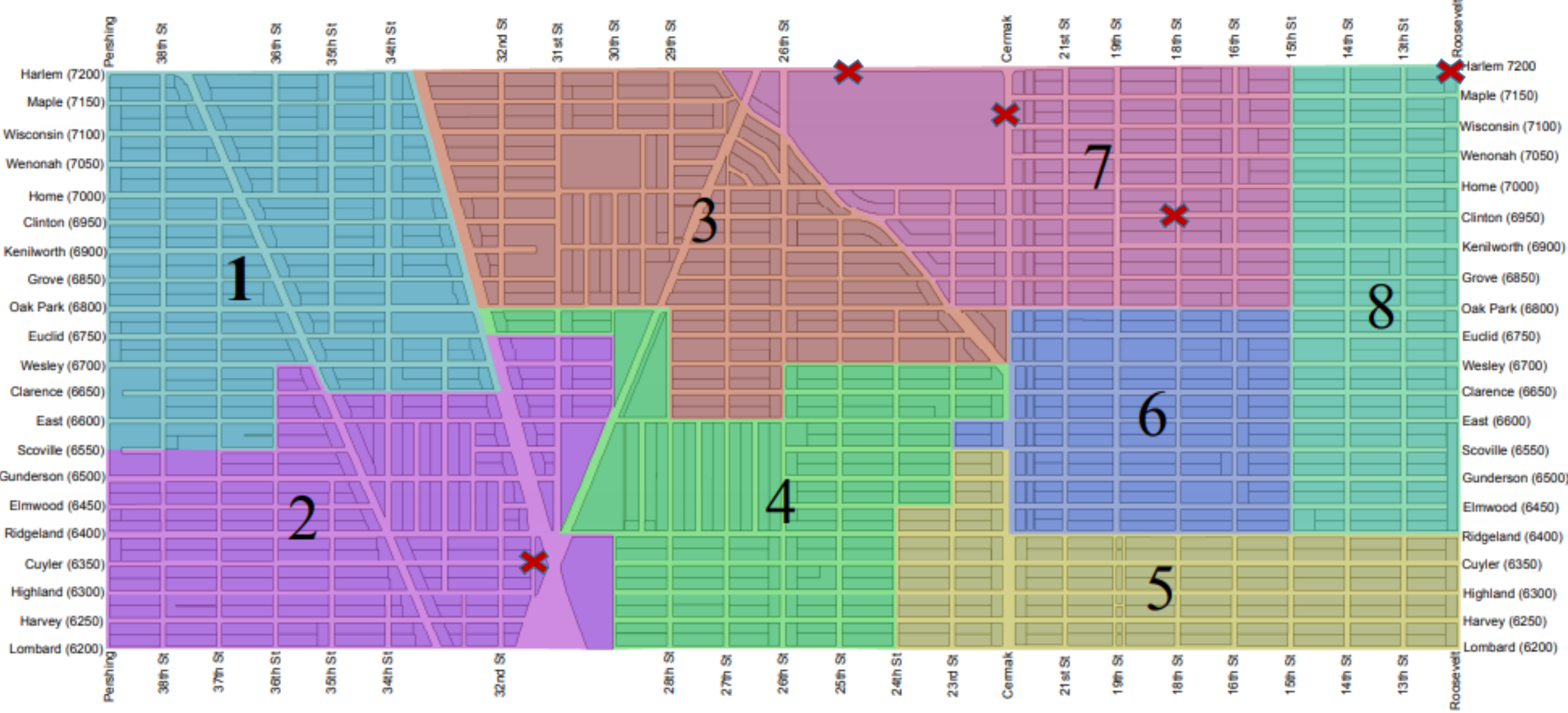

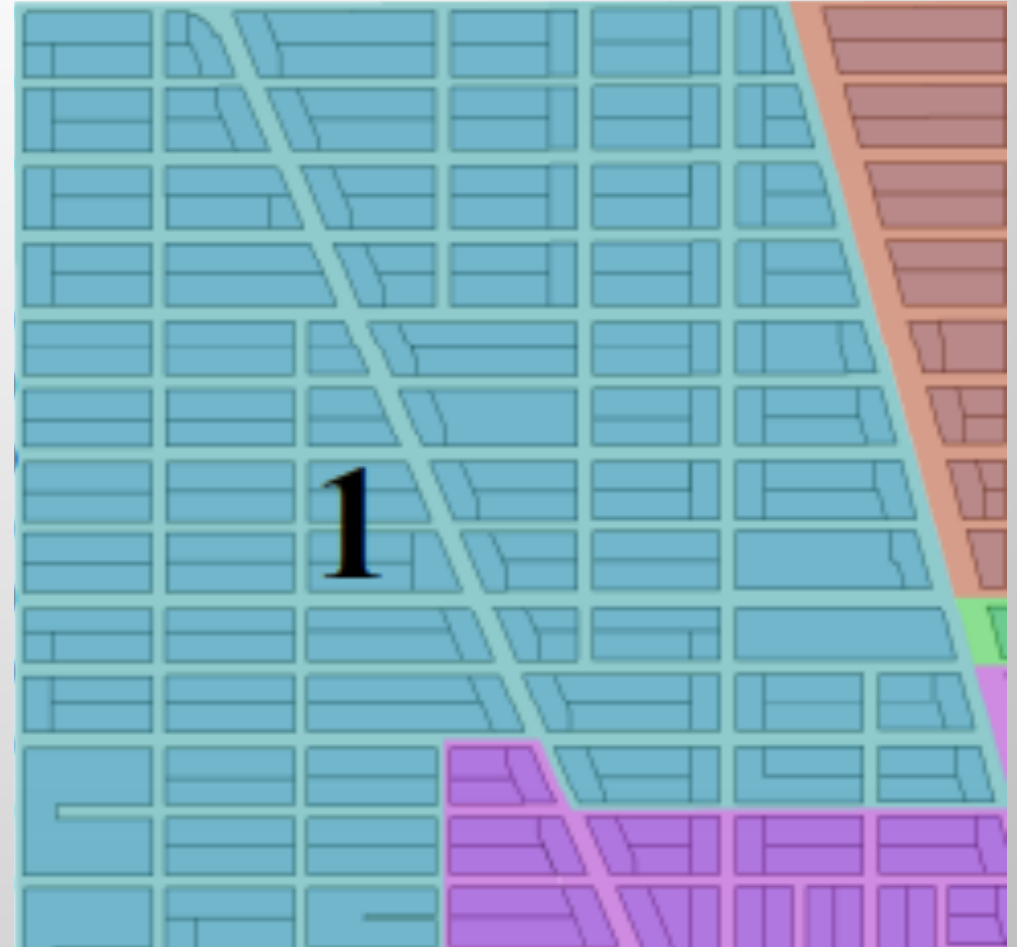

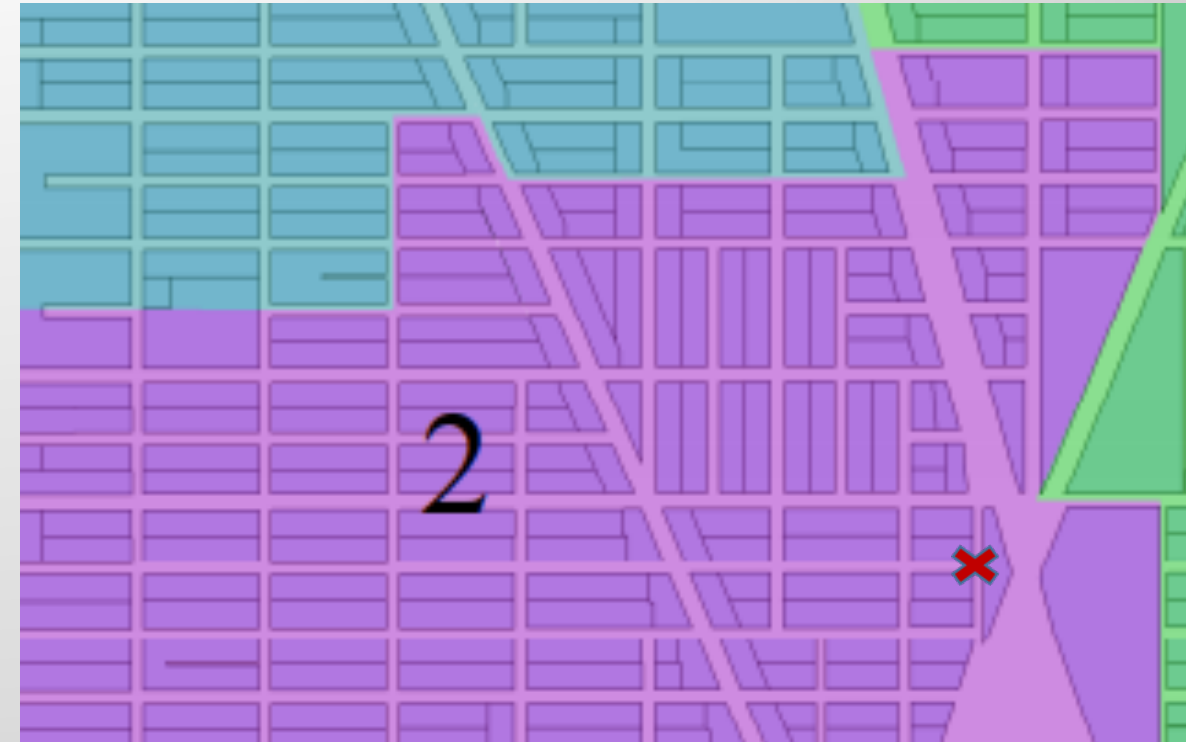

Aggravated Unlawful Use of a Weapon-No FOID, No CCL Unlawful Possession of a Controlled Substance – 7/08/2024 Cuyler Ave/Park Ave – 3:39p.m.

Officers conducted a traffic stop near Cuyler Ave/Park Ave. Officers made contact with the male driver who related he did not have his driver's license on his person and did not have valid insurance. Officers observed, in plain view, multiple spent shell casings throughout the inside of the vehicle. The driver further related to officers that he had a gun underneath his seat. Officers requested the driver step out of the vehicle and recovered a loaded firearm as well as a clear knotted plastic baggie containing a white powder like substance suspect Cocaine (weighing 1.7grams) from inside the vehicle. The subject was taken into custody and transported to the Berwyn Police Department for processing. A check of the subject's name revealed he did not possess a valid FOID or CCL. The offender was subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon- No FOID, No CCL and one (1) felony count of Unlawful Possession of a Controlled Substance. Case closed by arrest.

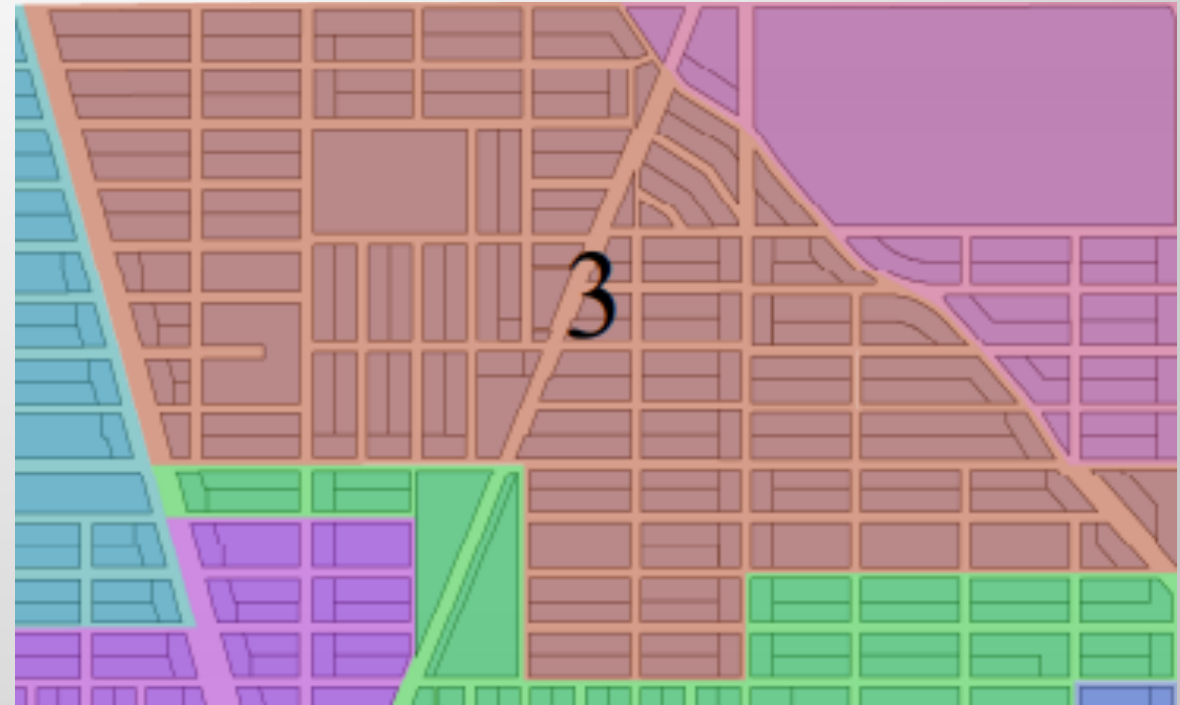

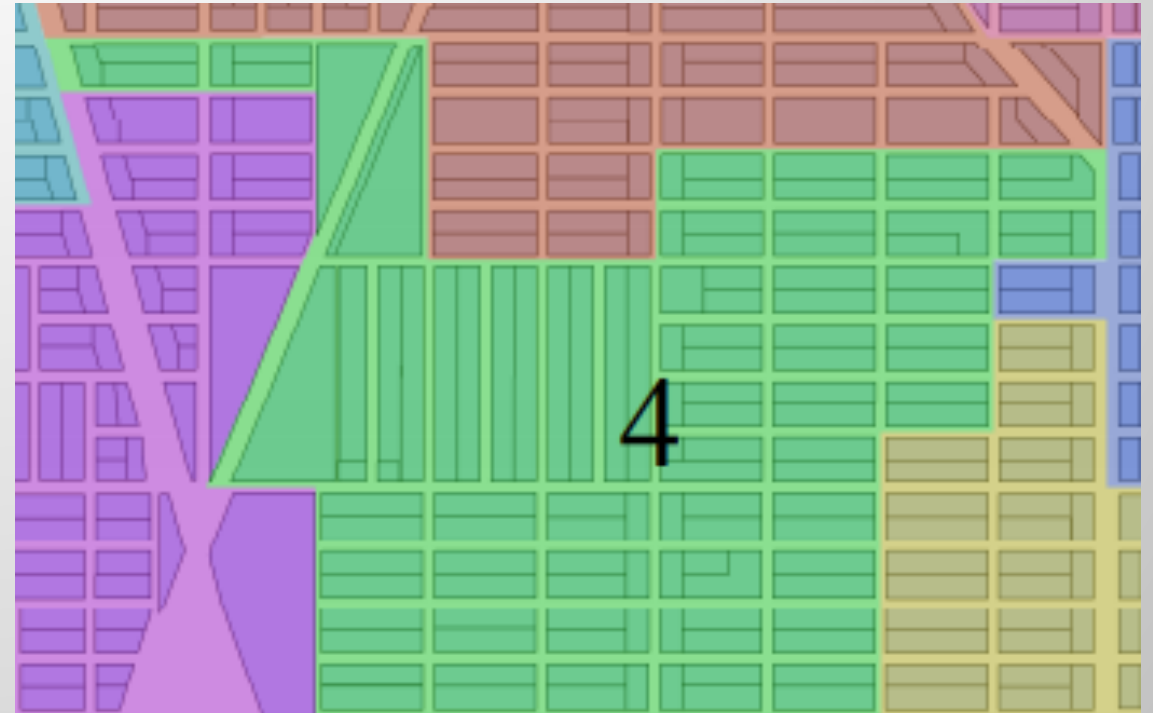

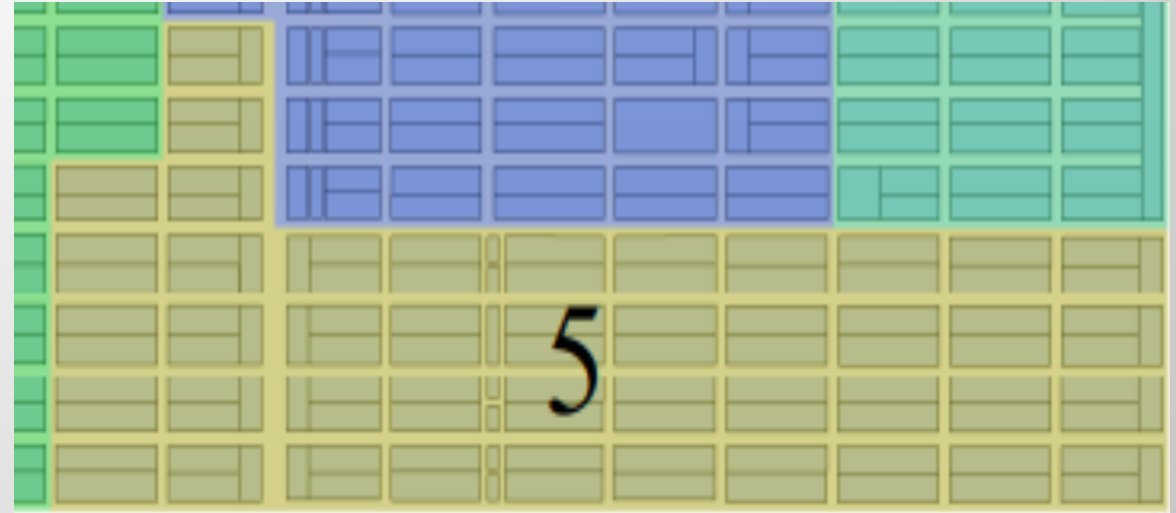

Theft– 7/12/2024

1800 block of Clinton Ave. – 11:37a.m.

Officers responded to the 1800 block of Clinton Ave. for a report of one (1) male subject chasing another male subject. Responding officers detained both subjects. The victim stated he observed an unknown Hispanic Male subject exiting his backyard while carrying his bicycle on his shoulder. The bicycle owner (victim) confronted the offender as he was stealing the bicycle and a fight ensued between the two (2) subjects. The offender then attempted to flee the scene and the victim chased after him on foot. Officers placed the offender in custody and transported him to the Berwyn Police Department for processing. A name check of the offender revealed that he was currently on parole and had two (2) outstanding warrants. The offender was subsequently charged accordingly. Case closed by arrest.

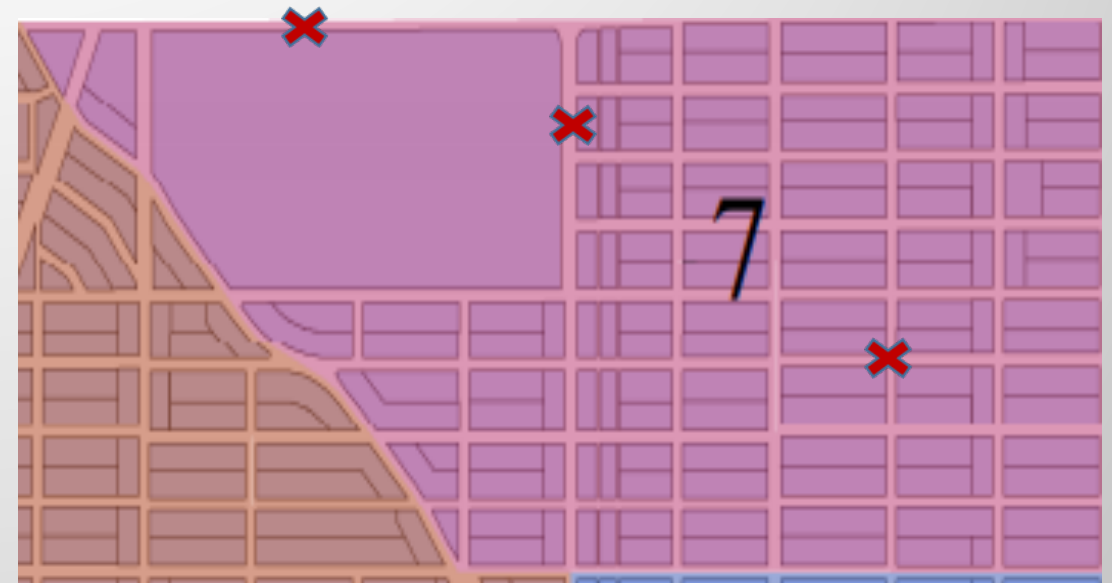
Robbery – 7/12/2024

Walgreens (7113 W. Cermak Rd.) – 11:47p.m.

Officers responded to Walgreens for a report of a robbery. Responding officers met with the store associate who stated an unknown Male Black subject walked behind the front register, grabbed several bottles of liquor and tobacco products and placed them in his backpack while ordering the associate not to move. The offender then exited the store and fled the scene in a vehicle heading Eastbound through the parking lot. The offender was further described as approximately 6'1", 30-40y.o.a., dark colored hair with dreadlocks, and carrying a Navy Blue colored backpack. No weapon was displayed during the robbery and there were no reported injuries. This investigation is ongoing.

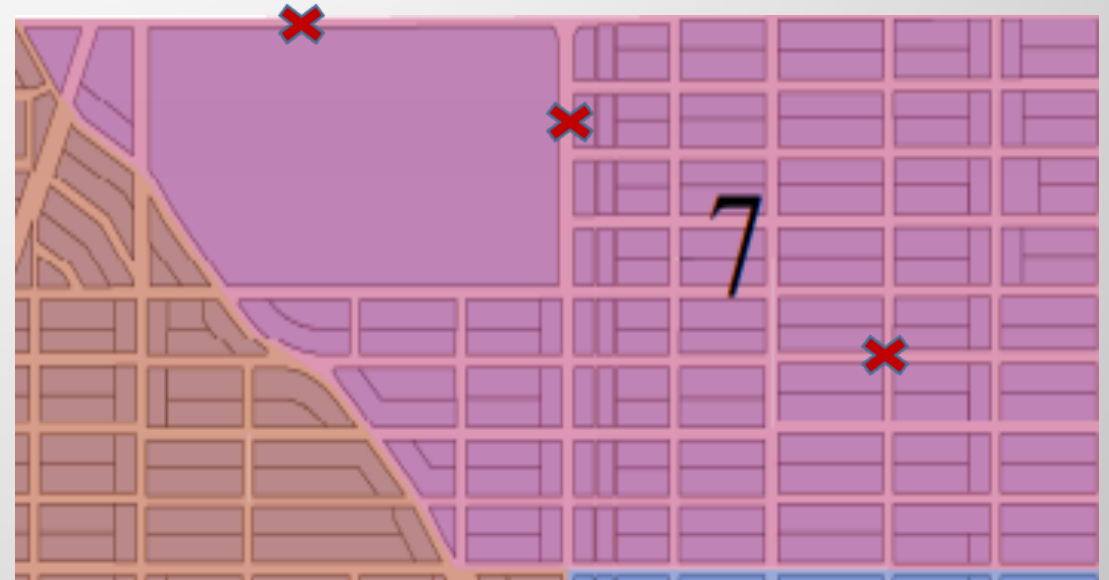

Officers responded to the 2400 block of Harlem Ave. for a report of a Male Black who was standing outside. Upon arrival, responding officers observed a Male Black subject standing outside with his pants below his buttocks and pleasuring himself. Officers immediately placed the offender in custody and transported him to the Berwyn Police Department for processing. The offender was subsequently charged with one (1) felony count of Public Indecency. Case closed by arrest.

SIGNIFICANT INCIDENTS IN 8TH WARD

Unlawful Use of a Firearm by a Felon Unlawful Possession of a Firearm by a Gang Member – 7/08/2024 1200 block of Harlem Ave. – 12:39a.m.

Officers observed a vehicle traveling at a high rate of speed (approximately 60 MPH) and attempted to conduct a traffic stop on said vehicle near Harlem Ave/Roosevelt Rd. Said vehicle did not stop immediately, instead they drastically lowered their rate of speed and continued at a very slow pace. Officers ultimately curbed said vehicle on the Westbound I-290 ramp at Harlem Ave. Officers made contact with the driver (male subject) and took him into custody without incident. A subsequent search of the vehicle revealed a loaded firearm inside the vehicle. A check of the subject's name revealed he does not have a valid FOID or CCL. The subject was transported to the Berwyn Police Department where he was subsequently charged with one (1) felony count of Unlawful Use of a Firearm by a Felon and one (1) felony count of Unlawful Possession of a Firearm by a Gang Member. Case closed by arrest.
