


Criminal Damage to Property Over \$10k – 1/27/2026


Unlawful Possession of a Weapon/Reckless Discharge of a Firearm

Berwyn Dispatch received a call from a witness who stated they heard one (1) gunshot and observed a male passenger in a parked, white SUV, in possession of a firearm near Euclid Ave./21st St. Responding officers located said vehicle and detained both occupants. Officers recovered one (1) loaded firearm from inside the vehicle and one (1) spent shell casing from the ground next to the passenger's door. A check in LEADS revealed the driver had a valid FOID but did not possess a CCL. The passenger did not possess a valid FOID or CCL. Pursuant to further investigation, both male subjects were taken into custody and charged accordingly. Case closed by arrest.


Shots Fired (Unfounded) – 2/02/2026






