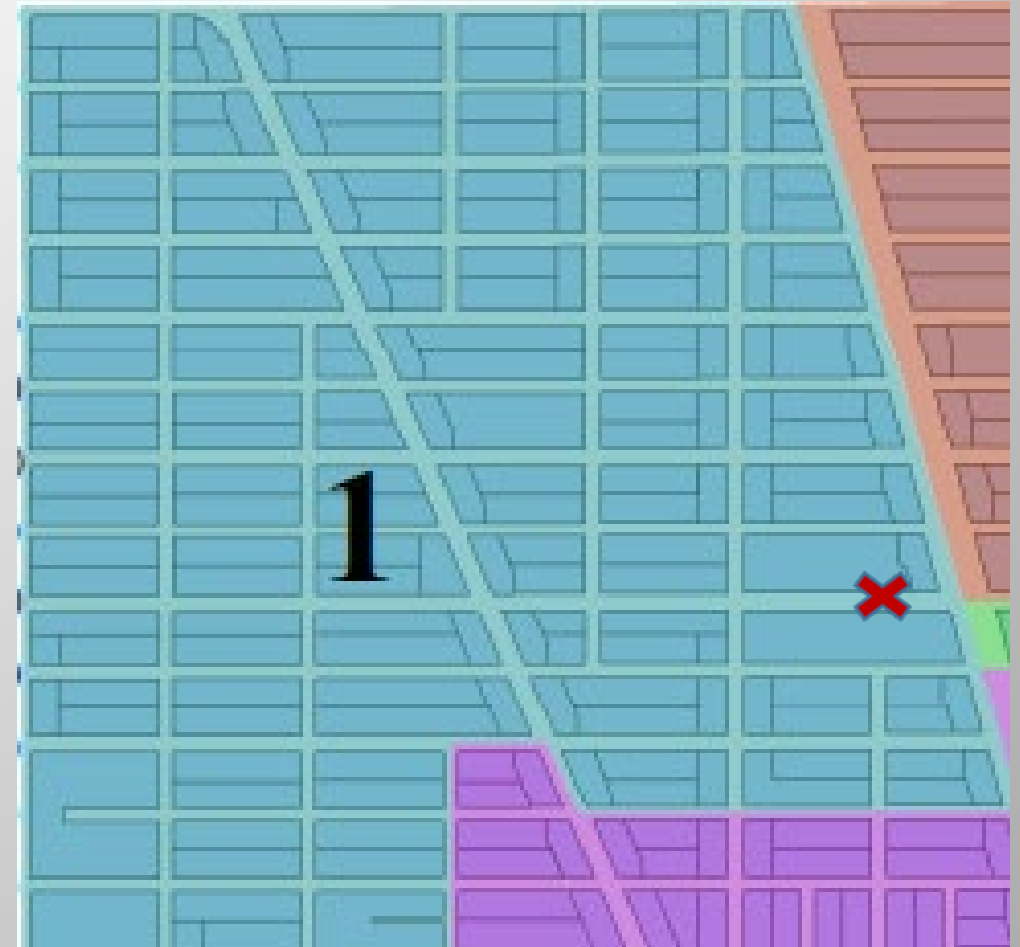
## Assist Other Agencies – 3/18/2026

MacNeal Hospital (3249 S. Oak Park Ave.) – 6:19 p.m.

The Berwyn Police Department received a notification regarding the escape of a prisoner in custody from a neighboring town at MacNeal Hospital. The individual managed to flee the hospital while still handcuffed, prompting an immediate response from local law enforcement. Upon receiving the alert, the Berwyn Police Department deployed multiple officers, supervisors, detectives, and tactical units to the scene. The Berwyn Police Department coordinated efforts with neighboring police agencies and Cook County Sheriff's Police, utilizing K9 units and drones to aid in the search. Police helicopters from Cook County and Chicago Police Departments were also dispatched to assist in locating the escaped prisoner. Officers aboard the police helicopter successfully identified a heat source in the 3300 block of Wesley. Following this lead, law enforcement officials apprehended the escaped individual without further incident.

Upon arrival, responding officers located the offender, who was bleeding from his hands. Witnesses positively identified the offender, who was subsequently taken into custody. BFD transported the offender to MacNeal Hospital, where he was treated and released for minor injuries. Upon release from the hospital, the offender was transported to the Berwyn Police Department and subsequently charged with one (1) misdemeanor count of Criminal Damage to Property. 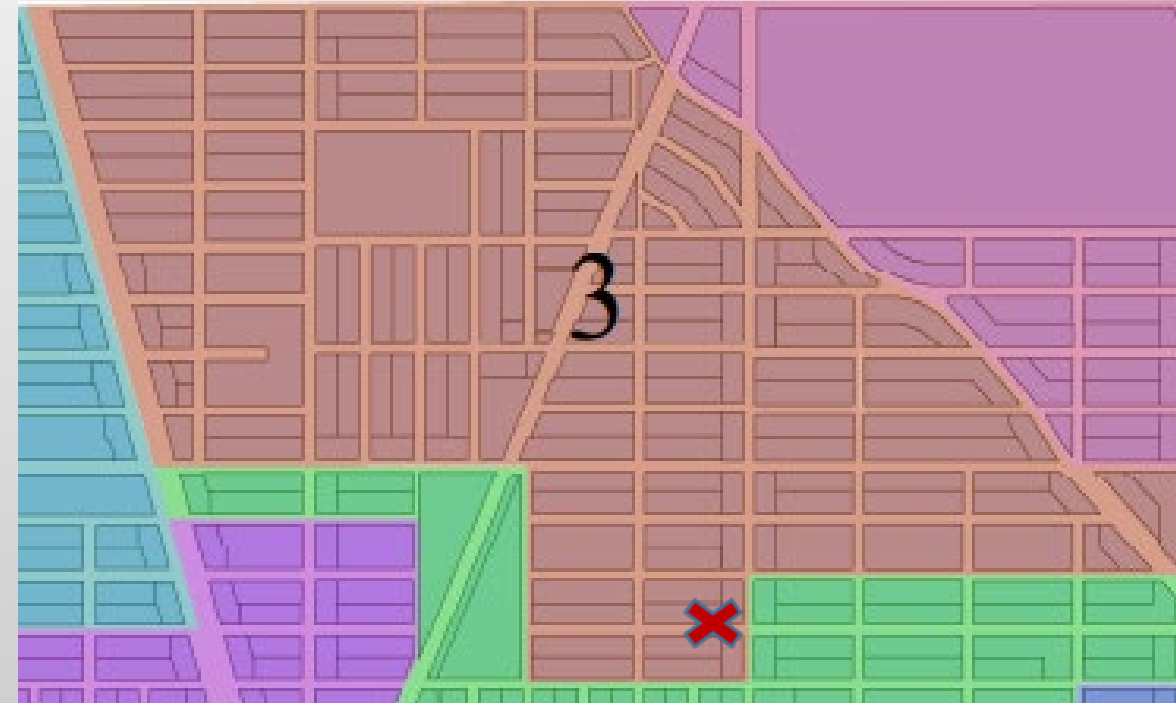
## **Burglary – 3/17/2026**

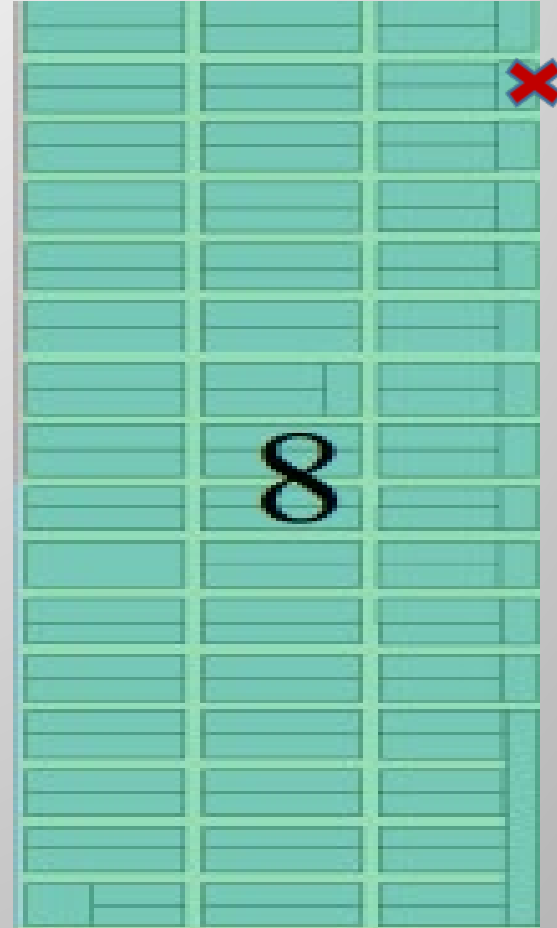
## Burglary – 3/17/2026
