



Officers responded to Pav YMCA for a report of a man with a gun. Upon arrival, officers met with a witness who related they observed a firearm fall out of the jacket of a male subject. The witness identified said male subject who was still on scene. Pursuant to a preliminary investigation on scene, officers recovered one (1) loaded handgun and numerous plastic bags containing cannabis gummies in the male subject's backpack. The offender was taken into custody without incident and transported to the Berwyn Police Department, where he was charged with one (1) felony count of Aggravated Unlawful Use of a Weapon. Case closed by arrest.

Officers responded to the 2800 block of Ridgeland Ave. for a report of a possible garage burglary. Upon arrival, officers located one (1) male subject inside of the garage. 
Loud Noise Complaint – 3/01/2026






