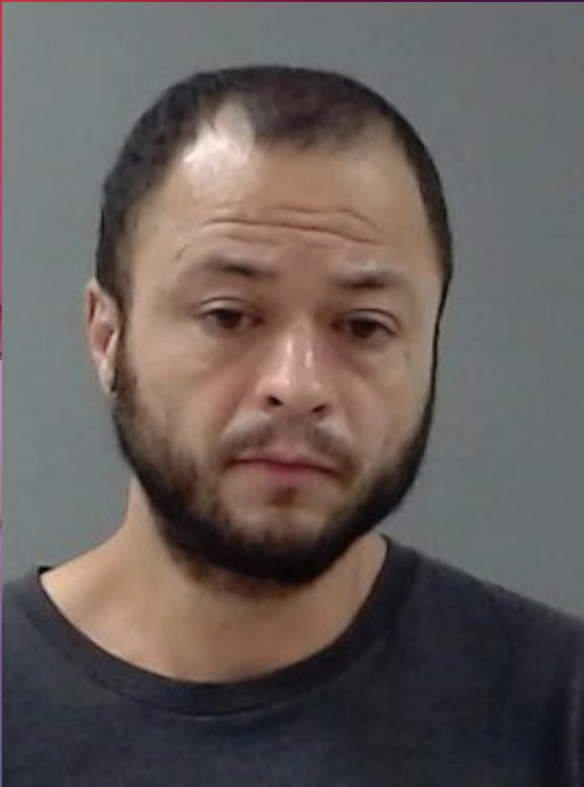

SIGNIFICANT INCIDENTS IN 1ST WARD

Disturbance – 4/23/2026

Aura Lounge (6814 Windsor Ave.) – 1:42 a.m.

While patrolling the area, officers responded to Aura Lounge for a possible disturbance. Officers met with security, who related that upon escorting several subjects out of the establishment OC spray was deployed by unknown subject(s). An ambulance was requested to assist the four (4) victims who were affected by the spray. Officers then relocated to Shell Gas Station (6400 Ogden Ave.) for a report of a male subject who stated he was sprayed with OC spray. As responding officers attempted to make contact with the victim, a male subject repeatedly interrupted them and refused to provide I.D. as requested by the officers. Said male subject was subsequently placed in custody and cited accordingly. None of the victims wished to sign complaints. Nothing further at this time.

SIGNIFICANT INCIDENTS IN 2ND WARD

Aggravated Unlawful Use of a Weapon/Unlawful Possession of a Firearm Smirz Park (3400 Highland Ave.) – 4/22/2026 – 4:49 p.m.

Berwyn Tactical Detectives attempted to conduct a street stop on three (3) male subjects smoking cannabis in Smirz Park. All three (3) subjects fled from the officers on foot. Officers observed one (1) of the male subjects throw a firearm while he was running. Said subject was apprehended and placed in custody without incident. The other two (2) subjects made good on their escape. One (1) male offender was transported to the Berwyn Police Department and subsequently charged with one (1) felony count of Aggravated Unlawful Use of a Weapon- Under 21 years of age and one (1) felony count of Unlawful Possession of a Weapon-Gang Member. Case closed by arrest.

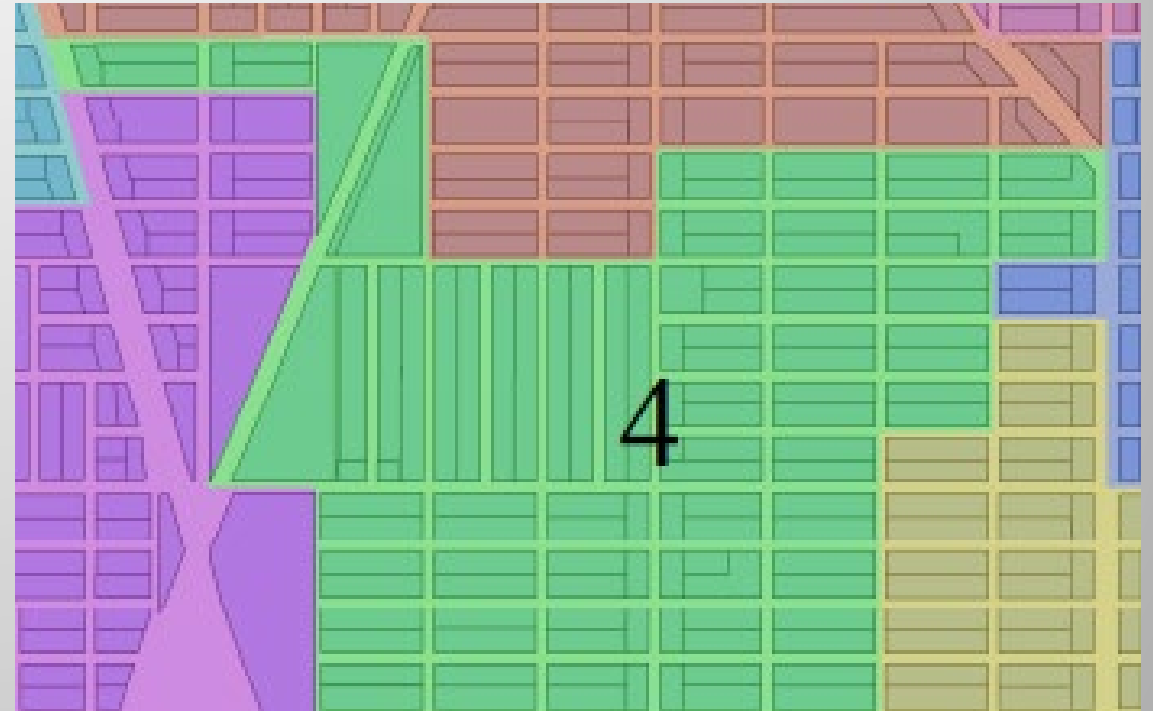

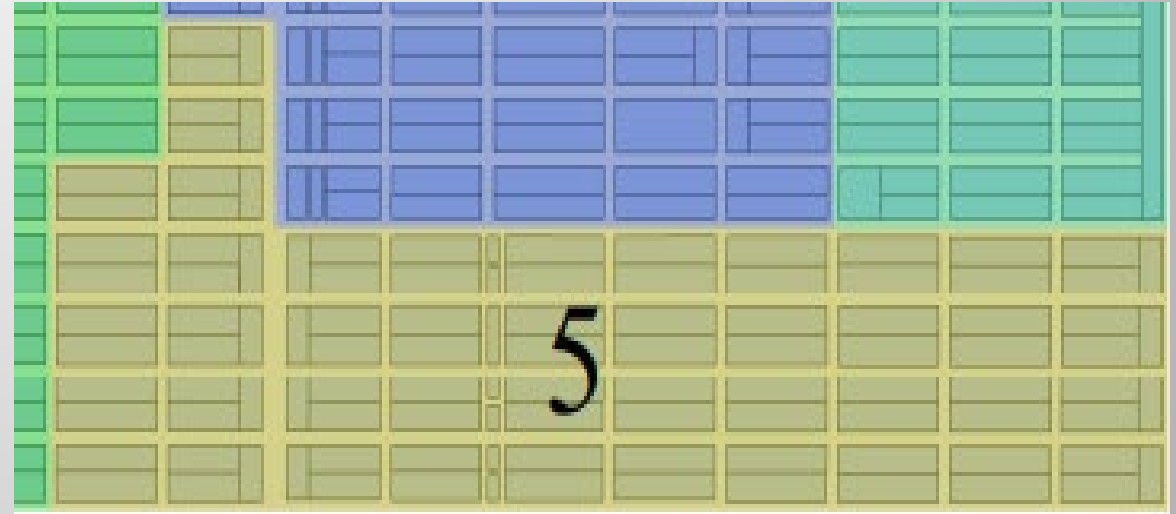

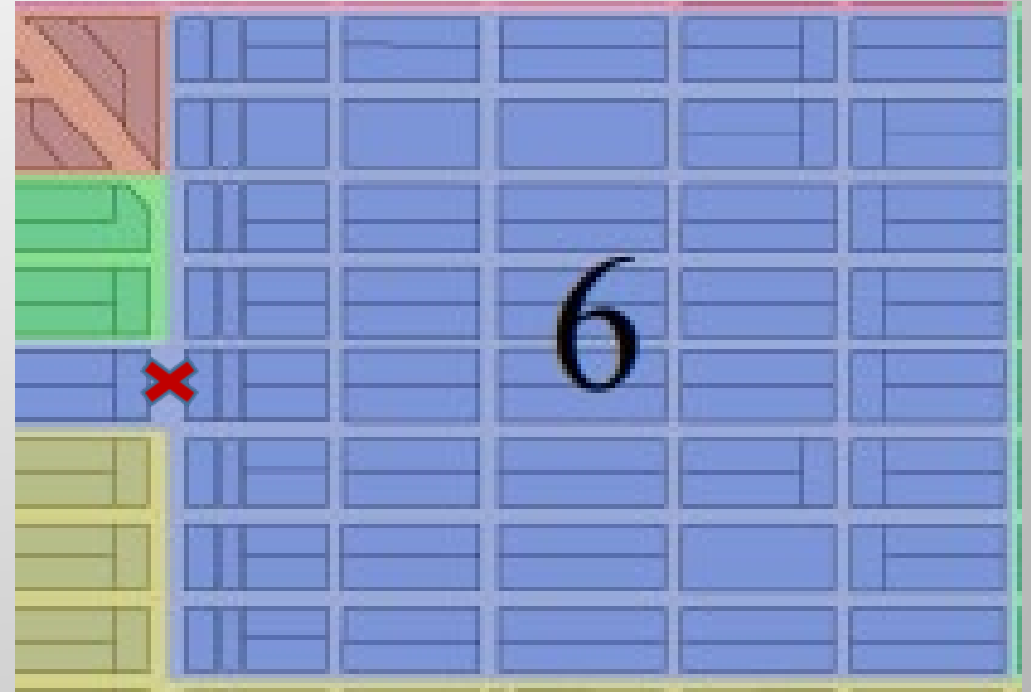
Loud Noise Complaint – 4/23/2026

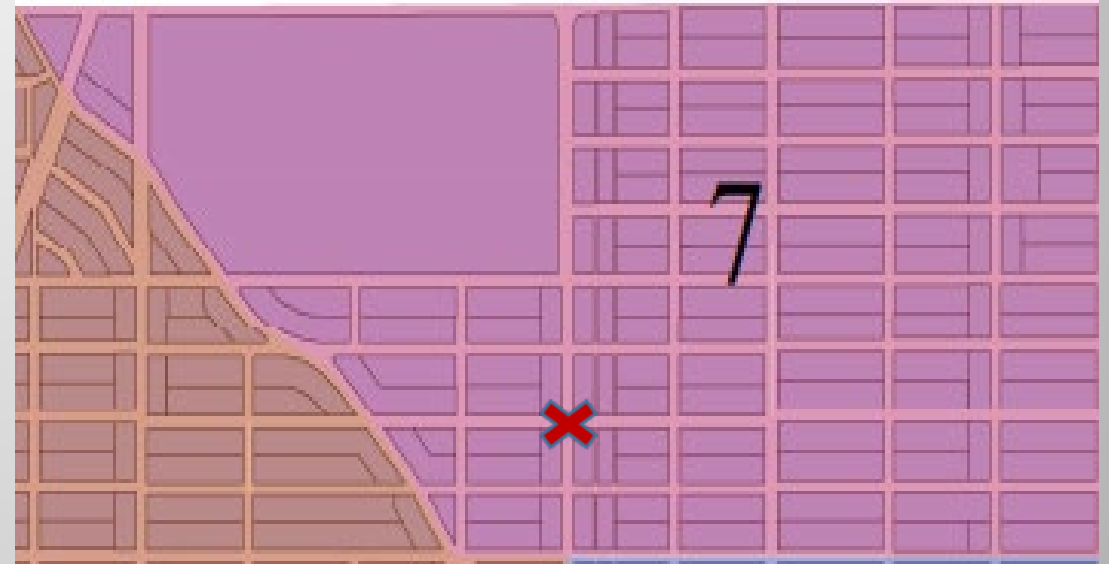

Officers responded to multiple calls reporting a fight in progress where a knife was involved. Upon arrival, responding officers observed three (3) male subjects and two (2) female subjects involved in an altercation. Officers separated the involved parties without incident. Officers located one (1) male victim lying on the ground with two (2) lacerations. The victim was transported to a local area hospital for treatment of non-life-threatening injuries. Stolen Motor Vehicle (KIA) – 4/26/2026 **1400 block of Wenonah Ave. – 12:44 a.m.**

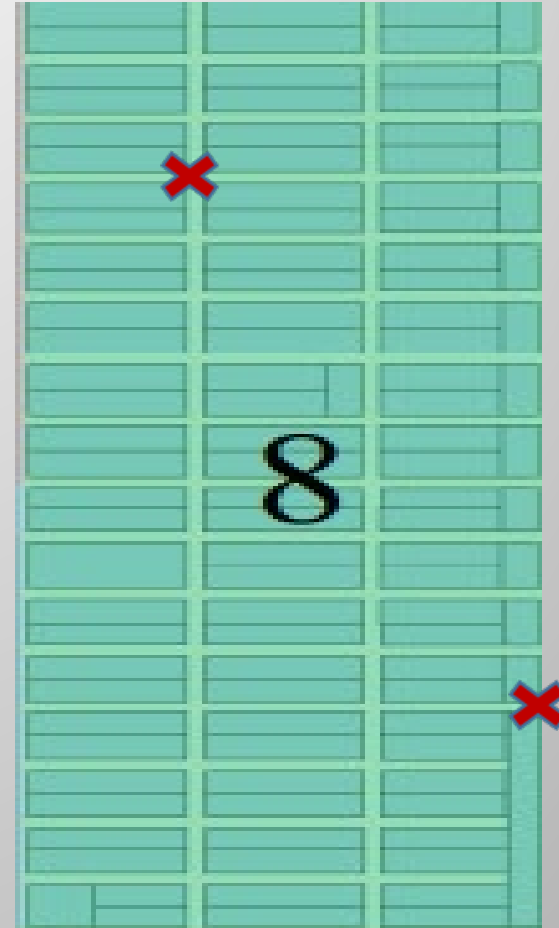

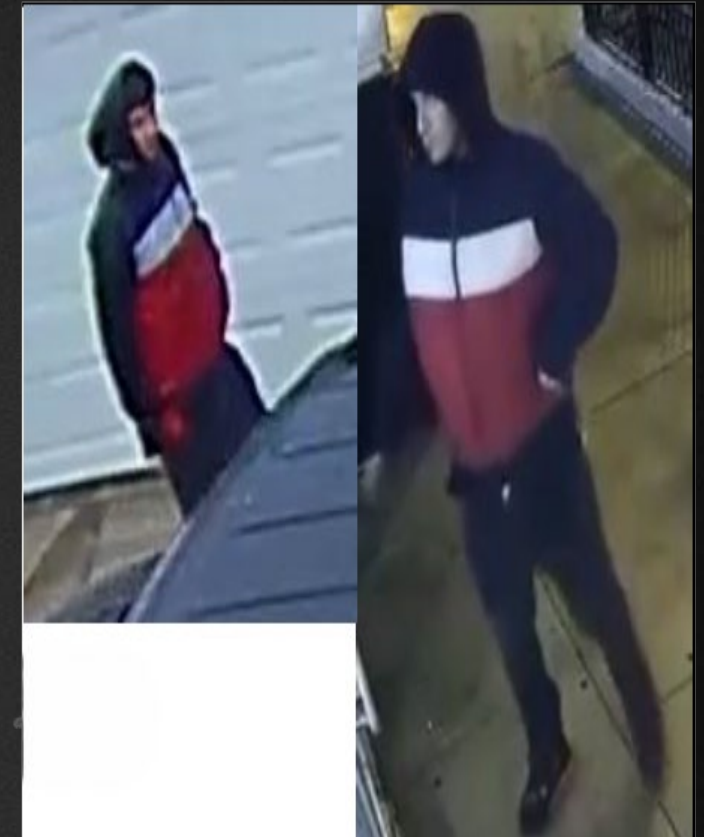

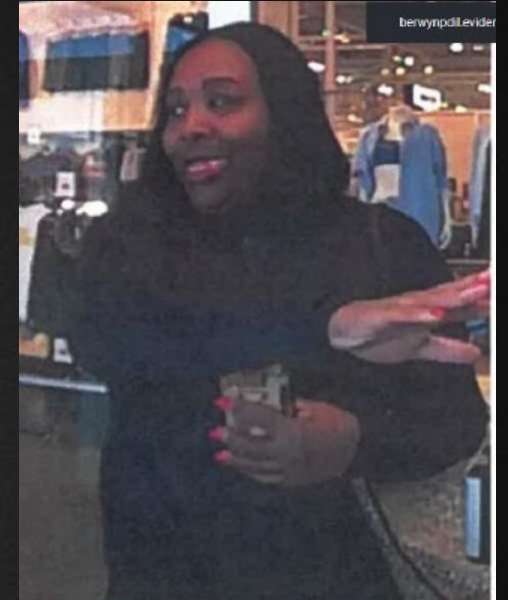
