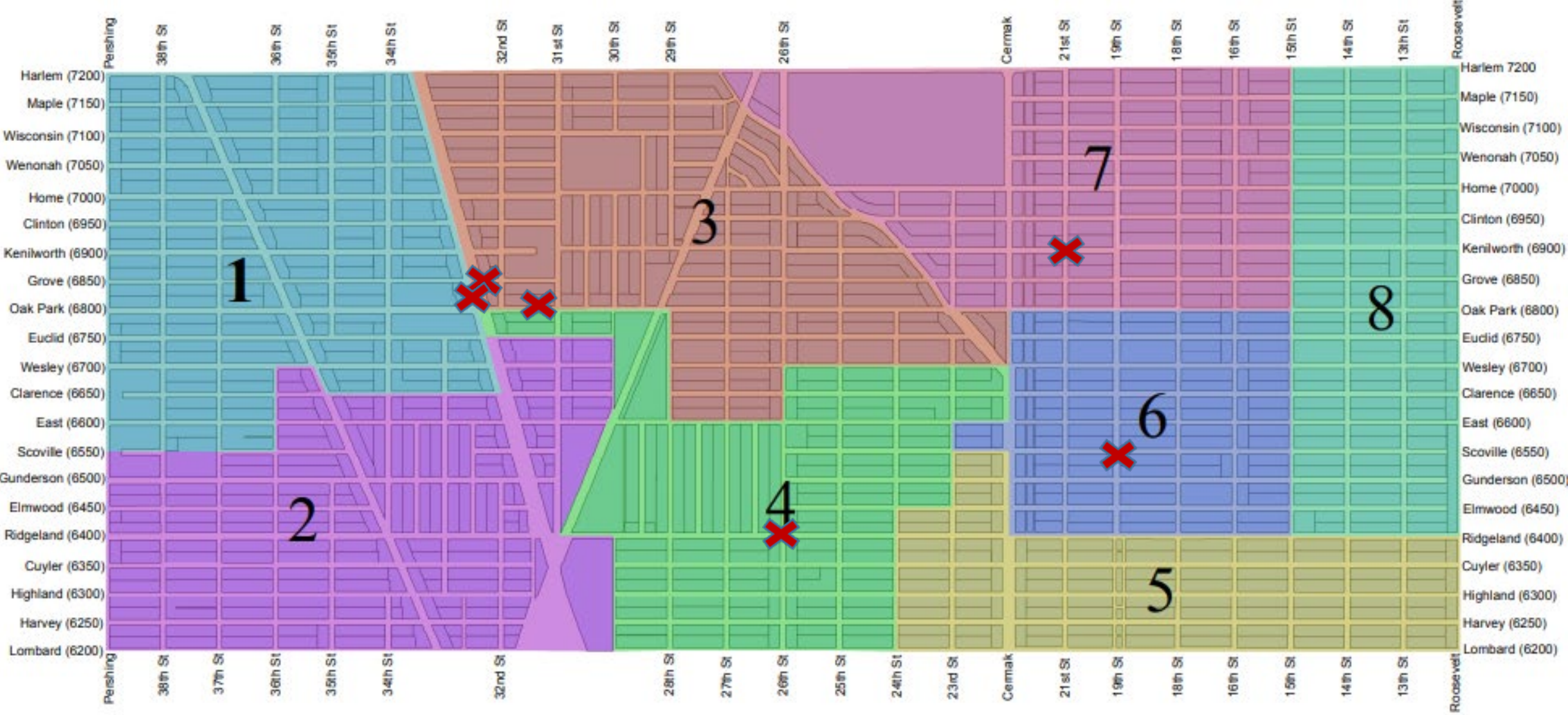

FOR WEEK OF 5/11/2026

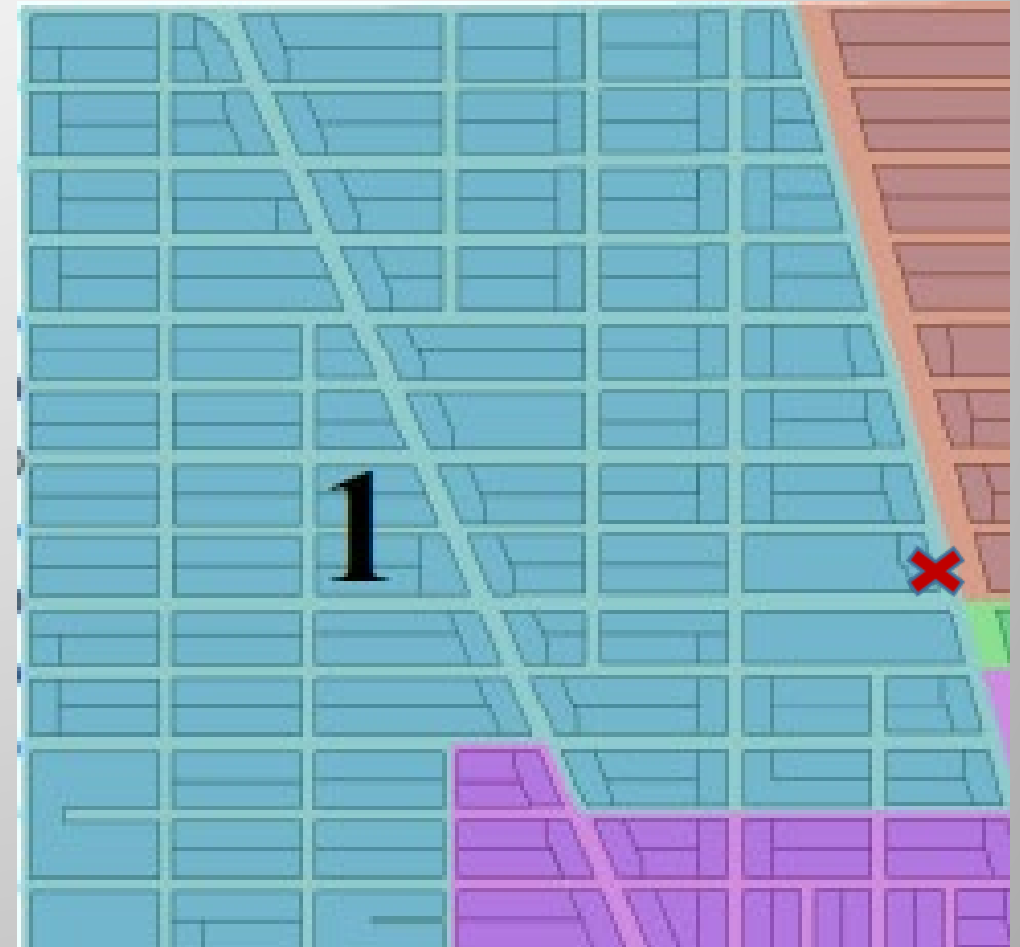
Disturbance/Fight/Battery – 5/16/2026

Aura Lounge (6814 Windsor Ave.) – 2:50 a.m.

Officers observed approximately 150+ subjects fighting near Windsor Ave./Grove Ave. Officers also observed several of the involved parties flashing gang signs. Two (2) officers were battered while attempting to place subjects in custody. One (1) male offender threatened to kill another officer. OC spray was deployed, and officers were able to disperse the crowd without further incident. Four (4) subjects were arrested and subsequently charged accordingly. Case closed by arrest.

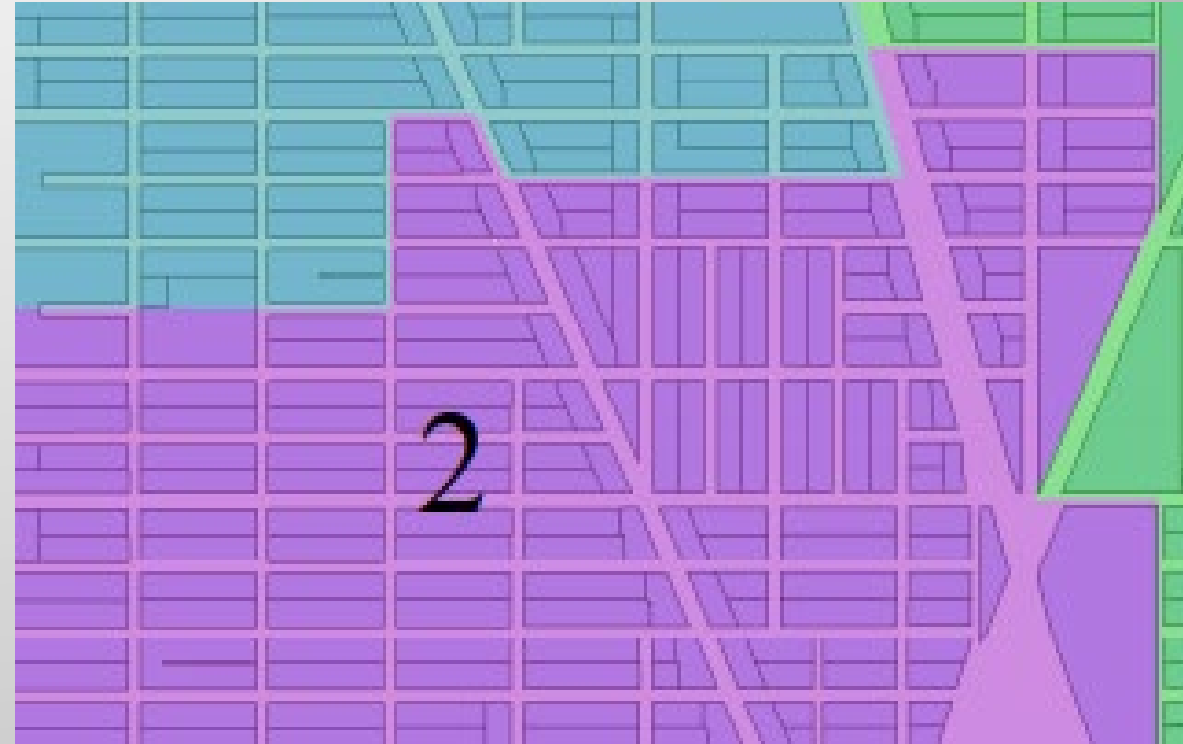

Disturbance – 5/14/2026

House of Slots (6823 Stanley Ave.) – 11:26 p.m.

Officers responded to House of Slots for a report of a disturbance involving a male patron who implied he had a gun. Upon arrival, responding officers met with the bartender, who related that two (2) patrons were involved in a fight where chairs were thrown inside the establishment. The bartender called security from a nearby business for assistance, at which time the involved parties were separated. The bartender further related that one (1) of the male subjects implied he had a gun, but never displayed it. Said subject left the scene prior to officer arrival. This investigation is ongoing.

Note: At the time of the incident, no manager was on duty. The business was cited accordingly.

SIGNIFICANT INCIDENTS IN 4TH WARD

FOR WEEK OF 5/11/2026

Disorderly Conduct/Resisting or Obstructing a Peace Officer – 5/15/2026 Pilsen Wellness Center (2400 Ridgeland Ave.) – 6:24 p.m.

Officers responded to Pilsen Wellness Center for a report of a male subject, wearing a ski mask, who threatened to damage vehicles and set fire to the establishment. Upon arrival, officers met with the reporting party (staff member) who related that the offender fled the scene through the alley. Responding officers conducted a check of the area and located a male subject matching the description in the 26th St. alley near East Ave. Said subject refused to comply with the officer's commands to remove his hands from the front pocket of his hooded sweatshirt. The officer attempted to place the subject in custody at which time he actively resisted in an attempt to defeat the arrest. Additional officers arrived on scene and the offender was placed under arrest without further incident. A positive identification was conducted. The offender was transported to the Berwyn Police Department and charged accordingly. Case closed by arrest.

Disturbance/Battery – 5/15/2026 Heritage Funeral Home (3117 Oak Park Ave.) – 7:30 p.m.

Berwyn Police Officers responded to Heritage Funeral Home for a call of a disturbance inside the establishment. Upon arrival, officers observed several subjects fighting inside the funeral home. Cicero, Forest View, and Stickney Police Departments also responded to provide additional assistance with crowd control. Five (5) subjects were taken into custody and transported to the Berwyn Police Department, where they were charged accordingly. Case closed by arrest.

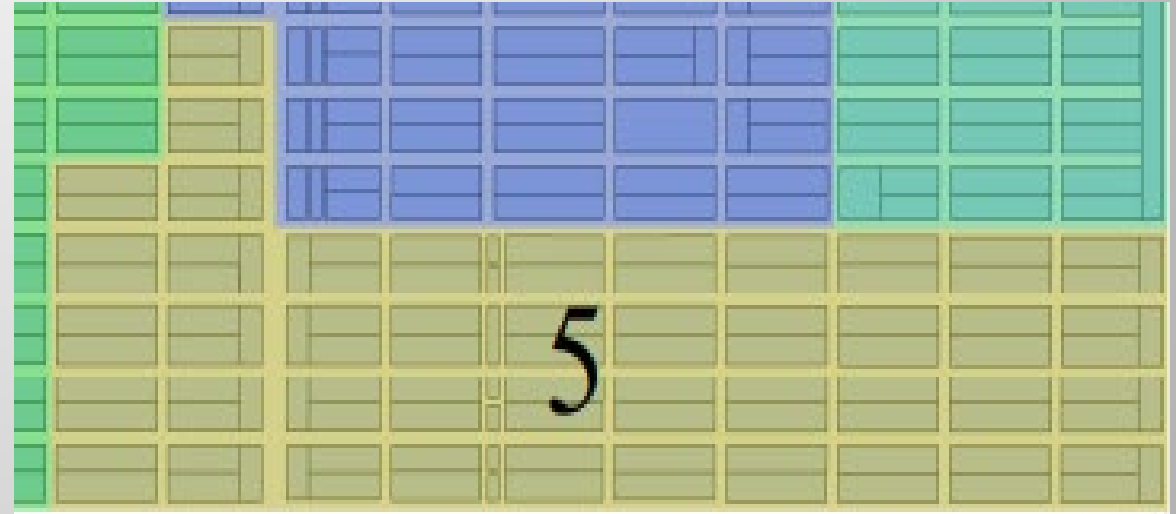

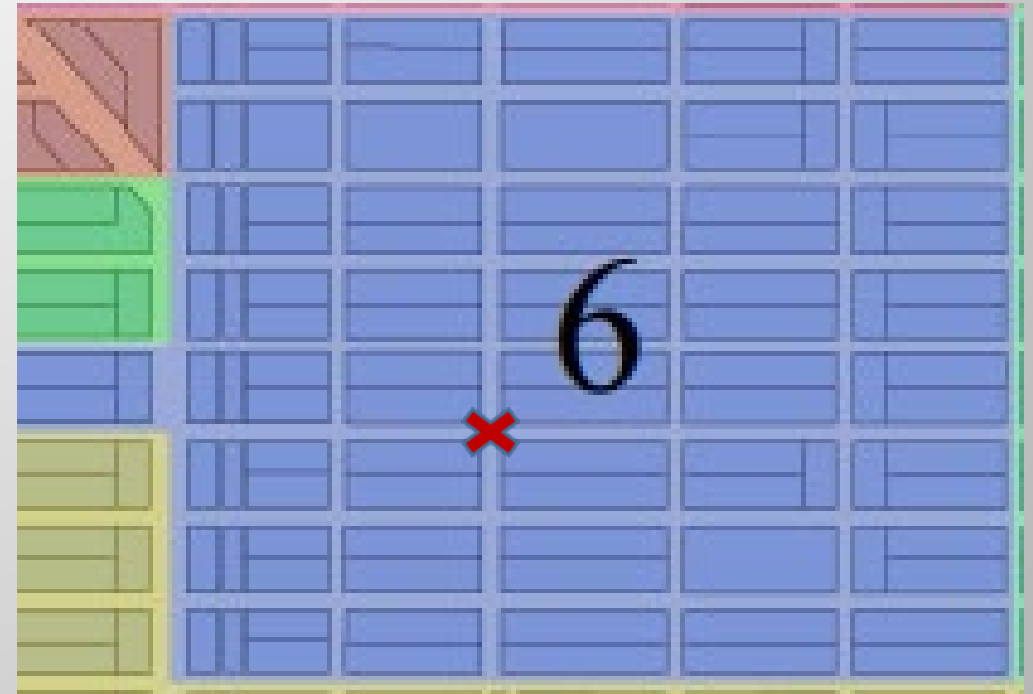
Shots Fired – 5/17/2026

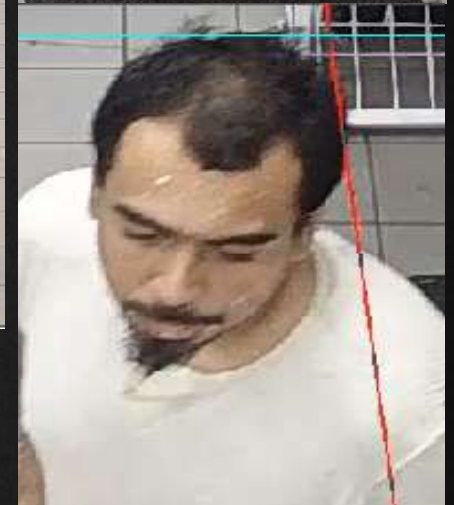

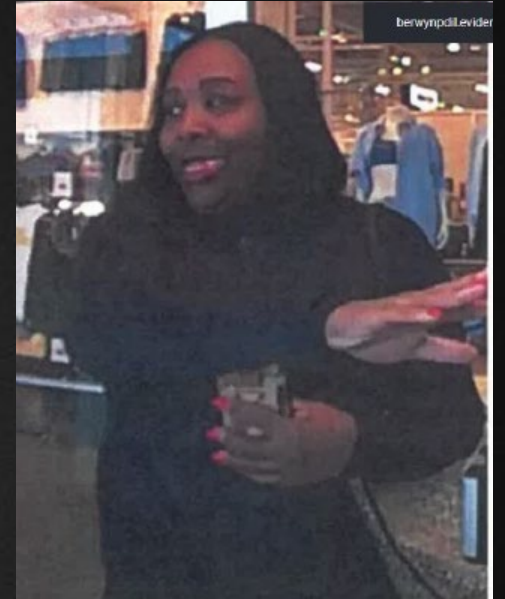
