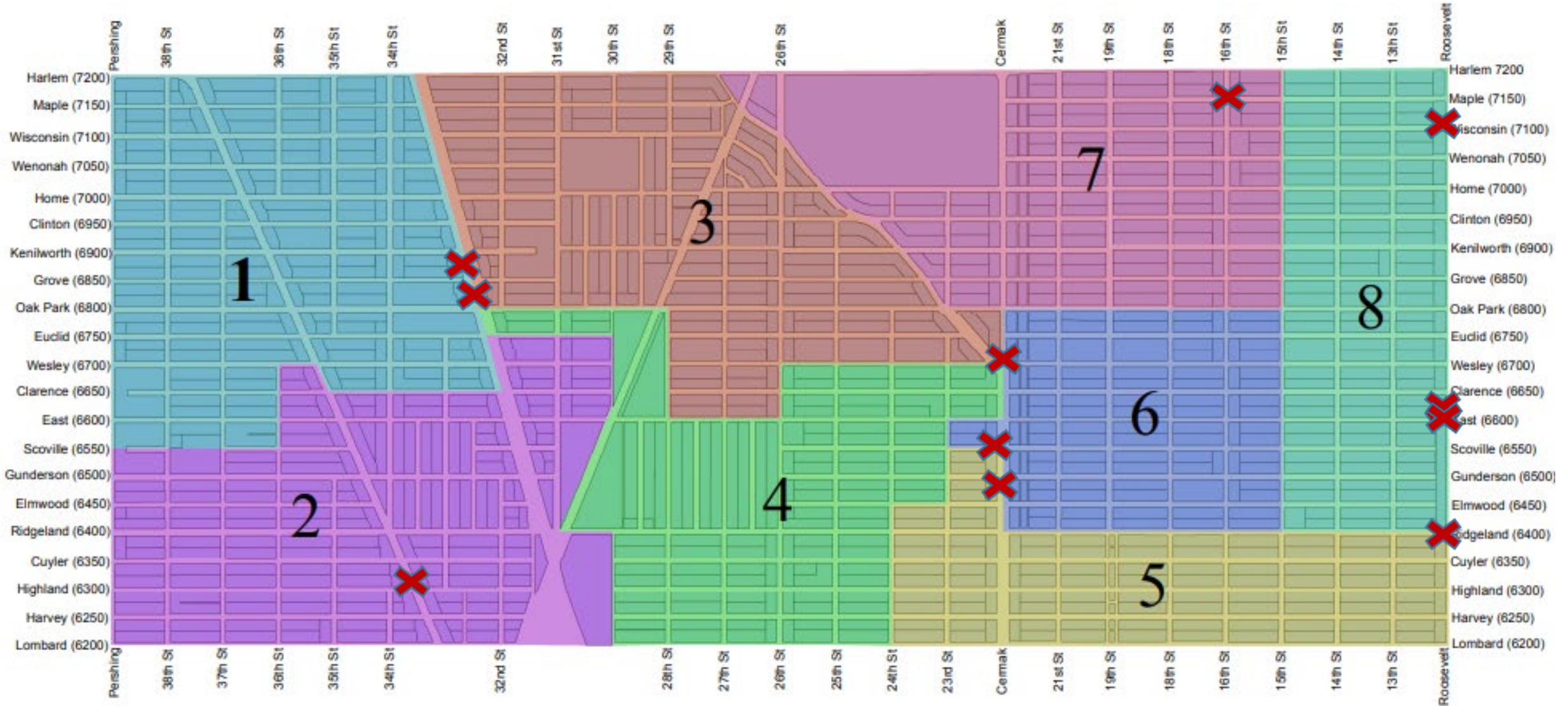

SIGNIFICANT INCIDENTS IN 1ST WARD

FOR WEEK OF 8/03/2026

Criminal Trespass to Real Property – 8/07/2026 Windsor Café (6834 Windsor Ave.) – 12:27 a.m.

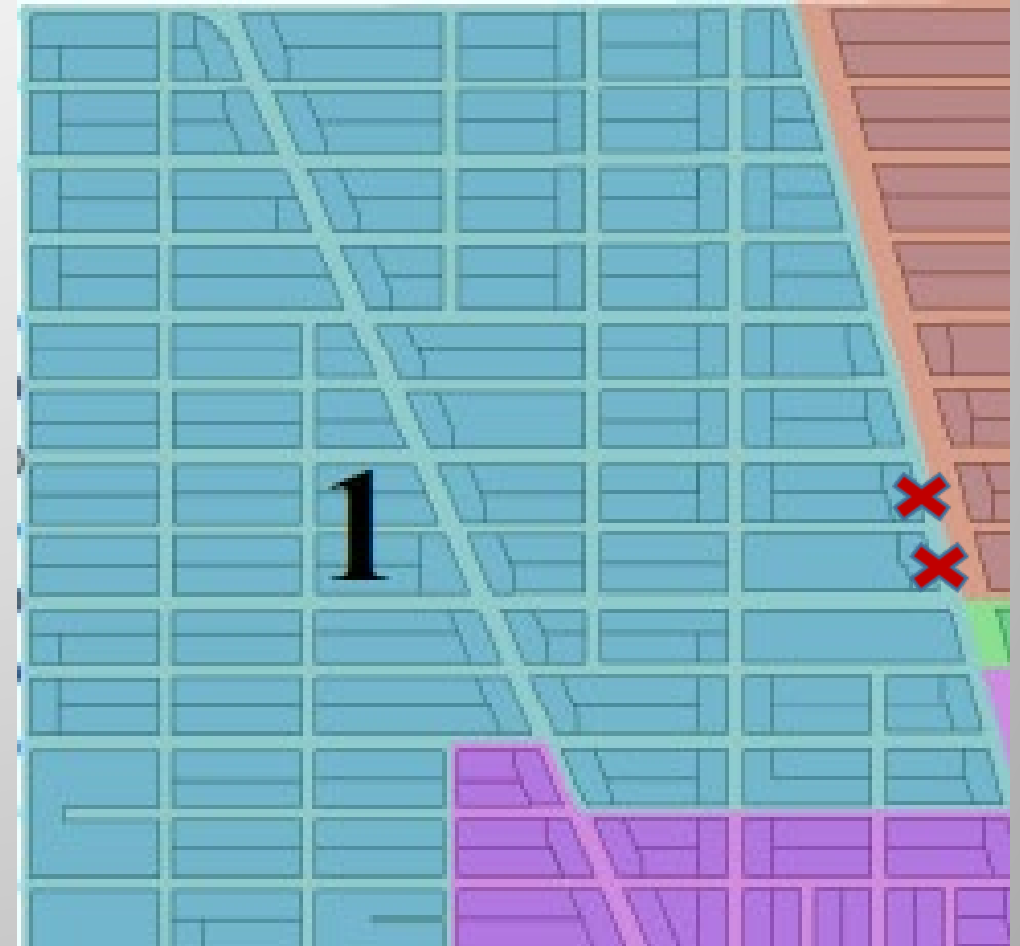
Officers responded to Windsor Café for a report of an unwanted subject. Upon arrival, officers met with the bar manager, who related that a male subject had been previously advised that he was not welcome in the business; however, said male subject was now outside attempting to enter the establishment. The manager further related that when they reminded the subject that he was not allowed to enter, he became irate and made threats towards the manager. Officers located the offender outside of the establishment and took him into custody without incident. The offender was transported to the Berwyn Police Department and charged accordingly. Case closed by arrest.

Battery – 8/09/2026 Aura Lounge (6814 Windsor Ave.) – 2:39 a.m.

Officers observed a physical altercation involving multiple female subjects in front of Aura Lounge. Officers responded and separated the involved parties. Two (2) female subjects were detained; however, they were uncooperative and did not wish to sign complaints. Shortly after, one (1) female subject (victim) approached officers and stated she had been battered by three (3) unknown female subjects who had since fled the scene. BFD transported said victim to MacNeal Hospital for treatment of minor injuries. This investigation is ongoing.

SIGNIFICANT INCIDENTS IN 2ND WARD

FOR WEEK OF 8/03/2026

Possession of a Firearm/Possession of a Stolen Motor Vehicle – 8/05/2026 6300 block of Ogden Ave. – 12:00 a.m.

Officers conducted a traffic stop on the 6300 block of Ogden Ave. on a vehicle that was occupied by a male driver and three (3) female passengers. The male driver immediately exited the vehicle and proceeded to the sidewalk, where he was detained by officers without incident. One (1) of the female passengers moved to the driver's seat and fled westbound on Ogden Ave. Soon after, officers located the offending vehicle abandoned and crashed near Ogden Ave./East Ave. A check of the vehicle revealed that it was reported stolen out of Calumet City. Officers conducted a check of the area and located the three (3) female offenders near 34th St./Wesley Ave. One (1) of the female offenders was found to be in possession of one (1) loaded firearm and narcotics. All three (3) female offenders were taken into custody and transported to the Berwyn Police Department. Pursuant to further investigation, one (1) of the female subjects was released without charges. The remaining two (2) female subjects and the male subject were subsequently charged accordingly. Case closed by arrest.

SIGNIFICANT INCIDENTS IN 3RD WARD

FOR WEEK OF 8/03/2026

Disorderly Conduct (JUVENILE) – 8/04/2026

Cermak Rd./Wesley Ave. – 5:45 p.m.

Berwyn Tactical Detectives were flagged down near Cermak Rd./Wesley Ave. by a Pace bus driver who related that they believed two (2) male subjects on the bus had a gun. The bus driver further related that said subjects were involved in a disturbance with an elderly subject. Additional officers arrived on scene and safely evacuated all bus occupants. Multiple witnesses reported hearing the offenders make threats to shoot up the bus. Witnesses positively identified both offenders. Officers placed both offenders (JUVENILES) in custody without incident. A check was conducted, which yielded negative results for any weapons. Passengers were rerouted onto another bus, and the juvenile offenders were transported to the Berwyn Police Department. Both offenders were subsequently petitioned with one (1) misdemeanor count of Disorderly Conduct. Case closed by arrest.

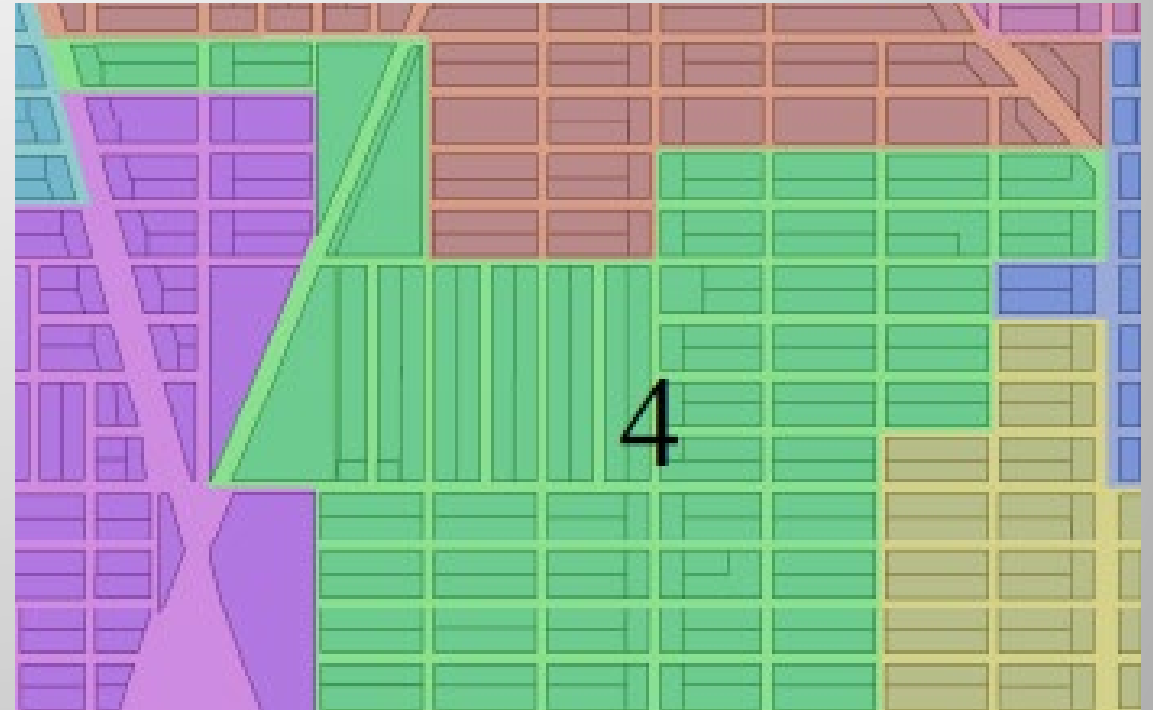

Aggravated Assault – 8/05/2026

Fuel Stop (6347 W. Roosevelt Rd.) – 2:51 a.m.

Berwyn Dispatch received a call from a store clerk at Fuel Stop who reported an unknown female subject threatened them with a gun approximately five (5) minutes prior to the call. Upon arrival, responding officers made contact with the clerk (victim), who related that they were on break outside of the store when a female subject attempted to enter the business (which was locked). The victim further related that the female subject became belligerent after he asked her to wait a minute. The victim stated that the offender spat on him and then removed a firearm from her vehicle and threatened him before fleeing the scene in an unknown direction. This investigation is ongoing.

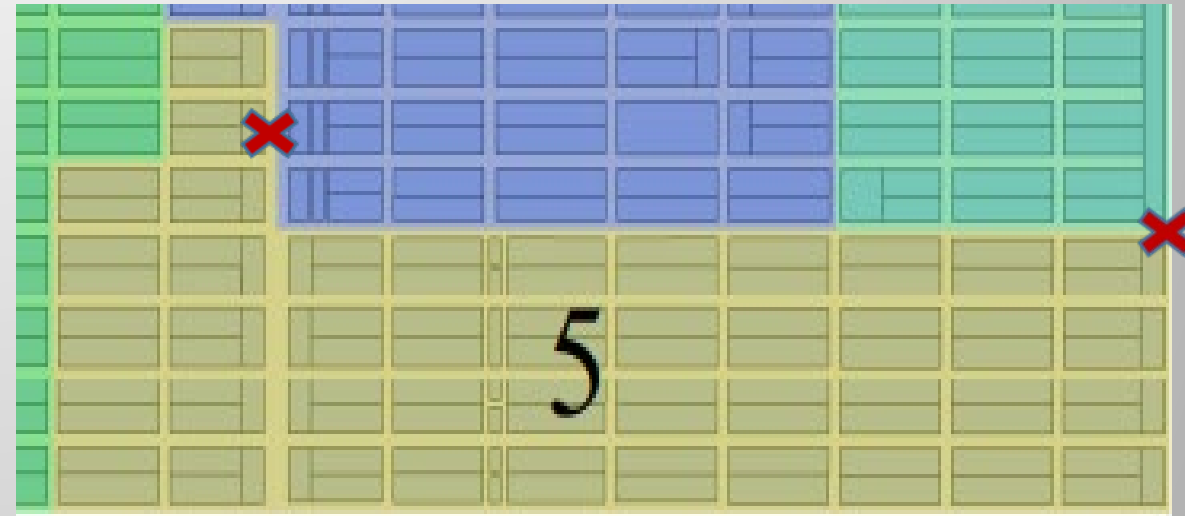
Battery (x2)/Resisting or Obstructing a Peace Officer – 8/05/2026

Jardin Restaurant (6431 W. Cermak Rd.) – 2:51 a.m.

Officers responded to Jardin Restaurant for a report of a battery. Upon arrival, responding officers observed a male subject detained by security. Officers learned that the male subject was detained after he had battered one (1) of the security guards. While officers were taking the male subject into custody, he actively resisted and kicked one (1) of the officers, causing both the offender and the officer to fall to the ground. The offender was transported to a local area hospital for treatment of minor injuries. Upon release from the hospital, the offender was transported to the Berwyn Police Department and subsequently charged accordingly. Case closed by arrest.

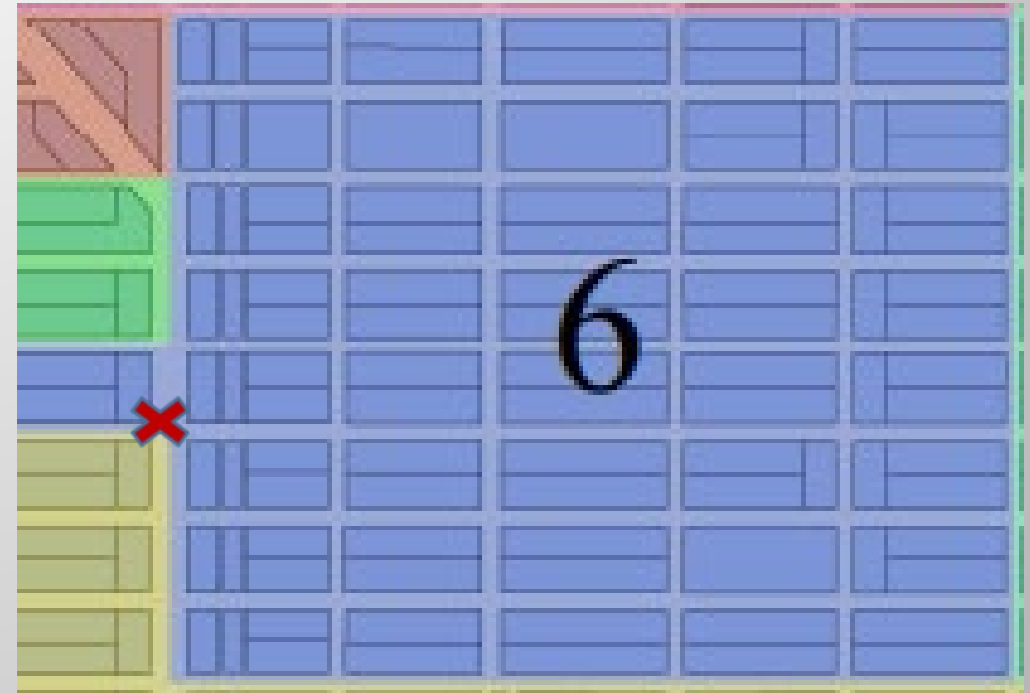

Aggravated Unlawful Possession of a Firearm – 8/04/2026 **Cermak Rd./Scoville Ave. – 10:34 p.m.**

Officers conducted a traffic stop near Cermak Rd./Scoville Ave. Upon making contact with the male driver, officers observed open alcohol inside the vehicle and subsequently asked the male subject to exit the vehicle. Upon opening his car door, officers observed a firearm protruding from the driver's side door panel. Both the male driver and male passenger were taken into custody without incident. Officers recovered one (1) loaded firearm from the vehicle. Both subjects were transported to the Berwyn Police Department. A LEADS check revealed that the firearm was reported stolen out of Chicago. After further investigation, the passenger was released without charges. The driver was charged with one (1) felony count of Aggravated Unlawful Possession of a Firearm. Case closed by arrest.

SIGNIFICANT INCIDENTS IN 7TH WARD

Aggravated Unlawful Possession of a Weapon – 8/07/2026 **Maple Ave./16th St. – 4:23 p.m.**

Officers conducted a traffic stop near Maple Ave./16th St. Officers made contact with the vehicle, which was occupied by one (1) female driver and one (1) male passenger. During the course of the stop, officers asked both occupants to exit the vehicle. Officers conducted a protective pat-down on the male subject and recovered a loaded firearm from his waistband. A name check revealed that the male subject had a revoked FOID and no CCL. Officers learned that the female subject did not have a valid driver's license (expired 2023). Both subjects were taken into custody without incident and transported to the Berwyn Police Department. The female subject was subsequently cited accordingly. The male offender was charged with one (1) felony count of Aggravated Unlawful Possession of a Weapon. Case closed by arrest.

SIGNIFICANT INCIDENTS IN 8TH WARD

Criminal Damage to Property/Attempt Burglary – 8/07/2026
Dotty’s Café (6635 W. Roosevelt Rd.) – 4:48 a.m.

Officers responded to Dotty’s Café for a report of a commercial alarm. Dispatch advised officers that the alarm company stated that they observed through surveillance video an unknown Male Black subject exit a silver vehicle and attempt to gain entry into the business using a sledgehammer. The subject fled the scene in an unknown direction prior to officer arrival. Responding officers observed damage to the front door of the business. A check of the area was conducted, which yielded negative results for any suspects. This investigation is ongoing.

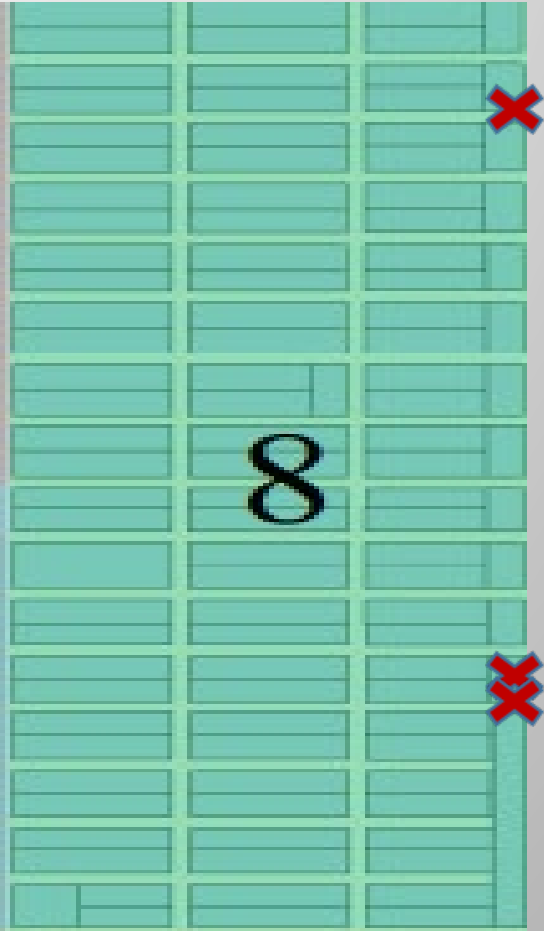
Commercial Burglary – 8/08/2026
Spins Café (7105 W. Roosevelt Rd.) – 6:09 a.m.

Officers responded to Spins Café for a report of a Commercial Burglary. Berwyn Dispatch advised officers that the caller stated they observed six (6) male subjects wearing masks attempting to make entry into the establishment. Upon arrival, officers met with Forest Park PD, who related that they observed two (2) offending vehicles. One (1) vehicle fled the scene westbound on Roosevelt Rd., and the second vehicle fled eastbound on Roosevelt Rd. Forest Park PD related that they initiated a vehicle pursuit during which one (1) of the offenders pointed a rifle at Forest Park PD. Both offending vehicles made good on their escape. Berwyn Police Officers cleared the interior of the business and observed three (3) gaming machines had been damaged and the cash drawers removed. This investigation is ongoing.

Criminal Damage to Property/Attempt Burglary – 8/09/2026
Shelby’s Place (6601 W. Roosevelt Rd.) – 6:01 a.m.

Officers were dispatched to Shelby’s Place for a call of a commercial burglary in progress. Dispatch advised officers that the caller related observing five (5) subjects wearing masks and all dark clothing exit a grey vehicle carrying sledgehammers and crowbars. The offenders fled the scene prior to officer arrival. Upon arrival, responding officers observed damage to the front window of the business. It was determined that the business’s fog deterrent system was activated and subsequently deterred the offenders from damaging or taking anything from within the business. This investigation is ongoing.
